# 2 OFS DM Application Pack Release 8.0.7.1.0

This release of the OFS DM Application Pack is cumulative and includes all enhancements and bug fixes done since the OFS DM Application Pack v8.0.7.0.0 ML release.

### 2.1 Prerequisites

The minimum patch set level must be OFS DM Application Pack v8.0.7.0.0 and OFS AAI v8.0.7.8.0.

NOTE

See the <u>OFS Analytical Applications Technology Matrix</u> for the Hardware and Software Requirements.

In case of the OFSAA environment has an ERF suite of applications installed, refer to <a href="My Oracle Support">My Oracle Support</a> - Doc ID <a href="2890601.1">2890601.1</a> and install the appropriate compatibility patches.

## 2.2 Installing this Release

To install this release, follow these steps:

- 1. Log in to My Oracle Support and search ID 34445855 under the Patches and Updates tab.
- 2. Download the OFS\_DM\_8.0.7.1.0\_LINUX.zip archive file and copy it to your OFSAA server in Binary mode.
- **3.** Shut down all the OFSAAI services. For more information, see the Stopping Infrastructure Services section in the <u>Oracle Financial Services Data Management Pack Installation Guide 8.0.7.0.0</u>.
- 4. Login to the OFSAA server with the user credentials that were used to install OFS DM.
- **5.** Extract the contents of the patch archive file using the command:

```
unzip -a <name of the file to be extracted>
```

For example: unzip -a OFS DM 8.0.7.1.0 LINUX.zip

Note: The above "-a" option is mandatory to unzip the patch.

If you notice an error message "unzip: not found [No such file or directory" before the package is installed, contact your UNIX administrator.

- 6. If you already have an unzip utility installed, skip to the next step.
  If you do not have an unzip utility, download the unzip utility (OS-specific), and copy it in **Binary** mode to the directory that is included in your PATH variable, typically **\$HOME** path or the directory in which you have copied the v8.0.7.1.0 ML Installer.
- **7.** Give EXECUTE permission to the file using the following command:

```
chmod -R 755 OFS DM PACK
```

- **8.** Modify the params.conf file present in the OFS\_DM\_PACK/OFS\_DM/conf directory and update the following parameters using the instructions given in the params.conf file.
- 9. In the params.conf file, update the value in the UPLOAD\_MODEL parameter to 0.

**10.** Give EXECUTE permission to the installer file. Navigate to the OFS\_DM\_PACK/ directory and execute the following command:

```
chmod 755 OFSAAIUpdate.sh
```

**11.** Execute the following software upgrade command:

```
./OFSAAIUpdate.sh
```

Verify that the maintenance level release is applied successfully by checking the following log files generated in the installation folder:

- OFS\_DM\_PACK/OFS\_DM/logs/OFS\_DM\_patch\_installation.log for the OFS Data Management Application Pack installation log file.
- **12.** You can ignore the following errors in the log files:
  - ORA-00001

If there are other errors, contact My Oracle Support.

- **13.** After the successful installation, follow these steps:
  - a. Clear the Application Cache.
  - **b.** Navigate to the following required directory depending on the configured Web Application Server and delete the files:
    - Tomcat: <Tomcat installation location>/work/Catalina/localhost/<Application Name>/org/apache/jsp
    - WebLogic: <WebLogic installation location>/domains/<Domain name>/servers/<Server name>/tmp/\_WL\_user/<Application name>/<auto generated folder>/jsp servlet
- 14. Delete the existing EAR or WAR file present in the \$FIC HOME/ficweb Directory.
- **15.** Generate the application EAR or WAR File and redeploy the application on your configured Web Application Server.

**16.** After the successful installation of the release, restart all OFSAAI Services.
