The AgileREPORTER in Regulatory Reporting (REG REP) Solution enables firms to automate the final mile of the reporting process. It provides pre-built integration to Lombard Risk Reporting, eliminating the need for further manual intervention. The solution ensures data integrity allowing banks to focus more time on analyzing and gaining new business insight from their growing stores of data instead of preparing data and reports with the sole objective of meeting submission deadlines.

2.2 **Pre-installation Requirements**

The prerequisite software that must be installed are as follows:

- Install and configure Oracle Financial Services Regulatory Reporting for Reserve Bank of India-Lombard Risk Integration Pack Release **v8.1.1.0.0** on your machine.
- AgileREPORTER version 21.1.2-b213.
- AgileREPORTER RBI Template package (AgileREPORTER_RBI_Package_v1.25.0.1).

2.3 Installing this One-off Patch Release

To install this one-off patch release, follow these steps:

- 1. Download the 32891579_GENERIC.zip archive file from <u>My Oracle Support</u> by searching patch **32891579** under the **Patches & Updates** tab.
- 2. Copy the archive file to your OFSAA server in Binary mode.

NOTE You must be logged in to the UNIX operating system as a non-root user.

- 4. Execute chmod -R 750 \$FIC_HOME
- 5. Execute unzip -a <name of the file to be unzipped>

```
For example: unzip -a 32891579_GENERIC.zip
```

NOTE The above "-a" option is mandatory to unzip the patch. If you notice an error message "unzip: not found [No such file or directory]", contact your UNIX administrator to resolve this issue.

- 6. Execute chmod -R 755 OFS REG REP RBI
- 7. Navigate to the <>/OFS REG REP RBI/conf directory.
- 8. Configure the UPLOAD_MODEL parameter in the params.conf file to determine if Model Upload is required or not using the following parameter values:

0 = If you have already performed the Model Upload and want to skip the Model Upload process

1 = If you want to perform the Model Upload

- 9. Navigate to the <>/OFS_REG_REP_RBI/bin directory and execute ./install.sh
- **10.** The installation progress can be viewed by periodically refreshing the log file under the <>/OFS_REG_REP_RBI/logs directory.
- After installation is completed, verify the log file for any Errors or Warnings. Contact <u>My Oracle Support</u> in case of any issues.



This patch installation requires approximately 10 minutes to complete in Oracle Test Labs.
