

# Preface

Oracle Financial Services Regulatory Reporting for US Federal Reserve – Lombard Risk Integration Pack helps the banks to comply with various guidelines issued by US Federal Reserve, including BCBS 239 regulations. It provides integrating risk data reporting systems and enhances the accuracy of reporting in banks. OFS Risk Regulatory Reporting (REG REP) Solution helps in achieving the objectives by enabling preset steps based on the generalization of a set of solutions. This is made possible by:

- Providing a centralized data storage for risk data through relevant subject areas of Financial Services Data Foundation (FSDF).
- Interfacing with a third party reporting tool such as Lombard Risk Reporter Portal to build necessary template reports to meet the regulatory expectations.

Data accuracy of risk reporting is ensured by:

• Data Governance Studio (DGS).

The OFS AGILE RP US FED solution enables financial services organizations to manage and execute regulatory reporting in a single integrated environment. It automates end-to-end processes from data capture through submission with industry-leading solutions. It leverages Oracle Financial Services Analytical Application (OFSAA) and Oracle Financial Services Data Foundation (OFSDF) for managing analytical application data. The AgileREPORTER in Regulatory Reporting (REG REP) Solution enables firms to automate the final mile of the reporting process. It provides pre-built integration to Lombard Risk Reporting, eliminating the need for further manual intervention. The solution ensures data integrity allowing banks to focus more time on analyzing and gaining new business insight from their growing stores of data instead of preparing data and reports with the sole objective of meeting submission deadlines.

# **1** Hardware and Software Requirements and Specifications

This section describes the various Operating System, Database, Web Server, and Web Application Server version and other variant details on which this release of the OFS Regulatory Reporting for US Federal Reserve (OFS AGILE RP US FED) application has qualified.

# 2 Preparing for Installation

This chapter provides necessary information to review before installing the OFS AGILE RP US FED Application v8.0.7.2.0. This chapter includes the following topics:

- Obtaining the Software
- Prerequisites for Installation
- <u>Configuration for GUI Mode Installation</u>
- <u>Copying and Extracting the Software</u>

### 2.1 Obtaining the Software

This release of OFS AGILE RP US FED 8.0.7.2.0 can be downloaded from the Oracle Software Delivery Cloud (<u>https://support.oracle.com/</u>). Log in and search for **29209089** under Patches and Updates.

You need to have a valid Oracle account in order to download the software.

# 2.2 Prerequisites for Installation

This installer has Fresh install capabilities and following are the prerequisites to install OFS AGILE RP US FED application:

- Oracle Financial Services Analytical Applications Infrastructure (OFSAAI) 8.0.7.0.0 (patch 28226275) plus other prerequisite OFSAAI patches (see Section 1.1 Pre-Installation Requirements of <u>OFS AAI Installation Guide</u>) should be installed and configured in your Machine (<u>OHC</u> Documentation Library).
- Oracle Financial Services Data Foundation (OFSDF) 8.0.7.1.0 (patch 29327317) plus other prerequisite OFSDF patches (see Section 3.1 Installer and Installation Prerequisites of <u>OFSDF</u> <u>Installation Guide</u>) should be installed and configured in your Machine (<u>OHC</u> Documentation Library).
- OFS AgileREPORTER **8.0.7.1.0** application should be installed and configured in your Machine.
- OFS AGILE RP US FED **8.0.7.1.0** application should be installed and configured in your Machine.
- Ensure that you have executed **.profile** before you trigger the installation.
- Ensure that the FICServer is up and running before you trigger the installation. For information on restarting the services, Refer *Oracle Financial Services Analytical Applications Infrastructure Release 8.0.2.0.0 Installation Guide* (<u>OHC</u> Documentation Library) for more information.



### 2.3 Installing OFS AGILE RP US FED 8.0.7.2.0 ML

Perform the following instructions to download, extract and install this ML patch:

- Search for patch 29209089 under the Patches & Updates tab and download the OFS\_AGILE\_RP\_USFED\_8.0.7.2.0\_GENERIC.zip archive file from <a href="https://support.oracle.com/">https://support.oracle.com/</a>
- 2. Copy the archive file to your OFSAA server in **Binary** mode.
- 3. Shut down all the OFSAA Services. For more information, refer to the *Start/Stop Infrastructure Services* section in <u>Oracle Financial Services Advanced Analytical Applications Infrastructure Pack</u> <u>Installation Guide – Release 8.0.2.0.0</u>.

**NOTE:** Ensure that the **FICSERVER** is up and running.

- 4. Execute chmod -R 750 \$FIC\_HOME
- 5. If you have an Unzip utility, skip to the next step.

Download the Unzip utility (OS specific) **unzip\_<os>.Z** from the location <u>https://updates.oracle.com/unzips/unzips.html</u> and copy it in **Binary** mode to the directory that is included in your PATH variable, typically **\$HOME** path or directory in which you have copied the 8.0.7.2.0 ML.

• Uncompress the unzip installer file using the command:

uncompress unzip\_<os>.Z

**NOTE:** If you notice an error message "uncompress: not found [No such file or directory]", contact your UNIX administrator.

- 6. Execute chmod 751 OFS\_AGILE\_RP\_USFED\_8.0.7.2.0\_GENERIC.zip
- Execute unzip -a <name of the file to be unzipped>
   For example: unzip -a OFS\_AGILE\_RP\_USFED\_8.0.7.2.0\_GENERIC.zip
- Configure UPLOAD\_MODEL parameter in the param.conf file present under the OFS\_AGILE\_RP\_USFED/conf directory to determine if Model Upload is required or not:

**0** = If you have already performed Model Upload and want to skip Model Upload process**1** = If you want to perform Model Upload

- 9. Navigate to OFS\_AGILE\_RP\_USFED/bin directory and execute ./install.sh
- 10. The installation progress can be viewed by periodically refreshing the log file under the **OFS\_AGILE\_RP\_USFED/logs** directory.
- 11. After installation is completed, verify the log file for any Errors or Warnings. Contact <u>My Oracle</u> <u>Support</u> in case of any issues.

**NOTE:** This patch installation has taken approximately 20 minutes to complete in Oracle Labs.



### 2.4 Post-installation Steps

Perform the following instructions after successful installation of the 8.0.7.2.0 ML patch:

• Apply the OFS AAI **33663417** mandatory patch.

ATTENTIONOn the 10th of December 2021, Oracle released Security Alert<br/>CVE-2021-44228 in response to the disclosure of a new<br/>vulnerability affecting Apache Log4J before version 2.15. The<br/>application of the **33663417** Mandatory Patch fixes the issue.<br/>For details, see the My Oracle Support Doc ID <u>2827801.1</u>.<br/>Ensure that you reapply the **33663417** Mandatory Patch<br/>whenever you install or upgrade the application or apply an<br/>incremental patch.

- Refer to the log file in the **/OFS\_AGILE\_RP\_USFED**/logs directory to ensure that there are no errors reported.
- Execute the following scripts in the ATOMIC SCHEMA followed by Commit command:
  - FSI\_M\_CELL\_DETAILS\_9C\_031\_041\_TEXT.sql
- Generate the application EAR / WAR file and redeploy the application on the configured Web Application Server. For more information on generating and deploying EAR / WAR file, refer to the Post Installation Configuration section in <u>Oracle Financial Services Advanced Analytical</u> <u>Applications Infrastructure Pack Installation Guide – Release 8.0.2.0.0</u>.
- Restart all the OFSAA services. For more information, see the Start/Stop Infrastructure Services section in <u>Oracle Financial Services Advanced Analytical Applications Infrastructure Pack</u> <u>Installation Guide – Release 8.0.2.0.0</u>.
- Execute **##INFODOM##\_SYNC\_ADJUSTMENT\_CELLS** batch for adjustment entries.
- Execute Resave batches to reflect the changes.
- Perform the additional configurations if required as mentioned under the Additional Configurations section in <u>OFS AAAI Release 8.0.2.0.0 Installation Guide</u>.





### 2.5 Post US FED Run Execution

Perform the following instructions after US FED Run Execution:

- 1. For prior date reporting, please see the <u>Prior Date Reporting</u> document.
- Execute <<INFODOM>>\_REG\_RUNEXE\_RESAVE batch to populate RUNEXESUMM table. Lombard AgileREPORTER would display additional filters of Run Execution ID and Run Status during report retrieval based on RUNEXESUMM table.
  - a. Run Execution ID is Run Execution Identifier concatenated with Run Description.
  - b. Run Status shows the status of US FED Run Execution.
  - c. Define the entities as SOLO or CONSOLIDATED in Lombard AgileREPORTER before retrieving returns.
- 3. Execute all the REFRESH batches to refresh the Derived Entities.

The Oracle Financial Services Regulatory Reporting for US Federal Reserve (OFS AGILE RP US FED) is now ready for use. If you encounter any problems during set up, contact OFSAA Support at <u>Oracle Support</u>.



# 3 Deploying Template Package and Config Package

This section describes the order to deploy the template package and config package after saving the derived entities:

- To deploy the product configuration on AgileREPORTER using the package OFS\_RP\_TEMPLATE\_USFED\_80720.zip bundled inside the Template\_Package directory of the installer:
  - a. Navigate to the **/Template\_Package** directory under the installer.
  - b. Unzip the files with the following command:

```
unzip OFS_RP_TEMPLATE_USFED_80720.zip
```

The **AR\_FED\_Package\_v1\_16\_1\_7.1rm** file is extracted with the above command.

- c. Navigate to the path where AgileREPORTER is installed and then go to the **/bin** directory.
- d. Add a new configuration with the following command:

./config.sh -p -a <Template\_Package Full Path>/<.lrm file>
For example:

```
./config.sh -p -a <Template_Package Full Path>/
AR_FED_Package_v1_16_1_7.lrm
```

- To deploy the product configuration on AgileREPORTER using the package
   OFSAA\_REG\_REP\_USFED\_80720.zip bundled inside Config\_Package folder of installer:
  - a. Navigate to the path where AgileREPORTER is installed and then go **/bin** directory under the installed location
  - b. Add a new configuration with the following command:

```
./config.sh -a <Config_Package Full Path>
For example:
```

```
./config.sh -a /scratch/kit/80720/OFS_AGILE_RP_USFED/
Config_Package/OFSAA_REG_REP_USFED_80720.zip
```

3. Update the Alias with the following command:

```
./config.sh -ea OFSAA_REG_REP_USFED_80720 -iv 8.0.7.2.0 -alias
"OFSAA FED DATA SOURCE" -aif
/scratch/agile/bin/aliasinfo.properties
```
