1 Preface

Oracle Financial Services Regulatory Reporting for US Federal Reserve – Lombard Risk Integration Pack helps the banks to comply with various guidelines issued by US Federal Reserve, including BCBS 239 regulations. It provides integrating risk data reporting systems and enhances the accuracy of reporting in banks. OFS Risk Regulatory Reporting (REG REP) Solution helps in achieving the objectives by enabling preset steps based on the generalization of a set of solutions. This is made possible by:

- Providing a centralized data storage for risk data through relevant subject areas of Financial Services Data Foundation (FSDF).
- Interfacing with a third party reporting tool such as Lombard Risk Reporter Portal to build necessary template reports to meet the regulatory expectations.

Data accuracy of risk reporting is ensured by:

- Data Governance Studio (DGS).

The Oracle Financial Services Regulatory Reporting for US Federal Reserve (OFS AGILE RP US FED) solution enables financial services organizations to manage and execute regulatory reporting in a single integrated environment. It automates end-to-end processes from data capture through submission with industry-leading solutions. It leverages Oracle Financial Services Analytical Application (OFSAA) and Oracle Financial Services Data Foundation (OFSDF) for managing analytical application data. The AgileREPORTER in Regulatory Reporting (REG REP) Solution enables firms to automate the final mile of the reporting process. It provides pre-built integration to Lombard Risk Reporting, eliminating the need for further manual intervention. The solution ensures data integrity allowing banks to focus more time on analyzing and gaining new business insight from their growing stores of data instead of preparing data and reports with the sole objective of meeting submission deadlines.

3.1 Obtaining the Software

This release of OFS AGILE RP US FED 8.0.8.0.0 can be downloaded from the Oracle Support Site (<https://support.oracle.com>). Log in and search for **29394473** under Patches and Updates.

You need to have a valid Oracle account in order to download the software.

3.2 Prerequisites for Installation

This installer has Fresh install capabilities and following are the prerequisites to install OFS AGILE RP US FED application:

- Oracle Financial Services Analytical Applications Infrastructure (OFSAAI) 8.0.8.0.0 (patch **29538056**) plus other prerequisite OFSAAI patches (see **Section 1.1 Pre-Installation Requirements** of [OFS AAI Installation Guide](#)) should be installed and configured in your Machine ([OHC](#) Documentation Library).
- Oracle Financial Services Data Foundation (OFSDF) 8.0.8.0.0 (patch **29627211**) plus other prerequisite OFSDF patches (see **Section 3.1 Installer and Installation Prerequisites** of [OFSDF Installation Guide](#)) should be installed and configured in your Machine ([OHC](#) Documentation Library).
- OFS AgileREPORTER **8.0.7.4.1** Application should be installed and configured in your Machine.
- OFS AGILE RP US FED **8.0.7.4.0** should be installed and configured in your Machine.

- The following columns must be added on top of FSDF 8.0.8.0.0 data model and sliced model upload must be performed.

- Ensure that you have executed **.profile** before you trigger the installation.
- Ensure that the FICServer is up and running before you trigger the installation. For information on restarting the services, Refer *Oracle Financial Services Analytical Applications Infrastructure Release 8.0.2.0.0 Installation Guide* ([OHC](#) Documentation Library) for more information.

3.3 Configuration for GUI Mode Installation

To install OFS AGILE RP US FED in GUI mode, you need to ensure the below software and configurations are available:

- Install and configure any PC X Server software such as Open Text Exceed (formerly Hummingbird Exceed) on the user desktop system from which the installation is triggered.
- Configure DISPLAY variable.

Ensure to set the DISPLAY variable on the system on which the OFSAA is installed, to point to the user desktop system where the PC X Server software has been installed.

Syntax:

```
export DISPLAY=hostname:n.n1
```

where, hostname is the IP Address/ Host Name of the user desktop system and n is the sequence number (usually 0).

For example: 10.11.12.13:0.0 or myhostname:0.0

3.4 Copying and Extracting the Software

After you obtain the installer, copy the installer (in BINARY mode) to the system on which the OFS AGILE RP US FED application components are installed.

NOTE You must be logged in to the UNIX operating system as a non-root user.

1. Download the unzip utility (OS specific) `unzip_<os>.Z`, and copy it in Binary mode to any directory and include the directory in your PATH variable. If you already have the unzip utility to extract the contents of the downloaded archive, skip to the next step.
2. Execute `chmod 751 OFS_AGILE_RP_USFED_8.0.8.0.0_GENERIC.zip`
3. Uncompress the unzip installer file using the command:

```
uncompress unzip_<os>.Z
```

NOTE If you notice an error message “`uncompress: not found [No such file or directory]`”, contact your UNIX administrator.

4. Execute `unzip -a <name of the file to be unzipped>`
 For example: `unzip -a OFS_AGILE_RP_USFED_8.0.8.0.0_GENERIC.zip`
5. Execute `chmod -R 755 OFS_AGILE_RP_USFED`

4 GUI Mode Installation

The OFS AGILE RP US FED installer can be installed in both GUI and silent mode.

For executing the installer in silent mode, refer to the section [Silent Mode Installation](#).

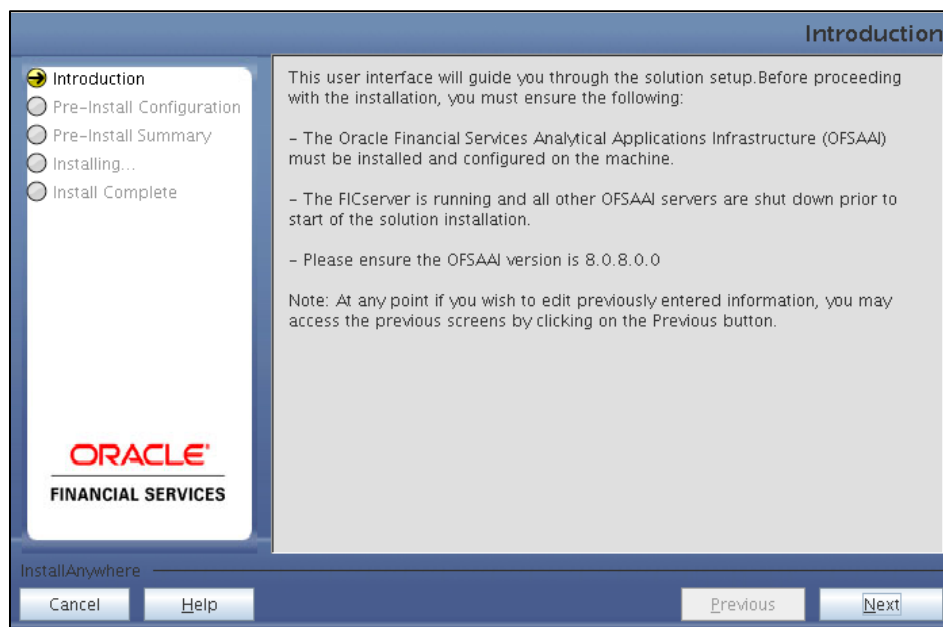
For running in GUI mode, follow these steps:

1. Log in to the system as `non-root` user
2. Execute the user `.profile` file
3. Navigate to installer location `OFS_AGILE_RP_USFED/bin`
4. Run the installer in GUI Mode by executing the command:
`./Setup.sh GUI`



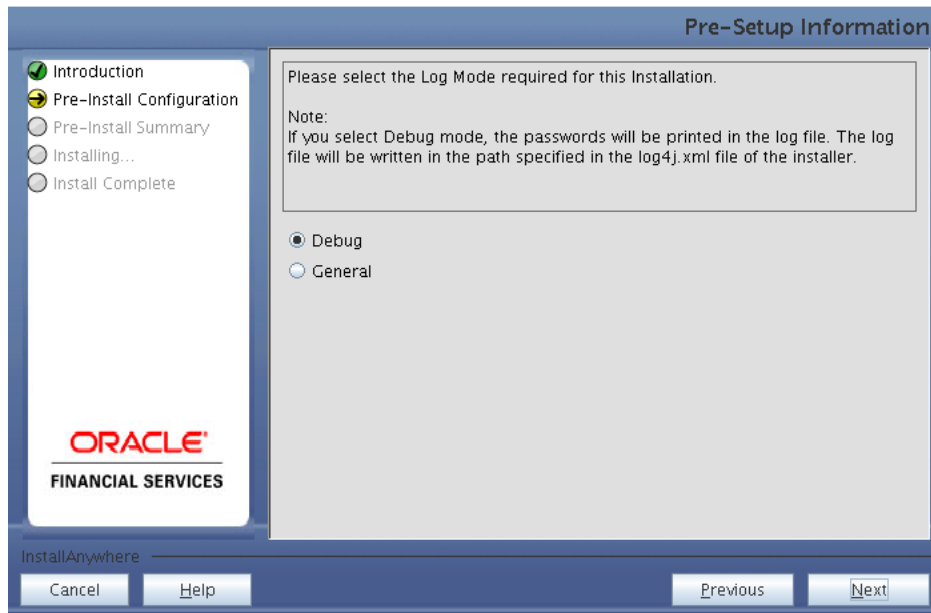
Installation Splash Screen

5. The **Introduction** screen displays the prerequisites for installation. Ensure that the prerequisites are satisfied before you proceed.

6. Choose the **Log Mode** for this installer. If you select, **Debug**, the Passwords are printed in the log file.



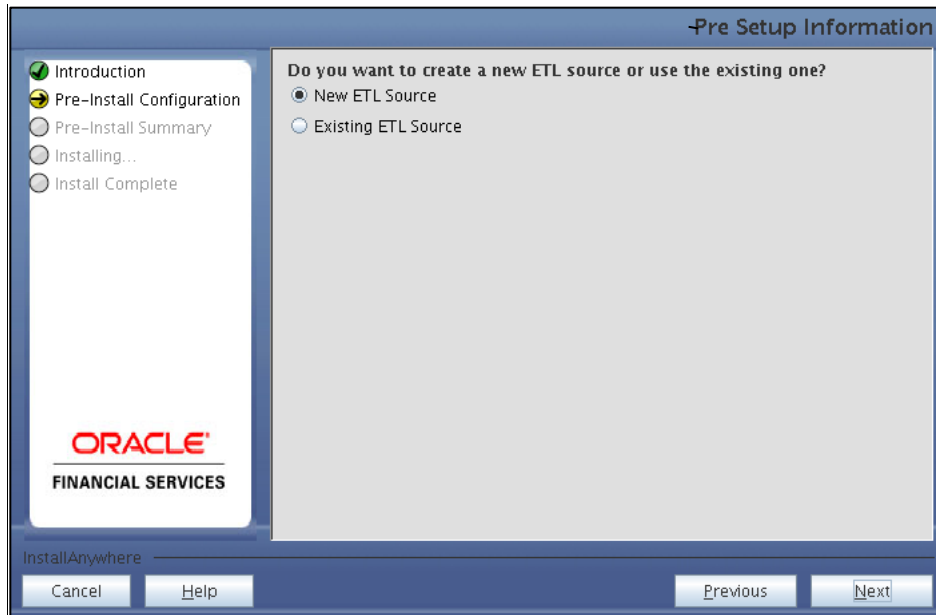
Pre-Setup Information – Log Mode Screen

7. In the **Pre-Setup Information** screen, specify the existing infodom name to be used for the application installation and click **Next**.



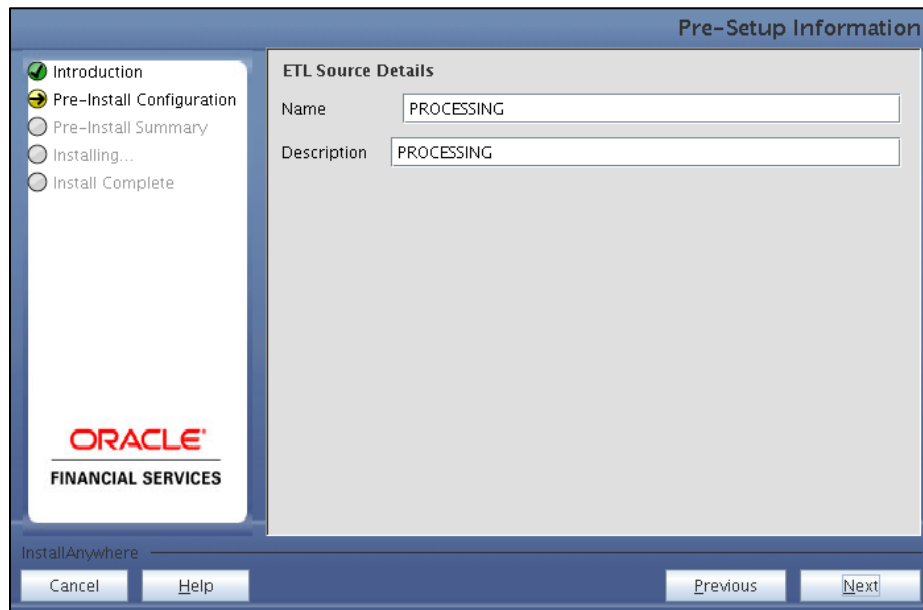
Pre-Setup Information – Infodom Type Screen

Pre-Setup Information – ETL Source Selection Screen

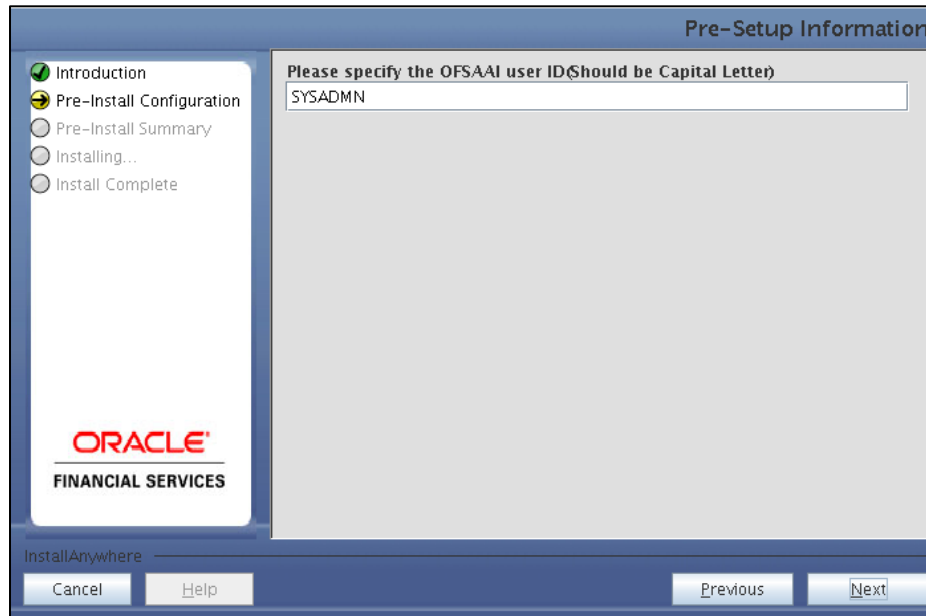
9. In the **Pre-Setup Information** screen, enter the **ETL Source Details** and click **Next**.

Default Value is: **SYSADMN**



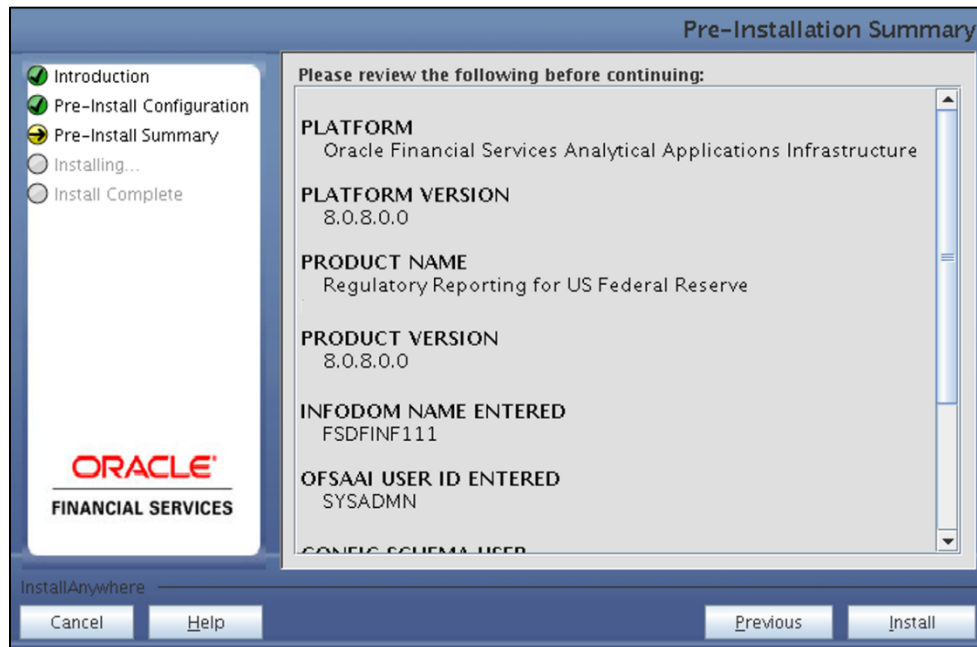
Pre-Setup Information – OFSAAI User ID Screen

11. The **Pre-Install Configuration (Please Wait)** screen is displayed.



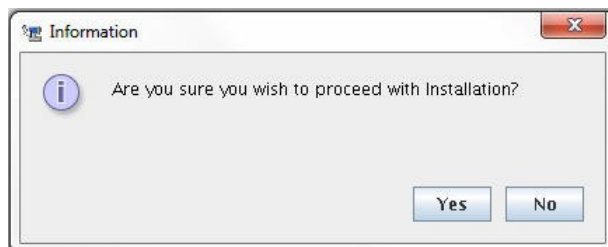
Pre-Install Configuration – Please Wait Screen

12. Review the settings in the **Pre-Installation Summary** screen and click **Install**.

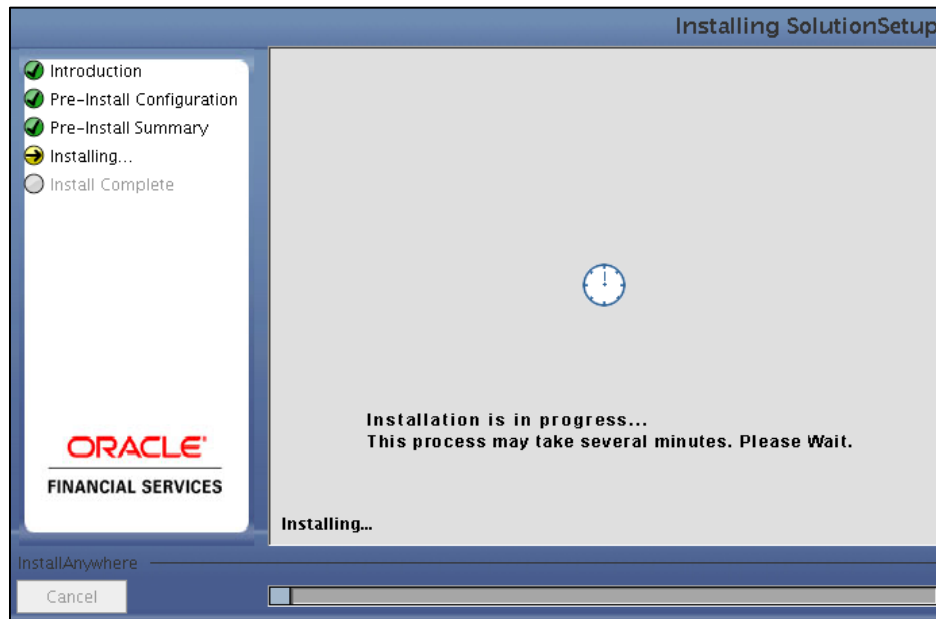


Pre-Installation Summary Screen

13. The following message is displayed. Select **Yes** to begin the installation process.

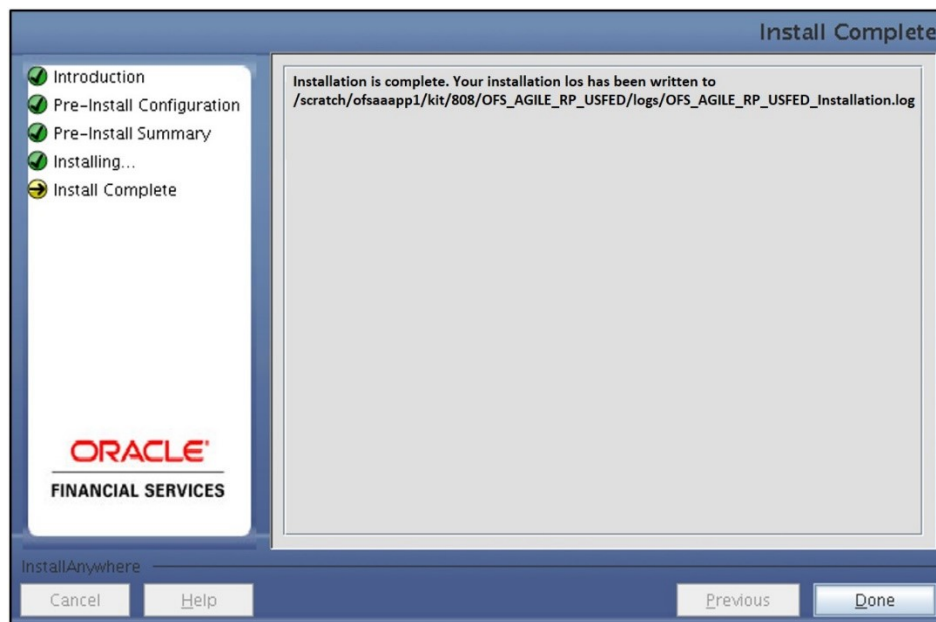


14. The **Installing SolutionSetup** screen is displayed.

16. Refer to the log file created in the path `/OFS_AGILE_RP_USFED/logs` of installer directory for any error messages.
17. Click **Done** to complete the installation.

5 Silent Mode Installation

Silent installation is achieved via a properties file (`Silent.props`) that must be updated with proper values, before attempting to install using the silent mode. Follow these steps to install in Silent Mode:

1. Navigate to installer directory `OFS_AGILE_RP_USFED/conf` containing the template file `Silent.template`.
2. Create a copy of this file and rename the copy as `Silent.props`.
3. Edit the `Silent.props` file and specify the parameters as per the requirements.

The following table lists all the properties that must be specified.

4. Log in to the system as `non-root` user
5. Execute the user `.profile`
6. Navigate to installer location `OFS_AGILE_RP_USFED/bin`

7. Run the installer in SILENT Mode with the following command:

```
./Setup.sh SILENT
```

Refer to the console log (or the `preinstall.log` file) for any error messages.

5.1 Post-installation Steps

Perform the following instructions after successful installation of the 8.0.8.0.0 Minor release:

- Apply the OFS AAI **33663417** mandatory patch.

ATTENTION

On the 10th of December 2021, Oracle released Security Alert CVE-2021-44228 in response to the disclosure of a new vulnerability affecting Apache Log4J before version 2.15. The application of the **33663417** Mandatory Patch fixes the issue.

For details, see the My Oracle Support Doc ID [2827801.1](#).

Ensure that you reapply the **33663417** Mandatory Patch whenever you install or upgrade the application or apply an incremental patch.

- Refer to the log file in the `/OFS_AGILE_RP_USFED/logs` directory to ensure that there are no errors reported.
- Generate the application EAR / WAR file and redeploy the application on the configured Web Application Server. For more information on generating and deploying EAR / WAR file, refer to the Post Installation Configuration section in [Oracle Financial Services Advanced Analytical Applications Infrastructure Pack Installation Guide – Release 8.0.2.0.0](#).
- Restart all the OFSAA services. For more information, see the Start/Stop Infrastructure Services section in [Oracle Financial Services Advanced Analytical Applications Infrastructure Pack Installation Guide – Release 8.0.2.0.0](#).
- Execute Resave batches to reflect the changes.
- Perform the additional configurations if required as mentioned under the Additional Configurations section in [OFS AAI Release 8.0.2.0.0 Installation Guide](#).

5.2 Migration of Existing Data

5.2.1 SCD for Account Purpose Dimension and Rule for Reg Loan Purpose

Account Purpose Dimension has SCD and Seeded Values. As part of regularization, the tables are treated as SCD and from this release Regulatory Loan Purpose Rule (RLUS_FLAS_REG_LOAN_PURPOSE_01) is moved to a Mapper (MPFD_ACCT_REG_LOAN_PURPOSE) Based Rule (RLUS_FRAS_REG_LOAN_PURPOSE_MAP).

The Mapper can be configured from OFSAAI for mapping between Account Purpose and Regulatory Loan Purpose Dimensions.

If you wish to continue with existing seeded values of Account Purpose Dimension, then execute the [MPFD_ACCT_REG_LOAN_PURPOSE_DEFAULT.sql](#) file in the Atomic Schema.

As the Target Surrogate Key column moved from Fact Loan Account Summary to Fact Regulatory Account Summary, to update the historical data (Previous Executed Runs), you can execute the attached [REG_LOAN_PURPOSE_UPDATE.sql](#) file in the Atomic Schema, which copies data from Fact Loan Account Summary to Fact Regulatory Account Summary for the existing run.

5.2.2 GL Type Defaulting Logic Movement from Report to T2T

If GL Type is missing for accounts, then it used to be defaulted at the Reporting layer as value “AST” (Asset). As the logic is moved to T2T, to update the historical data (Previous Executed Runs), you can execute the [N_GL_TYPE_DEFAULT.sql](#) file in the Atomic Schema, which updates data of GL Type Surrogate Key of Fact Regulatory Account Summary for “MSG” and “OTH” (Missing and Others).

5.3 Post US FED Run Execution

Perform the following instructions after US FED Run Execution:

1. For prior date reporting, please see the [Prior Date Reporting](#) document.
2. Execute <<INFODOM>>_REG_RUNEXE_RESAVE batch to populate **RUNEXESUMM** table.
Lombard AgileREPORTER would display additional filters of Run Execution ID and Run Status during report retrieval based on RUNEXESUMM table.
 - a. Run Execution ID is Run Execution Identifier concatenated with Run Description.
 - b. Run Status shows the status of US FED Run Execution.
 - c. Define the entities as SOLO or CONSOLIDATED in Lombard AgileREPORTER before retrieving returns.
3. Execute all the REFRESH batches to refresh the Derived Entities.

6 Template Package and Config Package Deployment

This section describes the order to deploy the template package and config package after saving the derived entities:

1. To deploy the product configuration on AgileREPORTER using the package `OFS_RP_TEMPLATE_USFED_80800.zip` bundled inside the `Template_Package` directory of the installer:
 - a. Navigate to the `/Template_Package` directory under the installer.
 - b. Unzip the files with the following command:


```
unzip OFS_RP_TEMPLATE_USFED_80800.zip
```

The `AgileREPORTER for FED v1.17.2-b34.lrm` file is extracted with the above command.
 - c. Navigate to the path where AgileREPORTER is installed and then go to the `/bin` directory.
 - d. Add a new configuration with the following command:


```
./config.sh -p -a <Template_Package Full Path>/<.zip file>
```

For example:

```
./config.sh -p -a <Template_Package Full Path>/
AgileREPORTER for FED v1.17.2-b34.lrm
```
2. To deploy the product configuration on AgileREPORTER using the package `OFSAA_REG_REP_USFED_80800.zip` bundled inside `Config_Package` directory of installer:
 - e. Navigate to `<LombardAgileREPORTER>/bin` directory under the installed location
 - f. Add a new configuration with the following command:


```
./config.sh -a <Config_Package Full Path>
```

For example:

```
./config.sh -a /scratch/kit/80800/OFS_REG_REP_USFED/
Config_Package/OFSAA_REG_REP_USFED_80800.zip
```
3. Update the Alias with the following command:


```
./config.sh -ea OFSAA_REG_REP_USFED_80800 -iv 8.0.8.0.0 -alias "OFSAA
FED DATA SOURCE" -aif /scratch/agile/bin/aliasinfo.properties
```
