Oracle Financial Services Regulatory Reporting for European Banking Authority (OFS AGILE RP EBA) enables the banks to comply with BCBS 239 regulations. It integrates risk data reporting systems and enhances the accuracy of reporting in banks. OFS Risk Regulatory Solution (RRS) helps in achieving the objectives by enabling preset steps based on the generalization of a set of solutions. This is made possible by:

- Providing centralized data storage for risk data through relevant subject areas of Financial Services Data Foundation (FSDF).
- Interfacing with a Regulatory Reporting tool OFS AgileREPORTER to build necessary template reports to meet the regulatory expectations.
- Managing the accuracy of risk reporting through Data Governance Studio (DGS).

# 3.1 Obtaining the Software

This release of OFS AGILE RP EBA 8.0.9.0.0 can be downloaded from the Oracle Support Services site (<u>https://support.oracle.com/</u>). Log in and search for **30732933** under the Patches and Updates tab.

You need to have a valid Oracle account in order to download the software.

# 3.2 Prerequisites for Installation

The following are the prerequisites to install the OFS AGILE RP EBA application:

- Oracle Financial Services Data Foundation (OFSDF) 8.0.9.0.0 (patch 30324968) plus other prerequisite OFSDF patches (see Section 3.1 Installer and Installation Prerequisites of <u>OFSDF Installation Guide</u>) should be installed and configured in your Machine (<u>OHC</u> Documentation Library).
- (Only for upgrade) Oracle Financial Services Regulatory Reporting for European Banking Authority 8.0.8.0.0 (patch **29931977**).
- Oracle Financial Services AgileREPORTER Application 8.0.8.1.0 (patch 30672152).
- Ensure that you have executed .profile file before you trigger the installation.
- Ensure that the FICServer is up and running before you trigger the installation. For information on restarting the services, see Oracle Financial Services Analytical Applications Infrastructure Release 8.0.2.0.0 Installation and Configuration Guide (OHC Documentation Library) for more information.

# 3.3 Installing OFS AGILE RP EBA 8.0.9.0.0 Release

Perform the following instructions to download, extract and install this release patch:

- 1. Download the OFS\_AGILE\_RP\_EBA\_8.0.9.0.0\_GENERIC.zip archive file from https://support.oracle.com/ for patch 30732933 under the Patches & Updates tab.
- 2. Copy the archive file to your OFSAA server in Binary mode.

3. Shut down all the OFSAA Services. For more information, refer to the Start/Stop Infrastructure Services section in <u>Oracle Financial Services Advanced Analytical Applications Infrastructure</u> <u>Pack Installation Guide – Release 8.0.2.0.0</u>.

**NOTE** Ensure that the **FICSERVER** is up and running.

- 4. Execute chmod -R 750 \$FIC\_HOME
- 5. If you have an Unzip utility, skip to the next step.

Download the Unzip utility (OS-specific) unzip\_<os>.z from the location <u>https://updates.oracle.com/unzips/unzips.html</u> and copy it in **Binary** mode to the directory that is included in your PATH variable, typically **\$HOME** path or directory in which you have copied the 8.0.9.0.0 patch.

Uncompress the unzip installer file using the command:

uncompress unzip\_<os>.Z

**NOTE** If you notice an error message "uncompress: not found [No such file or directory]", contact your UNIX administrator.

- 6. Execute chmod 751 OFS\_AGILE\_RP\_EBA\_8.0.9.0.0\_GENERIC.zip
- 7. Execute unzip <name of the file to be unzipped>

For example: unzip OFS\_AGILE\_RP\_EBA\_8.0.9.0.0\_GENERIC.zip

- 8. Navigate to installer directory OFS\_AGILE\_RP\_EBA/conf containing the template file Silent.template.
- 9. Create a copy of this file and rename the copy as Silent.props.
- **10.** Edit the **Silent.props** file and specify the parameters as per the requirements.

The following table lists all the properties that must be specified.

- 11. Execute the user .profile
- 12. Navigate to OFS\_AGILE\_RP\_EBA/bin directory and execute ./setup.sh SILENT
- **13.** The installation progress can be viewed by periodically refreshing the log file under the OFS\_AGILE\_RP\_EBA/logs directory.
- **14.** After installation is completed, verify the log file for any Errors or Warnings. Contact <u>My Oracle</u> <u>Support</u> in case of any issues.

**NOTE** This patch installation has taken approximately 30 minutes to complete in Oracle Labs.

#### 3.4 Post-installation Steps

The post-installation steps required for this release are:

1. Apply the OFS AAI 33663417 mandatory patch.

ATTENTION	On the 10th of December 2021, Oracle released Security Alert CVE-2021-44228 in response to the disclosure of a new vulnerability affecting Apache Log4J before version 2.15. The application of the <b>33663417</b> Mandatory Patch fixes the issue.
	For details, see the My Oracle Support Doc ID <u>2827801.1</u> .
	Ensure that you reapply the <b>33663417</b> Mandatory Patch whenever you install or upgrade the application or apply an incremental patch.

- 2. Refer to the log file in the /OFS\_AGILE\_RP\_EBA/logs directory to ensure that there are no errors reported. Contact <u>My Oracle Support</u> in case of any issues.
- **3.** Generate the application EAR / WAR file and redeploy the application on the configured Web Application Server. For more information on generating and deploying the EAR / WAR file, refer

to the Post Installation Configuration section in <u>Oracle Financial Services Advanced Analytical</u> <u>Applications Infrastructure Pack Installation Guide – Release 8.0.2.0.0</u>.

4. Restart all the OFSAA services. For more information, see the Start/Stop Infrastructure Services section in <u>Oracle Financial Services Advanced Analytical Applications Infrastructure Pack</u> Installation Guide – Release 8.0.2.0.0.

The Oracle Financial Services Regulatory Reporting for European Banking Authority is now ready for use.

# 4 Deploying Config Package

This section describes the steps to deploy the config package after saving the derived entities:

- To deploy the product configuration on Lombard AgileREPORTER using the package OFSAA\_REG\_REP\_EBA\_80900.zip bundled inside the Config\_Package folder of installer:
  - a. Navigate to <LombardAgileREPORTER>/bin under the installed location
  - **b.** Add a new configuration with the following command:

```
./config.sh -a <Config_Package Full Path>
```

For example:

```
./config.sh -a /scratch/kit/80900/OFS_AGILE_RP_EBA/Config_Package/
OFSAA_REG_REP_EBA_80900.zip
```

c. Activate the configuration with the following command:

./config.sh -t OFSAA\_REG\_REP\_EBA -iv 8.0.9.0.0

**d.** Update the Alias with the following command:

```
./config.sh -ea OFSAA_REG_REP_EBA -iv 8.0.9.0.0 -alias "OFSAA EBA
DATA SOURCE" -aif <LombardAgileREPORTER>/bin/aliasinfo.properties
```

- 2. To deploy the product configuration on Lombard AgileREPORTER using the package OFSAA\_REG\_REP\_ECB\_80900.zip bundled inside the Ana\_Config\_Package folder of installer:
  - a. Navigate to <LombardAgileREPORTER>/bin under the installed location
  - b. Add a new configuration with the following command:

```
./config.sh -a <Ana_Config_Package Full Path>
```

For example:

```
./config.sh -a /scratch/kit/80900/OFS_AGILE_RP_EBA/
Ana_Config_Package/OFSAA_REG_REP_ECB_80900.zip
```

c. Activate the configuration with the following command:

./config.sh -t OFSAA\_REG\_REP\_ECB\_80710 -iv 8.0.7.1.0

d. Update the Alias with the following command:

```
./config.sh -ea OFSAA_REG_REP_ECB_80710 -iv 8.0.7.1.0 -alias "OFSAA
EBA DATA SOURCE" -aif
<LombardAgileREPORTER>/bin/aliasinfo.properties
```

NOTE

As ECB and EBA are pointing towards the same database host, alias update will have same data source as **OFSAA EBA DATA SOURCE** in the manifest.xml file.

# 5 Deploying Template Package

This section describes the steps to deploy the template package:

- To deploy the product configuration on AgileREPORTER using the package <u>ECR\_v1.35.0-b12\_sign.lrm</u> bundled inside the <u>Template\_Package</u> directory of the installer:
  - a. Navigate to <AgileREPORTER>/bin directory under the installed directory
  - **b.** Add a new configuration with the following command:

```
./config.sh -p -a <Template_Package Full Path>/<.lrm file>
For example:
./config.sh -p -a <Template_Package Full Path>/
ECR_v1.35.0-b12_sign.lrm
```

- 2. To deploy the product configuration on AgileREPORTER using the package AR\_ANACREDIT\_Package\_v1\_3\_3\_1.1rm bundled inside the Template\_Package directory of the installer:
  - a. Navigate to <AgileREPORTER>/bin directory under the installed directory
  - b. Add a new configuration with the following command:

```
./config.sh -p -a <Template_Package Full Path>/<.lrm file>
For example:
./config.sh -p -a <Template_Package Full Path>/
AR_ANACREDIT_Package_v1_3_3_1.lrm
```
