# 1 Preface

Oracle Financial Services Regulatory Reporting for US Federal Reserve (OFS AGILE RP US FED) Pack helps banks comply with various guidelines issued by US Federal Reserve, including BCBS 239 regulations. It provides integrating risk data reporting systems and enhances the accuracy of reporting in banks. The OFS Risk Regulatory Reporting (REG REP) Solution helps in achieving the objectives by enabling preset steps based on the generalization of a set of solutions. This is made possible by:

- Providing centralized data storage for risk data through relevant subject areas of the Financial Services Data Foundation (FSDF).
- Interfacing with a third-party reporting tool such as Lombard Risk Reporter Portal to build necessary template reports to meet the regulatory expectations.

Data accuracy of risk reporting is ensured by:

- Data Governance Studio (DGS).

The Oracle Financial Services Regulatory Reporting for US Federal Reserve (OFS AGILE RP US FED) solution enables financial services organizations to manage and execute regulatory reporting in a single integrated environment. It automates end-to-end processes from data capture through submission with industry-leading solutions. It leverages Oracle Financial Services Analytical Application (OFSAA) and Oracle Financial Services Data Foundation (OFSDF) for managing analytical application data. The AgileREPORTER in Regulatory Reporting (REG REP) Solution enables firms to automate the final mile of the reporting process. It provides pre-built integration to Lombard Risk Reporting, eliminating the need for further manual intervention. The solution ensures data integrity allowing banks to focus more time on analyzing and gaining new business insights from their growing stores of data instead of preparing data and reports with the sole objective of meeting submission deadlines.

This document provides step-by-step instructions to install the Oracle Financial Services Regulatory Reporting for US Federal Reserve (OFS AGILE RP US FED) Release 8.0.9.6.0.

The document assumes you have experience in installing Enterprise components. A good understanding and knowledge of the following are expected from the administrator before starting the actual installation:

- OFSAA architecture
- Oracle Financial Services Regulatory Reporting for US Federal Reserve Components architecture
- Deployment of OFSAA Configuration Package on Lombard Risk AgileREPORTER Platform
- UNIX commands
- Database concepts and administrator commands
- Web server or Web application server deployment

### 3.1 Obtaining the Software

This release of OFS AGILE RP US FED 8.0.9.6.0 can be downloaded from the [My Oracle Support](#) website. Log in and search for patch ID **31691924** under the **Patches and Updates** tab and download the OFS\_AGILE\_RP\_USFED\_8.0.9.6.0\_GENERIC.zip archive file.

You must have a valid Oracle account to download the software.

### 3.2 Pre-installation Requirements

The prerequisite software that must be installed are as follows:

- Oracle Financial Services Analytical Applications Infrastructure (OFSAAI) 8.0.9.0.0 (patch ID **30330054**) plus other prerequisite OFSAAI patches (see *Section 2.1 Pre-Installation Requirements* of the [OFS AAI Installation and Configuration Guide](#)) should be installed and configured in your machine ([OHC](#) Documentation Library).
- Oracle Financial Services Data Foundation (OFSDF) 8.0.9.2.0 (patch ID **31336111**) plus other prerequisite OFSDF patches (see *Section 2.1 Pre-Installation Requirements* of the [OFSDF Installation and Configuration Guide](#)) should be installed and configured in your machine ([OHC](#) Documentation Library).
- Oracle Financial Services Regulatory Reporting for US Federal Reserve (OFS AGILE RP US FED) 8.0.9.0.0 (patch ID **30557952**) or higher.
- Oracle Financial Services AgileREPORTER Application 8.0.9.0.0 (patch ID **30982178**) must be installed and configured.
- Ensure that you have executed .profile before you trigger the installation.
- Ensure that the FICServer is up and running before you trigger the installation. For information on restarting the services, see the [OFS Analytical Applications Infrastructure Installation and Configuration Guide – Release 8.0.7.0.0](#).

### 3.3 Installing the OFS AGILE RP US FED 8.0.9.6.0 ML

To copy, extract, and install this ML patch, follow these steps:

1. Copy the downloaded archive file to your OFSAA server in Binary mode.
2. Shut down all the OFSAA Services. For more information, see the *Stopping Infrastructure Services* section in the [OFS Advanced Analytical Applications Infrastructure Pack Installation and Configuration Guide – Release 8.0.7.0.0](#).

**NOTE** Ensure that the `FICSERVER` is up and running.

3. Execute `chmod -R 750 $FIC_HOME`
4. If you have an Unzip utility, skip to the next step.

Download the Unzip utility (OS-specific) `unzip_<os>.Z` from the location <https://updates.oracle.com/unzips/unzips.html> and copy it in Binary mode to the directory that is included in your `PATH` variable, typically `$HOME` path or directory in which you have copied the 8.0.9.6.0 ML patch.

Uncompress the unzip installer file using the command:

```
uncompress unzip_<os>.Z
```

**NOTE** If you notice the error message: “*uncompress: not found [No such file or directory]*”, contact your UNIX administrator.

5. Execute `chmod 751 OFS_AGILE_RP_USFED_8.0.9.6.0_GENERIC.zip`
6. Execute `unzip -a <name of the file to be unzipped>`  
For example: `unzip -a OFS_AGILE_RP_USFED_8.0.9.6.0_GENERIC.zip`
7. Configure the `UPLOAD_MODEL` parameter in the `param.conf` file present under the `OFS_AGILE_RP_USFED/conf` directory to determine if Model Upload is required or not:  
0 = If you have already performed Model Upload and want to skip the Model Upload process  
1 = If you want to perform Model Upload
8. Navigate to the `OFS_AGILE_RP_USFED/bin` directory and execute `./install.sh`
9. The installation progress can be viewed by periodically refreshing the log file under the `OFS_AGILE_RP_USFED/logs` directory.
10. After the installation is completed, verify the log file for any errors or warnings. Contact [My Oracle Support](#) in case of any issue.

**NOTE** This patch installation has taken approximately 10 minutes to complete in Oracle Labs.

## 3.4 Post-installation Steps

After a successful installation of the 8.0.9.6.0 ML patch, follow these steps:

- Apply the OFS AAI **33663417 mandatory patch**.

### ATTENTION

On the 10th of December 2021, Oracle released Security Alert CVE-2021-44228 in response to the disclosure of a new vulnerability affecting Apache Log4J before version 2.15. The application of the **33663417** Mandatory Patch fixes the issue.

For details, see the My Oracle Support Doc ID [2827801.1](#).

Ensure that you reapply the **33663417** Mandatory Patch whenever you install or upgrade the application or apply an incremental patch.

- See the log file in the `/OFS_AGILE_RP_USFED/logs` directory to ensure that no errors have been reported.
- After replacing `##INFODOM##` with INFODOM name and `##SEGMENT##` with SEGMENT name, `##IPADDRESS##` with IP ADDRESS or the host name of OFSAAI server, execute the [USFED 80960 Config Post Script.sql](#) file in the Config Schema.
- Execute the [USFED 80960 Atomic Post Script.sql](#) file in the Atomic Schema.
- Generate the application EAR or WAR file and redeploy the application on the configured web application server. For more information on generating and deploying the EAR or WAR file, see the *Post Installation Configuration* section in the [OFS Advanced Analytical Applications Infrastructure Pack Installation and Configuration Guide – Release 8.0.7.0.0](#).
- Restart all the OFSAA services. For more information, see the *Starting Infrastructure Services* section in the [OFS Advanced Analytical Applications Infrastructure Pack Installation and Configuration Guide – Release 8.0.7.0.0](#).
- Resave all the reporting layer Derived Entities using the following batches to reflect the changes in this release:
  - INFODOM\_RESERVE\_DE\_USFED\_FFIEC009 (batch for Resaving the Derived Entities of US FED, FFIEC-009 report)
  - INFODOM\_RESERVE\_DE\_USFED\_FRY15 (batch for Resaving the Derived Entities of US FED, FR Y-15 report)
  - INFODOM\_RESERVE\_DE\_USFED\_FRY14QA (batch for Resaving the Derived Entities of US FED, FR Y-14Q A report)
- Derived Entities in the following batch are the processing derived entities used for reclassification and those are ready-to-use partition enabled using run Skey. Hence, these derived entities must not be modified for partitions.
  - INFODOM\_RESERVE\_DE\_USFED\_RUN\_FRY14QA (batch for Resaving the Derived Entities of US FED, RUN FR Y-14Q A report)

- INFODOM\_REG\_RUN\_T2T\_SEQUENCE\_RESET- This batch must be executed as part of Run Chart before execution of any RUN or Batch of the execution day. This batch helps to reset the sequence of the tables which use the synthetic column as primary key.
- Perform the Source Model generation for US FED Processing Source. For more information, see the *Generating Source Models* section in the [OFS Advanced Analytical Applications Infrastructure Pack Installation Guide – Release 8.0.7.0.0](#)

The Oracle Financial Services Regulatory Reporting for US Federal Reserve (OFS AGILE RP US FED) is now ready for use. If you encounter any problem during set up, contact OFSAA Support at [My Oracle Support](#).

## 3.5 Post US FED Run Execution

After the US FED Run execution, follow these steps:

1. For prior date reporting, see the [Prior Date Reporting](#) document.
2. Execute the <<INFODOM>>\_REG\_RUNEXE\_RESAVE batch to populate RUNEXESUMM table if you are not using the FFIEC-002 or FFIEC-002S reports.
3. If you are using the FFIEC-002 or FFIEC-02S reports, then execute the <Installer Path>/OFS\_REG\_REP\_USFED/Post\_Scripts/RUNEXESUMM\_VW.sql script in the atomic schema.

Lombard AgileREPORTER would display additional filters of Run Execution ID and Run Status during report retrieval based on the RUNEXESUMM table.

- a. Run Execution ID is the Run Execution Identifier concatenated with Run Description.
  - b. Run Status shows the status of US FED Run Execution.
  - c. Define the entities as SOLO or CONSOLIDATED in Lombard AgileREPORTER before retrieving returns.
4. Execute the REFRESH batches to refresh the Derived Entities.

## 3.6 Deploying Template Package

After saving the derived entities, follow these steps to deploy the template package:

1. To deploy the product configuration on Lombard AgileREPORTER using the package OFSAA\_RP\_TEMPLATE\_USFED\_80960.zip bundled inside the Template\_Package directory of the installer:
  - a. Navigate to the /Template\_Package directory inside the installer.
  - b. Unzip the files with the following command:
 

```
unzip OFS_RP_TEMPLATE_USFED_80960.zip
```

 The FED\_v1.23.0-b26\_sign.lrm file is extracted with the above command.
  - c. Navigate to the path where AgileREPORTER is installed and then go to the /bin directory.
  - d. Add a new configuration with the following command:

```
./config.sh -p -a <Template_Package Full Path>/<.lrm file>
```

For example:

```
./config.sh -p -a <Template_Package Full Path>/FED_v1.23.0-b26_sign.lrm
```

## 3.7 Deploying Config Package

After saving the derived entities, follow these steps to deploy the config package:

1. To deploy the product configuration on AgileREPORTER using the package OFSAA\_REG\_REP\_USFED\_80960.zip bundled inside Config\_Package directory of installer:
  - a. Navigate to the <LombardAgileREPORTER>/bin directory under the installed location.
  - b. Add a new configuration with the following command:

```
./config.sh -a <Config_Package Full Path>
```

For example:

```
./config.sh -a /scratch/kit/80960/OFS_AGILE_RP_USFED/Config_Package/  
OFSAA_REG_REP_USFED_80960.zip
```

2. Update the Alias with the following command:

```
./config.sh -ea OFSAA_REG_REP_USFED_80960 -iv 8.0.9.6.0 -alias "OFSAA FED  
DATA SOURCE" -aif <LombardAgileREPORTER>/bin/aliasinfo.properties
```
