- Performance issues with AR: UI
- De-support Oracle 12.2
- Warning message if a user is opening a return that is no longer in compliance with the Valid from & Valid To date
- Analysis Module should handle Multi-Field Unique Key (TAVA_KEYFIELD)
- Filtering by schedule produces only Report Lines for that schedule (e.g. FFIECO31 RI-A, RC-A)
- ATTESTATION_COMMENT column cannot insert received details from CDR if submission failed
- AgileREPORTER status.sh issue
- Unlock or Lock API call queries too much from the Database
- NO RUN status for text maps (and slow response)

2.1.1 US Federal Reserve (US FED)


