1.1 What is New in this Release for OFS AgileREPORTER

1.1.1 New Features

OFS AgileREPORTER is an application used to submit the Regulatory Reports to the regulator based on the jurisdiction.

The list of new features and enhancements in this release are as follows:

- TLS 1.3 support for AgileREPORTER
- Usage of external ZooKeeper and configurable root Znode
- Upgrade Apache Commons IO to at least 2.7
- Upgrade Apache Ant to at least 1.10.11
- Upgrade Spring Framework to at least 5:3.7 or 5.2.15
- Remove dependencies to log4v for Zookeeper
- Performance issues with AR: UI
- De-support Oracle 12.2
- Warning message if a user is opening a return that is no longer in compliance with the Valid from & Valid To date
- Analysis Module should handle Multi-Field Unique Key (TAVA_KEYFIELD)
- Filtering by schedule produces only Report Lines for that schedule (e.g. FFIECO31 RI-A, RC-A)
- ATTESTATION_COMMENT column cannot insert received details from CDR if submission failed
- AgileREPORTER status.sh issue
- Unlock or Lock API call queries too much from the Database
- NO RUN status for text maps (and slow response)

OFS AgileREPORTER is a form and workflow tool that enables the creation and submission of regulatory returns. The OFS AgileREPORTER Application is configured with product configurations delivered using Configuration Packages. Different Configuration Packages are loaded into the OFS AgileREPORTER Application to support different sets of regulatory returns based on the jurisdiction.

2.1 Trial Template Package

OFS AgileREPORTER contains Trial Template Packages for two jurisdictions. The details of the reports included are provided in the following sections.

2.1.1 US Federal Reserve (US FED)

The US FED Trial Template Package (Regulatory Reports for the US Federal Reserve) package contains the following US FED Return Templates:

- FR Y-9C
- FFIEC-101
- FFIEC-031

2.1.2 Reserve Bank of India (RBI)

The RBI Trial Template Package (Regulatory Reports for the Reserve Bank of India) contains the following RBI Return Templates:

- RCA3
- IRS
- RAQ
