It provides integrating risk data reporting systems and enhances the accuracy of reporting in banks. The OFS Risk Regulatory Reporting (REG REP) Solution helps in achieving the objectives by enabling preset steps based on the generalization of a set of solutions. This is made possible by:

- Providing a centralized data storage for risk data through relevant subject areas of Financial Services Data Foundation (FSDF).
- Interfacing with a third-party reporting tool such as Lombard Risk Reporter Portal to build necessary template reports to meet the regulatory expectations.

Data accuracy of risk reporting is ensured by:

• Data Governance Studio (DGS).

The Oracle Financial Services Regulatory Reporting for US Federal Reserve (OFS AGILE RP US FED) solution enables financial services organizations to manage and execute regulatory reporting in a single integrated environment. It automates end-to-end processes from data capture through submission with industry-leading solutions. It leverages Oracle Financial Services Analytical Application (OFSAA) and Oracle Financial Services Data Foundation (OFSDF) for managing analytical application data. The AgileREPORTER in Regulatory Reporting (REG REP) Solution enables firms to automate the final mile of the reporting process. It provides pre-built integration to Lombard Risk Reporting, eliminating the need for further manual intervention. The solution ensures data integrity allowing banks to focus more time on analyzing and gaining new business insight from their growing stores of data instead of preparing data and reports with the sole objective of meeting submission deadlines.



2.1 Download the OFS AGILE RP USFED Application Pack Installer

To download the OFS AGILE RP USFED Application Pack installer Release v8.1.1.0.0, follow these steps:

1. Log in to the Oracle Software Delivery Cloud with a valid Oracle account.

2. Search for the full product name **Oracle Financial Services Regulatory Reporting for US Federal Reserve** and download the installer archive.

3. Copy the installer archive into the download directory (in Binary mode) in the setup identified for the OFS AGILE RP USFED Application Pack installation.

2.2 **Prerequisites for Installation**

The following are the prerequisites to install the OFS AGILE RP USFED 8.1.1.0.0 application:

- Install and Configure Oracle Financial Services Analytical Applications Infrastructure (OFSAAI) v8.1.1.0.0 (patch **31574757**) and other prerequisite OFSAAI patches (see *Section 4 Pre-installation* of <u>OFS AAI Installation and Configuration Guide</u>) on your machine.
- Install and Configure Oracle Financial Services Analytical Applications Infrastructure (OFSAAI) One-off patches on your machine in the following order:
 - 32548944
 - 32163060
 - 32761898
 - 32792265
- Install and Configure Oracle Financial Services Data Foundation (OFSDF) Application Pack Release v8.1.1.0.0 (patch **32257272)** and other prerequisite OFSDF patches (see *Section 4.1 Pre-installation Checklist* of the <u>OFSDF Installation and Configuration Guide</u>) on your machine.
- Install and Configure Oracle Financial Services Data Foundation (OFSDF) Application Pack Release v8.1.1.1.0 (patch **32677985**) and other prerequisite OFSDF patches (see Section 2.1 Preinstallation Requirements of the OFSDF Installation and Configuration Guide) on your machine.
- Download the Oracle Financial Services Regulatory Reporting Key Indicator Data Model v8.1.1.1.0 (patch **32896577**) and apply the same from the User Interface (Using Sliced Model Upload Option).
- AgileREPORTER version **21.2.0**
- AgileREPORTER Templates version **FED v1.26.0**
- Ensure that you have executed the .profile file before you trigger the installation.

2.3 Installing this AGILE RP USFED 8.1.1.0.0 Release

Perform the following instructions to copy, extract, and install this release.

1. Copy the downloaded archived file to your OFSAA server in Binary mode.

2. Shut down all the OFSAAI Services.


NOTE Ensure that the FICSERVER is up and running.

- 3. Execute chmod -R 750 \$FIC_HOME
- **4.** If you have an Unzip utility, skip to the next step.

Download the Unzip utility (OS-specific) unzip_<os>. z from the location https://updates.oracle.com/unzips/unzips.html and copy it in **Binary** mode to the directory that is included in your PATH variable, typically **\$HOME** path or directory in which you have copied the 8.1.1.0.0 patch.

Uncompress the unzip installer file using the command:

uncompress unzip_<os>.Z



- 5. Execute chmod -R 751 OFS_AGILE_RP_USFED_8.1.1.0.0_GENERIC.zip
- 6. Execute unzip -a <name of the file to be unzipped>

For example: unzip -a OFS_AGILE_RP_USFED_8.1.1.0.0_GENERIC.zip

NOTE The above "-a" option is mandatory to unzip the patch. If you notice an error message "*unzip*: not found [No such file or *directory*]", contact your UNIX administrator to resolve the issue.

- 7. Navigate to the appsLibConfig/conf directory containing the Silent.template file.
- 8. Create a copy of this file and rename the copy as Silent.props.
- 9. Edit the Silent.props file and specify the parameters as per the requirements.

- **10.** Execute the user .profile file.
- **11.** Navigate to the OFS_AGILE_RP_USFED/bin directory and execute ./setup.sh SILENT
- **12.** The installation progress can be viewed by periodically refreshing the log file under the OFS AGILE_RP_USFED/logs directory.

After installation is completed, verify the log file for any Errors or Warnings. Contact <u>My Oracle Support</u> in case of any issues. NOTE

This patch installation required approximately 10 minutes to complete in Oracle Test Labs.

2.4 Prerequisites for an Upgrade Installation

The following are the prerequisites to upgrade the OFS AGILE RP USFED from 8.0.x to 8.1.1 application:

• Install and configure Oracle Financial Services Regulatory Reporting for US Federal Reserve Release 8.0.7.0.0 patch (**28877384**) or higher on your machine.

2.5 Upgrading to OFS AGILE RP USFED from 8.0.x to 8.1.1.0.0 Release

Perform the following instructions to upgrade from OFS AGILE RP USFED 8.0.x to 8.1.1.0.0 release:

- Download the Oracle Financial Services Analytical Applications Infrastructure (OFSAAI) v8.1.1.0.0 (patch **31574757**) and install it in your existing environment. For more information, see <u>OFS AAI Installation and Configuration Guide</u>.
- **2.** Download the OFS Data Foundation Upgrade Utility and execute it in your environment. For more information, see <u>OFS FSDF Installation and Configuration Guide</u>.
- **3.** After replacing ##INFODOM## with INFODOM name, execute the <u>USFED Config Prescripts.sql</u> file in the Config Schema.
- 4. Update cache size of Metadata Objects under DynamicServices.xml under \$FIC_HOME/conf with required values according to metadata in the system. For example, <PARAMETER NAME="DATASET_CACHE_SIZE" VALUE="3000"/> is the default value. This should be increased to a larger value if there are a greater number of datasets present in the system than the default value.

Say you have 5000 datasets, then you can update it to <PARAMETER NAME="DATASET_CACHE_SIZE" VALUE="6000"/> assuming 1000 more may get created

- **5.** Ensure to restart all the OFSAA services after updating the DynamicServices.xml.
- **6.** Download the Oracle Financial Services Data Foundation (OFSDF) Erwin File Release v8.1.1.1.0 patch (**32681554**) and merge it with the existing custom model if any. Upload that data model from the AAI User Interface (Using Incremental Model Upload Option).
- 7. Download the Oracle Financial Services Data Foundation (OFSDF) Application Pack Release v8.1.0.0.0 and install it in your existing environment by selecting UPLOAD_MODEL=0 (# 0 = If you have already performed Model Upload and want to skip the Model Upload Process). For more information, see the <u>OFS FSDF Installation and Configuration Guide</u>.
- Download the Oracle Financial Services Data Foundation (OFSDF) Application Pack Release v8.1.1.0.0 patch (32257272) and install it in your existing environment by selecting UPLOAD_MODEL=0 (# 0 = If you have already performed Model Upload and want to skip the Model Upload Process).

For more information, see the OFS FSDF Installation Guide).

- Download the Oracle Financial Services Data Foundation (OFSDF) Application Pack Release v8.1.1.0 patch (32677985) and install it in your existing environment by selecting UPLOAD_MODEL=0 (# 0 = If you have already performed Model Upload and want to skip the Model Upload Process).
 For more information, see the OFS FSDF Installation Guide).
- **10.** Apply the FSDF Post-scripts from FSDF Upgrade Utility.
- **11.** Install and Configure Oracle Financial Services Analytical Applications Infrastructure (OFSAAI) One-off patches on your machine in the following order:
 - 32548944
 - **32163060**
 - 32761898
 - 32792265
- Download the Oracle Financial Services Regulatory Reporting Key Indicator Data Model v8.1.1.1.0 (patch 32896577) and apply the same from the User Interface (Using Sliced Model Upload Option).
- **13.** Download and install the OFS AGILE RP USFED v8.1.1.0.0 in your existing environment as mentioned in the <u>section 2.3</u>.

2.6 **Post-installation Steps**

Follow these steps after a successful installation of the 8.1.1.0.0 release:

• Apply the OFS AAI **33663417** mandatory patch.

ATTENTION	On the 10th of December 2021, Oracle released Security Alert CVE-2021-44228 in response to the disclosure of a new vulnerability affecting Apache Log4J before version 2.15. The application of the 33663417 Mandatory Patch fixes the issue.
	For details, see the My Oracle Support Doc ID <u>2827801.1</u> .
	Ensure that you reapply the 33663417 Mandatory Patch whenever you install or upgrade the application or apply an incremental patch.

- See the log file in the /OFS_AGILE_RP_USFED/logs directory to ensure that no errors are reported.
- Replace ##INFODOM## with INFODOM name and execute the <u>USFED_81100_Config_Script.sql</u> file in the Config Schema.
- Generate the application EAR or WAR file and redeploy the application on the configured Web Application Server.
 For more information on generating and deploying the EAR or WAR file, see the *Post Installation Configuration* section in the <u>OFS Analytical Applications Infrastructure Installation</u> and Configuration Guide.

- Restart all the OFSAA services.
 For more information, see the *Starting Infrastructure Services* section in the <u>OFS Analytical</u> <u>Applications Infrastructure Installation and Configuration Guide</u>.
- To perform additional steps for secure configuration of drill-down from the AgileREPORTER portal, see the *Configuration for Referrer Header Validation* section in the <u>OFS Analytical</u> <u>Applications Infrastructure Security Guide</u>.
- Perform the additional configurations, if required, as mentioned under the *Additional Configurations* section in the <u>OFS Analytical Applications Infrastructure Installation and</u> <u>Configuration Guide</u>.

2.7 Post US FED Run Execution

After the US FED Run execution, follow these steps:

- 1. For prior date reporting, see the <u>Prior Date Reporting</u> document.
- 2. Execute the <<INFODOM>>_REG_RUNEXE_RESAVE batch to populate the **RUNEXESUMM** table if you are not using the FFIEC-002 or FFIEC-002S reports.

If you are using the FFIEC-002 or FFIEC-002S reports, then execute the <Installer Path>/OFS_REG_REP_USFED/Post_Scripts/RUNEXESUMM_VW.sql file in atomic schema.

Lombard AgileREPORTER would display additional filters of Run Execution ID and Run Status during report retrieval based on the RUNEXESUMM table:

- **a.** Run Execution ID is the Run Execution Identifier concatenated with Run Description.
- **b.** Run Status shows the status of US FED Run Execution.
- c. Define the entities as SOLO or CONSOLIDATED in Lombard AgileREPORTER before retrieving returns.
 For more information on Derived Entity Resave, see the MOS.

2.8 Deploying Template Package

After saving the derived entities, follow these steps to deploy the template package:

- 1. To deploy the product configuration on Lombard AgileREPORTER using the package OFSAA_RP_TEMPLATE_USFED_81100.zip bundled inside the Template_Package directory of the installer:
 - **a.** Navigate to the /Template_Package directory inside the installer.
 - **b.** Unzip the files with the following command:

unzip OFS_RP_TEMPLATE_USFED_81100.zip

The FED v1.26.0-b18 sign.lrm file is extracted with the above command.

- c. Navigate to the path where AgileREPORTER is installed and then go to the /bin directory.
- **d.** Add a new configuration with the following command:

./config.sh -p -a <Template Package Full Path>/<.lrm file>

For example:

```
./config.sh -p -a <Template_Package Full Path>/FED_v1.26.0-
b18 sign.lrm
```

2.9 Deploying Configuration Package

After saving the derived entities, follow these steps to deploy the config package:

- To deploy the product configuration on Lombard AgileREPORTER using the package OFSAA_REG_REP_USFED_81100.zip bundled inside the Config_Package directory of the installer:
 - e. Navigate to the <LombardAgileREPORTER>/bin directory under the installed location.
 - **f.** Add a new configuration with the following command:

./config.sh -a <Config Package Full Path>

For example:

```
./config.sh -a /scratch/kit/81100/OFS_REG_REP_USFED/Config_Package/
OFSAA_REG_REP_USFED_81100.zip
```

2. Update the Alias with the following command:

```
./config.sh -ea OFSAA_REG_REP_USFED_81000 -iv 8.1.0.0.0 -alias "OFSAA
FED DATA SOURCE" -aif <LombardAgileREPORTER>/bin/aliasinfo.properties
```
