- Warning: If Data Encryption is activated, it is not possible to deactivate.
- FBS Service 1.7.4.4 is mandatory if AGILE Reporter is integrated with AGILE STB Calcs.
- CR4AR 1.7.3 is mandatory to install Compliance Product without BDE.
- FBS Service and CR4AR installation package are included in AGILE Reporter release.
- There is a folder on the release package (For JBoss EAP) which includes JSF patch for userprovided JBoss EAP installation.

2.1.1 US Federal Reserve (US FED)


The US FED Trial Template Package (Regulatory Reports for the US Federal Reserve) package contains the following US FED Return Templates:
