2 Introduction to Oracle Financial Services Regulatory Reporting for US Federal Reserve

Oracle Financial Services Regulatory Reporting for US Federal Reserve (OFS AGILE RP US FED) Pack helps banks comply with various guidelines issued by US Federal Reserve, including BCBS 239 regulations. It provides integrating risk data reporting systems and enhances the accuracy of reporting in banks. The OFS Risk Regulatory Reporting (REG REP) Solution helps in achieving the objectives by enabling preset steps based on the generalization of a set of solutions. This is made possible by:

- Providing a Centralized Data Storage for Risk Data through relevant subject areas of Financial Services Data Foundation (FSDF).
- Interfacing with a third-party reporting tool such as Lombard Risk Reporter Portal to build necessary template reports to meet the regulatory expectations.

Data Accuracy of Risk Reporting is ensured by:

- Data Governance Studio (DGS).

The Oracle Financial Services Regulatory Reporting for US Federal Reserve (OFS AGILE RP US FED) solution enables financial services organizations to manage and execute regulatory reporting in a single integrated environment. It automates end-to-end processes from data capture through submission with industry-leading solutions. It leverages Oracle Financial Services Analytical Application (OFSAA) and Oracle Financial Services Data Foundation (OFSDF) for managing analytical application data. The AgileREPORTER in Regulatory Reporting (REG REP) Solution enables firms to automate the final mile of the reporting process. It provides pre-built integration to Lombard Risk Reporting, eliminating the need for further manual intervention. The solution ensures data integrity allowing banks to focus more time on analyzing and gaining new business insight from their growing stores of data instead of preparing data and reports with the sole objective of meeting submission deadlines.

OFS Regulatory Reporting for US Federal Reserve (OFS AGILE RP US FED) is a separately licensed product.

2.1 Obtaining the Software

This release of OFS AGILE RP USFED v8.1.2.1.0 can be downloaded from the [My Oracle Support](#) website. Log in and search for **35114937** under the Patches and Updates Tab and download the `OFS_AGILE_RP_USFED_8.1.2.1.0_GENERIC.zip` archive file.

You must have a valid Oracle account to download the software.

2.2 Prerequisites for Installation

The following are the prerequisites to install the OFS AGILE RP USFED 8.1.2.1.0 application:

- Install and Configure Oracle Financial Services Analytical Applications Infrastructure (OFSAAI) v8.1.2.0.0 (patch **32791983**) and other prerequisite OFSAAI Patches (see *Section 4 Pre-installation of [OFS AAI Installation and Configuration Guide](#)*) on your machine.
- Install and Configure Oracle Financial Services Data Foundation (OFSDf) Application Pack Release v8.1.2.0.0 (patch **32820351**) and other prerequisite OFSDf Patches (see *Section 4.1 Pre-installation Checklist of the [OFSDf Installation and Configuration Guide](#)*) on your machine.
- Install and Configure Oracle Financial Services Agile REPORTER Release v8.1.2.0.0 (patch **34006800**) on your machine.
- Install and Configure Oracle Financial Services Data Foundation (OFSDf) Application Pack Release v8.1.2.1.0 (patch **33716139**) and other prerequisite OFSDf Patches (see *Section 4.1 Pre-installation Checklist of the [OFSDf Installation and Configuration Guide](#)*) on your machine.
- Ensure that you have executed the .profile file before you trigger the installation.

2.3 Installing this AGILE RP USFED 8.1.2.1.0 Release

Perform the following instructions to copy, extract, and install this release.

1. Copy the downloaded archived file to your OFSAA Server in Binary Mode.
2. Shut down all the OFSAAI Services.
For more information, see the *Stopping Infrastructure Services* Section in the [OFS Analytical Applications Infrastructure Installation and Configuration Guide Release](#).

NOTE Ensure that the FICSERVER is up and running.

3. Execute `chmod -R 750 $FIC_HOME`
4. If you have an Unzip utility, skip to the next step.

Download the Unzip utility (OS-specific) `unzip_<os>.z` from the location <https://updates.oracle.com/unzips/unzips.html> and copy it in **Binary** mode to the directory that is included in your PATH variable, typically **\$HOME** path or directory in which you have copied the 8.1.2.1.0 patch.

Uncompress the unzip installer file using the command:

```
uncompress unzip_<os>.Z
```

NOTE

If you notice an error message “*uncompress: not found [No such file or directory]*”, contact your UNIX Administrator.

It is recommended you extract the contents (unzip) of every installer in a separate folder. Do not use one single folder to unzip contents of different release or patches as some files could be overwritten.

5. Execute `chmod -R 751 OFS_AGILE_RP_USFED_8.1.2.1.0_GENERIC.zip`
6. Execute `unzip -a <name of the file to be unzipped>`

For example: `unzip -a OFS_AGILE_RP_USFED_8.1.2.1.0_GENERIC.zip`

NOTE

The above "-a" option is mandatory to unzip the patch. If you notice an error message “*unzip: not found [No such file or directory]*”, contact your UNIX Administrator to resolve the issue.

7. Navigate to the `appsLibConfig/conf` directory containing the `params.conf` file.
8. Create a copy of this file and rename the copy as `Silent.props`.
9. Edit the `Silent.props` file and specify the parameters as per the requirements.

The following table lists all the properties that must be specified.

Table 2: List of Properties and Parameters for the Silent.props File

LOG_MODE	Mode for logging.	1 = Debug 0 = General	OPTIONAL. The default is 0.

ENABLE_CONCURRENCY	Specify if you want to Enable Parallel Processing.	0 = No 1 = Yes	OPTIONAL
CONCURRENCY_LEVEL	Specify if you want to Enable Parallel Processing.	For example: CONCURRENCY_LEVEL=10, which means 10 threads created for parallelism	MANDATORY when ENABLE_CONCURRENCY=1.

10. Execute the user `.profile` file.
11. Navigate to the `OFS_AGILE_RP_USFED/bin` directory and execute `./setup.sh SILENT`
12. The installation progress can be viewed by periodically refreshing the log file under the `OFS_AGILE_RP_USFED/logs` directory.

After installation is completed, verify the log file for any Errors or Warnings.

NOTE

This patch installation required approximately 10 minutes to complete in Oracle Test Labs.

2.4 Post-installation Steps

Follow these steps after a successful installation of the 8.1.2.1.0 release:

- See the log file in the `/OFS_AGILE_RP_USFED/logs` directory to ensure that no errors are reported.
- Generate the application EAR or WAR file and redeploy the application on the configured Web Application Server.
For more information on generating and deploying the EAR or WAR file, see the *Post Installation Configuration* Section in the [OFS Analytical Applications Infrastructure Installation and Configuration Guide](#).
- Restart all the OFSAA Services.

- Perform the additional configurations, if required, as mentioned under the *Additional Configurations* Section in the [OFS Analytical Applications Infrastructure Installation and Configuration Guide](#).

2.5 Post US FED Run Execution

After the US FED Run execution, follow these steps:

1. For prior date reporting, see the [Prior Date Reporting](#) document.
2. Execute the `<<INFODOM>>_REG_RUNEXE_RESAVE` batch to populate the **RUNEXESUMM** table if you are not using the FFIEC-002 or FFIEC-002S reports.

If you are using the FFIEC-002 or FFIEC-002S reports, then execute the `<Installer Path>/OFS_REG_REP_USFED/Post_Scripts/RUNEXESUMM_VW.sql` file in atomic schema.

Lombard AgileREPORTER would display additional filters of Run Execution ID and Run Status during report retrieval based on the RUNEXESUMM table:

- a. Run Execution ID is the Run Execution Identifier concatenated with Run Description.
- b. Run Status shows the status of US FED Run Execution.
- c. Define the entities as SOLO or CONSOLIDATED in Lombard AgileREPORTER before retrieving returns.

2.6 Deploying Template Package

After saving the derived entities, follow these steps to deploy the Template Package:

1. To deploy the product configuration on Lombard AgileREPORTER using the package `OFS_AR_TEMPLATE_USFED_81210.zip` bundled inside the `Template_Package` directory of the installer:
 - a. Navigate to the `/Template_Package` directory inside the installer.
 - b. Unzip the files with the following command:


```
unzip OFS_AR_TEMPLATE_USFED_81210.zip
```

The `FED_v22.12.2-b25_sign.lrm` file is extracted with the above command.
 - c. Navigate to the path where AgileREPORTER is installed and then go to the `/bin` directory.
 - d. Add a new configuration with the following command:

```
./config.sh -p -a <Template_Package Full Path>/<.lrm file>
```

For example:

```
./config.sh -p -a <Template_Package Full Path>/FED_v22.12.2-  
b25_sign.lrm
```

3 Integration with Agile REPORTER

This section provides information on how to integrate with Agile REPORTER for Last Mile Reporting using either Product Seeded Mapping Logic (Config Package) or Dynamic Mapping Logic (Dynamic Integration Package) in the application.

3.1 Deploying Config Package

This section describes the steps to deploy the Config Package after saving the derived entities. This Config Package consists of the Reporting Logic seeded by the product for each line item.

1. To deploy the product configuration on AgileREPORTER using the package OFSAA_REG_REP_USFED_81210.zip bundled inside the Config_Package folder of the installer:
 - a. Navigate to the <LombardAgileREPORTER>/bin directory under the installed location.
 - b. Add a new configuration with the following command:

```
./config.sh -a <Config_Package Full Path>
```

For example:

```
./config.sh -a /scratch/kit/812/OFS_REG_REP_USFED/Config_Package/  
OFSAA_REG_REP_USFED_81210.zip
```

2. Update the Alias with the following command:

```
./config.sh -ea OFSAA_REG_REP_USFED_81210 -iv 8.1.2.1.0 -alias  
"OFSAA FED DATA SOURCE" -aif scratch/agile/bin/aliasinfo.properties
```

3.2 Deploying Dynamic Integration Package

This section describes the steps to deploy the Dynamic Integration Package after saving the derived entities and performing the Report Publish. This Integration Package consists of the Reporting Logic seeded by the product as a Key Value pair for each line item. The Key Value can be controlled through report publish and therefore, the final reporting is dynamic.

1. To deploy the product configuration on AgileREPORTER using the package OFSAA_REG_REP_USFED_81210.zip bundled inside the Dynamic_Package folder of the installer:
 - a. Navigate to the <LombardAgileREPORTER>/bin directory under the installed location.
 - b. Add a new configuration with the following command:

```
./config.sh -a <Dynamic_Package Full Path>
```

For example:

```
./config.sh -a/scratch/ofsaapp1/kit/81210/KIT_OFS_REG_REP_USFED  
/OFS_REG_REP_USFED/Dynamic_Integration_Package/OFSAA_REG_REP_USFED_8  
1210.zip
```

2. Update the Alias with the following command:

```
./config.sh -ea OFSAA_REG_REP_USFED_81210 -iv 8.1.2.1.0 -alias  
"OFSAA FED DATA SOURCE" -aif scratch/agile/bin/aliasinfo.properties
```
