Introduction to Oracle Financial Services Regulatory Reporting for US Federal Reserve

Oracle Financial Services Regulatory Reporting for US Federal Reserve (OFS AGILE RP US FED) Pack helps banks comply with various guidelines issued by US Federal Reserve, including BCBS 239 regulations. It provides integrating risk data reporting systems and enhances the accuracy of reporting in banks. The OFS Risk Regulatory Reporting (REG REP) Solution helps in achieving the objectives by enabling preset steps based on the generalization of a set of solutions. This is made possible by:

- Providing a Centralized Data Storage for Risk Data through relevant subject areas of Financial Services Data Foundation (FSDF).
- Interfacing with a third-party reporting tool such as Lombard Risk Reporter Portal to build necessary template reports to meet the regulatory expectations.

Data Accuracy of Risk Reporting is ensured by:

• Data Governance Studio (DGS).

The Oracle Financial Services Regulatory Reporting for US Federal Reserve (OFS AGILE RP US FED) solution enables financial services organizations to manage and execute regulatory reporting in a single integrated environment. It automates end-to-end processes from data capture through submission with industry-leading solutions. It leverages Oracle Financial Services Analytical Application (OFSAA) and Oracle Financial Services Data Foundation (OFSDF) for managing analytical application data. The AgileREPORTER in Regulatory Reporting (REG REP) Solution enables firms to automate the final mile of the reporting process. It provides pre-built integration to Lombard Risk Reporting, eliminating the need for further manual intervention. The solution ensures data integrity allowing banks to focus more time on analyzing and gaining new business insight from their growing stores of data instead of preparing data and reports with the sole objective of meeting submission deadlines.

OFS Regulatory Reporting for US Federal Reserve (OFS AGILE RP US FED) is a separately licensed product.

2.1 Obtaining the Software

This release of OFS AGILE RP USFED v8.1.2.1.11 can be downloaded from the <u>My Oracle Support</u> website. Log in and search for **36355559** under the **Patches and Updates** tab and download the 36355559_81200_Generic.zip archive file.

You must have a valid Oracle account to download the software.

2.2 Prerequisites for Installation

The following are the prerequisites to install the OFS AGILE RP USFED 8.1.2.1.11 application:

- Install and Configure Oracle Financial Services Analytical Applications Infrastructure (OFSAAI) v8.1.2.0.0 (patch **32791983**) and other prerequisite OFSAAI patches (see Section 4 Pre-installation of OFS AAI Installation and Configuration Guide) on your machine.
- Install and Configure Oracle Financial Services Data Foundation (OFSDF) Application Pack Release v8.1.2.0.0 (patch **32820351)** and other prerequisite OFSDF patches (see *Section 4.1 Pre-installation Checklist* of the <u>OFSDF Installation and Configuration Guide</u>) on your machine.
- Install and Configure Oracle Financial Services Regulatory Reporting for US Federal Reserve (OFS AGILE RP US FED) Release v8.1.2.0.0 (patch **34006800**) on your machine.
- Install and Configure Oracle Financial Services Data Foundation (OFSDF) Application Pack Release v8.1.2.1.0 (patch **33716139)** and other prerequisite OFSDF patches (see *Section 4.1 Preinstallation Checklist* of the <u>OFSDF Installation and Configuration Guide</u>) on your machine.
- Install and Configure Oracle Financial Services Regulatory Reporting for US Federal Reserve (OFS AGILE RP US FED) v8.1.2.1.10 (patch 36246024) (see Section 3.2 Prerequisites-installation of <u>OFS AGILE RP US FED Installation Guide</u>) on your machine.
- Ensure that you have executed the .profile file before you trigger the installation.

2.3 Installing this AGILE RP USFED 8.1.2.1.11 Release

Perform the following instructions to copy, extract, and install this release.

- 1. Copy the downloaded archived file to your OFSAA Server in Binary Mode.
- Shut down all the OFSAAI Services.
 For more information, see the *Stopping Infrastructure Services* Section in the <u>OFS Analytical</u> <u>Applications Infrastructure Installation and Configuration Guide Release</u>.

NOTE Ensure that the FICSERVER is up and running.

- 3. Execute chmod -R 750 \$FIC_HOME
- 4. If you have an Unzip utility, skip to the next step.

Download the Unzip utility (OS-specific) unzip_<os>. I from the location <u>https://updates.oracle.com/unzips/unzips.html</u> and copy it in **Binary** mode to the directory that is included in your PATH variable, typically **\$HOME** path or directory in which you have copied the 8.1.2.1.11 patch.

Uncompress the unzip installer file using the command:

```
uncompress unzip_<os>.Z
```

NOTEIf you notice an error message "uncompress: not found [No
such file or directory]", contact your UNIX Administrator.It is recommended you extract the contents (unzip) of every
installer in a separate folder. Do not use one single folder to
unzip contents of different release or patches as some files5. Execute chmod -R 751 p36355559_81200_Generic.zip

6. Execute unzip -a <name of the file to be unzipped>

For example: unzip -a p36355559 81200 Generic.zip

NOTE The above "-a" option is mandatory to unzip the patch. If you notice an error message "*unzip: not found [No such file or directory]*", contact your UNIX Administrator to resolve the issue.

- 7. Navigate to the appsLibConfig/conf directory containing the params.conf file.
- 8. Configure the UPLOAD_MODEL parameter in the params.conf file to determine if the Model Upload is required or not by using the following parameter values:
 - 0 = If you have already performed Model Upload and want to skip the Model Upload process.
 - 1 = If you want to perform the Model Upload.

NOTE By default, the parameter value is 0.

- 9. Navigate to the OFS AGILE RP USFED/bin directory and execute ./setup.sh SILENT
- **10.** The installation progress can be viewed by periodically refreshing the log file under the OFS AGILE RP USFED/logs directory.

After installation is completed, verify the log file for any Errors or Warnings. Contact <u>My Oracle Support</u> in case of any issues.

NOTE This patch installation required approximately 10 minutes to complete in Oracle Test Labs.

2.4 **Post-installation Steps**

Follow these steps after a successful installation of the 8.1.2.1.11 release:

- See the log file in the /OFS_AGILE_RP_USFED/logs directory to ensure that no errors are reported.
- Generate the application EAR or WAR file and redeploy the application on the configured Web Application Server.
 For more information on generating and deploying the EAR or WAR file, see the *Post Installation Configuration* Section in the <u>OFS Analytical Applications Infrastructure Installation</u>
- Restart all the OFSAA Services.
 For more information, see the *Starting Infrastructure Services* Section in the <u>OFS Analytical</u> <u>Applications Infrastructure Installation and Configuration Guide</u>.
- To perform additional steps for secure configuration of drill-down from the AgileREPORTER portal, see the *Configuration for Referrer Header Validation* Section in the <u>OFS Analytical</u> <u>Applications Infrastructure Security Guide</u>.
- Perform the additional configurations, if required, as mentioned under the *Additional Configurations* Section in the <u>OFS Analytical Applications Infrastructure Installation and</u> <u>Configuration Guide</u>.

2.5 Post US FED Run Execution

and Configuration Guide.

After the US FED Run execution, follow these steps:

- 1. For prior date reporting, see the Prior Date Reporting document.
- 2. Execute the <<INFODOM>>_REG_RUNEXE_RESAVE batch to populate the RUNEXESUMM table if you are not using the FFIEC-002 or FFIEC-002S reports.

If you are using the FFIEC-002 or FFIEC-002S reports, then execute the <Installer Path>/OFS_REG_REP_USFED/Post_Scripts/RUNEXESUMM_VW.sql file in atomic schema.

Lombard AgileREPORTER would display additional filters of Run Execution ID and Run Status during report retrieval based on the RUNEXESUMM table:

- **a.** Run Execution ID is the Run Execution Identifier concatenated with Run Description.
- **b.** Run Status shows the status of US FED Run Execution.
- c. Define the entities as SOLO or CONSOLIDATED in Lombard AgileREPORTER before retrieving returns.
 For more information on Derived Entity Resave, see the MOS.

2.6 Deploying Template Package

After saving the derived entities, follow these steps to deploy the Template Package:

- To deploy the product configuration on Lombard AgileREPORTER using the package OFS_AR_TEMPLATE_USFED_81210.zip bundled inside the Template_Package directory of the installer:
 - **a.** Navigate to the /Template Package directory inside the installer.
 - **b.** Unzip the files with the following command:

unzip OFS_AR_TEMPLATE_USFED_81210.zip

The FED_v23.12.2-b24_sign.lrm file is extracted with the above command.

- **c.** Navigate to the path where AgileREPORTER is installed and then go to the /bin directory.
- **d.** Add a new configuration with the following command:

```
./config.sh -p -a <Template Package Full Path>/<.lrm file>
```

For example:

```
./config.sh -p -a <Template_Package Full Path>/ FED_v23.12.2-
b24 sign.lrm
```
