1.1 What is New in this Release for OFS AgileREPORTER

This section lists the New Features and changes in OFS AgileREPORTER Release v8.1.2..0.0.

1.1.1 New Features

OFS AgileREPORTER is an application used to submit the Regulatory Reports to the regulator-based on the jurisdiction.

The list of new features and enhancements in this release are as follows:

- Cannot delete user groups in AgileREPORTER: This functionality enables the user to delete a User Group as long as that User Group is not assigned to any returns.
- Return bulk actions: Users can now Export, Validate, Lock, Unlock, and delete multiple returns from the dashboard in a few clicks.
- Promote internal APIs to ixternal: Users can now perform the execution group API by simply opening the AGILE Reporter RESTful API reference page via a menu item.
- Cross-summing between regulators: Cross-product/jurisdiction sums and validations are supported, with entity code defaulting to the calling return's entity code.
- Read/write Modeshape tables: Modeshape is removed and only two tables are kept to read/write in AgileREPORTER.
- SQL Server 2014 is not suported

OFS AgileREPORTER is a form and workflow tool that enables the creation and submission of Regulatory returns. The OFS AgileREPORTER Application is configured with product configurations delivered using Configuration Packages. Different Configuration Packages are loaded into the OFS AgileREPORTER Application to support different sets of regulatory returns based on the jurisdiction.

2.1 Trial Template Package

OFS AgileREPORTER contains Trial Template Packages for two jurisdictions. The details of the reports included are provided in the following sections.

2.1.1 US Federal Reserve (US FED)

The US FED Trial Template Package (Regulatory Reports for the US Federal Reserve) package contains the following US FED Return Templates:

- FFIEC-101
- FFIEC-031

2.1.2 Reserve Bank of India (RBI)

The RBI Trial Template Package (Regulatory Reports for the Reserve Bank of India) contains the following RBI Return Templates:

- RCA3
- IRS
- RAO
