- Remove mandatory validations from return submission.
- Script Validation Rule: Fail Empty Grid.
- Daily Schedule with business days offset.
- User can log in when SEC_USERS_IS_ENABLED=0.
- There is no login history and login audit log after using an SSO configuration.
- SEC_USER_DETAILS table is not updated when creating a user from API call.

2.1.1 US Federal Reserve (US FED)


The US FED Trial Template Package (Regulatory Reports for the US Federal Reserve) package contains the following US FED Return Templates:
