OFS AgileREPORTER is an application used to submit the Regulatory Reports to the regulator-based on the jurisdiction.

The list of new features and fixes in this release are as follows:

• Validation of returns sometimes fails with problems generated for every instance of every validation rule. The replication circumstances are complex and related to the number of pages instances in the returns (one per currency of the LCR), number of rows in tables in the returns and even number of CPUs in the server.

2.1.1 US Federal Reserve (US FED)


