1.1 What is New in this Release for OFS AgileREPORTER

This section lists the New Features and changes in OFS AgileREPORTER Release v8.1.2.5.0.

1.1.1 New Features

OFS AgileREPORTER is an application used to submit the Regulatory Reports to the regulator-based on the jurisdiction.

The list of new features and fixes in this release are as follows:

- WildFly and JBoss EAP have been updated.
- AgileREPORTER now retains the previous selection for the submission module to which it belongs, ensuring that the filing indicator controls are pre-populated with the previous choices during the next submission attempt.
- Empty templates now are supported for positive or negative filing indicators for some reporting authorities only.
- AgileREPORTER now processes reply to messages without valid MAP information, enabling it to handle reply error messages from FBS that will be sent at the BATCHRUN level.
- Red Hat Enterprise Linux 9 and Oracle Enterprise Linux 9 are now supported.
- The ETL BatchRun Request message is now changed.
- The look and feel is refreshed for Dashboard and ReturnView.
- RHEL7 and OEL 7 are no longer supported.
- Create return from CSV is enabled only for ECR regulatory product.
- The FormConfig cache key now includes the tenant identifier or the implementation version.
- AR was unable to locate the AR_FBS_Batch_STATUS table which is used to communicate between AgileREPORTER and FBS for TEXT MAP type. This issue has been fixed.
- Within the previous AgileREPORTER platform version, the derived cells in the forms ARF2211 and ARF2221 were considered as static cells that need to be automated although they are

configured as sum cells in the product. Now, using the new AgileREPORTER platform version, the derived cells are summing up the amounts as expected.

- When updating a Return - via ReturnSources - job is not “Waiting” but proceeds and completes successfully.
- The passwords are now encrypted.

OFS AgileREPORTER is a form and workflow tool that enables the creation and submission of Regulatory returns. The OFS AgileREPORTER Application is configured with product configurations delivered using Configuration Packages. Different Configuration Packages are loaded into the OFS AgileREPORTER Application to support different sets of regulatory returns based on the jurisdiction.

2.1 Trial Template Package

OFS AgileREPORTER contains Trial Template Packages for two jurisdictions. The details of the reports included are provided in the following sections.

2.1.1 US Federal Reserve (US FED)

The US FED Trial Template Package (Regulatory Reports for the US Federal Reserve) package contains the following US FED Return Templates:

- FR Y-9C
- FFIEC-101
- FFIEC-031

2.1.2 Reserve Bank of India (RBI)

The RBI Trial Template Package (Regulatory Reports for the Reserve Bank of India) contains the following RBI Return Templates:

- RCA3
- IRS
- RAQ
