AR-25281	No Security for Accessing the Swagger Documentation in AR	Access to Swagger documentation and the REST API in AGILE Reporter is now secured. These endpoints require authentication to prevent unauthorized access.
AR-25317	Broken Access Control in User Validation Screen	Users without privileges were able to access restricted pages and enable disabled buttons through the browser's inspect tool. Access control and button restrictions have been properly applied.
AR-25343	Information Disclosure Related to the Log Path Under Wildfly	The standard error message UI now has the Wildfly installation directory redacted so that the Wildfly version is not available to (potentially hostile) UI users.
AR-25764	Page instances Lost During Excel Import	AR now imports multiple instances from CRIR and CCR Excel files.
AR-25898	Error Handling for Existing User Group During Excel File Import	The import process for user groups now handles case-insensitive names, preventing duplication errors when importing groups with uppercase names from Excel, even if a corresponding lowercase group exists.
AR-26581	Unauthorized Users Can Access Some Endpoints	The system now responds to the user with no functional privileges to Edit/Create/Delete a privilege group by providing an error message.
AR-26790	User Must Not be Able to Remove or Deactivate Product via API without the Privilege" Product Update"	The user attempting to use API to execute AR functions needs functional privileges as well as API privilege(s).
AR-26792	APIDocs Path Description Needs a Better Description	Additional swagger API documentation for filePath parameter- to clarify it is a server-side path reference.

The OFS AgileREPORTER Application is configured with product configurations delivered using Configuration Packages. Different Configuration Packages are loaded into the OFS AgileREPORTER Application to support different sets of regulatory returns based on the jurisdiction.
