3. Prerequisites

OBAPIs 18.1.0.0.0 Base with OBP flavor should be installed through OBAPIs Installer. This installation will be henceforth referred to in this manual as 'OBAPIs18.1 Base'.

For OBAPIs 18.1 Base installation, refer documents mentioned in *section 1.5 Related Information Sources*.

4. Installation

4.1 Pre Installation

OBAPIs18.1.0.0.0 Base with OBP flavor should be installed through installer.

4.2 Preference

Do changes in /config/preference.xml: Preference **EnumerationConfig** should be overridden by preference EnumerationConfigOBP2502LZN.

4.3 Steps of installation

Download and extract. Post extraction 'OBAPIs_LZNInstaller' folder would be available.

Ensure before installation following sub-directories are available:

- app
- db
- ui

4.3.1 Application deployment

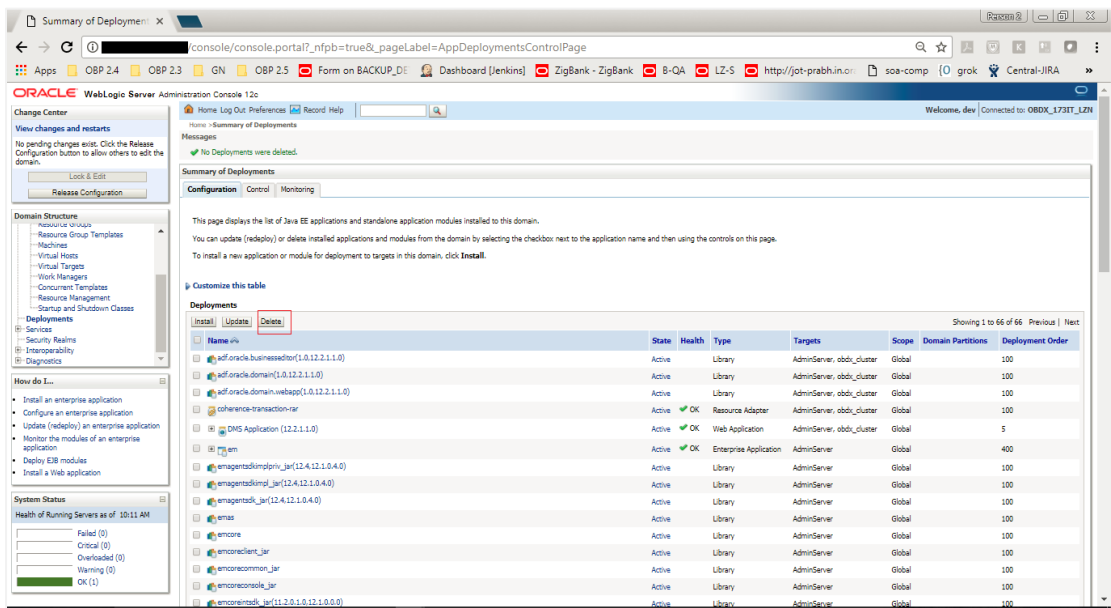
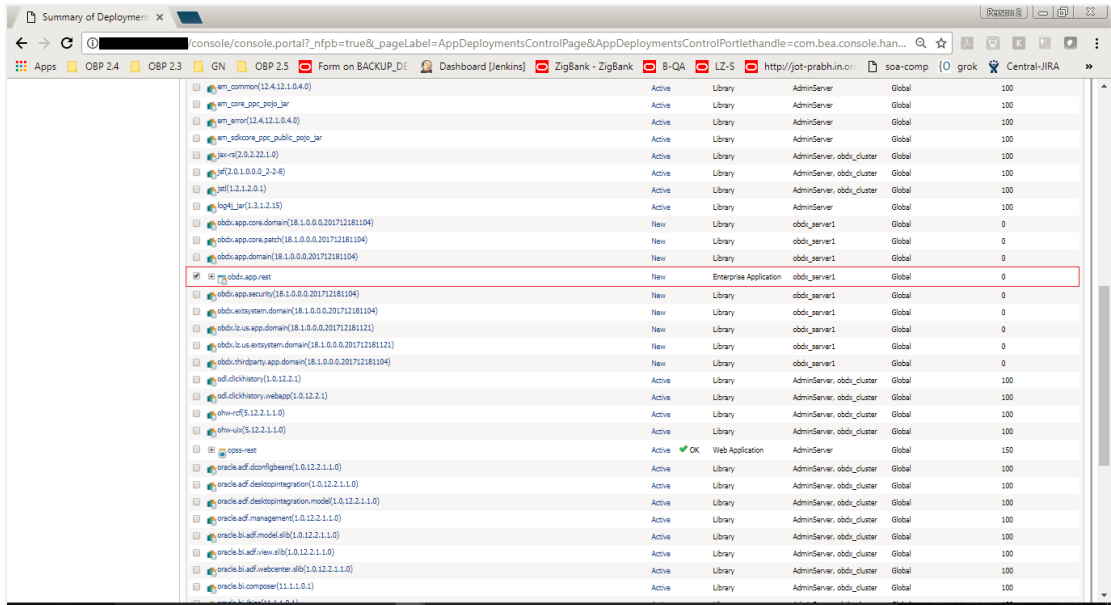
The 'app' directory will have 3 artifacts to be deployed on the OBAPIs 18.1.0.0.0 Application server.

- i. OBAPIs.app.rest.ear
 - **Un-deploy 'OBAPIs.app.rest.ear' Enterprise Application** from OBAPIs 18.1 Application Server. This artifact had been deployed as a part of OBAPIs 18.1 Base Installation.
 - Deploy 'OBAPIs.app.rest.ear' artifact as an Enterprise Application.
- ii. OBAPIs.lz.us.app.domain.ear
 - Deploy this artifact as a **library**.
- iii. OBAPIs.lz.us.extsystem.domain.ear
 - Deploy this artifact as a **library**.

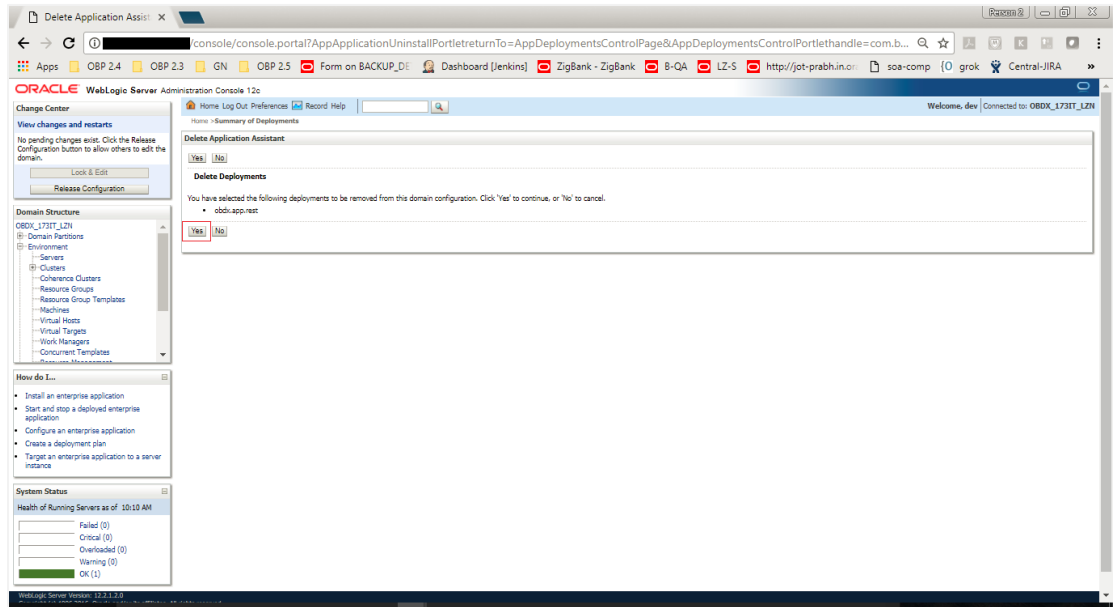
Note: Login to Weblogic Server. **First shut down the application server.** Go to Deployments, Un-deploy the REST application project of the OBAPIs 18.1.0.0.0 Base and deploy REST application project of the OBAPIs 18.1.0.0.0 US LZN and other two libraries (ii & iii) mentioned above. **All other libraries of OBAPIs 18.1.0.0.0. Base are required for OBAPIs 18.1.0.0.0 US LZN. Do not remove them. Start the application server.**

Steps to Un-deploy library/application –

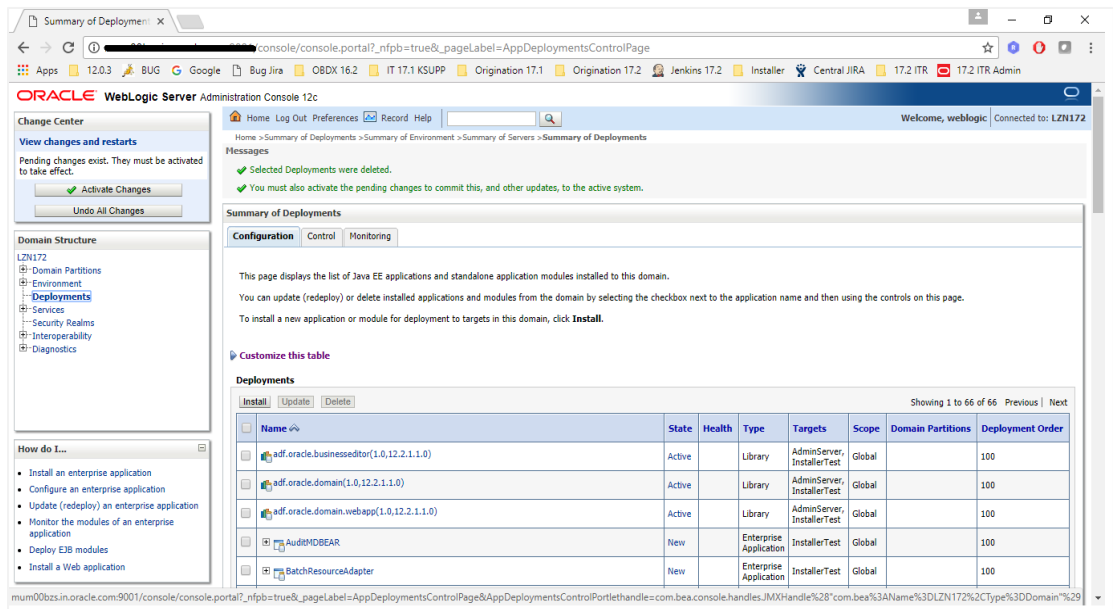
Login into Weblogic Server. Go to Deployments. Select the library/application and click on delete.



Confirm delete.

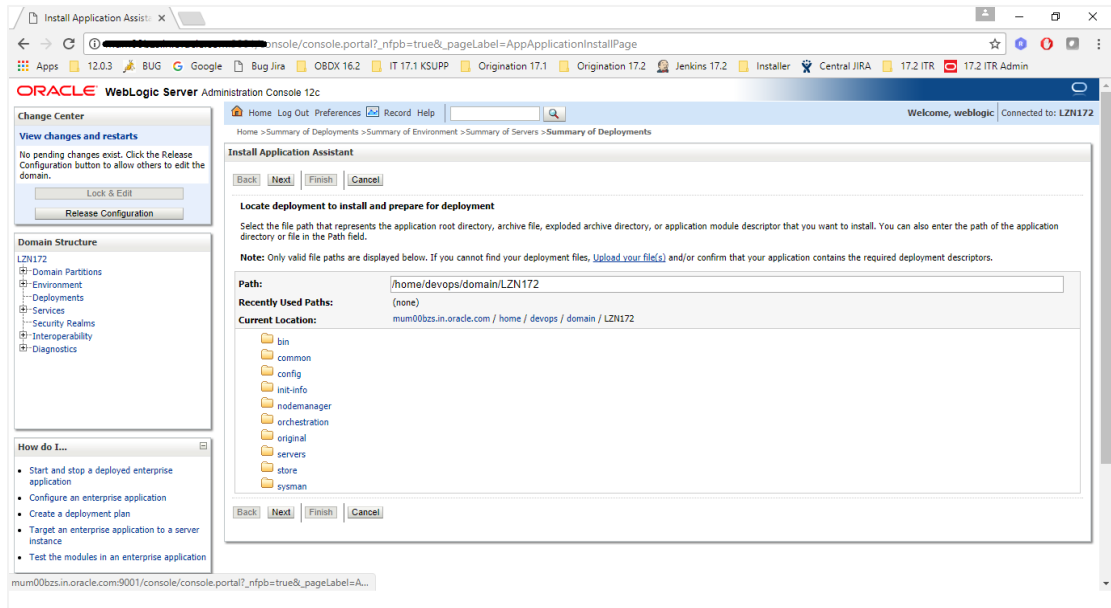


Success message will be displayed.

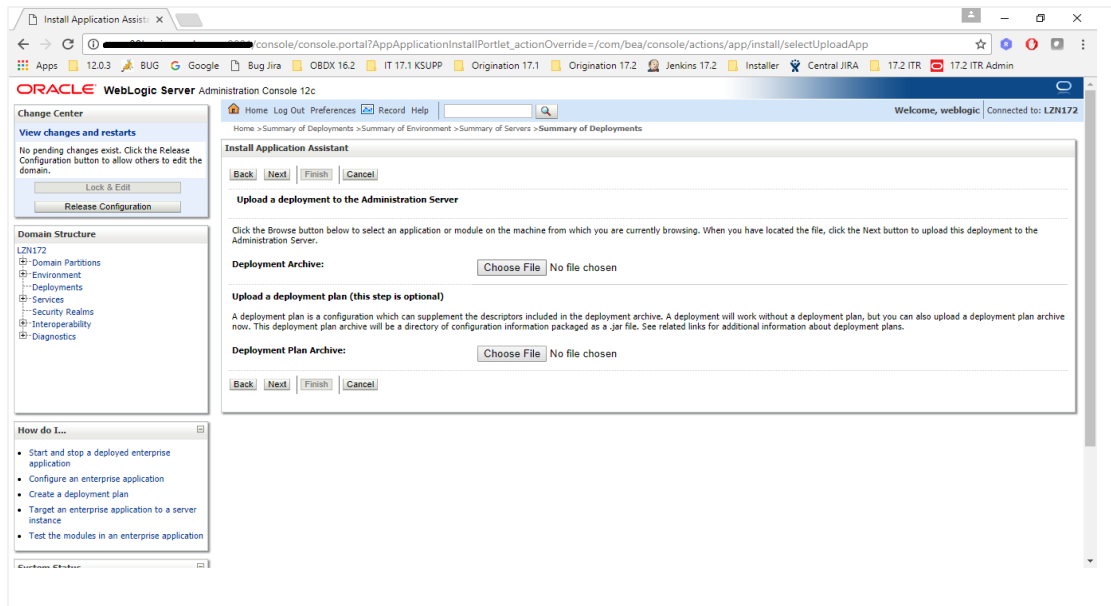


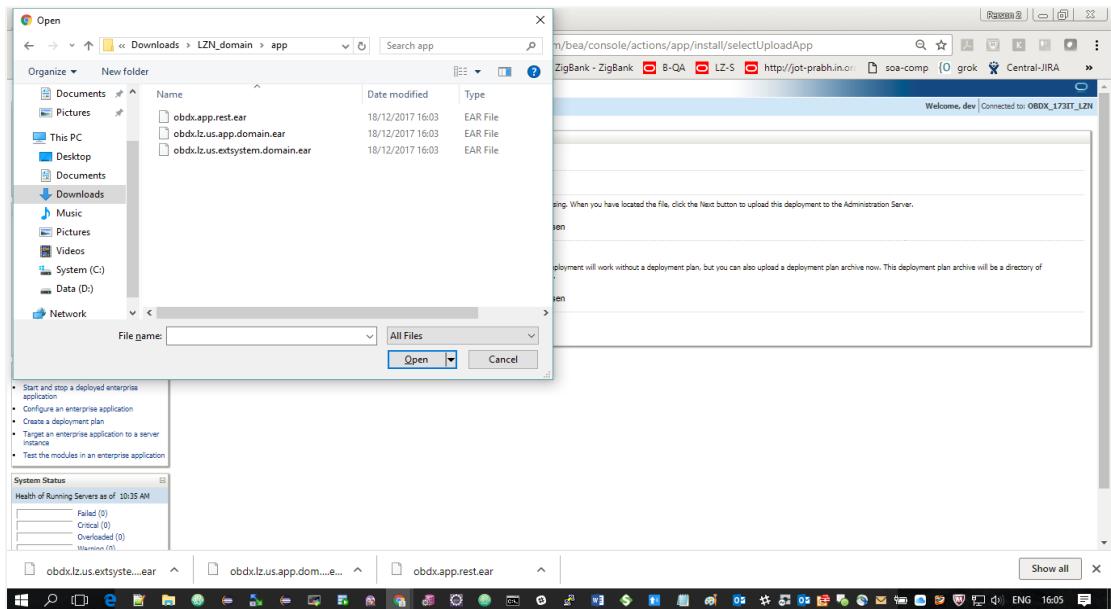
Steps to Deploy library/application -

Click on install to deploy library/application. Click on Upload Button.

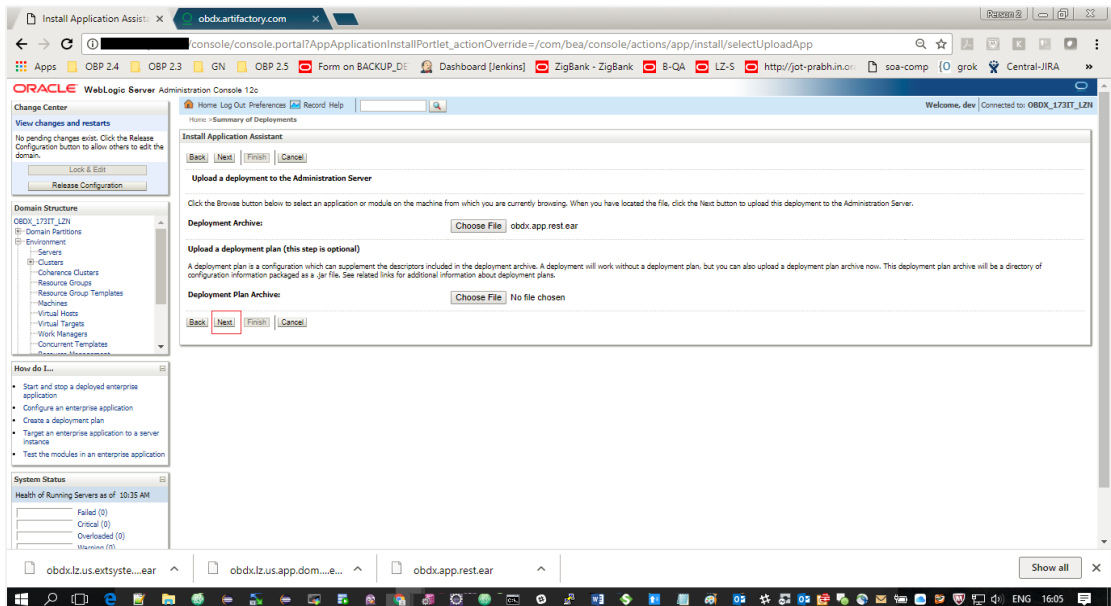


Click on 'Choose File' to select the library/application to upload.

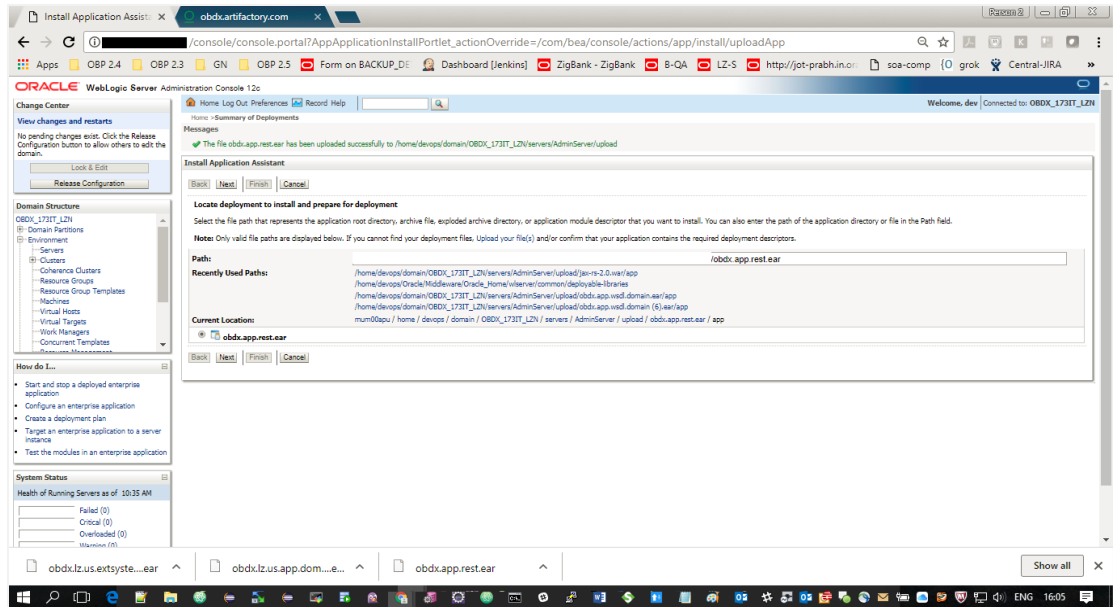




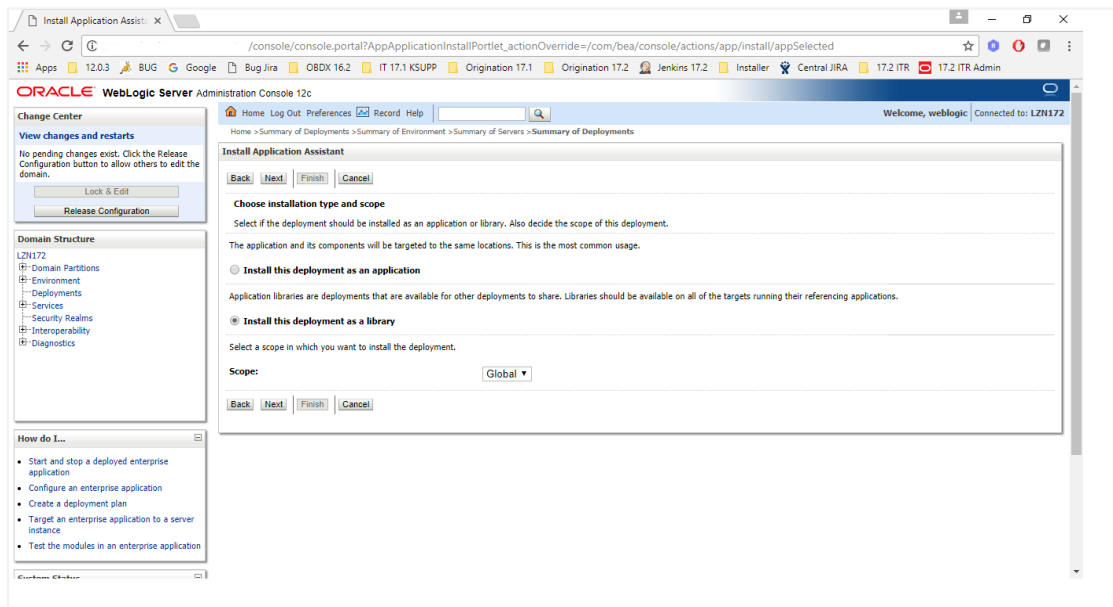
Click on NEXT button.



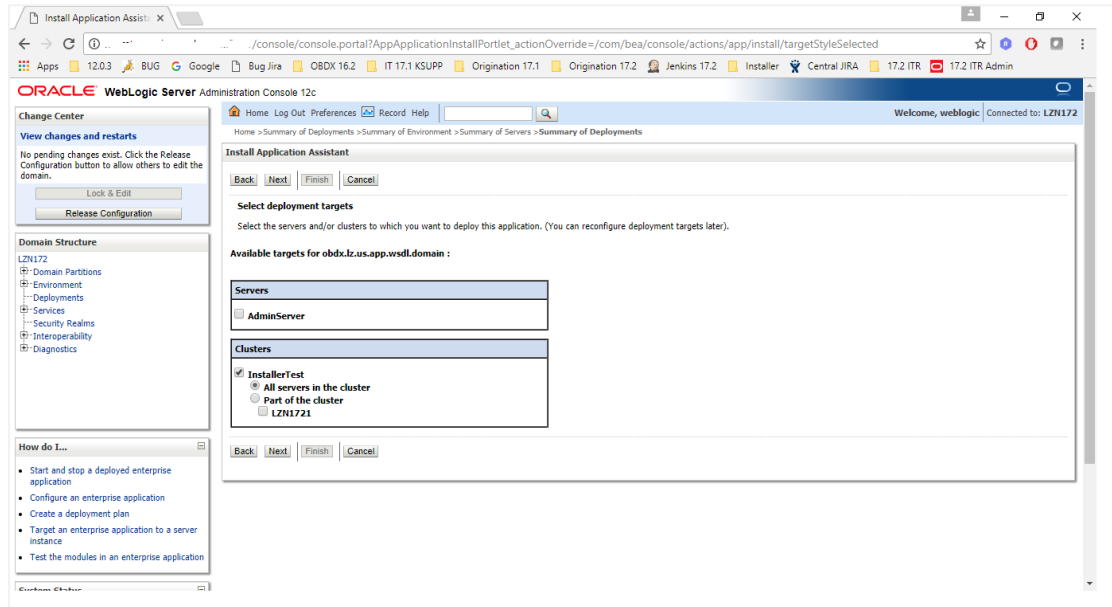
Again click on NEXT button.



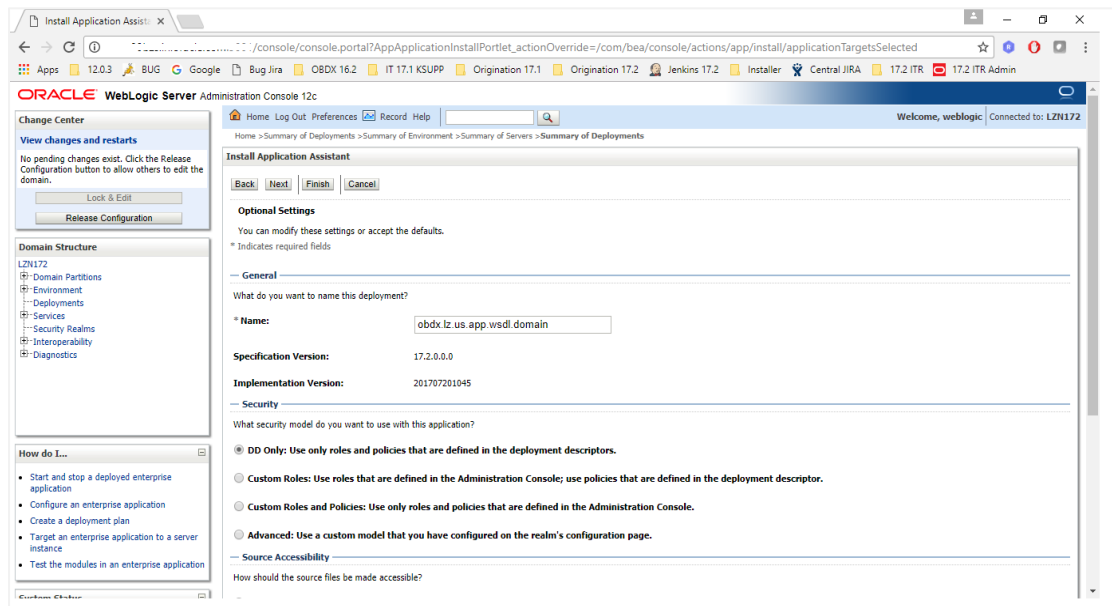
Select 'Install as library/application', as per the deployment.

Confirmation of installation will be displayed.

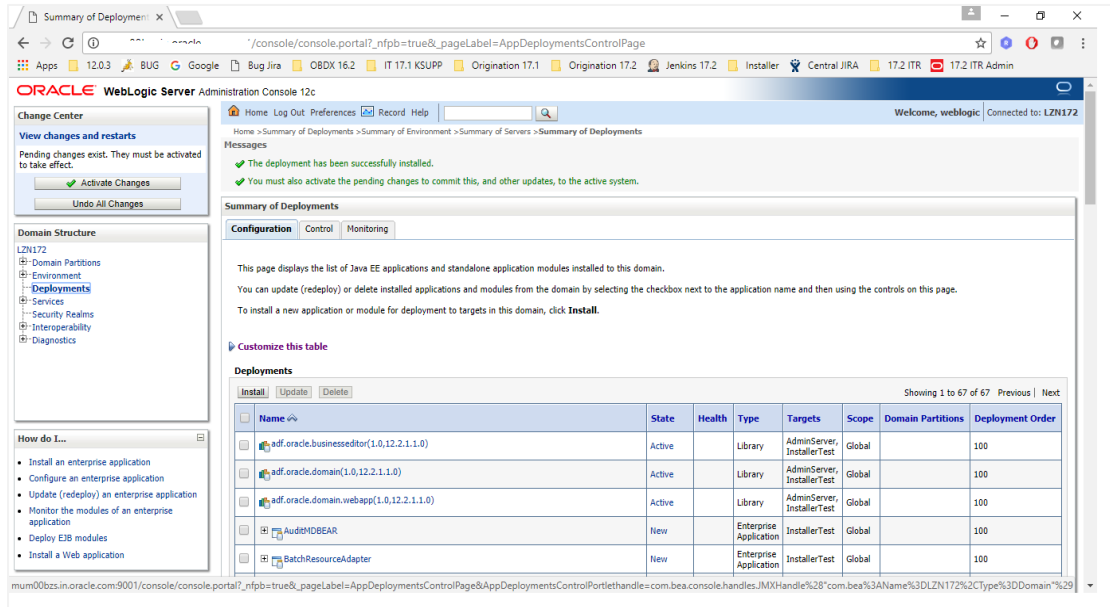


Figure 1 : Deployments after OBAPIs18.1.0.0.0 Base Installation

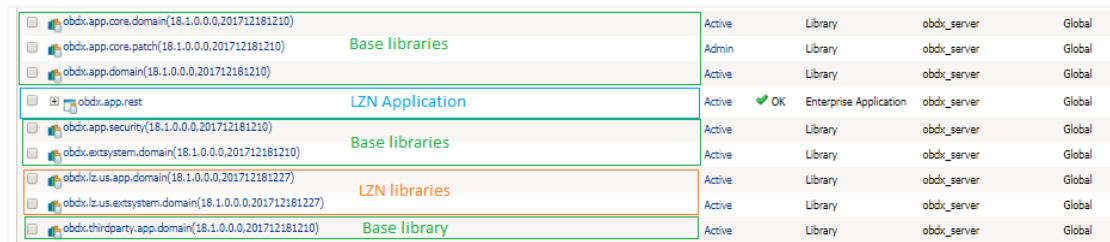


Figure 2: Deployments after OBAPIs 18.1.0.0.0 US LZN Installation

4.3.2 Database scripts deployment

The 'db' directory will have two sub-directories: dml and ddl. Executes all scripts present in the dml folder.

Note: There are no ddl scripts to execute.

4.3.3 UI deployment

The 'ui' directory contains all the UI related files. The UI deployed by OBAPIs 18.1.0.0.0 Base installation should be replaced by the UI contents of this directory.

Note: No change required in OHS.

5.1 Additional Configuration

Apart from the configuration given in section 5 of 'User Manual Oracle Banking APIs OBP US LZN Setup and Configuration' document, below table consists additional non-mandatory configuration for OBAPIs18.1.0.0.0 US LZN

- 'OriginationConfig' category id in DIGX_FW_CONFIG_ALL_B

Property Id	Description	Default Value
MARTICULAR_CONSULAR_CARD_EXPIRY_DURATION	This property contains maximum allowed expiry duration (in years) for Mexican CID card.	15
MARTICULAR_CONSULAR_CARD_MAX_LENGTH	This property contains maximum length allowed for Mexican CID card ID.	30
RESIDENT_STABILITY_MONTH_DURATION	This property contains minimum duration (in months) of Residence needs to be captured during the origination process.	12
SSN_MAX_LENGTH	This property contains maximum length allowed for the SSN.	10
STATE_ID_EXPIRY_DURATION	This property contains maximum allowed expiry duration(in years) for state ID card	15
STATE_ID_MAX_LENGTH	This property contains maximum length allowed for the State ID.	30

5.2 OBP Application Configurations.

Following maintenance/configurations should be done in OBP application.

5.2.1 Funding table template maintenance

This maintenance decides which all sections like LMI, Fees should be part of funding table.

5.2.2 Application level fees

This maintenance decides which all fees like 'Title Search fee', 'Registration fee' should be shown on application tracker and funding table.

5.2.3 Financial template maintenance

This maintenance decides which all income, expense, liability and asset should be visible as part of financial template. It is also used to decide the mandatory and non-mandatory options for income, expense, liability and asset.

6. Product configuration

To enable the products execute the following script.

```
Update DIGX_OR_PRODUCT_TYPE set STATUS = 'ACTIVE' where ID IN ('SAVINGSH1', 'CHECKINGH1', 'TERMDEPOSITH1', 'CREDITCARDH1', 'AUTOLOANH1', 'PERSONALLOANH1');
```

This will enable the savings, checking, term deposits, credit cards, auto loans and personal loans products.
