
Executive Summary

Preface

Oracle Financial Services Regulatory Reporting for US Treasury – Lombard Risk Integration Pack (OFS REG REP US Treasury) enables the banks to comply with TIC regulations. It provides integrating risk data reporting systems and enhances the accuracy of reporting in banks. OFS Risk Regulatory Reporting (RRR) helps in achieving the objectives by enabling preset steps based on the generalization of a set of solutions. This is made possible by:

- Providing a centralized data storage for risk data through relevant subject areas of Financial Services Data Foundation (FSDF).
- Interfacing with a Regulatory Reporting tool Lombard AgileREPORTER to build necessary template reports to meet the regulatory expectations.
- Managing accuracy of risk reporting through Data Governance Studio (DGS).

This document provides step-by-step instructions to install the Oracle Financial Services Regulatory Reporting for US Treasury – Lombard Risk Integration Pack (OFS REG REP US Treasury) Release 8.0.5.1.0 Maintenance Level (ML) release.

OFS REG REP US Treasury Pack Release 8.0.5.1.0

This Maintenance Level (ML) Release of OFS REG REP US Treasury – Lombard Risk Integration Pack is cumulative and includes all enhancements and bug fixes done since the OFS REG REP US Treasury – Lombard Integration Pack v8.0.5.0.0 release. For more information, refer the Oracle Financial Services Regulatory Reporting for US Treasury – Lombard Risk Integration Pack Guide – Release 8.0.5.1.0 on OHC.

Pre-installation Requirements

The prerequisite software that must be installed are:

- Oracle Financial Services Analytical Applications Infrastructure (OFSAAI) 8.0.5.1.0 (patch 27094265 plus mandatory consolidated one-off patch 27504805)
- Oracle Financial Services Data Foundation (FSDF) 8.0.5.1.0 (patch 27197750)
- Oracle Financial Services Regulatory Reporting for US Treasury Lombard Risk Integration Pack 8.0.5.0.0 (patch 27470634)
- AgileREPORTER version 1.15.8.2-b37
- AgileREPORTER Templates version ARforTIC_v1.0.0.2
- Ensure that you have executed .profile before you trigger the installation.
- Ensure that the FIC Server is up and running before you trigger the installation. For information on restarting the services, Refer Oracle Financial Services Advanced Analytical Applications Infrastructure Pack Installation Guide – Release 8.0.5.0.0 (OHC Documentation Library) for more information.

How to Apply This Maintenance Level Release?

To apply this maintenance release, follow the steps in <u>Installing OFS REG REP US Treasury 8.0.5.1.0 ML</u> and <u>Post-installation Steps</u> sequentially.

Installing OFS REG REP US Treasury 8.0.5.1.0 ML

Perform the following instructions to download, extract and install this ML patch:

- 1. Download the OFS_REG_REP_USTRE_8.0.5.1.0_GENERIC.zip archive file from https://support.oracle.com/ for patch 28040268 under the *Patches & Updates* tab.
- 2. Copy the archive file to your OFSAA server in **Binary** mode.
- 3. Shut down all the OFSAA Services except the FIC Server. For more information, refer to the Start/Stop Infrastructure Services section in <u>Oracle Financial Services Advanced Analytical Applications Infrastructure Pack Installation Guide Release 8.0.5.0.0</u>.

NOTE: Ensure that the **FIC Server** is up and running.

- 4. Execute chmod -R 750 \$FIC_HOME
- 5. If you have an Unzip utility, skip to the next step.

Download the Unzip utility (OS specific) unzip_<os>.Z from the location https://updates.oracle.com/unzips/unzips.html and copy it in Binary mode to the directory that is included in your PATH variable, typically \$HOME path or directory in which you have copied the 8.0.5.1.0 ML.

Uncompress the unzip installer file using the command:

uncompress unzip_<os>.Z

NOTE: If you notice an error message "uncompress: not found [No such file or directory]", contact your UNIX administrator.

- 6. Execute chmod 751 OFS REG REP USTRE 8.0.5.1.0 GENERIC.zip
- 7. Execute unzip -a <name of the file to be unzipped>
 For example: unzip -a OFS REG REP USTRE 8.0.5.1.0 GENERIC.zip
- 8. Configure UPLOAD_MODEL parameter in the param.conf file present under the OFS_REG_REP_USTR/conf directory to determine if Model Upload is required or not:
 0 = If you have already performed Model Upload and want to skip Model Upload process
 1 = If you want to perform Model Upload
- 9. Navigate to OFS REG REP USTR/bin directory and execute ./install.sh
- The installation progress can be viewed by periodically refreshing the log file under the OFS REG REP USTR/logs directory.
- 11. After installation is completed, verify the log file for any Errors or Warnings. Contact My Oracle Support in case of any issues.

NOTE: This patch installation has taken approximately 35 minutes to complete in Oracle Labs.

Post-installation Steps

Perform the following instructions after successful installation of the 8.0.5.1.0 ML patch:

- Refer to the log file in the /OFS_REG_REP_USTR/logs directory to ensure that there are no errors reported.
- Restart all the OFSAAI Servers. For more information, refer to the Start/Stop Infrastructure Services section in <u>Oracle Financial Services Advanced Analytical Applications Infrastructure Pack Installation</u> <u>Guide – Release 8.0.5.0.0</u>.
- Execute the following batch to Re-save the Derived Entities EXCEPT the following batches:
 - <<infodom>>_reg_rep_ustre_de_resave
- Execute the following batch:
 - O <<INFODOM>> USTRE RUNEXE RESAVE

Deploying Lombard AgileREPORTER Package Configuration

After saving the derived entities, proceed to deploy the product configuration on the Lombard AgileREPORTER using the OFSAA_REG_REP_USTRE_8.0.5.1.0.zip file bundled inside Config Package directory (OFS REG REP USTR\Config Package\) of the installer.

Refer to the *Lombard AgileREPORTER Installation Guide v1.15.8* document to deploy Product Configuration on Lombard AgileREPORTER.
