

Textura Payment Management v22.11 Release Notes

What's New in This Release?

The Textura v22.11 release includes improvements to the user interface, new functionality, and numerous bug fixes.

Below is a summary of the overall changes:

- Google Chrome Support Ending for Windows 7 & 8.1
 - With the release of Chrome 110 (tentatively scheduled for February 7, 2023), Google will officially end support for Windows 7 and Windows 8.1. You'll need to ensure your device is running Windows 10 or later to continue receiving future Chrome releases.
 - Older versions of Chrome will continue to work, but there will be no further updates released for users on these operating systems. If you are currently on Windows 7 or Windows 8.1, we encourage you to move to a supported Windows version before February 2023 to ensure you continue to receive the latest security updates and Chrome features.
- Documents notarized by users commissioned in the State of Arizona now have the ability to display the notary seal.
- An administrative task now appears for Enterprise and Local Admins to update their organisation's ethnicity.
- Data Service has been updated to include additional columns for Contracts and Change Orders.
- For Projects located in Alberta, Canada, the system will now provide Alberta Form 2 and Alberta Form 3 documents to support Alberta Prompt Payment regulation.
- The Security of Payments (SOP) Act name now dynamically appears on documents based on the project site location.
- Numerous bugs have been fixed in this release.
