

Textura Payment Management v22.4 Release Notes

What's New in This Release?

The Textura v22.4 release includes improvements to the user interface, new functionality, and numerous bug fixes.

Below is a summary of the overall changes:

- Web help is now available via an in-application tray. Users will experience less navigation and better help context.
- Project Managers are now able to delete subcontracts.
- Enterprise Classification Tracking now opens via an in-application tray and contains numerous enhancements.
- A new Enterprise Classification Tracking report is available to Main Contractors for reporting diverse spend for a defined period of time.
- Coming Soon has been renamed to 'Connect With Us' in the help menu.
- Textura Payment Accelerator now supports system-generated subcontractor emails in French.
- Access to inactive projects has been improved for users.
- Service Requests now open via in-application tray that slide in from the right.
- Textura Payment Accelerator data has been added to Data Service for Main Contractors to access.
- Numerous bugs have been fixed in this release.
