1 Features and Updates

The following sections contain a list of updates for all modules of Suite8 and the XML Interface.

Cashiering

Charge It

Direct payment against article postings is now available via the **Charge It** feature. It is now possible to pay for articles directly by cash, credit cards and vouchers in addition to posting them to the room.

The functionality is only available when the global setting Charge It - Enable Direct Article Payment under **Setup > Configuration > Global Settings > Billing > Billing > Billing 3** is activated.

Central Reservation System (CRS)

You can now use the guest anonymization feature for Hotel Connector and CRS. Anonymization is handled and configured in Partner and Master independently.

A periodic reminder can be set in Master to run anonymization process.

Manual anonymization in Partner will trigger question if should be anonymized in Central too. If so the profile will be set to ASAP in Central and anonymized once no subscription to other hotels exist.

Configuration

Statistics

You can now configure seasons so that statistical reports can be reported against seasons. A season is a period identified by a start date and an end date.
 Season Type and Season Detail has been added to Suite 8 configuration under Setup > Configuration > Common Functions > Statistics > Seasons.

This can be enabled by activating the feature control **Season Statistic Configuration** and enabling the global setting **Season Statistic Configuration** in **Global Settings** > **Generic** > **Generic** 4 **screen**.

A season type and associated season details along with start and end dates and active/inactive status can be added and modified. They are stored in SETT and SEDE tables respectively and can be used for statistical purposes.

POS8

 You can now reorder an existing posted item on the check by clicking the reorder button.

Features and Updates 1-1

- In case a hard posting done is voided, the system will now prompt for a reason
 if the parameter Item Void Reason is set to yes. The adjusted report
 FCR_POS_92500_CANCEL_REPORT.rpt includes also the void reason.
- An override mechanism to void hard posted (saved) items on a check is available now. If a waiter does not have the right to void saved items, the system will prompt for manager override. On entering the manager credentials, the item will be voided and the user can continue operations without having to log in again.
- You will now be able to add the Report path setting to posback > edit system parameters > Interfaces.
- Profile integration with POS 8 is now more stable in the following ways:
 - a. A flag (C) for a company profile and (G) for a guest profile is now displayed against the profile when a guest profile search is done.
 - b. A flag (R) for Room and (FA) for Financial Account is now displayed against the guest profile when a guest profile search is done depending on if the guest is checked into a room or if only financial account is associated with the guest.
 - c. A company can now be added to a guest profile successfully.
 - d. Adding more than one profile to a table reservation is now supported.

Profiles

Profiles with open leisure activities will not be anonymized.

Reservation

The UI of the room move reason screen is modified to improve usability by reducing multiple clicks and by merging the two screens to a single screen.

Bed Management

- In reservation search grid the room and bed numbers are now displayed when there is just one room or bed assigned. In case of multiple guests with different rooms or beds assigned, text Multiple **Rooms** or **Multiple Beds** is displayed.
- A red indicator is now shown on the bottom of the reservation screen if there is a scheduled bed move for today, which is not performed.
 On clicking the button Guest at the bottom or by selecting the Profiles tab and choosing to display Room in the guest grid, scheduled bed moves are displayed in red font. In the column Room/Bed, the current room/bed is displayed in brackets []. After the bed move is performed, the red indicator and the red font in guest room grid disappears.
- When you disable the Bed Management Feature in global settings, a new checkbox Bed Management Display is displayed. This new flag must be checked to see bed reservations in the reservation grids. Note that these reservations are read only and if they need to be edited, bed management feature must first be activated and the bed reservations must be changed to room reservations.

1-2 Features and Updates

- A new report **B4548 Open Balances per guest** is available now. The new views V8_REP_OPENBALANCES_BM, V8_REP_OPENBAL_PERGUEST_BM, V8_REP_OPENBAL_ROOMANDBED are added to support this report.
- New database views to support packages per guest reports and detailed info per day per guest are available now e.g. V8_REP_PACKAGES_PER_GUEST (and related).
- A new attendant report for Bed Management is available now. The report layout
 and content is similar to the Housekeeping attendant screen under Rooms
 Management > Attendants. Amenities are taken from reservation settings.
- New views have been created to provide data for history and forecast statistic reports for bed management. The views are named as per examples below:
 V8_STAT_FOR_SOURCE_DAY_BED = daily source code forecast
 V8_STAT_SHIS_SOURCE_MONTH_BED = monthly source code history

Spa and Leisure

If a guest is set to be anonymized, with bookings still existing in the future, the button **Anonymize** now changes to **Cancel Anonymization**. You can now remove this guest from being anonymized automatically.

Online Interface

- Seekda mapper has been renamed to Kognitiv mapper as the name of the company
 has changed. When updating an existing Seekda installation, you need to run the
 Online Interface installshield, select the option 'Add new mapper', then choose the
 new Kognitiv mapper and enter the same hotel code that is used in the existing
 Seekda installation. The installshield will then create the new Kognitiv mapper
 using the existing Seekda settings so that it is not needed to configure the
 conversion and other settings again.
- It is now possible to limit the number of log files generated by the Online Interface monitor. On the monitor **Global Settings tab** in the field **Number of backup log files** you can specify how many log files should be generated. Once the maximum number of log files is then reached, the oldest log files will be recycled.

CCM

You can now add hourly and flat rates to events in addition to per person rate in package configuration.

webConnect

- Google analytics/ Google add words are now supported. This google service allows
 to monitor webConnect and to give the customer information about the revenue,
 number of bookings, use behavior etc.
- Deposit payments via a credit card in web connect is now supported. When a credit
 card payment is processed in web connect > CCM for an advance deposit, the
 deposit posting will be done on an automatically created FA for the department
 code added in the CCM section of the home page setup. An automatic invoice based

- on the report template specified in global settings > advanced deposit will be printed after the payment posting. Upon check in of the financial account the revenue part of the deposit will be reverted.
- CCM Web Connect now supports packages having events setup with different rate types such as per person, by hourly and flat rates.
- You can now configure sub events for webConnect.
- You can see now rate breakdown of the events and sub events included in the package by clicking on the **Show More** button in package search result screen.

Miscellaneous

- A new attribute **<gastart>** is added to the generic guest data interface XML output file for FERATEL. A new setup field **<**SendGastArt>1**<**/SendGastArt> is added to "Interface Config" to activate or deactivate this attribute.
- A new attribute Company Code is added to the generic guest data interface for FERATEL. This is used to identify Suite8 during login process. User and password is no longer be used in the URL. The data input value is hidden by ***. Two new setup fieldsare added in "Interface Config":
 - <AddPMSImportNode>1</AddPMSImportNode> adds a new group to the xml file <SendCompanyCode>1</SendCompanyCode> adds the new companyCode value to the new group-node in the xml file.

If the guest data interface is used for other provider than Feratel,

AddPMSImportNode and SendCompanyCode can be disabled by changing the value to 0.

Cashiering	27946067	While emailing a folio from a billing window associated to a company profile, you can now select the email address of either the contact profile attached or the company profile.
Catering & Conference	27810953	When resources/miscellaneous items that do not have a valid rate for the given date are added to the event, you will be informed that no valid rate exists for the item for the given date and then given an option to add the item after entering the price at his discretion.
	27343473	For conference participants having reservations, no additional FA account will be created. During manual conference posting, the posting button will open the billing screen of the reservation for manual posting. Automatic package posting will also post to the reservation if it exists.
Bed Management	27551532	You cannot change a room reservation to a bed reservation anymore if the number of persons are different during the stay. Number of persons must be the same for the whole stay for bed reservations.
Configuration	27164935	The package loading has been refactored to only download package header information and load details only when an item is selected in the tree to avoid query result sets to be truncated.
CRM	25801084	You will now be able to send emails directly from the HTML in the lower part of the profile screen to the email address defined in the communication.
webConnect	28364560	Support has been added for TLS 1.2. Some payment providers like nets payment and pay pal no longer support TLS 1.1.
	28324054	If a payment has been cancelled in Home Page, The shopping cart items are not duplicated if the payment process is executed again.
Miscellaneous	27620433	The Oracle Maintenance Job installation is now working properly again using the Suite8 Install Shield.
	27165055	Refactoring and Optimization of Freports and FreportsBinary screens is done to avoid result cap issue. Loading of sections, reports, binaries (on freportbinary) are now significantly faster. More filtering options, better screen refresh and sorting by list view columns or display order.
