# Introduction to Oracle Insurance IFRS 17 Analyzer Application Pack

IFRS17 is an international norm that supersedes the current reporting standards, IFRS 4. The new standards provide the users of financial statements with a new perspective of the financial accounts of insurance companies.

## 1.1 Overview

Insurance companies need to identify the risks that arise from the insurance contracts along with the calculation of assets and liabilities. IFRS 4 was introduced in March 2004 and was intended to provide limited improvements to accounting for insurance contracts. IFRS 4 permitted companies to continue previous accounting practices for insurance contracts, but did enhance the disclosure requirements.

IFRS17 standards, released in May 2017, supersedes the current reporting standards IFRS 4 on accounting for insurance contracts and has an effective date of 1 January 2021. The new standards provide users of financial statements with a new perspective of the financial accounts of insurance companies. IFRS 17 introduces an approach that tackles some challenges in accounting for insurance contracts currently addressed inconsistently when a company applies IFRS 4.

- IFRS 17 provides updated information about the obligations, risks, and performance of insurance contracts.
- Increases transparency in financial information reported by insurance companies, which will give investors and analysts more confidence in understanding the insurance industry.
- Introduces consistent accounting for all insurance contracts based on a current measurement model.

## 1.2 Why Oracle Insurance IFRS 17 Analyzer?

Oracle Insurance IFRS 17 Analyzer application follows the IFRS 17 standards diligently and enables insurance companies to adhere to the disclosure requirements as proposed under IFRS 17, along with an ability to compute Contractual Service Margin and Net Liabilities.

IFRS 17 requires Insurance companies to have consistent accounting standards for the Insurance contracts which ensures timely recognition of losses in the book of accounts. Insurance companies are required to identify and report the Fulfillment Cash Flows and Contractual Service Margin at every reporting date, based on the current market conditions. Oracle Insurance IFRS 17 Analyzer application helps the organizations in arriving at the insurance obligations (Insurance Contract liabilities reported on the balance sheet), using different methodologies for a set of portfolios, by assessing the net liability for every insurance contract.

IFRS 17 standard requires the entities to perform initial recognition of insurance contracts and execute periodical re-assessment of the insurance liabilities, based on the current assumption sets. The insurance liabilities are presented in every reporting period and those reflect the change in the amount since inception. The profitability of insurance contracts is amortized for the contract, based on the services provided. One of the critical requirements of IFRS 17 is to estimate the measurements at the most granular level, rather than at the aggregated portfolio level. Groups are formed with a portfolio to reflect the insurance contract that shares similar risks. The financial report separately showcases the asset and the liabilities of the groups of contracts. This primarily involves showcasing the insurance and finance results separately per insurance groups.

## 2.1 Pre Installation Requirements

Following are the Pre Installation Requirements of Oracle Insurance IFRS 17 Analyzer Pack release 8.0.8.1.0:

- The minimum patch set level should be 8.0.8.0.0
- For details about configuring the Oracle Database Release 19c Server and Client for existing installations of OFSAA running Oracle Database Release 12c Server and Client, see the MOS Doc ID: 2699715.1.
- OFS IIA application is compatible with WebLogic 12.2.x and does not support WebLogic 12.1.3. If the WebLogic version is 12.1.3, upgrade to WebLogic 12.2.x.
- Enable the unlimited cryptographic policy. By default, JCE Policy JAR files are available for the Java versions mentioned in the following link and for later versions:

For Java versions, where unlimited cryptographic policy is not enabled by default, perform the following steps:

1. Download the JCE Policy related JARs: **local\_policy.jar** and **US\_export\_policy.jar**.

2. Copy (or replace) the downloaded JCE Policy related JARs, **local\_policy.jar**, and **US\_export\_policy.jar**, into the /jre/lib/security folder of Java installation directory used for OFSAAI and the web application servers.

## 2.2 How to apply this Patch?

This section explains the installation process of this patch.

### 2.2.1 Installing Oracle Insurance IFRS 17 Pack

Refer to the following instructions to download, extract, install, and configure this patch:

1. Login to <https://support.oracle.com/> and search for **30146039** under the *Patches & Updates* tab.
2. Download the OFSAA 8.0.8.0.0 IIA ML RELEASE #1 archive file and copy it to your OFSAA server in Binary mode.

**Note:** There are different archive files for different operating systems such as AIX, Solaris, and RHEL/OEL.

3. Stop all the OFSAAI services. For more information, see the **Start/Stop Infrastructure Services** section in Oracle Insurance IFRS 17 Pack Installation Guide Release 8.0.8.0.0.
4. Login to the OFSAA server as a non-root user and navigate to the \$FIC\_HOME folder.
5. Assign WRITE permission to the file/folders such as commonscripts, EXEWebService, ficapp, ficweb, and ficdb in the \$FIC\_HOME folder by executing the command:  
**chmod -R 775 \***
6. If you have the Unzip utility, skip to the next step or download the Unzip utility (OS-specific) and copy it in Binary mode to the directory that is included in your PATH variable, typically \$HOME path or directory in which you have copied the 8.0.8.1.0 ML.
  - Uncompress the unzip installer file using the command:

**uncompress unzip\_<os>.Z**

**Note:** If you notice an error message "**uncompress: not found [No such file or directory]**" when the package is not installed, contact your UNIX administrator.

7. Give EXECUTE permission to the utility using the command:  
**chmod 751 unzip\_<os>**
8. Extract the contents of the 8.0.8.1.0 ML archive file using either of the following commands:  
**unzip <name of the file to be unzipped>**

9. Update the params.conf file present in the OFS\_IIA\_PACK/OFS\_IIA/conf folder. You must set the value for the tag UPLOAD\_MODEL to 1 to upload the data model that comes with installer. The additional update instructions are present in the file(params.conf).

To download the Data Model Erwin file, Login to <https://support.oracle.com/> and search for 30450474 under the Patches & Updates tab. If customization to the data model has been done in environment being upgraded, then before uploading the same, customizations need to be applied again in merged data model.

If you do not have permissions to create new folder for backup, then provide an alternate location as value for BACKUP\_LOCATION tag in **params.conf** file, present in OFS\_IFRS\_PACK folder.

In case of customized datamodel upload, then update the params.conf file present in the OFS\_IFRS\_PACK/OFS\_IFRS/conf/ folder accordingly.

10. Give EXECUTE permission to the ML patch installer script. Navigate to the folder OFS\_AAI and execute the command:

```
chmod 755 OFSAAIUpdate.sh
```

11. Execute the following command:

```
./OFSAAIUpdate.sh
```

12. Verify if the ML is applied successfully by checking the log files generated in OFS\_IIA\_PACK/OFS\_IIA/logs and OFS\_IIA\_PACK/logs folders. You can ignore ORA-00001 and ORA-02292 in the log file. In case of any other errors, contact Oracle Support.

**Note:** If any applications are installed on top of the OFS AAI Application Pack 8.0.8.0.0 version, execute the update\_dq\_batches\_optional\_params.sql script, which is available in \$FIC\_HOME/Post\_AAI\_Migration folder, after the installation of the applications.

13. Post successful installation of the ML, perform the following steps:

- Clear the application cache. Navigate to the following path depending on the configured web application server and delete the files.

**Tomcat:** <Tomcat installation folder>/work/Catalina/localhost/<Application name>/org/apache/jsp

**Weblogic:** <Weblogic installation location>/domains/<Domain name>/servers/<Server name>/tmp/\_WL\_user/<Application name>

**Websphere:** <Websphere installation directory>/AppServer/profiles/<Profile name>/temp/<Node name>/server1/<Application name>/<.war file name>

14. Delete the existing EAR/WAR file available in the folder \$FIC\_HOME/ficweb.
15. Generate the application EAR/WAR file and redeploy the application onto your configured web application server. For more information on generating and deploying the EAR/ WAR file, refer to the Post Installation Configuration section in Oracle Insurance IFRS 17 Pack Installation Guide Release 8.0.8.0.0.
16. Restart all the OFSAAI services. For more information, refer to the Start/Stop Infrastructure Services section in Oracle Insurance IFRS 17 Pack Installation Guide Release 8.0.8.0.0.

## 2.3 Post Installation Configurations

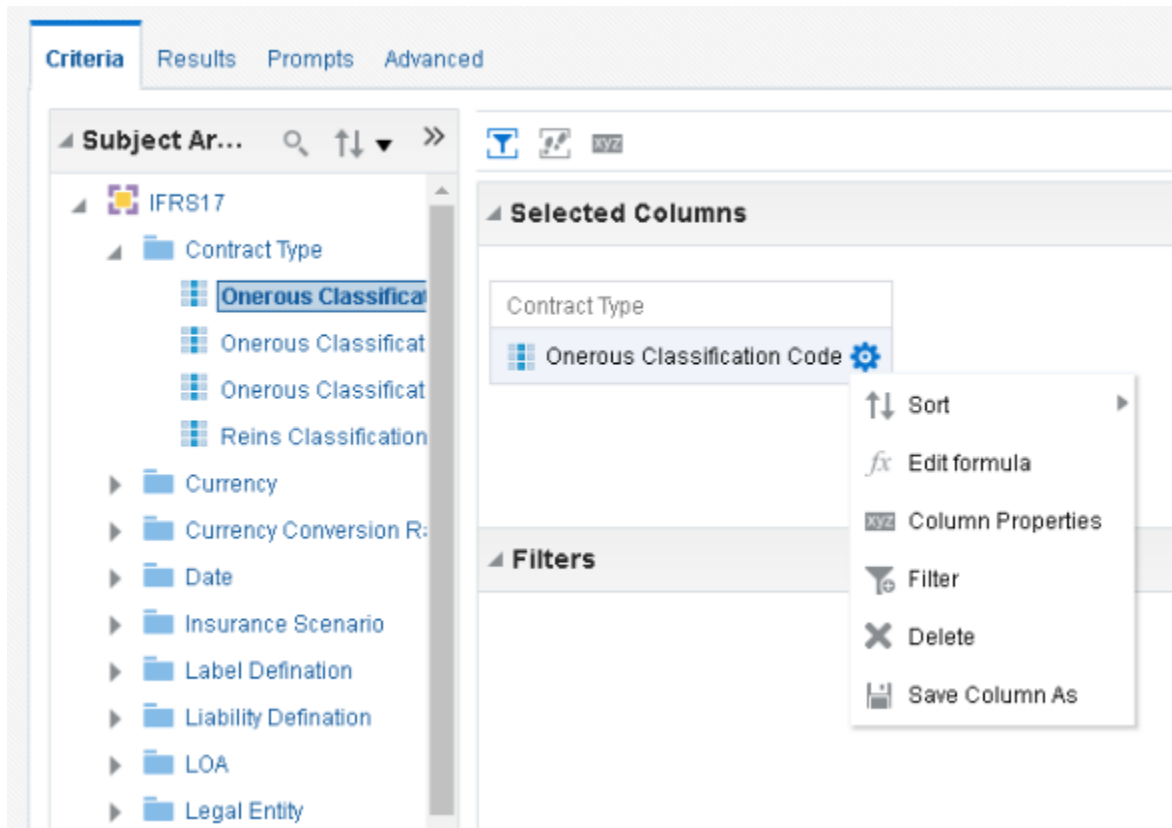
### 2.3.1 Creating Global Variables for OBIEE

To create the global variables for OBIEE, in this release of IIA application, perform the following procedure:

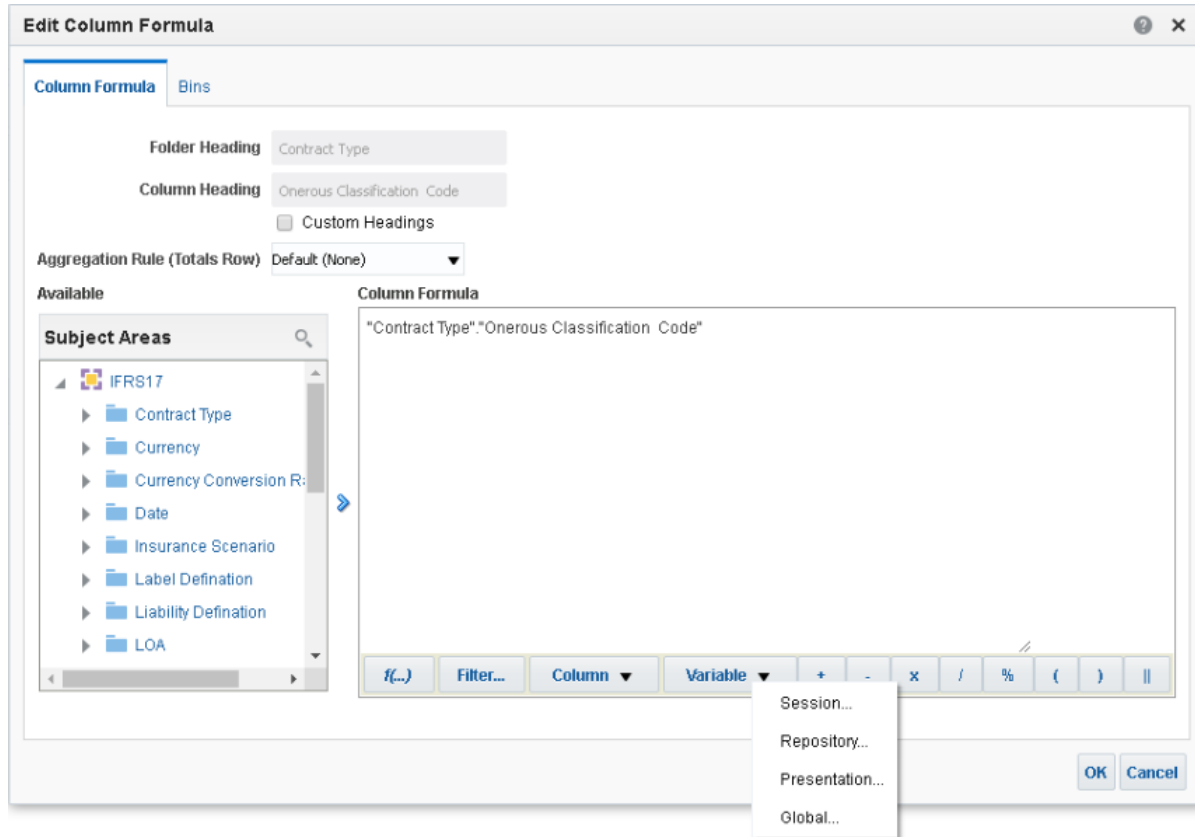
1. Host the RPD and Catalog for IIA solution as part of this release.
2. Log in into OBIEE/analytics using the application URL.
3. Click the **Analytics** link.



4. Click and select the subject area as **IFRS17**.  
The subject area details are displayed.
5. Expand a folder and double click on any column from the subject area.
6. Click **Edit formula**.



7. Click the *Variables* tab and select **Global** from the menu.



8. Create a global variable with the following details:

- **Variable Name:** denomination

**Value:** case when '@{denomination}{in thousand}' = 'in thousand' then 1000 else 1000000 end

**Type:** Text

This variable is used to divide all amount values by thousand or million, depending on the selected criteria.

### 2.3.2 Configurations to Enable DELETE Functionality in LOB and Geography Dimensions

To enable DELETE functionality of members in LOB and Geography dimensions, perform the following procedure:

1. Edit the file **AMHMConfig.properties** present in the conf or folder of the deployed path.
2. Add the following entries:
  - MEMBER\_DEL-<<INFODOM>>-<<Dimension id of Geography>>=Y
  - MEMBER\_DEL-<<INFODOM>>-<<Dimension id of LOB>>=Y

For example: MEMBER\_DEL-OFS081223INFO-2002=Y

### 2.3.3 Update the web.xml

Update the value `/*` in the following script, with a value which will not be present in a URL.  
For example: `<url-pattern>/xyz</url-pattern>`

```
<filter-mapping>
<filter-name>FilterServlet</filter-name>
<url-pattern>/*</url-pattern>
</filter-mapping>
```

### 2.3.4 Mapping Batches to User Groups

You need to map the IIA Batches to corresponding User Groups, in which the user is mapped.

### 2.3.5 Update excludeURLList.cfg for Calculation Preference Definitions

Ensure that you perform the following before creating Calculation Preference definitions.

1. Locate the **excludeURLList.cfg** file present in `webroot/conf/` folder.
2. Remove the additional space present at the end of the following entry:
  - `[SQLIA]./iiaService/calculationController/save`
3. Save the changes and restart the webserver.
