It provides comprehensive state-of-the-art data management capability to manage customer data. It has the capability to support different types of party roles and their relationships. It maintains party data for all entities that interact with the bank including associates and service providers.

Oracle Banking Party Management has a comprehensive Single Party View for all data and information related to the party. This helps in driving operational efficiency by providing a 360 degree view of the party.

Oracle Banking Party Management provides highly comprehensive financial data management capabilities. It captures and maintains party's financial information which can be used during application processing. It has a detailed setup mechanism which helps banks maintain their financial parameters and various statement templates. Financial data can be captured for multiple years. Break-up of some of the financial parameters can also be captured.
