Trading platform enables trading of syndicated loans and keeps track of position and balances of different portfolios of bank.

Bilateral Loans

Empowers financial institutions of varied sizes to offer and manage complex commercial loan products catering to large corporate and SMEs. Product manufacturing enables the bank to create innovative products, cuts down time to market and respond to competition efficiently and effectively. Rule driven delinquency handling provides better control over stressed loan assets enabling timely action.

Syndicated Loans

Empowers large multinational banks and Financial Institutions to structure complex syndicated loans under three tier architecture. 1.5 Enhancements to the Existing Modules

1.5.1 Loans – Computing Financial Operation Tax

Financial operation tax is also termed as 'IOF' in Portuguese, which can be calculated at the time of contract booking, loan late payment, VAMI principal increase and Rollover are collected in the following ways

- Collected as Advance type
- Capitalized with Principal

1.5.2 Loans - Multi-level Authorization

You can do multi-level authorization when transaction amount goes beyond the transaction limit specified, this can be done through the following:

- Transaction limit
- User limit
- Combination of Transaction limit and User limit.

1.5.3 Loans – Manual Disbursement

- Product configuration for auto and manual disbursement products
- Scheduled auto-disbursements
- New screen for manual disbursements

1.5.4 Loans – Grace Period Compounding

Moratorium period is also termed as payment holiday period, where no payment is allowed during this period, however interest calculation happens with moratorium interest rate. This can be collected in the following ways.

- Liquidate immediate
- Liquidate with first instalment
- Liquidate across schedules
- Capitalize with principal

1.5.5 LS – Straight Through Processing Support for Reversal Transactions

Support enabled for payment reversal transactions initiated in the syndications module to be replicated to the loans module without manual intervention.

1.5.6 Loans - Discounted Loan Products

- Interest schedules for discounted loan products
- Support for life cycle events like prepayments, value dated amendments, rate revisions, roll-over and re-pricing

1.5.7 Upload Templates for OL, Subsystems, LS, and SLT

Data to be uploaded in the upload tables using files like Excel /CSV files for the following function ids.

- FCDTRONL,
- LBDTRONL,
- LBDDDONL,
- OLDTRONL, and
- LBDINSTR

1.5.8 OBCL-OBDX Integration - Web Service for Loan Details

Integration with OBDX to provide loan details for a customer, accounting entries for a loan, and interest details of a loan

1.5.9 LS - Product-wise, Currency-wise, and Borrower-wise Limit

- Define sublimit specific to a currency for specific borrower products
- Define sublimit for all LC products .One borrower sublimit should be tracked against all LC

1.5.10 LS and Loans - RESTful Web Services

RESTful Web services are supported for OBCL (OL and LS).

1.5.11 LS - Agreement Details

- Additional fields to store agreement related information for a syndication deal
- Data storage enabled at a syndication facility and tranche level
- Support available for data modification at a later stage during the life cycle

1.5.12 LS– Bankers’ acceptance for True Discounted Loans

- Enhancements to support Banker’s Acceptance – True Discounted Loans for syndication and loans module.
- Interest and discount computations for the loan tenor is done upfront and recovered from the borrower during disbursement.
- Participant accounting for syndication is carried out as per the respective asset contributions.
- Straight through processing to the loans module takes place for the self-participant contribution.

1.5.13 Loans Syndication – Fixed rates

- Support for Penalty for non-payments for fixed user input rates
- Margin and Spread features enabled for fixed user input rates
- Straight through processing enabled for equivalent changes in the loans module
