## About this Release

## Pre-requisites

Before installing this patch, ensure that Oracle Utilities Testing Accelerator v6.0.0.0.1 is installed.

Before using the components in the this product pack against an existing Oracle Utilities Customer Care and Billing v2.5.0.1 application, make sure that the following patches are applied.

- 22955243: Ability to provide input to additional fields for automation testing.
- 23279058: Automation testing related changes.
- 24502590: Create business service for Account Update/Read functionality.

## Patch Contents

The Oracle Utilities Testing Accelerator v6.0.0.0.1 Patch 28941451 includes the Oracle Utilities Customer Care and Billing v2.5.0.1 media pack.

## New Product Packs

### Oracle Utilities Customer Care and Billing v2.5.0.1

Oracle Utilities Testing Accelerator for Oracle Utilities Customer Care and Billing is a test starter pack built on top of Oracle Utilities Testing Accelerator that generates test automation scripts for Web services using Oracle Workbench.

This release includes seven sample flows used to understand the flow creation process.

- C1-StartService  
Creates a meter/meter configuration, meter read, pending start SA, and completion of the start service FA before the SA is activated.
- C1-StopService  
Initiates a 'stop service' request. As part of the full 'stop service' flow, steps for creating a final meter read and completion of the stop service FA are included.
- C1-CreatePaymentEvent  
Creates a payment event, and then distributes and freezes the payments.
- C1-CreatePremiseAndAccount  
Creates a premise, service point, person, and account; collectively referred to as “V” objects.
- C1-CreateBill  
Generates, freezes, and completes a bill. It uses the C1-BillAdd and C1-BillUpdate components, and an additional F1-SendResultsMail component to be able to notify the user of the test results via an email.
- C1-EndToEndStartService  
Creates a premise, service point, person, and account, collectively referred to as “V” objects. It also creates a meter, meter configuration, and meter read, and starts a service agreement. All pending field activity created by start/stop are also completed before activating the service agreement.

- C1-CloudSanity

Creates a person and then submits a VAL-PER batch.

**Note:** Create the timezone first manually to proceed.

## Upgrading from Oracle Utilities Customer Care and Billing v2.4.0.3

Use the **CM Content Upgrade** feature of Oracle Utilities Testing Accelerator to migrate/upgrade the custom components and flows from Oracle Utilities Customer Care and Billing v2.4.0.3 to Oracle Utilities Customer Care and Billing v2.5.0.1.
