## 2. Steps to add new table for purging

1. Create history table for table to be purged  
E.g. created history table for audit log – DIGX\_AUDIT\_LOGGING\_HIST.sql
2. Write database function to do purging for table data, i.e. to insert data in history table and delete data from actual table based on date or you can add your own condition in where clause.  
E.g. create database function for audit log – AP\_DIGX\_AUDIT\_LOGGING.sql

3. Generate seed entry for DIGX\_PU\_SHELL\_PARAMS –

Following are some important columns:

**COD\_PURGE\_ID:** unique value in table and specify sequence of purging activity

**NAM\_PURGE\_TBL:** Name of table to be purged

**FRQ\_PURGE:** specify time duration of purging .when again the purging activity will take place.

E.g. if it is 1 then next day purging will take place, if it is 2 than after 2 day activity will take place

**PERD\_RETENTION:** Up to what date the data should be retained in actual table

E.g. if it is 15 then current date - 15 days = date up to purge

Up to that date the data will be present in actual table and previous data will be moved to history table

**NAM\_PURGE\_PROC:** Name of database function which is responsible to do actual purging activity for this table (or related tables).

E.g. AP\_DIGX\_AUDIT\_LOGGING.sql

**DAT\_LAST\_PURGE:** Indicates when last purging occurred.

**DAT\_NEXT\_PURGE:** Indicates when next purge will occur.

**DAT\_PURGE\_UPTO:**-Gives information about date up to which data has been purged.

**TYP\_PURGE:**-It specifies purge type i.e. if purge type is 'T' then whole data will get deleted without backup and if type is 'S' then it will call appropriate database function which we have maintain in NAM\_PURGE\_PROC column .

**MODULE\_ID:**-Specify purging is for which module

E.g. Framework – FW, Payment – PY etc.

4. Set BATCH\_START\_SEC, BATCH\_START\_MIN, and BATCH\_START\_HOUR for batch scheduler in digx\_fw\_config\_all\_b table.

5. After batch execution, following tables should get updated:
  - digx\_bt\_job\_category\_master
  - digx\_pu\_shell\_params
  - digx\_pu\_statistics
  
6. WebLogic setup:
  - Deploy BatchResourceAdapter.ear on managed server.
  - Create new non XA data source named "BATCH" for purging and do necessary changes in persistence.xml and jdbc.properties files.
  - Restart the managed server.
