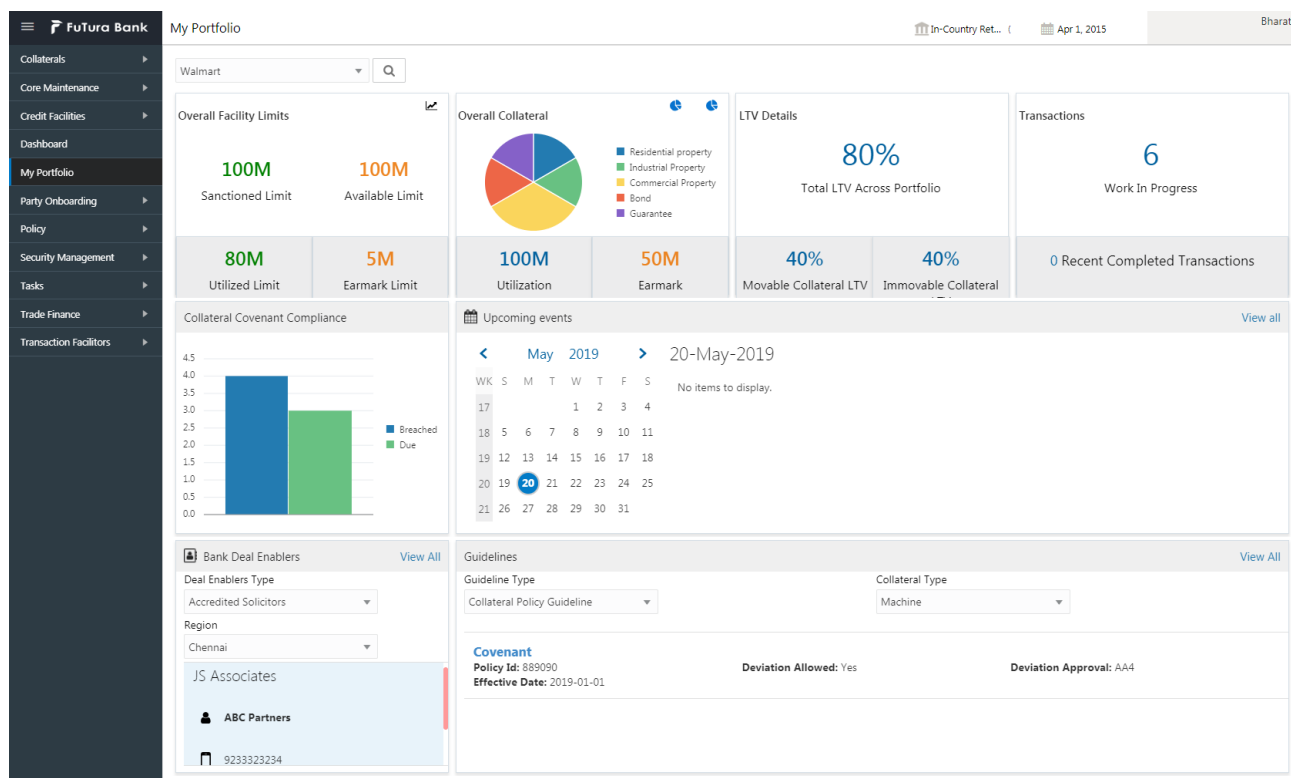
## 2. Collateral 360 Degree View

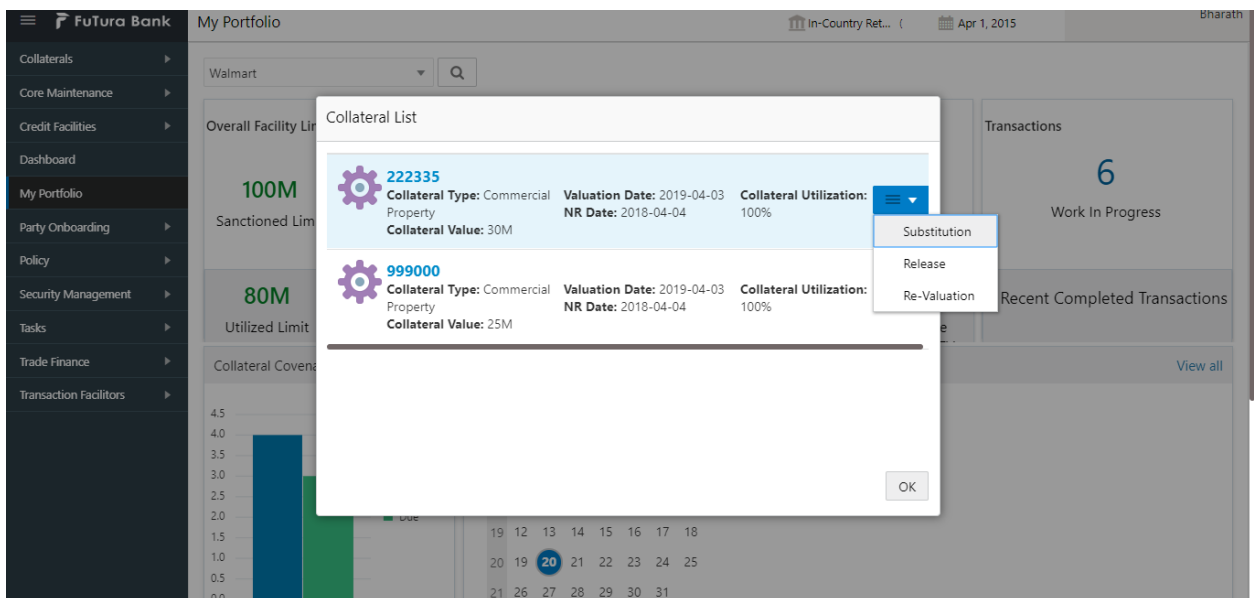

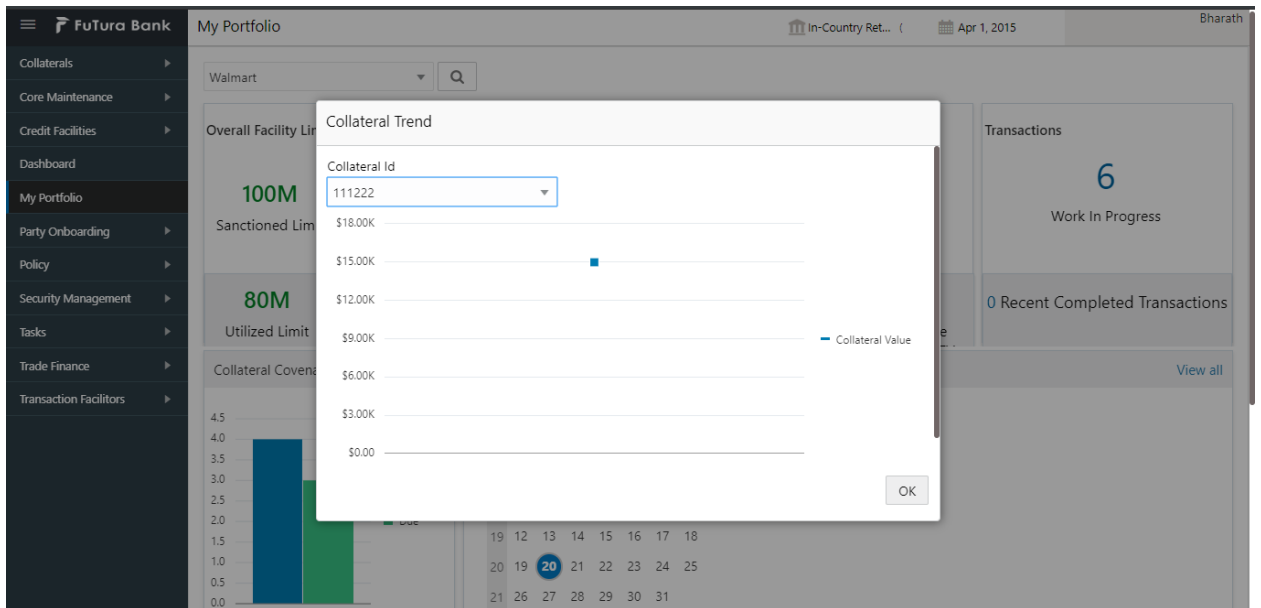

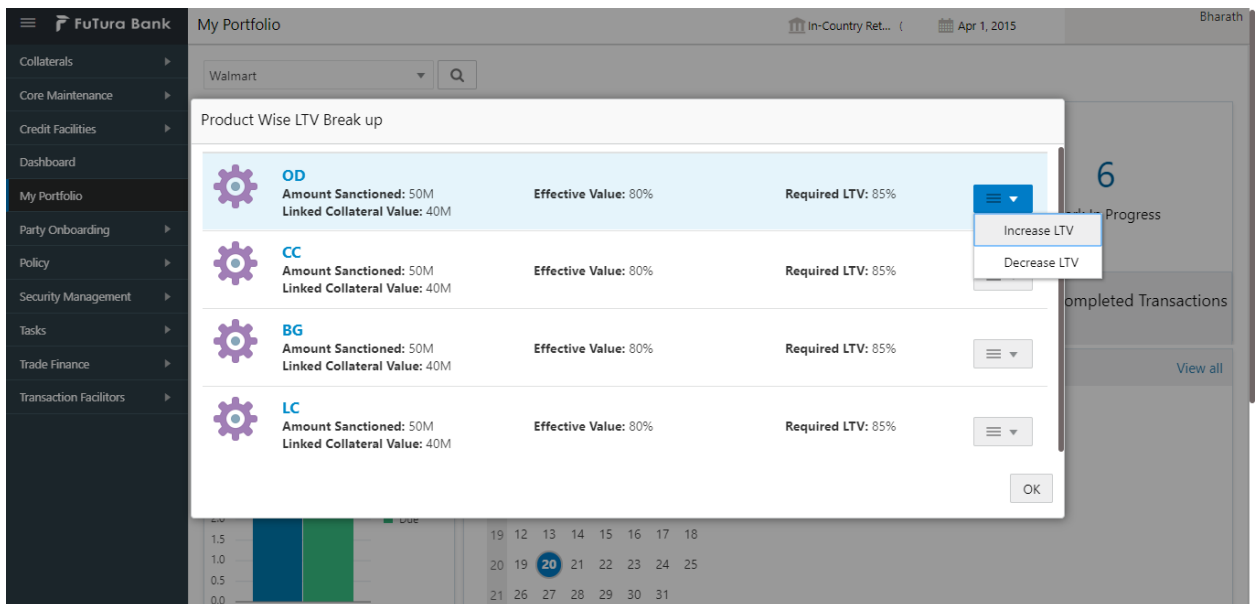

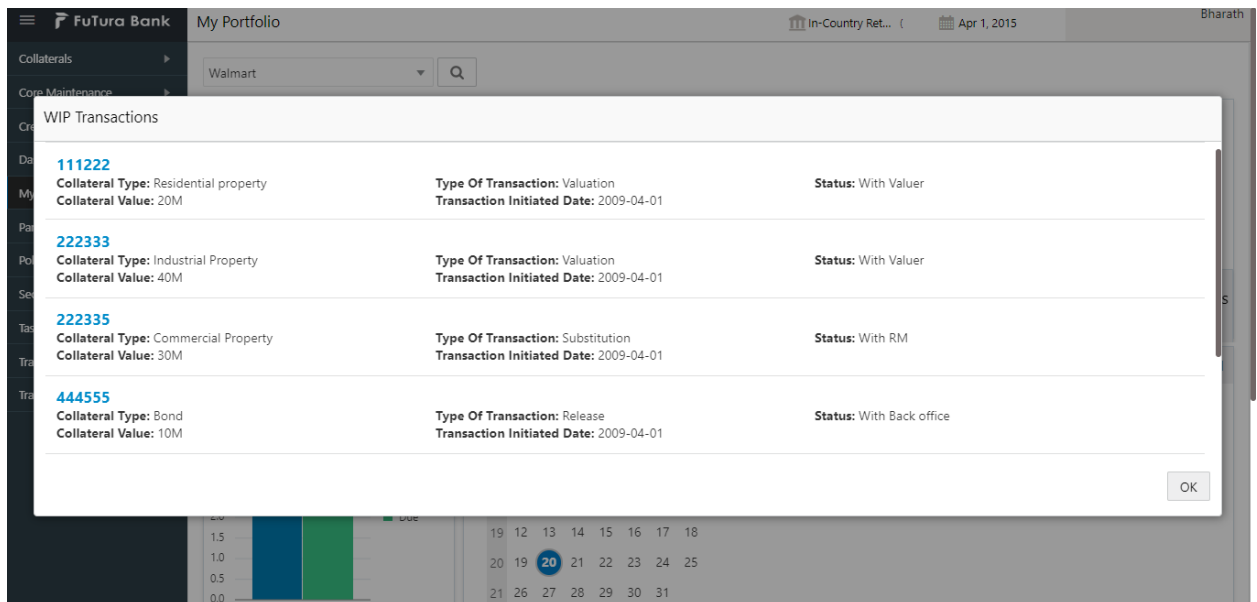

On pressing the Work in progress or completed transactions, the below shown screen will be displayed

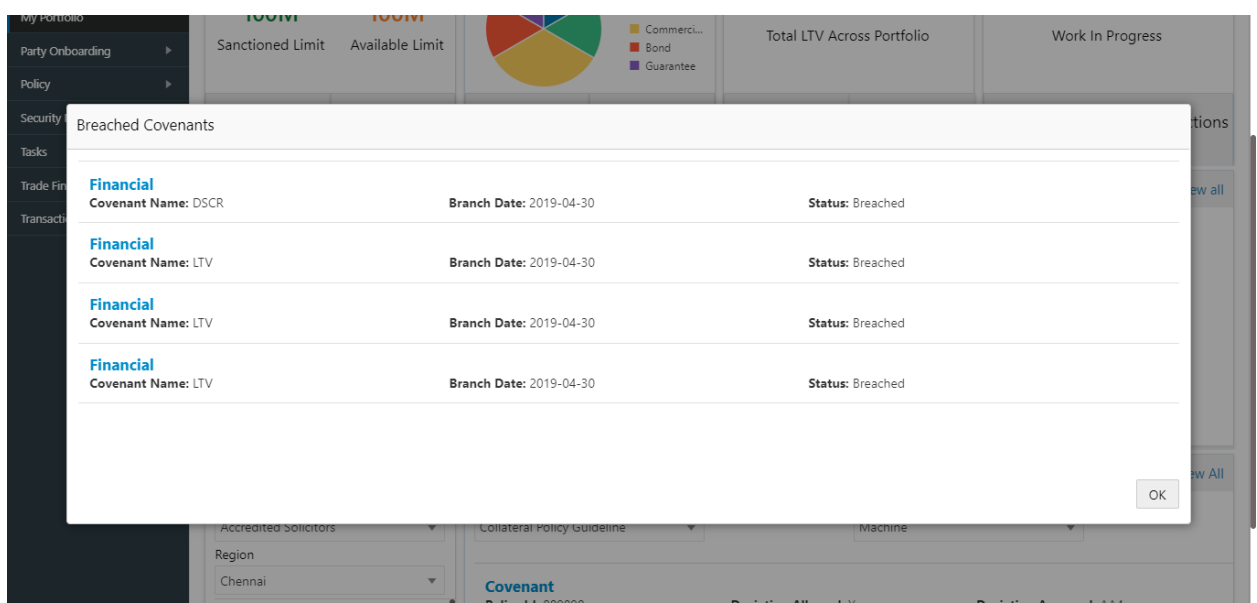

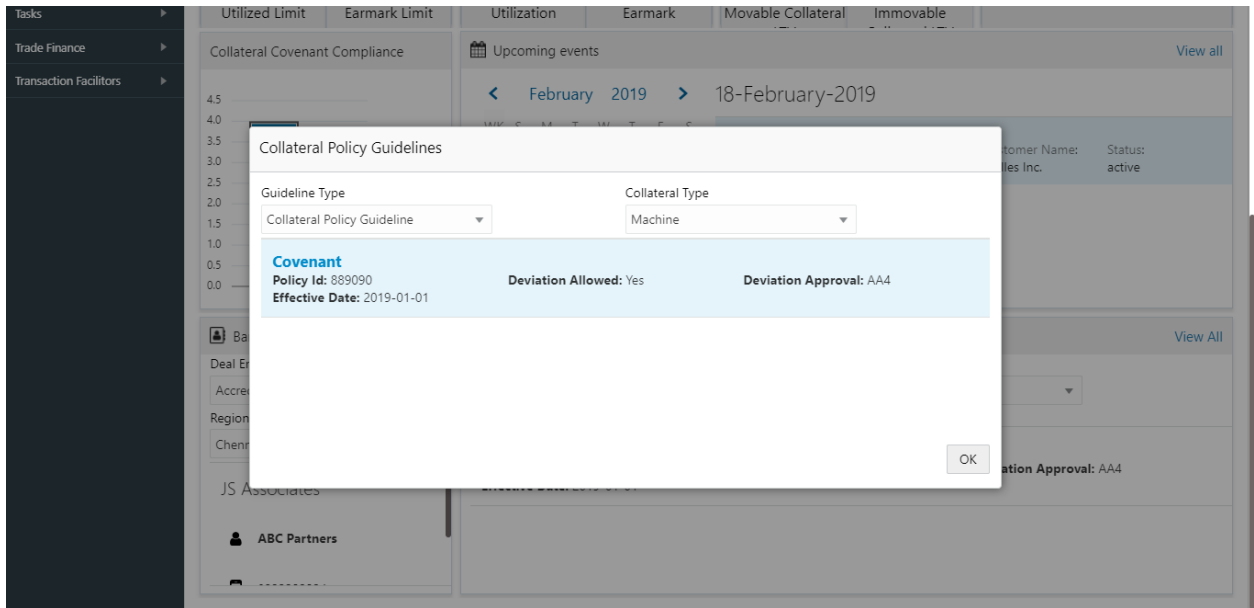

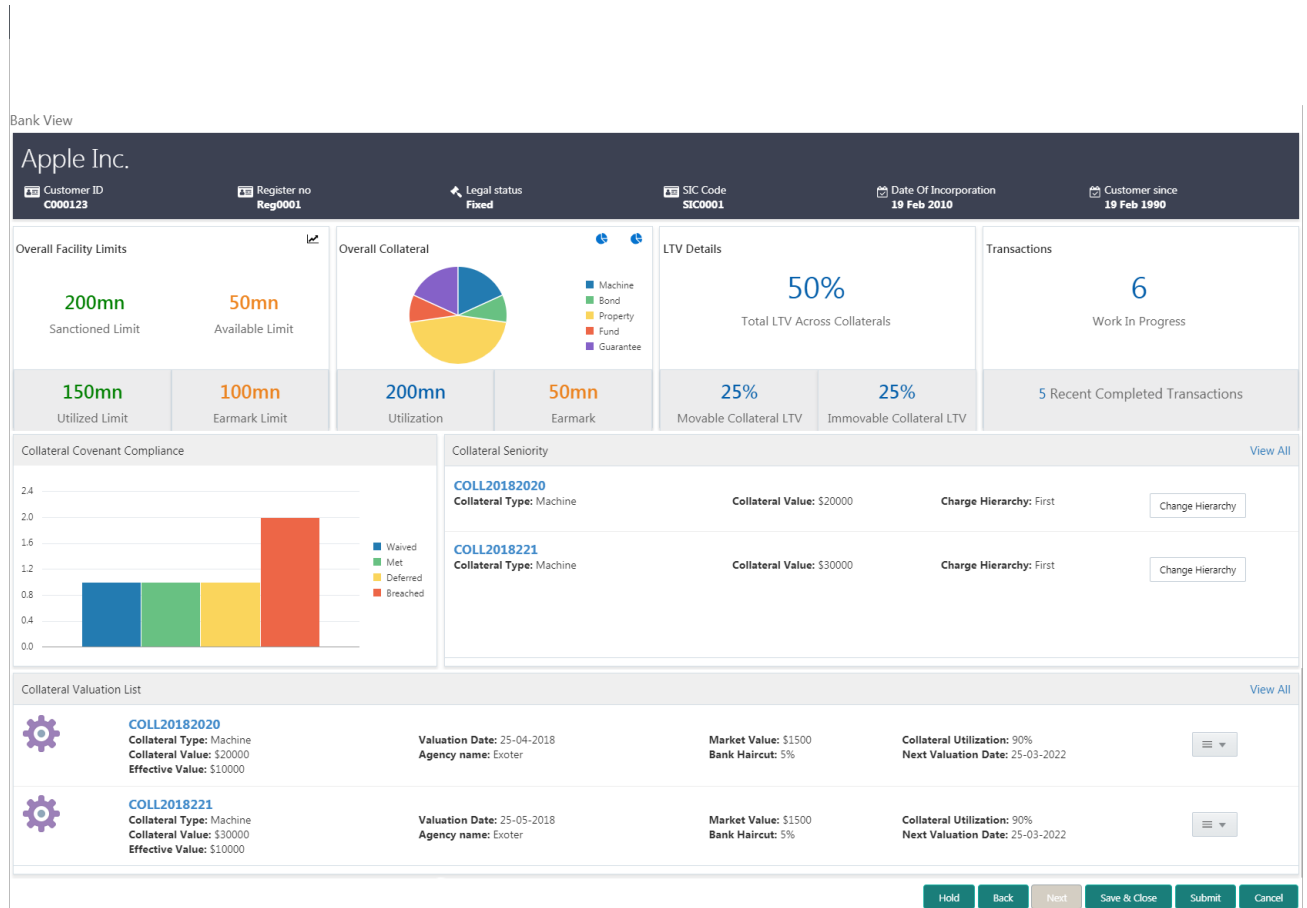

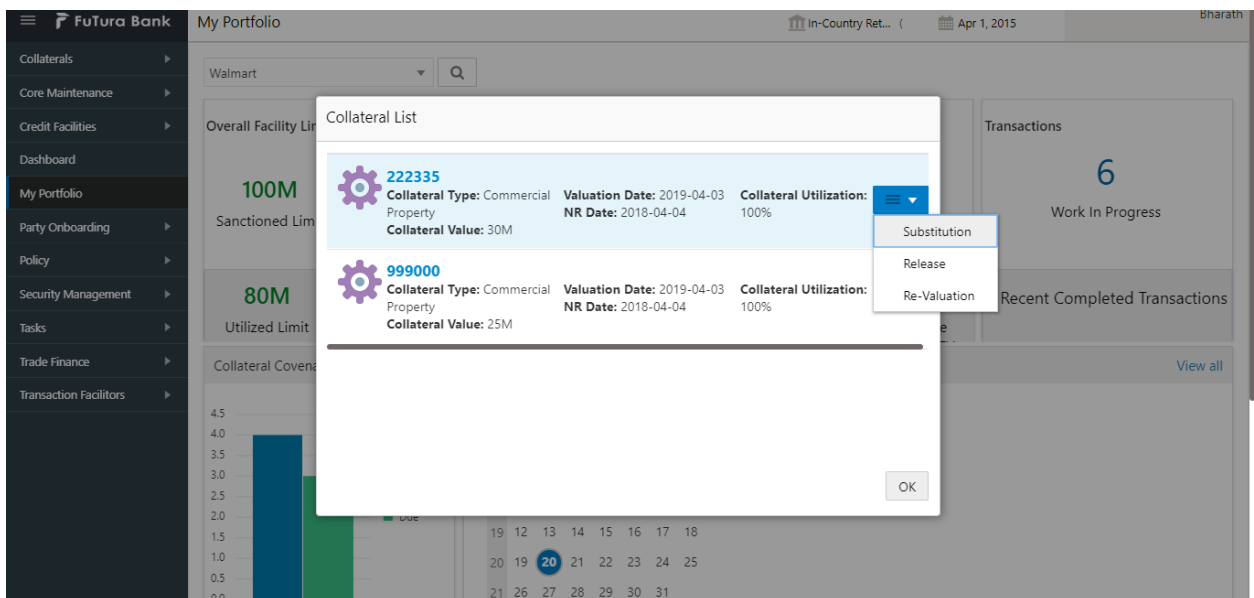

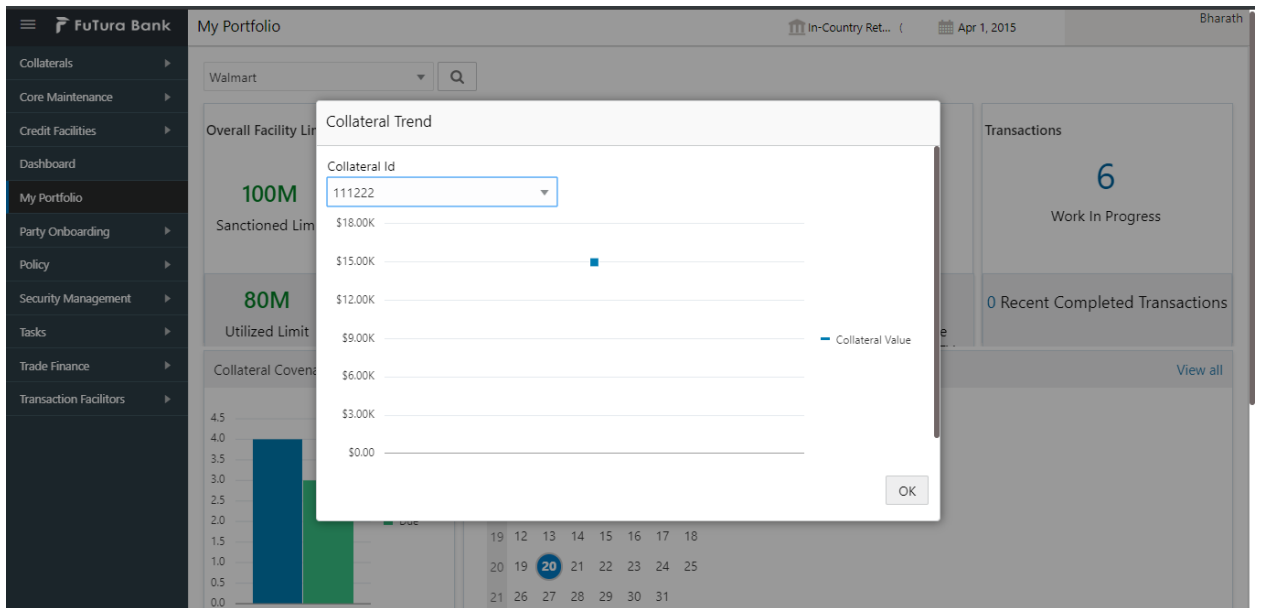

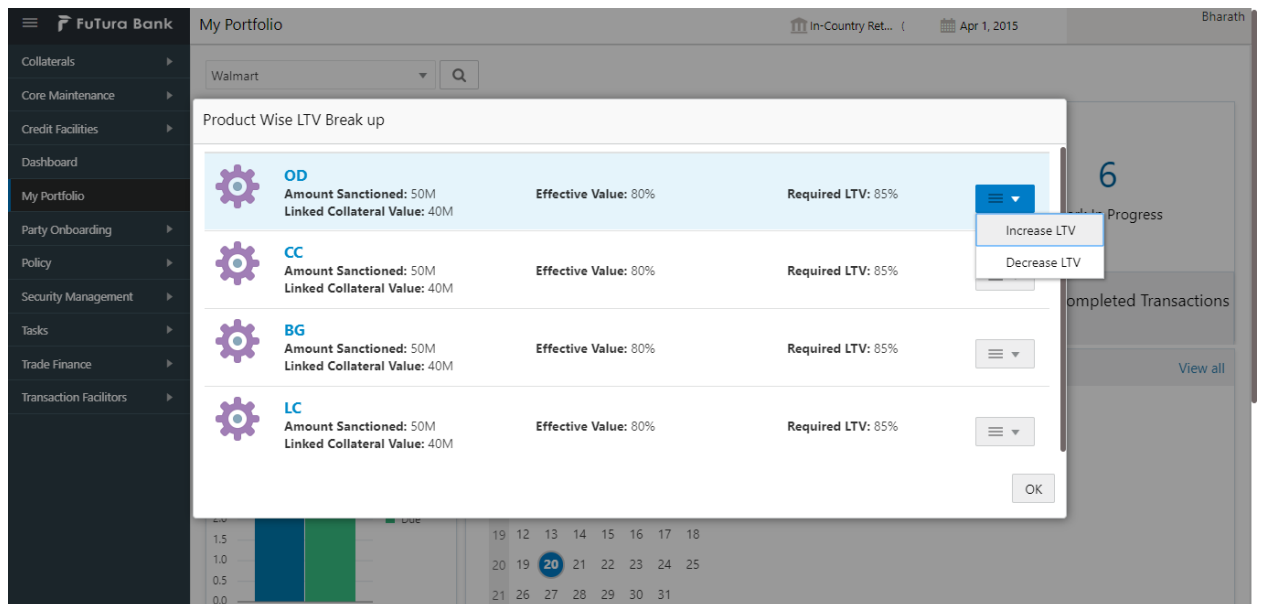

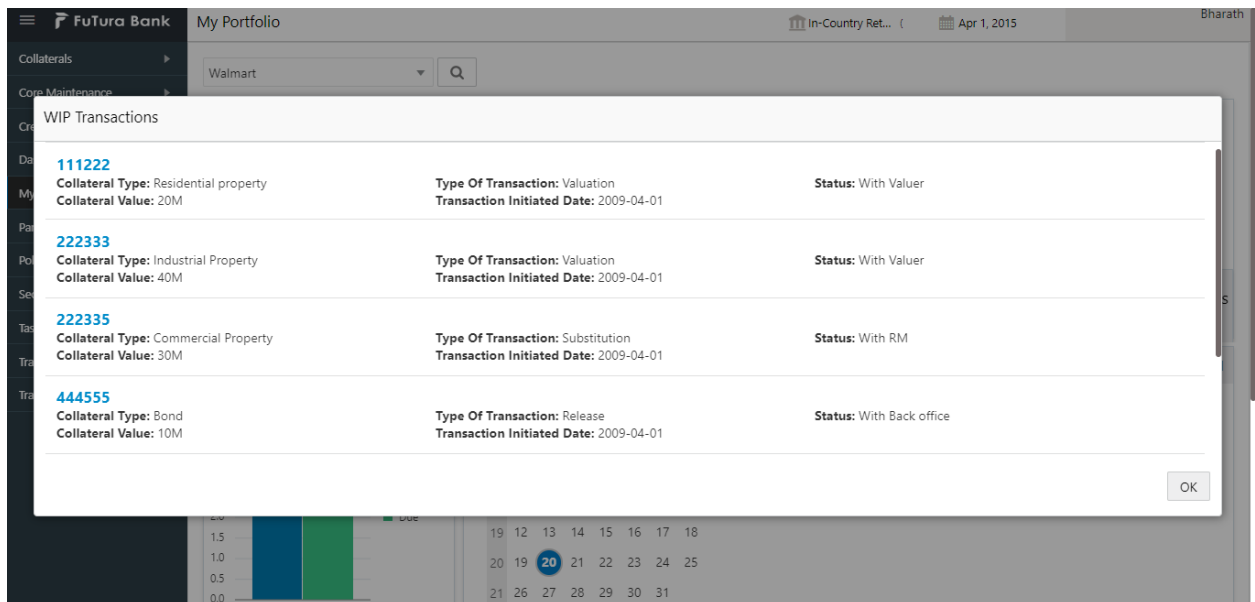

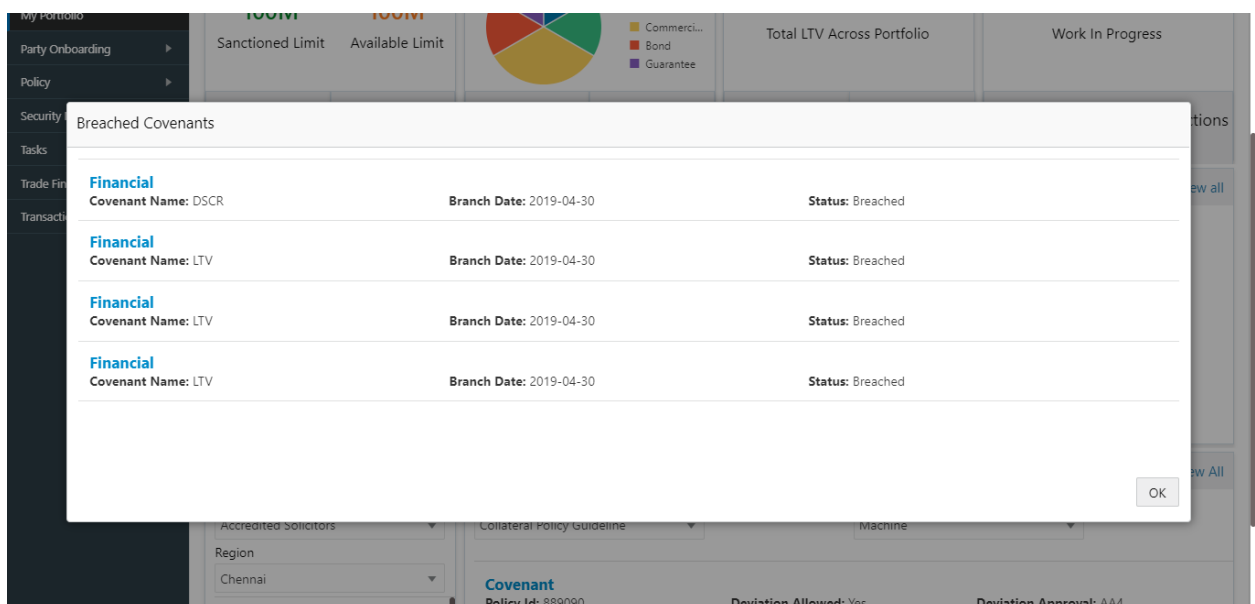

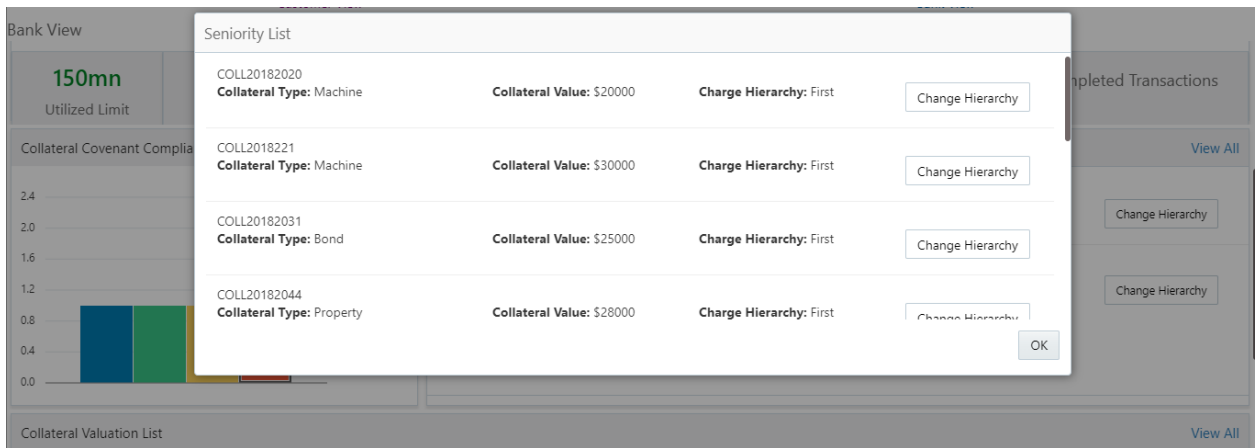

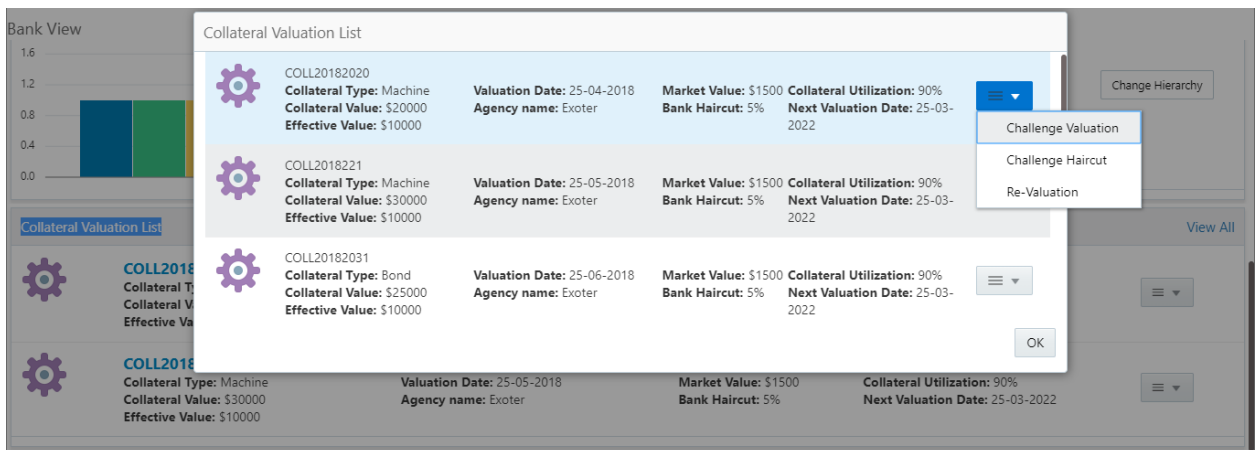

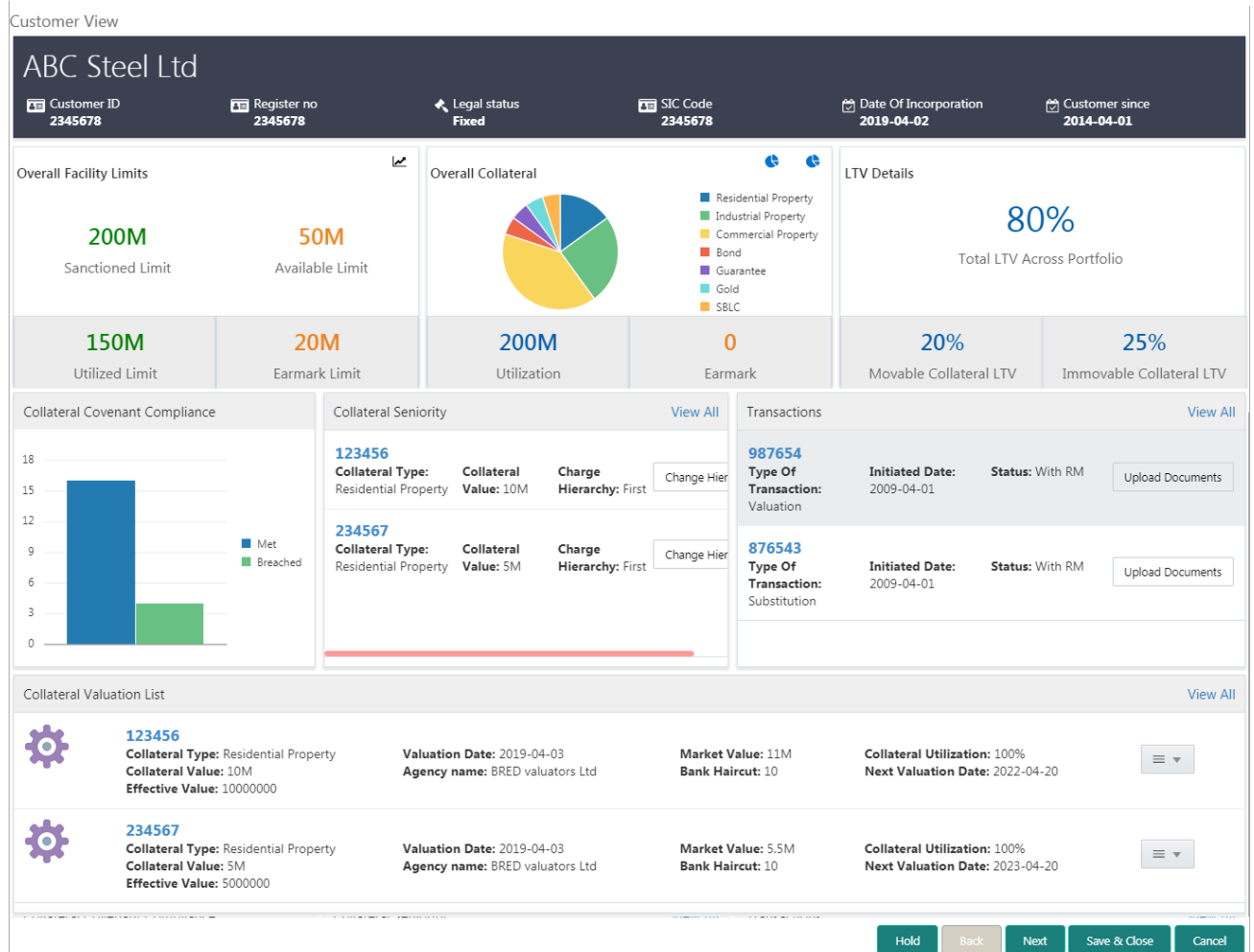

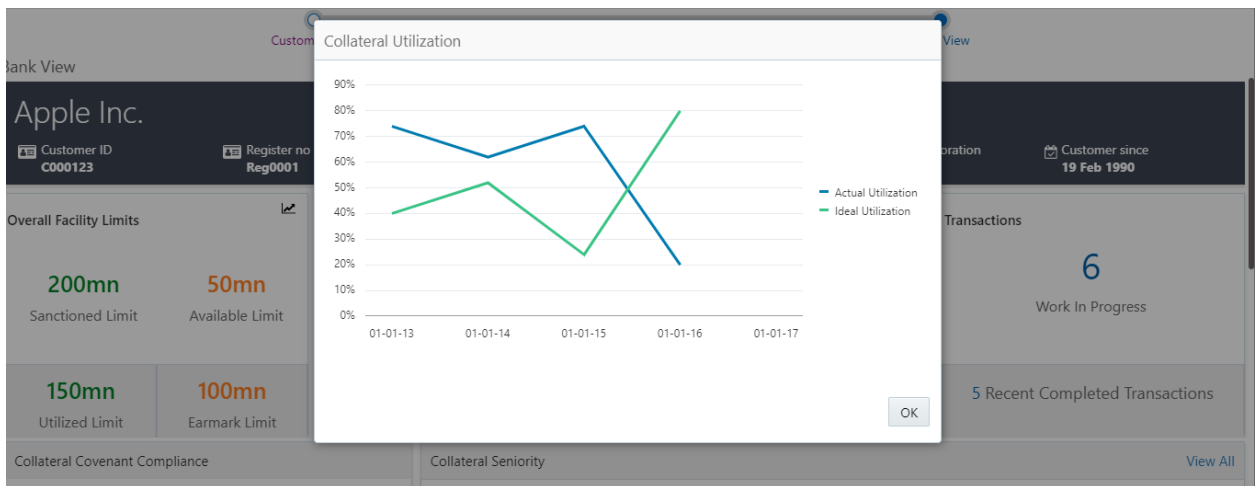

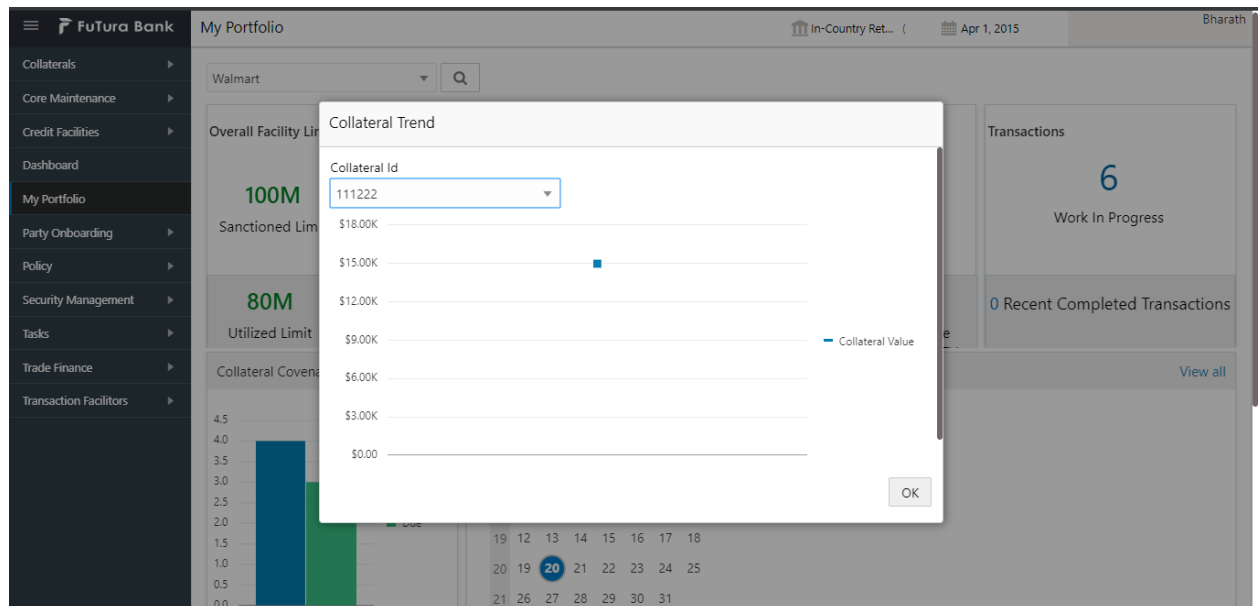

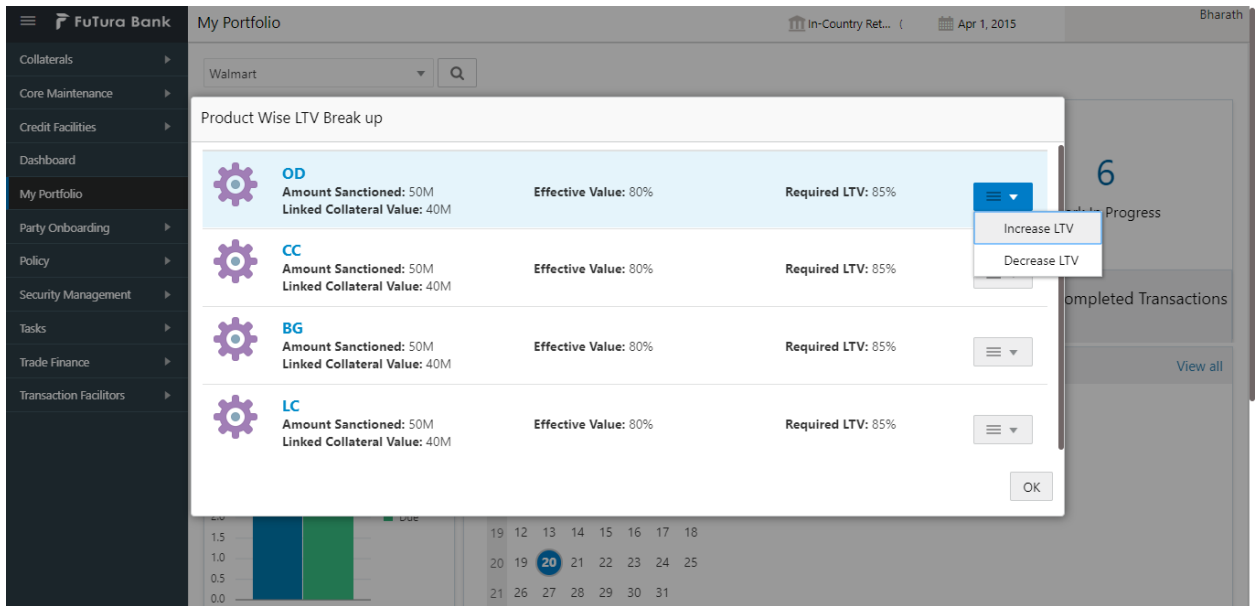

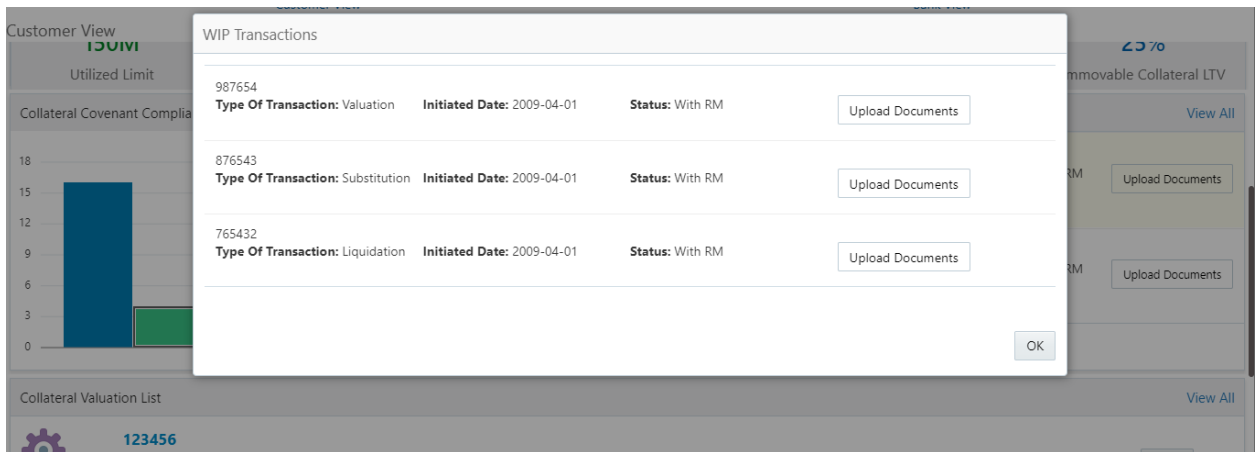

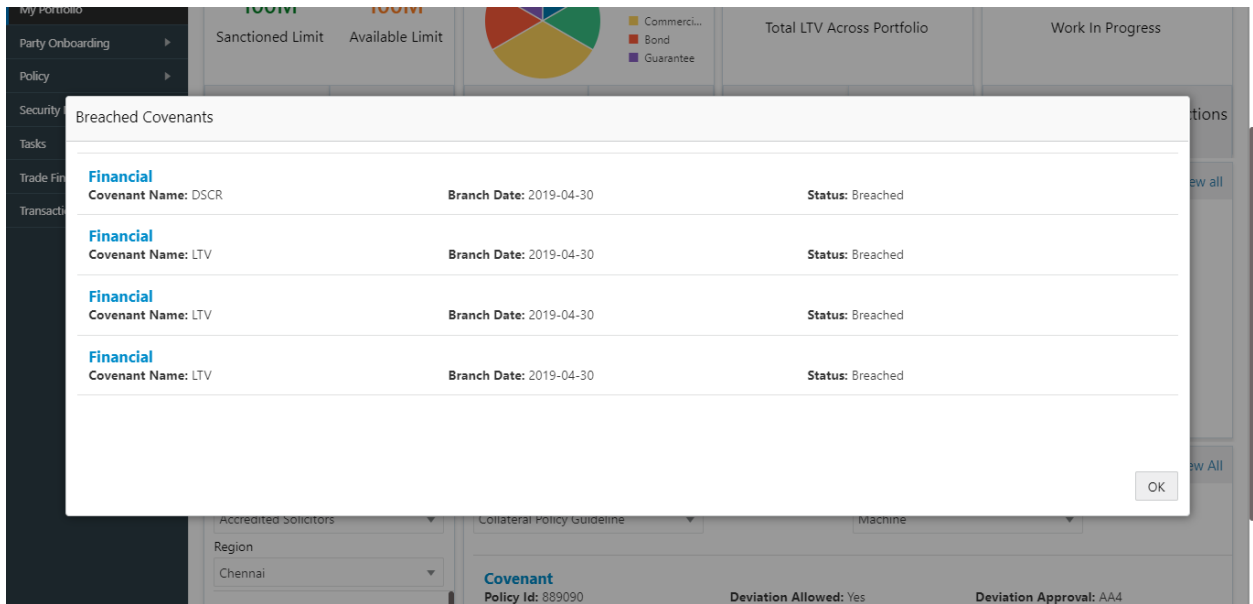

On selecting the bar chart, the below shown screen will be shown

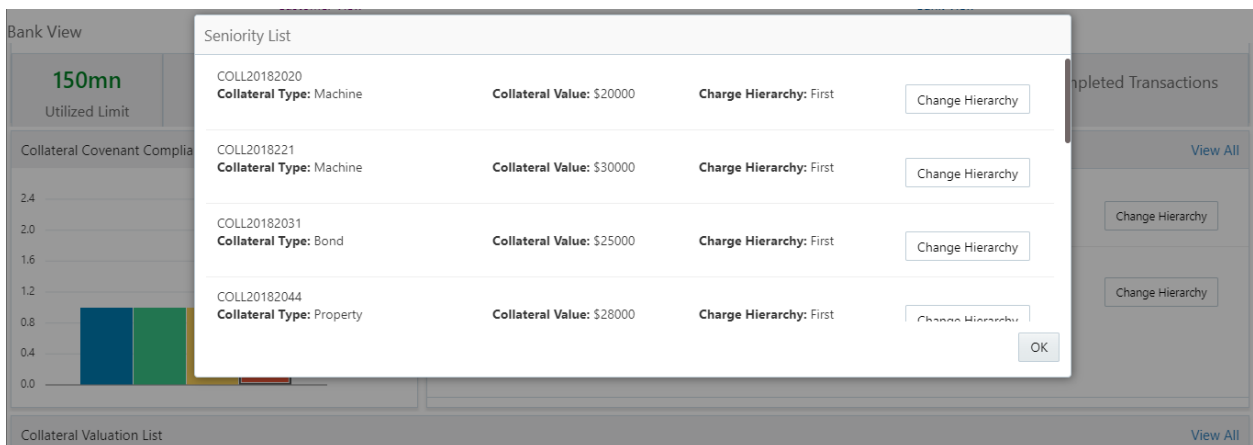
