Oracle Banking Retail and SME Loans Servicing provides various inquiries which enable the bank to satisfy customer inquiries. Oracle Banking Retail and SME Loans Servicing can service loan accounts opened either through Oracle Banking Originations or any other loan origination system. Oracle Banking Retail and SME Loans Servicing has a single dashboard from which all loan servicing transactions can be executed and all inquires can be performed.
