This document highlights the major changes for Release 19.0.1 of the Oracle Retail Sales Audit.

## Overview

Oracle Retail Sales Audit (ReSA) provides the tools to evaluate point-of-sale and customer order data to ensure the accuracy and completeness of information exported to downstream systems used in optimization processes, financial reporting, and analysis.

## Applying the Patch Release

Before applying the ReSA 19.0.1 patch release, be sure that:

- RMS 19.0 has been installed.
- RMS 19.0.1 has been installed.
- ReSA 19.0 has been installed.

Before applying the new files over your code:

- Note whether any modules have been customized. If so, the customizations must be reapplied to the new version of the module, or the fix may need to be applied to the custom version of the code.
- Copy the original files to a different directory before you copy over them, in case you need to refer to them at a later date.

## Running Scripts

Back up data before running any script, because the scripts provided *do not* preserve data. See defect reports for details.

Check with your database administrator to determine whether your database should be analyzed after a script is run. In many cases, an analysis of the database is necessary

to take advantage of new or modified indexes intended to improve performance of the application.
