## 1 About the Oracle HTTP Server Installation

The standard installation for Oracle HTTP Server described in this guide creates the standard topology, which represents a sample starting topology for this product.

- About Oracle HTTP Server Oracle HTTP Server provides web services for Oracle Fusion Middleware.
- Using the Standard Installation Topology as a Starting Point The standard installation topology is a flexible topology that you can use as a starting point in production environments.

### About Oracle HTTP Server

Oracle HTTP Server provides web services for Oracle Fusion Middleware.

In summary, Oracle HTTP Server:

- Delivers the HTTP Listener for the Oracle WebLogic Server through the built-in Oracle WebLogic Server Proxy Plug-In
- Provides the Web Server component for Oracle Fusion Middleware
- Serves static web content, such as HTML, JavaScript, images, and dynamic web content built with CGI/FastCGI-based applications.

Oracle HTTP Server can be installed in either an existing Oracle home or in a standalone domain:

 In an existing Oracle home, Oracle HTTP Server is collocated with a WebLogic Server, so the Oracle HTTP Server instance can be managed like any other element of the WebLogic Server domain. Specifically, you can manage a Oracle HTTP Server instance from the Oracle Enterprise Manager Fusion Middleware Control or the WLST command line interface. You can configure a collocated Oracle HTTP Server to run in either Full-JRF or Restricted-JRF mode. See About Full-JRF and Restricted-JRF Modes.

• In a standalone domain, the standalone Oracle HTTP Server topology is installed and configured without Oracle Fusion Middleware Infrastructure. See About the Standard Installation Topology for Oracle HTTP Server in a Standalone Domain.

### Using the Standard Installation Topology as a Starting Point

The standard installation topology is a flexible topology that you can use as a starting point in production environments.

The information in this guide helps you to create a standard installation topology for Oracle HTTP Server. If required, you can later extend the standard installation topology to create a



secure and highly available production environment, see Next Steps After Configuring the Domain.

# About the Standard Installation Topology for Oracle HTTP Server in a WebLogic Server Domain

Oracle HTTP Server can be installed in an existing Oracle home, collocated with a WebLogic Server domain

In this type of installation, the Oracle HTTP Server instance can be managed like any other elements of the WebLogic Server domain. Specifically, you can manage your Oracle HTTP Server instance from the Oracle Enterprise Manager Fusion Middleware Control, the WLST Command line interface, and the Node Manager.

Figure 1-1 shows the standard Oracle Fusion Middleware Infrastructure topology with an Oracle HTTP Server instance collocated in the same domain home. You can also use this topology to scale out to a high availability environment spanning multiple machines.

Oracle HTTP Server	The Oracle HTTP Server binaries and an Oracle HTTP Server instance.
Cluster	A collection of multiple WebLogic Server instances running simultaneously and working together. For more information, see Overview of Managed Servers and Managed Server Clusters in <i>Understanding</i> <i>Oracle Fusion Middleware</i> .
Machine	A logical representation of the computer that hosts one or more WebLogic Server instances (servers). Machines are also the logical glue between the Managed Servers and the Node Manager. You must associate Managed Servers with a machine to use Node Manager to start or stop them.
Managed Server	A host for your applications, application components, web services, and their associated resources. For more information, see Overview of Managed Servers and Managed Server Clusters in <i>Understanding</i> <i>Oracle Fusion Middleware</i> .
Infrastructure	<ul> <li>A collection of services that include:</li> <li>Metadata repository (MDS) containing metadata for Oracle Fusion Middleware components, such as the Oracle Application Developer Framework. For more information, see What Is the Metadata Repository? in Understanding Oracle Fusion Middleware.</li> <li>Oracle Application Developer Framework (Oracle ADF)</li> <li>Oracle Web Services Manager (OW/SM)</li> </ul>

### About Full-JRF and Restricted-JRF Modes

You can configure a collocated Oracle HTTP Server to run in either Full-JRF or Restricted-JRF mode.

Table 1-2 provides a comparison of these two modes.



Operational Mode	Description	Recommended Use Case
Full Domain (or Full-JRF)	Full-JRF mode is dependent on a database connection.	This operational mode is best if your domain is accessing upper stack features, such as Oracle SOA Suite or Oracle Web Services Manager.
Restricted-JRF	Restricted-JRF mode works without a database connection.	This operational mode is best if your domain only accesses Oracle Traffic
	Users can still manage all products via the Oracle Enterprise Manager Fusion Middleware Control, but they cannot use cross component wiring.	Director and Oracle HTTP Server.

#### Table 1-2 Comparison of Full-JRF and Restricted-JRF Modes

Note that migrating from Restricted-JRF to Full-JRF is not currently supported.

# About the Standard Installation Topology for Oracle HTTP Server in a Standalone Domain

Oracle HTTP Server can be installed in a standalone domain in its own Oracle home.

You can create a standalone Oracle HTTP Server domain dedicated to managing system components only. A standalone configuration resides in its own Oracle home, which you create during the installation process, which means that the standalone Oracle HTTP Server topology can be installed and configured without the Oracle Fusion Middleware Infrastructure.

A standalone domain cannot be managed with Fusion Middleware Control. You can manage your standalone Oracle HTTP Server domain with the WLST command-line and other features available in a standalone domain.

Figure 1-2 shows the standard Oracle HTTP Server instance in the Web tier.

### Roadmap for Verifying Your System Environment

Before you begin the installation and configuration process, you must verify your system environment.

Table 2-3 identifies important tasks and checks to perform to ensure that your environment is prepared to install and configure Oracle HTTP Server.

- Verifying Certification, System, and Interoperability Requirements Oracle recommends that you use the certification matrix and system requirements documents with each other to verify that your environment meets the requirements for installation.
- Selecting an Installation User The user who installs and configures your system must have the required permissions and privileges.



- Understanding Directories for Installation and Configuration During the installation and domain configuration process, you must plan on providing the locations for these directories: Oracle home, Domain home, and the Application home.
- About JDK Requirements for an Oracle Fusion Middleware Installation Most Fusion Middleware products are in .jar file format. These distributions do not include a JDK. To run a .jar distribution installer, you must have a certified JDK installed on your system.
- About Database Requirements for an Oracle Fusion Middleware Installation Many Oracle Fusion Middleware products require database schemas prior to configuration. If you do not already have a database where you can install these schemas, you must install and configure a certified database.

### Verifying Certification, System, and Interoperability Requirements

Oracle recommends that you use the certification matrix and system requirements documents with each other to verify that your environment meets the requirements for installation.

#### 1. Verifying that your environment meets certification requirements:

Make sure that you install your product on a supported hardware and software configuration. See the certification document for your release on the *Oracle Fusion Middleware Supported System Configurations* page.

Oracle has tested and verified the performance of your product on all certified systems and environments. Whenever new certifications are released, they are added to the certification document right away. New certifications can be released at any time. Therefore, the certification documents are kept outside the documentation libraries and are available on Oracle Technology Network.

#### 2. Using the system requirements document to verify certification:

Oracle recommends that you use the *Oracle Fusion Middleware System Requirements and Specifications* document to verify that the certification requirements are met. For example, if the certification document indicates that your product is certified for installation on 64-Bit Oracle Linux 6.5, use this document to verify that your system meets the required minimum specifications. These include disk space, available memory, specific platform packages and patches, and other operating system-specific requirements. System requirements can change in the future. Therefore, the system requirement documents are kept outside of the documentation libraries and are available on Oracle Technology Network.

#### 3. Verifying interoperability among multiple products:

To learn how to install and run multiple Fusion Middleware products from the same release or mixed releases with each other, see Oracle Fusion Middleware 12c Interoperability and Compatibility in *Understanding Interoperability and Compatibility*.

#### Selecting an Installation User

The user who installs and configures your system must have the required permissions and privileges.



About User Permissions

The user who installs a Fusion Middleware product owns the files and has certain permissions on the files.

- About Non-Default User Permissions on UNIX Operating Systems Changing the default permission setting reduces the security of the installation and your system. Oracle does not recommend that change the default permission settings.
- Verifying that the Installation User has Administrator Privileges on Windows Operating Systems

To update the Windows Registry, you must have administrator privileges.

#### About User Permissions

The user who installs a Fusion Middleware product owns the files and has certain permissions on the files.

- Read and write permissions on all non-executable files (for example, .jar, .properties, or .xml). All other users in the same group as the file owner have read permissions only.
- Read, write, and execute permissions on all executable files (for example, .exe, .sh, or .cmd). All other users in the same group as the file owner have read and execute permissions only.

This means that someone other than the person who installs the software can use the installed binaries in the Oracle home directory to configure a domain or set of Fusion Middleware products.

During configuration, the files generated by the configuration process are owned by the user who ran the Configuration Wizard. This user has the same permissions as described above for the installation user. However, security-sensitive files are not created with group permissions. Only the user that created the domain has read and write permissions and can administer the domain.

Consider the following examples:

Example 1: A Single User Installs the Software and Configures the Domain

This example explains the file permissions where the same user installs the software and configures the domain.

To ensure proper permissions and privileges for all files, Oracle recommends that the same owner perform both tasks: install the Oracle Fusion Middleware product and configure the WebLogic Server domain by using the Configuration Wizard.





### Figure 2-2 Directory Structure when a Single User Installs the Software and Configures the Domain

If the user who creates the domain is different than the user who installed the software, then both users must have the same privileges, as shown in the next example.

#### Example 2: The Oracle Home Directory and Domain are Created by Different Users

This example explains the file permissions where one user creates the Oracle home and another user configures the domain.

### Figure 2-3 Directory Structure when Different Users Install the Software and Configure the Domain



#### Note:

Certain domain files do not have group permissions. For example, cwallet.sso.

Consider the following points before you run the installer:

 On UNIX operating systems, Oracle recommends that you set umask to 027 on your system before you install the software. This ensures that the file permissions are set properly during installation. Use the following command:

```
umask 027
```

You must enter this command in the same terminal window from which you plan to run the product installer.

- On UNIX operating systems, do not run the installation program as a root user. If you run the installer as a root user, the startup validation may fail and you cannot continue the installation.
- When you manage a product installation (for example, applying patches or starting managed Servers), use the same user ID that you used to install the product.
- On Windows operating systems, you must have administrative privileges to install the product. See Verifying the Installation User has Administrator Privileges on Windows Operating Systems.

#### About Non-Default User Permissions on UNIX Operating Systems

Changing the default permission setting reduces the security of the installation and your system. Oracle does not recommend that change the default permission settings.

If other users require access to a particular file or executable, use the UNIX sudo command or other similar commands to change the file permissions.

Refer to your UNIX operating system Administrator's Guide or contact your operating system vendor, if you need further assistance.

#### Verifying that the Installation User has Administrator Privileges on Windows Operating Systems

To update the Windows Registry, you must have administrator privileges.

By default, users with the administrator privilege sign in to the system with regular privileges, but can request elevated permissions to perform administrative tasks.

To perform a task with elevated privileges:

- 1. Find the Command Prompt icon, either from the Start menu or the Windows icon in the lower-left corner.
- 2. Right-click Command Prompt and select Run as administrator.

This opens a new command prompt window, and all actions performed in this window are done with administrator privileges.



Note:

If you have User Access Control enabled on your system, you may see an additional window asking you to confirm this action. Confirm and continue with this procedure.

3. Perform the desired task.

For example, to start the product installer:

For a jar file, enter:

java -jar distribution name.jar

For an executable (.exe, .bin, or .sh file), enter:

distribution name.exe

### Understanding Directories for Installation and Configuration

During the installation and domain configuration process, you must plan on providing the locations for these directories: Oracle home, Domain home, and the Application home.

- Understanding the Recommended Directory Structure Oracle recommends specific locations for the Oracle Home, Domain Home, and Application Home.
- About the Oracle Home Directory When you install any Oracle Fusion Middleware product, you must use an Oracle home directory.
- About the Domain Home Directory The Domain home is the directory where domains that you configure are created.
- About the Application Home Directory The Application home is the directory where applications for domains you configure are created.
- Installing Multiple Products in the Same Domain There are two methods to install and configure multiple products in one domain. This is also known as *extending* a domain.
  - Preparing for Shared Storage Oracle Fusion Middleware allows you to configure multiple WebLogic Server domains from a single Oracle home. This allows you to install the Oracle home in a single location on a shared volume and reuse the Oracle home for multiple host installations.

#### Understanding the Recommended Directory Structure

Oracle recommends specific locations for the Oracle Home, Domain Home, and Application Home.

Oracle recommends a directory structure similar to the one shown in Figure 2-4.





#### Figure 2-4 Recommended Oracle Fusion Middleware Directory Structure

A base location (Oracle base) should be established on your system (for example, /home/ oracle) and from there, two separate branches should be created. The product directory should contain the product binary files and all of the Oracle home directories. The config directory should contain your domain and application data.

Oracle recommends that you do not keep your configuration data anywhere underneath the Oracle home; if you upgrade your product to another major release, you will be required to create a new Oracle home for binaries. You must also make sure that your configuration data exist in a location to which the binaries in the Oracle home have access.

The /home/oracle/product (for the Oracle home) and /home/oracle/config (for the application and configuration data) directories are used in examples throughout the documentation; be sure to replace these directories with the actual directories on your system.

#### About the Oracle Home Directory

When you install any Oracle Fusion Middleware product, you must use an Oracle home directory.

This directory is a repository for common files that are used by multiple Fusion Middleware products installed on the same machine. These files ensure that Fusion Middleware operates correctly on your system. They facilitate checking of cross-product dependencies during installation. For this reason, you can consider the Oracle home directory a *central support directory* for all Oracle Fusion Middleware products installed on your system.

Fusion Middleware documentation refers to the Oracle home directory as ORACLE\_HOME.

#### **Oracle Home Considerations**

Keep the following in mind when you create the Oracle home directory and install Fusion Middleware products:



- Do not include spaces in the name of your Oracle home directory; the installer displays an error message if your Oracle home directory path contains spaces.
- You can install only one instance of each Oracle Fusion Middleware product in a single Oracle home directory. If you need to maintain separate versions of a product on the same machine, each version must be in its own Oracle home directory.

Although you can have several different products in a single Oracle home, only one version of each product can be in the Oracle home.

#### **Multiple Home Directories**

Although in most situations, a single Oracle home directory is sufficient, it is possible to create more than one Oracle home directory. For example, you need to maintain multiple Oracle home directories in the following situations:

- You prefer to maintain separate development and production environments, with a separate product stack for each. With two directories, you can update your development environment without modifying the production environment until you are ready to do so.
- You want to maintain two different versions of a Fusion Middleware product at the same time. For example, you want to install a new version of a product while keeping your existing version intact. In this case, you must install each product version in its own Oracle home directory.
- You need to install multiple products that are not compatible with each other. See Oracle Fusion Middleware 12c (12.2.1.4.0) Interoperability and Compatibility in *Understanding Interoperability and Compatibility*.

#### Note:

If you create more than one Oracle home directory, you must provide nonoverlapping port ranges during the configuration phase for each product.

#### About the Domain Home Directory

The Domain home is the directory where domains that you configure are created.

The default Domain home location is *ORACLE\_HOME/user\_projects/domains/ domain\_name*. However, Oracle strongly recommends that you do not use this default location. Put your Domain home *outside* of the Oracle home directory, for example, in /home/oracle/config/domains. The config directory should contain domain and application data. Oracle recommends a separate domain directory so that new installs, patches, and other operations update the *ORACLE\_HOME* only, *not* the domain configuration.

See Understanding the Recommended Directory Structure for more on the recommended directory structure and locating your Domain home.

Fusion Middleware documentation refers to the Domain home directory as DOMAIN\_HOME and includes all folders up to and including the domain name. For example, if you name your domain exampledomain and locate your domain data in the /home/oracle/config/domains directory, the documentation would use DOMAIN\_HOME to refer to /home/oracle/config/domains/exampledomain.



#### About the Application Home Directory

The Application home is the directory where applications for domains you configure are created.

The default Application home location is <code>ORACLE\_HOME/user\_projects/applications/</code> <code>domain\_name</code>. However, Oracle strongly recommends that you locate your Application home *outside* of the Oracle home directory; if you upgrade your product to another major release, you must create a new Oracle home for binaries.

See Understanding the Recommended Directory Structure for more on the recommended directory structure and locating your Application home..

Fusion Middleware documentation refers to the Application home directory as *APPLICATION\_HOME* and includes all folders up to and including the domain name. For example, if you name your domain exampledomain and you locate your application data in the /home/oracle/config/applications directory, the documentation uses *APPLICATION\_HOME* to refer to /home/oracle/config/applications/exampledomain.

#### Installing Multiple Products in the Same Domain

There are two methods to install and configure multiple products in one domain. This is also known as *extending* a domain.

#### • Method 1.

Install and configure Product A, including creating the schemas and starting all servers in the domain to verify a successful domain configuration.

This is the method used in all installation guides in the Fusion Middleware library. You can repeat this process for as many products as necessary. It allows you to validate one product at a time and add more products incrementally.

To install Product B in the same domain as Product A:

1. Stop all servers to prevent any updates to the domain while you add the new product.

See Starting and Stopping Oracle Fusion Middleware in *Administering Oracle Fusion Middleware*.

- 2. Follow the instructions in the installation guide for Product B, including creating the necessary schemas.
- 3. Run the Configuration Wizard to configure the domain.

During configuration, the Configuration Wizard automatically detects the components that have been installed and offers you the option to extend the existing Product A domain to include Product B.

#### • Method 2.

Install all of the required products, then create the schemas for all of the products. After you create the schemas, configure the domain by using the necessary product templates, then start all the servers.

This method of creating a multi-product domain may be slightly faster than Method 1; however, the installation guides in the Fusion Middleware library do not provide specific instructions for this method of domain creation.

#### Preparing for Shared Storage

Oracle Fusion Middleware allows you to configure multiple WebLogic Server domains from a single Oracle home. This allows you to install the Oracle home in a single location on a shared volume and reuse the Oracle home for multiple host installations.

If you plan to use shared storage in your environment, see Using Shared Storage in *High Availability Guide* for more information.

#### About JDK Requirements for an Oracle Fusion Middleware Installation

Most Fusion Middleware products are in .jar file format. These distributions do not include a JDK. To run a .jar distribution installer, you must have a certified JDK installed on your system.

Make sure that the JDK is installed *outside* of the Oracle home. If you install the JDK under the Oracle home, you may encounter problems when you try to perform tasks in the future. Oracle Universal Installer validates that the Oracle home directory is empty; the install does not progress until you specify an empty directory. Oracle recommends that you locate your JDK installation in the /home/oracle/products/jdk directory.

Platform-specific distributions have a .bin (for UNIX operating systems) or .exe (for Windows operating systems) installer; in these cases, a platform-specific JDK is in the distribution and you do not need to install a JDK separately. However, you may need to upgrade this JDK to a more recent version, depending on the JDK versions that are certified.

Always verify the required JDK version by reviewing the certification information on the *Oracle Fusion Middleware Supported System Configurations* page. For 12c (12.2.1.4.0), the certified JDK is 1.8.0\_211 and later.

## About Database Requirements for an Oracle Fusion Middleware Installation

Many Oracle Fusion Middleware products require database schemas prior to configuration. If you do not already have a database where you can install these schemas, you must install and configure a certified database.



To find a certified database for your operating system, see the certification document for your release on the *Oracle Fusion Middleware Supported System Configurations* page on the Oracle Technology Network (OTN).

To make sure that your database is properly configured for schema creation, see *Repository Creation Utility Requirements* in the *Oracle Fusion Middleware System Requirements and Specifications* document.

After your database is properly configured, you use the Repository Creation Utility (RCU) to create product schemas in your database. This tool is available in the Oracle home for your Oracle Fusion Middleware product. See About the Repository Creation Utility in *Creating Schemas with the Repository Creation Utility*.

### **Obtaining the Product Distribution**

The Oracle HTTP Server distribution available as a standalone executable installation program that includes a Java Runtime Environment.

To locate and download the Oracle HTTP Server distribution, see Obtaining Product Distributions in *Planning an Installation of Oracle Fusion Middleware*.

### Installing the Oracle HTTP Server Software

Follow the steps in this section to install the Oracle HTTP Server software. Before beginning the installation, ensure that you have verified the prerequisites and completed all steps covered in Preparing to Install and Configure Oracle HTTP Server.

- Starting the Installation Program You can start the installation program on UNIX or Windows.
- Navigating the Installation Screens The installer shows a series of screens where you verify or enter information.
- Verifying the Installation After you complete the installation, verify whether it was successful by completing a series of tasks.
- Post-Installation Steps
   Perform the following update immediately after the installation of the Oracle HTTP Server software.

### Starting the Installation Program

You can start the installation program on UNIX or Windows.

To start the installation program:

- 1. Sign in to the host system.
- 2. Go to the directory where you have extracted the contents of product distribution archive file.
- 3. Enter the following command:
  - (UNIX) ./fmw 12.2.1.4.0 ohs linux64.bin
  - (Windows) setup\_fmw\_12.2.1.4.0\_ohs\_win64.exe
  - (For other platforms) ./fmw\_12.2.1.4.0\_OHS \_platform\_hardware architecture.bin

For example: ./fmw\_12.2.1.4.0\_OHS \_solaris\_sparc64.bin

#### Note:

You will not be able to execute  $./fmw_12.2.1.4.0_ohs_linux64.bin$  if it does not have execute permission. Make sure to check and grant execute permission before running this command.

When the installation program appears, you are ready to begin the installation.



### Navigating the Installation Screens

The installer shows a series of screens where you verify or enter information.

The following table lists the order in which installer screens appear. If you need additional help with an installation screen, click **Help**.

Screen	Description
Installation Inventory Setup	On UNIX operating systems, this screen opens if this is the first time you are installing any Oracle product on this host. Specify the location where you want to create your central inventory. Make sure that the operating system group name selected on this screen has write permissions to the central inventory location.

	This screen does not appear on Windows operating systems.
Welcome	Review the information to make sure that you have met all the prerequisites, then click <b>Next</b> .
Auto Updates	Select to skip automatic updates, select patches, or search for the latest software updates, including important security updates, through your My Oracle Support account.
Installation Location	Specify your Oracle home directory location.
	You can click <b>View</b> to verify and ensure that you are installing Oracle HTTP Server in the correct Oracle home.
Installation Type	Select either Standalone HTTP Server (Managed independently of WebLogic server) or Collocated HTTP Server (Managed through WebLogic server). See About Oracle HTTP Server for more information on these two installation types.
Prerequisite Checks	This screen verifies that your system meets the minimum necessary requirements.
	To view the list of tasks that gets verified, select <b>View Successful Tasks</b> . To view log details, select <b>View Log</b> . If any prerequisite check fails, then an error message appears at the bottom of the screen. Fix the error and click <b>Rerun</b> to try again. To ignore the error or the warning message and continue with the installation, click <b>Skip</b> (not recommended).
Installation Summary	Use this screen to verify installation options you selected. If you want to save these options to a response file, click <b>Save Response File</b> and enter the response file location and name. The response file collects and stores all the information that you have entered, and enables you to perform a silent installation (from the command line) at a later time. Click <b>Install</b> to begin the installation.
Installation Progress	This screen shows the installation progress.
	When the progress bar reaches 100% complete, click <b>Finish</b> to dismiss the installer, or click <b>Next</b> to see a summary.
Installation Complete	This screen displays the Installation Location and the Feature Sets that are installed. Review this information and click <b>Finish</b> to close the installer.



### Verifying the Installation

After you complete the installation, verify whether it was successful by completing a series of tasks.

- Reviewing the Installation Log Files
   Review the contents of the installation log files to make sure that the installer did not encounter any problems.
- Checking the Directory Structure The contents of your installation vary based on the options you selected during the installation.
- Viewing the Contents of the Oracle Home You can view the contents of the Oracle home directory by using the viewInventory script.

### Reviewing the Installation Log Files

Review the contents of the installation log files to make sure that the installer did not encounter any problems.

By default, the installer writes logs files to the <code>Oracle\_Inventory\_Location/logs</code> (on UNIX operating systems) or <code>Oracle\_Inventory\_Location/logs</code> (on Windows operating systems) directory.

For a description of the log files and where to find them, see Installation Log Files in *Installing Software with the Oracle Universal Installer*.

#### Checking the Directory Structure

The contents of your installation vary based on the options you selected during the installation.

To verify that your installation completed successfully, you can compare your directory structure to the one shown in Oracle HTTP Server Directory Structure.

For more information about the directory structure after installation, see What are the Key Oracle Fusion Middleware Directories? in *Understanding Oracle Fusion Middleware*.

#### Viewing the Contents of the Oracle Home

You can view the contents of the Oracle home directory by using the viewInventory script.

### **Post-Installation Steps**

Perform the following update immediately after the installation of the Oracle HTTP Server software.

Updating to 19c Database Client:

Install the new patches to update the OHS Database client and OSS patches to use 19c Database client libraries. For more information about upgrading the new Database client 19c for Oracle Fusion Middleware 12.2.1.4.0, see Doc ID 2921245.1.

# Configuring Oracle HTTP Server in a Collocated Domain

After you have installed Oracle HTTP Server, you can extend an existing Infrastructure domain with Oracle HTTP Server.

#### Note:

 Perform the configuration steps in this section only if you selected Collocated HTTP Server (Managed through WebLogic server) in the Installation Type screen. If you selected Standalone HTTP Server (Managed independently of WebLogic server), see Configuring Oracle HTTP Server in a Standalone Domain.

For information about Oracle HTTP Server domain configuration options, see About Oracle HTTP Server.

• Due to the incompatibility of database clients, a Collocated domain with Oracle Analytics Server 7.0 (2023) and Oracle HTTP Server 12c (12.2.1.4) is not supported. You must install Oracle Analytics Server 7.0 (2023) and Oracle HTTP Server 12c (12.2.1.4) in separate Oracle home directories.

If you have not created the Oracle Fusion Middleware Infrastructure domain, you can create it at the same time as Oracle HTTP Server. For instructions, see Configuring the Oracle Fusion Middleware Infrastructure Domain in *Installing and Configuring the Oracle Fusion Middleware Infrastructure*. However, in **Selecting Advanced Configurations**, ensure that you select **System Components** too.

- Stopping the Administration Server Before starting the configuration wizard, it is important to shut down the Administration Server. This prevents any configuration locks, saves, or activations from occurring during the configuration of the domain.
- Starting the Configuration Wizard Start the Configuration Wizard to begin configuring a domain.
- Navigating the Configuration Wizard Screens to Extend the Domain
   Use the Configuration Wizard to extend an existing Infrastructure domain with an Oracle
   HTTP Server instance.
- Starting the Servers After configuration is complete, start Node Manager, then the WebLogic Administration Server and Managed Servers.



### Stopping the Administration Server

Before starting the configuration wizard, it is important to shut down the Administration Server. This prevents any configuration locks, saves, or activations from occurring during the configuration of the domain.

To stop the Administration Server, go to the *DOMAIN\_HOME*/bin directory.

- On UNIX operating systems:
  - ./stopWebLogic.sh
- On Windows operating systems:

stopWebLogic.cmd

You may be prompted for the login credentials of the Administrator user you provided when you configured the Oracle Fusion Middleware Infrastructure domain.

### Starting the Configuration Wizard

Start the Configuration Wizard to begin configuring a domain.

To start the Configuration Wizard:

**1.** Change to the following directory:

(UNIX) ORACLE HOME/oracle common/common/bin

(Windows) ORACLE HOME\oracle common\common\bin

where <code>ORACLE\_HOME</code> is your 12c (12.2.1.4.0) Oracle home.

2. Enter the following command:

(UNIX)./config.sh

(Windows) config.cmd

# Navigating the Configuration Wizard Screens to Extend the Domain

Use the Configuration Wizard to extend an existing Infrastructure domain with an Oracle HTTP Server instance.

#### Note:

- Oracle Enterprise Manager-Restricted JRF
- Oracle Restricted JRF
- WebLogic Coherence Cluster Extension

If you are unsure what operational mode you want, see About Full-JRF and Restricted-JRF Modes for an overview of both modes.

### Configuring High Availability Options

Use this screen to configure service migration and persistence settings that affect high availability. This screen appears for the first time when you create a cluster that uses automatic service migration, persistent stores, or both, and all subsequent clusters that are added to the domain by using the Configuration Wizard, automatically apply the selected HA options.

### **Enable Automatic Service Migration**

Select **Enable Automatic Service Migration** to enable pinned services to migrate automatically to a healthy Managed Server for failover. It configures migratable target definitions that are required for automatic service migration and the cluster leasing. Choose one of these cluster leasing options:

- Database Leasing Managed Servers use a table on a valid JDBC System Resource for leasing. Requires that the Automatic Migration data source have a valid JDBC System Resource. If you select this option, the Migration Basis is configured to Database and the Data Source for Automatic Migration is also automatically configured by the Configuration Wizard. If you have a high availability database, such as Oracle RAC, to manage leasing information, configure the database for server migration according to steps in High-availability Database Leasing.
- Consensus Leasing Managed Servers maintain leasing information in-memory. You use Node Manager to control Managed Servers in a cluster. (All servers that are migratable, or which could host a migratable target, must have a Node Manager associated with them.) If you select this option, the Migration Basis is configured to Consensus by the Configuration Wizard.

See Service Migration for more information on Automatic Service Migration.

#### JTA Transaction Log Persistence

This section has two options: Default Persistent Store and JDBC TLog Store.

- Default Persistent Store Configures the JTA Transaction Log store of the servers in the default file store.
- JDBC TLog Store Configures the JTA Transaction Log store of the servers in JDBC stores.

Oracle recommends that you select **JDBC TLog Store**. When you complete the configuration, you have a cluster where JDBC persistent stores are set up for Transaction logs.

#### JMS Service Persistence

A persistent **JMS store** is a physical repository for storing persistent message data and durable subscribers. It can be either a disk-based **file store** or a JDBC-accessible database. You can use a **JMS file store** for paging of messages to disk when memory is exhausted.

- JMS File Store Configures a component to use JMS File Stores. If you select this
  option, you can choose the File Store option in the Advanced Configuration Screen to
  change the settings, if required. In the File Stores screen, you can set file store names,
  directories, and synchronous write policies.
- JMS JDBC Store Configures a component to use JDBC stores for all its JMS servers. When you complete the configuration, you have a cluster and JDBC persistent stores are configured for the JMS servers.

### Specifying the Database Configuration Type

Use the Database Configuration type screen to specify details about the database and database schema.

On the Database Configuration type screen, all fields are pre-populated, because you already configured the domain to reference the Fusion Middleware schemas that are required for the Infrastructure domain. Verify and ensure that credentials in all the fields are the same that you have provided while configuring Oracle Fusion Middleware Infrastructure.

Verify the database connection information, then select **Get RCU Configuration**. The following output in the Connection Result Log indicates that the operation succeeded:

```
Connecting to the database server...OK
Retrieving schema data from database server...OK
Binding local schema components with retrieved data...OK
```

Successfully Done.

A green check mark in the Status column indicates a successful test. If you encounter any issues, see the error message in the Connection Result Log section of the screen, fix the problem, then try to test the connection again.

By default, the schema password for each schema component is the password you specified while creating your schemas. If you want different passwords for different schema components, manually edit them in the previous screen (JDBC Component Schema) by entering the password you want in the **Schema Password** column, against each row. After specifying the passwords, select the check box corresponding to the schemas that you changed the password in and test the connection again.

All of the remaining fields are pre-populated, but you can change the values as required. For example, verify that the default port numbers are not used by other services.

### Note:

If you change the admin host from default IP address 127.0.0.1 to any other IP address, you must ensure the following:

- Set ServerName directive in admin.conf to the host name or domain name that maps to the IP address that you have chosen.
- Create an SSL certificate with a common name matching the host name or domain name set up using the ServerName directive.

  - Double-click ohs1 in the System Components list box.
  - Select the ohs1 in the System Components list box and click the right arrow.

You can associate an Oracle HTTP Server machine to an existing machine or create a new machine. You typically create additional machines when you are planning to scale out the topology to multiple host computers.   - (Windows) Go to the DOMAIN\_HOME\bin directory.set JAVA HOME=C:\home\Oracle\Java\jdk1.8.0 211.
- 2. Enter the following command:
  - (UNIX) Using nohup and nm.out as an example output file:

nohup ./startNodeManager.sh > LOG DIR/nm.out&

where *LOG\_DIR* is the location of directory in which you want to store the log files.

(Windows) startNodeManager.cmd



### Note:

On Windows operating systems, Oracle recommends that you configure Node Manager to run as a startup service. This allows Node Manager to start up automatically each time the system is restarted.

### **Tip**:

You can verify that the Administration Server is up and running by accessing the Administration Server Console. The URL is provided on the Configuration Success screen, as described in "Writing Down Your Domain Home and Administration Server URL" in Navigating the Configuration Wizard Screens to Configure the Domain (http://administration\_server\_host:administration\_server\_port/console). The default Administration Server port number is 7001.

### Note:

Make sure that the database hosting your product schemas is up and running and accessible by the Administration Server.

If you have selected **Collocated HTTP Server (Managed through WebLogic server)**, see Configuring Oracle HTTP Server in a Collocated Domain.

# Starting the Configuration Wizard

where <code>ORACLE\_HOME</code> is your 12c (12.2.1.4.0) Oracle home.

(Windows) config.cmd

So, avoid renaming the Oracle HTTP Server component, unless you want the default settings.

### Note:

### Starting the Oracle HTTP Server Instance

startComponent.cmd system component name

where *system\_component\_name* is the Oracle HTTP Server system component name you provided while configuring the domain.

For example:

startComponent.cmd ohs1

### Missing Libraries Might Cause HTTPD to Exit Without Notice

On the Windows platform, Oracle HTTP Server requires certain Microsoft software to be installed in order to function properly.

If the following software is not installed, Oracle HTTP Server may exit with no output or generate an error message, depending on registry settings.

- Microsoft Visual C++ 2010 Feature Pack Redistributable Package (x64)
- Microsoft Visual C++ 2012 Feature Pack Redistributable Package (x64)
- Any other packages recommended by Microsoft



If Oracle HTTP Server fails to start and no error messages are logged by Oracle HTTP Server in the server error log or in Node Manager logs, follow this procedure to diagnose the problem:

- Verify that the following runtime libraries are installed: Microsoft Visual C++ 2010 and 2012 Feature Pack Redistributable Package (x64)
  - a. If either runtime library is missing, download it from http://www.microsoft.com
  - **b.** After installing the package, install any service packs or other fixes to this package that are recommended by Microsoft.
  - c. Try to start Oracle HTTP Server again after installing the runtime library and associated service packs or fixes..
- 2. Attempt to start Oracle HTTP Server from a command prompt.

### Note:

Oracle HTTP Server does not function properly when started from a command prompt in this manner. This mechanism for starting Oracle HTTP Server is for diagnostic purposes only.

- a. Create the *DOMAIN\_HOME*/servers/*ohs-instancename*/logs directory if it has not yet been created by Oracle HTTP Server.
- b. Try to start Oracle HTTP Server using Fusion Middleware Control or WLST.
- c. Copy the file DOMAIN\_HOME/servers/ohs-instancename/logs/lastinvocation.log to a new file startohs.cmd.
- d. Open a new command prompt and run startohs.cmd in that new command prompt.
- e. If it generates error messages after the script runs, use those messages to diagnose the startup failure.
- f. If it does not generate error messages after the script runs, proceed to the next step.
- 3. Collect Windows error information when attempting to start Oracle HTTP Server.

Error reporting for Oracle HTTP Server library errors may be inhibited on your system. Refer to the following Microsoft article for information on verifying or correcting error reporting:

"HOWTO: How To Change Hard Error Popup Handling in Windows NT" at http:// support.microsoft.com/kb/128642

- a. Change ErrorMode to the desired value.
  - The default mode is 1, which means library errors are not reported for Oracle HTTP Server.
  - Change the mode to 2 to enable reporting to the Windows event log. This is the recommended setting for this task.
  - Change the mode to 0 to enable hard error pop-ups. If this is changed to 0, set it back to the previous value immediately after collecting diagnostic information as it can result in operational problems if errors occur when the server is unattended.
- **b.** Try to start Oracle HTTP Server using Fusion Middleware Control or WLST or the startohs.cmd script which was created in the previous step.



c. Check for diagnostic information in a hard error popup or in the Windows event log, depending on the setting of ErrorMode.

To check the Windows event log, open Windows Event Viewer and view the logs for Event Viewer (Local) / Windows Logs / Application

Find the event log entries written at the time of the attempt to start Oracle HTTP Server.

Errors locating runtime libraries might be reported as SideBySide errors with event ids 33 or 35, which text describing the Oracle library attempting to load the library and the specific library being loaded. Example:

```
level=Error
Source=SideBySide
Event Id = 33
Activation context generation failed for
"C:\work\Oracle\MD1212\ORACLE~1\bin\oraiau.dll".
Dependent Assembly
Microsoft.VC90.CRT,processorArchitecture="amd64",

Please use sxstrace.exe for detailed diagnosis.

The indicated library must be installed. This example shows VC90, which is the Microsoft Visual C++ 2010 library described in Step 1 above.

d. Restore ErrorMode to the previous setting.

# 7 Uninstalling or Reinstalling Oracle HTTP Server

Follow the instructions in this section to uninstall or reinstall Oracle HTTP Server.

### Note:

This task applies only to *standalone* Oracle HTTP Server. You cannot uninstall Oracle HTTP Server when it is collocated in a WebLogic Server domain, as partial deconfiguration of a configured domain is not supported.

Oracle recommends that you always use the instructions in this section to remove the software. If you try to remove the software manually, you may encounter problems when you try to reinstall the software again at a later time. Following the procedures in this section ensures that the software is properly removed.

- Stopping Oracle Fusion Middleware Before running the Uninstall Wizard, Oracle recommends that you stop all servers and processes associated with the Oracle home you are going to remove.
- Uninstalling the Software Follow the instructions in this section to start the Uninstall Wizard and remove the software.
- Verifying the Uninstallation of Oracle HTTP Server in a Standalone Domain When Oracle HTTP Server is installed in a standalone domain, you may need to manually delete directories and files.
- Removing the Oracle Home Directory Manually After you uninstall the software, you must manually remove your Oracle home directory and any existing subdirectories that the Uninstall Wizard did not remove.
- Removing the Program Shortcuts on Windows Operating Systems
   On Windows operating systems, you must also manually remove the program shortcuts; the Deinstallation Wizard does not remove them for you.
- Removing the Domain and Application Data After you uninstall the software, you must remove the domain and application data.
- Reinstalling the Software You can reinstall your software into the same Oracle home as a previous installation only if you uninstalled the software by following the instructions in this section, including manually removing the Oracle home directory.

### Note:

This task applies only to *standalone* Oracle HTTP Server. You cannot uninstall Oracle HTTP Server when it is collocated in a WebLogic Server domain, as partial deconfiguration of a configured domain is not supported.

If you want to uninstall the product in a silent (command-line) mode, see Running the Oracle Universal Installer for Silent Uninstallation in *Installing Software with the Oracle Universal Installer*.

# Starting the Uninstall Wizard

To start the Uninstall Wizard:

- Change to the following directory: (UNIX) ORACLE\_HOME/oui/bin (Windows) ORACLE HOME\oui\bin
- 2. Enter the following command:

(UNIX)./deinstall.sh

(Windows) deinstall.cmd

# Verifying the Uninstallation of Oracle HTTP Server in a Standalone Domain

When Oracle HTTP Server is installed in a standalone domain, you may need to manually delete directories and files.

To verify the uninstallation of Oracle HTTP Server in a standalone domain:

- **1.** Go to the ORACLE\_HOME directory.
- 2. Enter 1s to list the directories and files in ORACLE\_HOME.
- If any files or directories exist in ORACLE\_HOME, delete them by entering the following command:

rm -rf

# Removing the Oracle Home Directory Manually

After you uninstall the software, you must manually remove your Oracle home directory and any existing subdirectories that the Uninstall Wizard did not remove.

For example, if your Oracle home directory is /home/Oracle/product/ORACLE\_HOME on a UNIX operating system, enter the following commands:

```
cd /home/Oracle/product
rm -rf ORACLE HOME
```

On a Windows operating system, if your Oracle home directory is C:\Oracle\Product\ORACLE\_HOME, use a file manager window and navigate to the C:\Oracle\Product directory. Right-click on the ORACLE\_HOME folder and select Delete.



# Removing the Program Shortcuts on Windows Operating Systems

On Windows operating systems, you must also manually remove the program shortcuts; the Deinstallation Wizard does not remove them for you.

To remove the program shortcuts on Windows:

- 1. Change to the following directory: C:\ProgramData\Microsoft\Windows\Start Menu\Programs\Oracle\ORACLE\_HOME\Product
- 2. If you only have one product installed in your Oracle home, delete the *ORACLE\_HOME* directory. If you have multiple products installed in your Oracle home, delete all products before you delete the *ORACLE\_HOME* directory.

# Removing the Domain and Application Data

After you uninstall the software, you must remove the domain and application data.

To remove the domain and application data:

1. Manually remove your Domain home directory. For example:

On a UNIX operating system, if your Domain home directory is /home/Oracle/ config/domains/ohs domain, enter the following command:

```
cd /home/Oracle/config/domains
```

```
rm -rf ohs_domain
```

On a Windows operating system, if your Domain home directory is C:\Oracle\Config\domains\ohs\_domain, use a file manager window and navigate to the C:\Oracle\Config\domains directory. Right-click on the ohs\_domain folder and select Delete.

2. Manually remove your Application home directory. For example:

On a UNIX operating system, if your Application home directory is /home/Oracle/ config/applications/ohs domain, enter the following commands:

```
cd /home/Oracle/config/applications
```

```
rm -rf ohs_domain
```

On a Windows operating system, if your Application home directory is C:\Oracle\Config\applications\ohs\_domain, use a file manager window and navigate to the C:\Oracle\Config\applications directory. Right-click on the ohs domain folder and select Delete.

3. Back up the domain\_registry.xml file in your Oracle home, then edit the file and remove the line associated with the domain that you are removing. For example, to remove the ohs domain, find the following line and remove it:

<domain location="/home/Oracle/config/domains/ohs domain"/>

Save and exit the file when you are finished.



# Reinstalling the Software

You can reinstall your software into the same Oracle home as a previous installation only if you uninstalled the software by following the instructions in this section, including manually removing the Oracle home directory.

When you reinstall, you can then specify the same Oracle home as your previous installation.

If ODI is installed again in the same location where it was previously deleted, delete the entire Oracle Home where it was previously installed.

Consider the following cases where the Oracle home is not empty:

• Installing in an existing Oracle home that contains the same feature sets.

The installer warns you that the Oracle home that you specified during installation already contains the same software you are trying to install.

• Installing in an existing, non-empty Oracle home.

For example, suppose you chose to create your Domain home or Application home somewhere inside your existing Oracle home. This data is not removed when you uninstall a product, so if you try to reinstall into the same Oracle home, the installer does not allow it. Your options are:

- Uninstall your software from the Oracle home (as this section describes) and then remove the Oracle home directory. After you uninstall the software and remove the Oracle home directory, you can reinstall and reuse the same Oracle home location. Any domain or application data that was in the Oracle home must be re-created.
- Select a different Oracle home directory.



# A Oracle HTTP Server Directory Structure

- About Webgate WebGate is a web server plug-in that intercepts HTTP requests and forwards them to an existing Oracle Access Manager instance for authentication and authorization.
- General Prerequisites for Configuring Oracle HTTP Server WebGate Before you can configure Oracle HTTP Server WebGate, you must have installed and configured a certified version of Oracle Access Manager.
- Configuring Oracle HTTP Server WebGate Configuring Oracle HTTP Server WebGate for Oracle Access Manager requires several steps.
- Starting OHS after WebGate Configuration You have to start the OHS after the WebGate is configured.
- Registering the Oracle HTTP Server WebGate with Oracle Access Manager You can register the WebGate agent with Oracle Access Manager by using the Oracle Access Manager Administration console.

# About Webgate

WebGate is a web server plug-in that intercepts HTTP requests and forwards them to an existing Oracle Access Manager instance for authentication and authorization.

For Oracle Fusion Middleware 12c, the Oracle WebGate software is installed as part of the Oracle HTTP Server 12c software installation. See Registering and Managing OAM 11g Agents in *Adminstrator's Guide for Oracle Access Management*.

# General Prerequisites for Configuring Oracle HTTP Server WebGate

Before you can configure Oracle HTTP Server WebGate, you must have installed and configured a certified version of Oracle Access Manager.

For the most up-to-date information, see the certification document for your release on the *Oracle Fusion Middleware Supported System Configurations* page.

### Note:

For production environments, it is highly recommended that you install Oracle Access Manager in its own environment and not on the machines that are hosting the enterprise deployment.

# Configuring Oracle HTTP Server WebGate

Configuring Oracle HTTP Server WebGate for Oracle Access Manager requires several steps.

- Replace OHS\_ORACLE\_HOME with the complete path to the Oracle home where you installed the Oracle HTTP Server software.
- Replace OHS\_Configuration\_Staging\_Directory with the path to the following location in the Oracle HTTP Server domain home:

DOMAIN HOME/config/fmwconfig/components/OHS/componentName

1. Change to deployWebGate directory in the Oracle HTTP Server.

(UNIX) OHS ORACLE HOME/webgate/ohs/tools/deployWebGate

(Windows) OHS ORACLE HOME\webgate\ohs\tools\deployWebGate

 To create the WebGate Instance directory and enable WebGate logging on OHS Instance, enter the following command::

(UNIX) ./deployWebGateInstance.sh -w
OHS\_Configuration\_Staging\_Directory -oh OHS\_ORACLE\_HOME

(Windows) deployWebGateInstance.bat -w
OHS Configuration Staging Directory -oh OHS ORACLE HOME

3. Verify that a webgate directory and subdirectories was created by the deployWebGateInstance command:

For example, on UNIX:

```
ls -lart OHS_Configuration_Staging_Directory/webgate/
total 6
drwxr-x---+ 8 orcl oinstall 20 Oct 2 07:14 ..
drwxr-xr-x+ 4 orcl oinstall 4 Oct 2 07:14 .

drwxr-xr-x+ 3 orcl oinstall 4 Oct 2 07:14 config
```

4. To set the PATH environment variable, enter the following command:

(UNIX) export LD\_LIBRARY\_PATH=\$LD\_LIBRARY\_PATH:OHS\_ORACLE\_HOME/lib

```
(Windows) set PATH=%PATH%; OHS_ORACLE_HOME\bin
```



5. Change to the EditHttpConf directory:

(UNIX) OHS ORACLE HOME/webgate/ohs/tools/setup/InstallTools/EditHttpConf

(Windows) OHS\_ORACLE\_HOME\webgate\ohs\tools\EditHttpConf

6. Enter the following command from the InstallTools directory:

```
(UNIX) ./EditHttpConf -w OHS_Configuration_Staging_Directory [-oh
OHS_ORACLE_HOME] [-o output_file_name] [-dcc custom_dcc_scripts/
pages_location]
```

```
(Windows) EditHttpConf -w OHS_Configuration_Staging_Directory [-oh
OHS_ORACLE_HOME] [-o output_file_name] [-dcc
custom dcc scripts\pages location]
```

This command does the following:

- Copies the apache\_webgate.template file from the Oracle HTTP Server Oracle home to a new webgate.conf file in the Oracle HTTP Server configuration directory.
- Updates the httpd.conf file to add one line, so it includes the webgate.conf.
- Generates a WebGate configuration file. The default name of the file is webgate.conf, but you can use a custom name by using the <code>output\_file</code> argument to the command.

If you want to customize Detached Credential Collector (DCC) scripts or pages, such as the oamsso/logout.html, oamsso-bin/login.p, or logout.pll scripts), then you can copy these scripts from the following location to the custom location identified by the -dcc parameter to EditHttpConf utility:

ORACLE HOME/webgate/ohs/

# Starting OHS after WebGate Configuration

You have to start the OHS after the WebGate is configured.

To start the OHS after WebGate configuration, perform the following steps:

1. Modify the following OHS configuration file to set LD\_LIBRARY\_PATH to WebGate libcurl.

\$DOMAIN\_HOME/config/fmwconfig/components/OHS/instances/\$INSTANCE/
ohs.plugins.nodemanager.properties

2. Add the following in the OHS configuration file:

environment.LD\_LIBRARY\_PATH=\$ORACLE\_HOME/webgate/ohs/lib/:\$ORACLE\_HOME/ohs/ lib:\$ORACLE HOME/oracle common/lib:\$ORACLE HOME/lib

3. Restart the Node Manager and the OHS instance.

#### Note:

Replace LD LIBRARY PATH with LIBPATH for AIX platform only.

# Locating and Preparing the RREG Tool

To set up the RREG tool, complete the following steps:

- 1. Sign in to one of the Oracle Access Manager hosts in the Application tier.
- 2. Change to the following directory in the Oracle Access Manager Oracle home:

OAM ORACLE HOME/oam/server/rreg/client

### Note:

The location is required only for the out-of-band mode.

In this example, *OAM\_ORACLE\_HOME* refers to the Oracle home on the system where the Oracle Access Manager software was installed.

### Note:

If the Oracle Enterprise Deployment Guide for IDM was used, OAM\_ORACLE\_HOME may be /u01/oracle/products/access/iam.

### Note:

If you do not have privileges or access to the Oracle Access Manager server, then you can use out-of-band mode to generate the required files and register the WebGate with Oracle Access Manager. See About RREG In-Band and Out-of-Band Mode.



- 3. Decompress the RREG.tar.gz file to the required directory.
- 4. From the unzipped directory, open the oamreg.sh file and set the following environment variables in the file, as follows:
  - Set OAM\_REG\_HOME to the absolute path to the directory in which you extracted the contents of RREG archive.

Set  ${\tt JAVA\_HOME}$  to the absolute path of the directory in which a supported JDK is installed on your machine.

## Updating the Standard Properties in the OAM11gRequest.xml File

Before you can register the Webgate agent with Oracle Access Manager, you must update some required properties in the <code>OAM11gRequest.xml</code> file.

### Note:

If you plan to use the default values for most of the parameters in the provided XML file, then you can use the shorter version (OAM11gRequest\_short.xml, in which all non-listed fields will take a default value.

### Note:

In the primary server list, the default names are mentioned as OAM\_SERVER1 and OAM\_SERVER2 for OAM servers. Rename these names in the list if the server names are changed in your environment.

### To perform this task:

**1.** If you are using in-band mode, then change directory to the following location in the directory:

OAM\_ORACLE\_HOME/oam/server/rreg/input

If you are using out-of-band mode, then change directory to the location where you unpacked the RREG archive.

- 2. Make a copy of the OAM11GRequest.xml file template.
- Review the properties listed in the file, and then update your copy of the OAM11GRequest.xml file to make sure the properties reference the host names and other values specific to your environment.

OAM11gRequest.xml Property	Set to
serverAddress	The host and the port of the Administration Server for the Oracle Access Manager domain.
agentName	Any custom name for the agent. Typically, you use a name that identifies the Fusion Middleware product you are configuring for single sign-on.
applicationDomain	A value that identifies the Web tier host and the FMW component you are configuring for single sign-on.



OAM11gRequest.xml Property	Set to
security	The security mode of the Oracle Access Manager server, which can be open, simple, or certificate mode.
	For an enterprise deployment, Oracle recommends simple mode, unless additional requirements exist to implement custom security certificates for the encryption of authentication and authorization traffic.
	In most cases, avoid using open mode, because in open mode, traffic to and from the Oracle Access Manager server is not encrypted.
	For more information using certificate mode or about Oracle Access Manager supported security modes in general, see Securing Communication Between OAM Servers and WebGates in the <i>Administrator's Guide for</i> <i>Oracle Access Management</i> .

## Running the RREG Tool

The following topics provide information about running the RREG tool to register your Oracle HTTP Server Webgate with Oracle Access Manager.

- About RREG In-Band and Out-of-Band Mode
- Running the RREG Tool in In-Band Mode
- Running the RREG Tool in Out-Of-Band Mode

### About RREG In-Band and Out-of-Band Mode

You can run the RREG Tool in one of two modes: in-band and out-of-band.

Use **in-band** mode when you have the privileges to access the Oracle Access Manager server and run the RREG tool yourself from the Oracle Access Manager Oracle home. You can then copy the generated artifacts and files to the Web server configuration directory after you run the RREG Tool.



Use **out-of-band** mode if you do *not* have privileges or access to the Oracle Access Manager server. For example, in some organizations, only the Oracle Access Manager server administrators have privileges access the server directories and perform administration tasks on the server. In out-of-band mode, the process can work as follows:

- 1. The Oracle Access Manager server administrator provides you with a copy of the RREG archive file (RREG.tar.gz).
- 2. Untar the RREG.tar.gz file that was provided to you by the server administrator.

For example:

gunzip RREG.tar.gz

tar -xvf RREG.tar

After you unpack the RREG archive, you can find the tool for registering the agent in the following location:

RREG HOME/bin/oamreg.sh

In this example, *RREG\_Home* is the directory in which you extracted the contents of RREG archive.

- 3. Use the instructions in Updating the Standard Properties in the OAM11gRequest.xml File to update the OAM11gRequest.xml file, and send the completed OAM11gRequest.xml file to the Oracle Access Manager server administrator.
- 4. The Oracle Access Manager server administrator then uses the instructions in Running the RREG Tool in Out-Of-Band Mode to run the RREG Tool and generate the *AgentID* response.xml file.
- 5. The Oracle Access Manager server administrator sends the *AgentID\_*response.xml file to you.
- 6. Use the instructions in Running the RREG Tool in Out-Of-Band Mode to run the RREG Tool with the *AgentID\_*response.xml file and generate the required artifacts and files on the client system.

### Running the RREG Tool in In-Band Mode

To run the RREG Tool in in-band mode:

1. Change to the RREG home directory.

If you are using in-band mode, the RREG directory is inside the Oracle Access Manager Oracle home:

OAM\_ORACLE\_HOME/oam/server/rreg

If you are using out-of-band mode, then the RREG home directory is the location where you unpacked the RREG archive.

- 2. Change to the following directory:
  - (UNIX) RREG\_HOME/bin
  - (Windows) RREG HOME\bin

cd RREG\_HOME/bin/

3. Set the permissions of the oamreg.sh command so that you can execute the file:

chmod +x oamreg.sh


#### 4. Enter the following command:

./oamreg.sh inband RREG HOME/input/OAM11GRequest edg.xml

In this example:

- It is assumed that the edited OAM11GRequest.xml file is located in the RREG\_HOME/ input directory.
- The output from this command is saved to the following directory:

```
RREG HOME/output/
```

The following example shows a sample RREG session:

#### Running the RREG Tool in Out-Of-Band Mode

To run the RREG Tool in out-of-band mode on the WEBHOST server, the administrator uses the following command:

RREG HOME/bin/oamreg.sh outofband input/OAM11GRequest.xml

In this example:

- Replace RREG\_HOME with the location where the RREG archive file was unpacked on the server.
- The edited OAM11GRequest.xml file is located in the RREG HOME/input directory.



 The RREG Tool saves the output from this command (the AgentID\_response.xml file) to the following directory:

RREG\_HOME/output/

The Oracle Access Manager server administrator can then send the *AgentID* response.xml to the user who provided the OAM11GRequest.xml file.

To run the RREG Tool in out-of-band mode on the Web server client machine, use the following command:

RREG HOME/bin/oamreg.sh outofband input/AgentID response.xml

In this example:

- Replace RREG\_HOME with the location where you unpacked the RREG archive file on the client system.
- The *AgentID\_*response.xml file, which was provided by the Oracle Access Manager server administrator, is located in the *RREG\_HOME*/input directory.
- The RREG Tool saves the output from this command (the artifacts and files required to register the Webgate software) to the following directory on the client machine:

RREG\_HOME/output/

## Files and Artifacts Generated by RREG

The files that get generated by the RREG Tool vary, depending on the security level you are using for communications between the WebGate and the Oracle Access Manager server. For more information about the supported security levels, see Securing Communication Between OAM Servers and WebGates in *Administrator's Guide for Oracle Access Management*.

Note that in this topic any references to *RREG\_HOME* should be replaced with the path to the directory where you ran the RREG tool. This is typically the following directory on the Oracle Access Manager server, or (if you are using out-of-band mode) the directory where you unpacked the RREG archive:

OAM ORACLE HOME/oam/server/rreg/client

The following table lists the artifacts that are always generated by the RREG Tool, regardless of the Oracle Access Manager security level.

File	Location	
cwallet.sso	RREG_HOME/output/Agent_ID/	
ObAccessClient.xml	RREG_HOME/output/Agent_ID/	

The following table lists the additional files that are created if you are using the SIMPLE or CERT security level for Oracle Access Manager:

File	Location
aaa_key.pem	RREG_HOME/output/Agent_ID/
aaa_cert.pem	RREG_HOME/output/Agent_ID/
password.xml	RREG_HOME/output/Agent_ID/



Note that the password.xml file contains the obfuscated global passphrase to encrypt the private key used in SSL. This passphrase can be different than the passphrase used on the server.

You can use the files generated by RREG to generate a certificate request and get it signed by a third-party Certification Authority. To install an existing certificate, you must use the existing aaa\_cert.pem and aaa\_chain.pem files along with password.xml and aaa key.pem.

## Copying Generated Artifacts to the Oracle HTTP Server WebGate Instance Location

After the RREG Tool generates the required artifacts, manually copy the artifacts from the *RREG\_Home/output/agent\_ID* directory to the Oracle HTTP Server configuration directory on the Web tier host.

The location of the files in the Oracle HTTP Server configuration directory depends upon the Oracle Access Manager security mode setting (OPEN, SIMPLE, or CERT).

The following table lists the required location of each generated artifact in the Oracle HTTP Server configuration directory, based on the security mode setting for Oracle Access Manager. In some cases, you might have to create the directories if they do not exist already. For example, the wallet directory might not exist in the configuration directory.

#### Note:

For an enterprise deployment, Oracle recommends simple mode, unless additional requirements exist to implement custom security certificates for the encryption of authentication and authorization traffic. The information about using open or certification mode is provided here as a convenience.

Avoid using open mode, because in open mode, traffic to and from the Oracle Access Manager server is not encrypted.

For more information using certificate mode or about Oracle Access Manager supported security modes in general, see Securing Communication Between OAM Servers and WebGates in *Administrator's Guide for Oracle Access Management*.

If you need to redeploy the ObAccessClient.xml to WEBHOST1 and WEBHOST2, delete the cached copy of ObAccessClient.xml from the servers. The cache location on WEBHOST1 is:

OHS\_DOMAIN\_HOME/servers/ohs1/cache/

And you must perform the similar step for the second Oracle HTTP Server instance on WEBHOST2:

OHS\_DOMAIN\_HOME/servers/ohs2/cache/

## Restarting the Oracle HTTP Server Instance

For information about restarting the Oracle HTTP Server instance, see Restarting Oracle HTTP Server Instances by Using WLST in *Administering Oracle HTTP Server*.

If you have configured Oracle HTTP Server in a WebLogic Server domain, you can also use Oracle Fusion Middleware Control to restart the Oracle HTTP Server instances. For more information, see Restarting Oracle HTTP Server Instances by Using Fusion Middleware Control in *Administering Oracle HTTP Server*.



## C Updating the JDK After Installing and Configuring an Oracle Fusion Middleware Product

Consider that you have a JDK version jdk1.8.0\_121 installed on your machine. When you install and configure an Oracle Fusion Middleware product, the utilities, such as Configuration Wizard (config.sh|exe), OPatch, or RCU point to a default JDK, for example, jdk1.8.0\_121. After some time, Oracle releases a new version of the JDK, say jdk1.8.0\_211 that carries security enhancements and bug fixes. From 12*c* (12.2.1.3.0) onwards, you can upgrade the existing JDK to a newer version, and can have the complete product stack point to the newer version of the JDK.

You can maintain multiple versions of JDK and switch to the required version on need basis.

• About Updating the JDK Location After Installing an Oracle Fusion Middleware Product The binaries and other metadata and utility scripts in the Oracle home and Domain home, such as RCU or Configuration Wizard, use a JDK version that was used while installing the software and continue to refer to the same version of the JDK. The JDK path is stored in a variable called JAVA\_HOME which is centrally located in .globalEnv.properties file inside the ORACLE\_HOME/oui directory.

# About Updating the JDK Location After Installing an Oracle Fusion Middleware Product

The binaries and other metadata and utility scripts in the Oracle home and Domain home, such as RCU or Configuration Wizard, use a JDK version that was used while installing the software and continue to refer to the same version of the JDK. The JDK path is stored in a variable called JAVA\_HOME which is centrally located in .globalEnv.properties file inside the *ORACLE\_HOME*/oui directory.

The utility scripts such as config.sh|cmd, launch.sh, or opatch reside in the ORACLE\_HOME, and when you invoke them, they refer to the JAVA\_HOME variable located in .globalEnv.properties file. To point these scripts and utilities to the newer version of JDK, you must update the value of the JAVA\_HOME variable in the .globalEnv.properties file by following the directions listed in Updating the JDK Location in an Existing Oracle Home .

To make the scripts and files in your Domain home directory point to the newer version of the JDK, you can follow one of the following approaches:

• Specify the path to the newer JDK on the Domain Mode and JDK screen while running the Configuration Wizard.

For example, consider that you installed Oracle Fusion Middleware Infrastructure with the JDK version 8u121. So while configuring the WebLogic domain with the Configuration Assistant, you can select the path to the newer JDK on the Domain Mode and JDK screen of the Configuration Wizard. Example: /scratch/jdk/jdk1.8.0 131.



 Manually locate the files that have references to the JDK using grep (UNIX) or findstr (Windows) commands and update each reference. See Updating the JDK Location in an Existing Domain Home.

#### Note:

If you install the newer version of the JDK in the same location as the existing JDK by overwriting the files, then you don't need to take any action.

- Updating the JDK Location in an Existing Oracle Home The getProperty.sh|cmd script displays the value of a variable, such as JAVA\_HOME, from the .globalEnv.properties file. The setProperty.sh|cmd script is used to set the value of variables, such as OLD\_JAVA\_HOME or JAVA\_HOME that contain the locations of old and new JDKs in the .globalEnv.properties file.
- Updating the JDK Location in an Existing Domain Home You must search the references to the current JDK, for example jdk1.8.0\_121 manually, and replace those instances with the location of the new JDK.

### Updating the JDK Location in an Existing Oracle Home

The getProperty.sh|cmd script displays the value of a variable, such as JAVA\_HOME, from the .globalEnv.properties file. The setProperty.sh|cmd script is used to set the value of variables, such as OLD\_JAVA\_HOME or JAVA\_HOME that contain the locations of old and new JDKs in the .globalEnv.properties file.

The getProperty.sh|cmd and setProperty.sh|cmd scripts are located in the following location:

(UNIX) ORACLE\_HOME/oui/bin

(Windows) ORACLE HOME\oui\bin

Where, *ORACLE\_HOME* is the directory that contains the products using the current version of the JDK, such as jdk1.8.0\_121.

To update the JDK location in the .globalEnv.properties file:

1. Use the getProperty.sh|cmd script to display the path of the current JDK from the JAVA\_HOME variable. For example:

(UNIX) ORACLE\_HOME/oui/bin/getProperty.sh JAVA\_HOME
(Windows) ORACLE\_HOME\oui\bin\getProperty.cmd JAVA\_HOME
echo JAVA\_HOME

Where JAVA\_HOME is the variable in the .globalEnv.properties file that contains the location of the JDK.

 Back up the path of the current JDK to another variable such as OLD\_JAVA\_HOME in the .globalEnv.properties file by entering the following commands:

(UNIX) ORACLE\_HOME/oui/bin/setProperty.sh -name OLD\_JAVA\_HOME
-value specify\_the\_path\_of\_current\_JDK
(Windows) ORACLE\_HOME\oui\bin\setProperty.cmd -name
OLD JAVA HOME -value specify the path of current JDK



This command creates a new variable called OLD\_JAVA\_HOME in the .globalEnv.properties file, with a value that you have specified.

**3.** Set the new location of the JDK in the JAVA\_HOME variable of the .globalEnv.properties file, by entering the following commands:

(UNIX) ORACLE\_HOME/oui/bin/setProperty.sh -name JAVA\_HOME -value specify\_the\_location\_of\_new\_JDK (Windows) ORACLE\_HOME\oui\bin\setProperty.cmd -name JAVA\_HOME value specify\_the\_location\_of\_new\_JDK

After you run this command, the JAVA\_HOME variable in the .globalEnv.properties file now contains the path to the new JDK, such as jdk1.8.0\_131.

## Updating the JDK Location in an Existing Domain Home

You must search the references to the current JDK, for example jdk1.8.0\_121 manually, and replace those instances with the location of the new JDK.

You can use the grep (UNIX) or findstr (Windows) commands to search for the jdk-related references.

You'll likely be required to update the location of JDK in the following three files:

(UNIX) DOMAIN\_HOME/bin/setNMJavaHome.sh (Windows) DOMAIN HOME\bin\setNMJavaHome.cmd

(UNIX) DOMAIN\_HOME/nodemanager/nodemanager.properties (Windows) DOMAIN HOME\nodemanager\nodemanager.properties

(UNIX) DOMAIN\_HOME/bin/setDomainEnv.sh (Windows) DOMAIN HOME\bin\setDomainEnv.cmd
