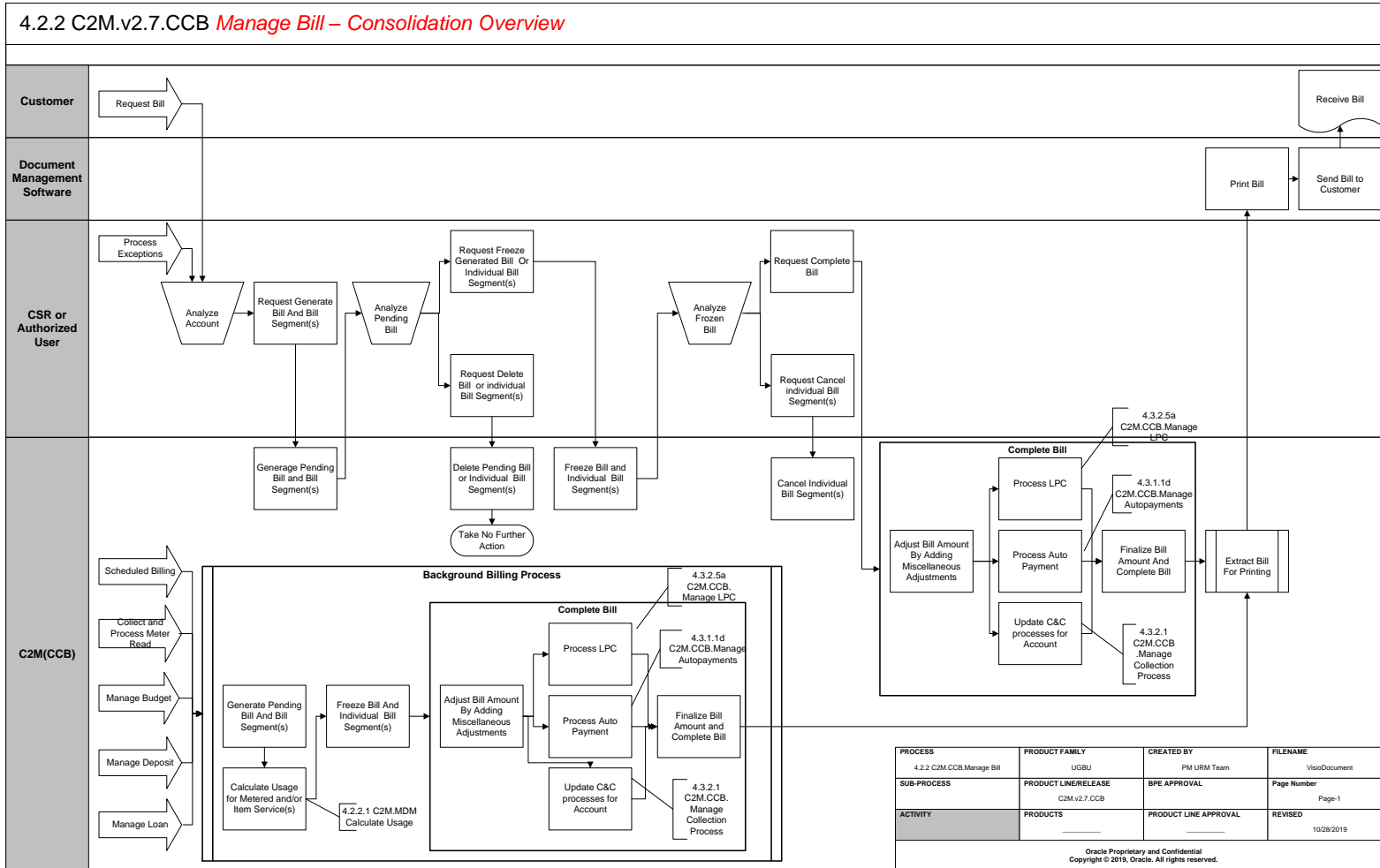
**Business Process:** 4.2.2 C2M.CCB.Manage Bill

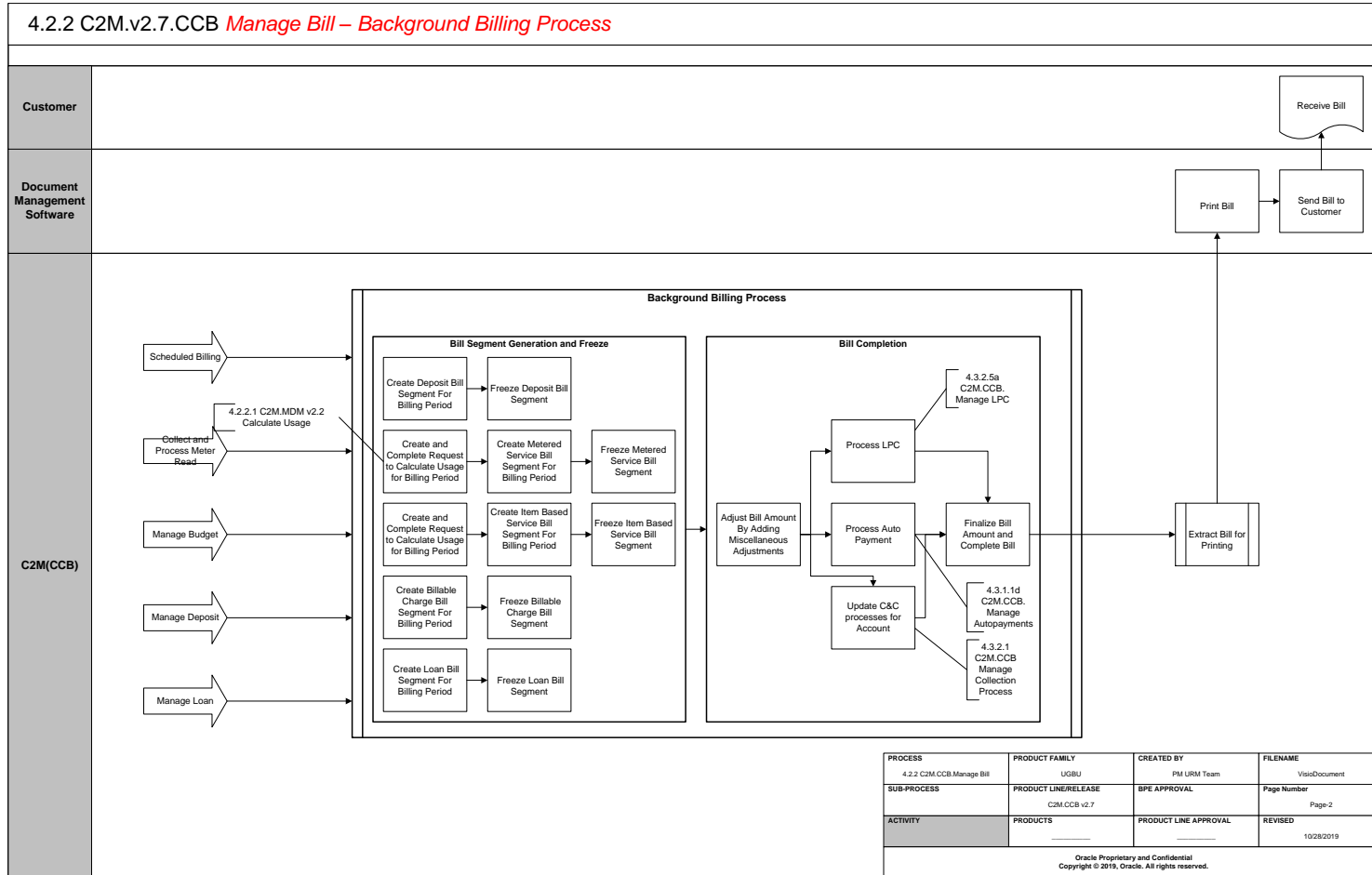

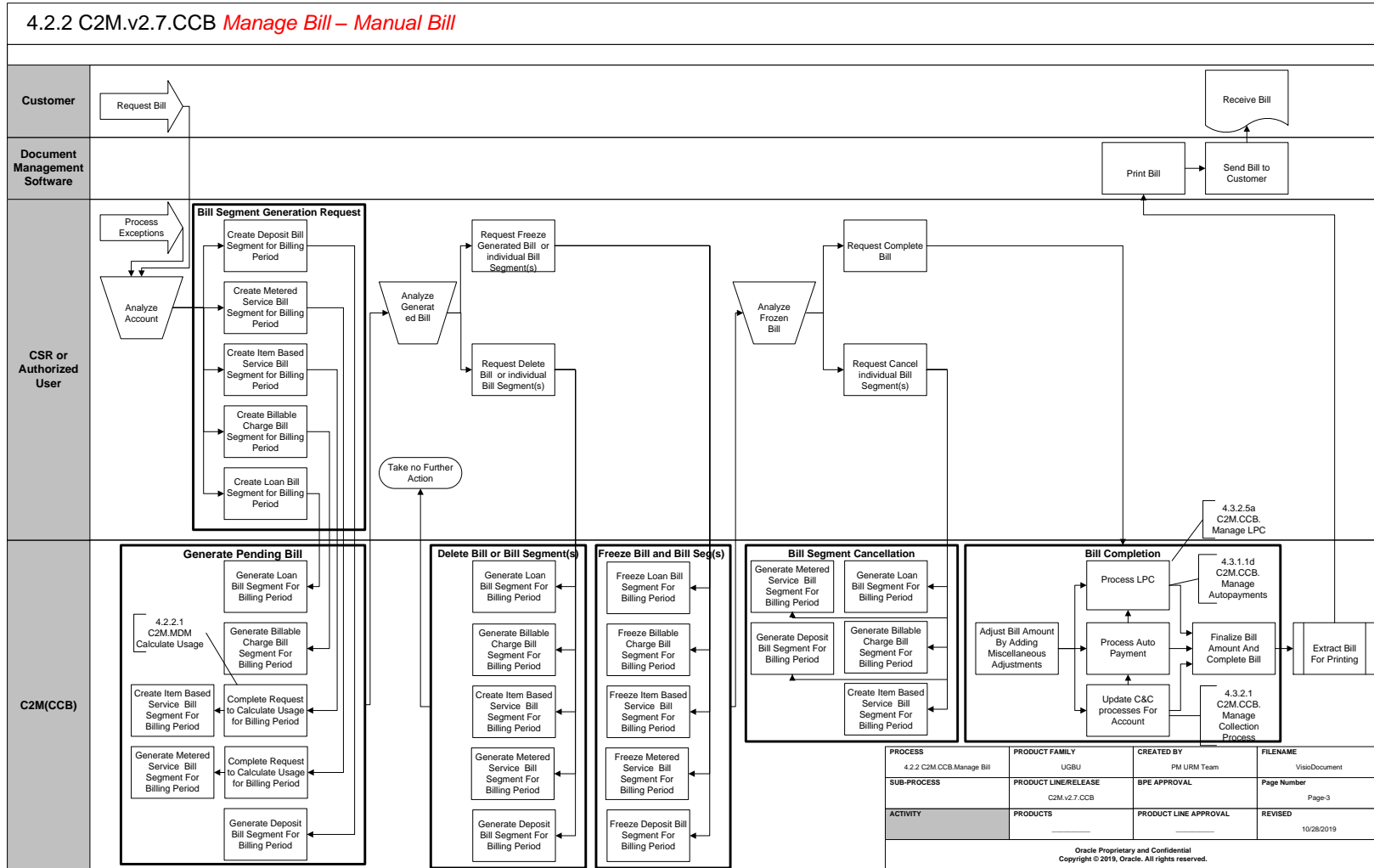
