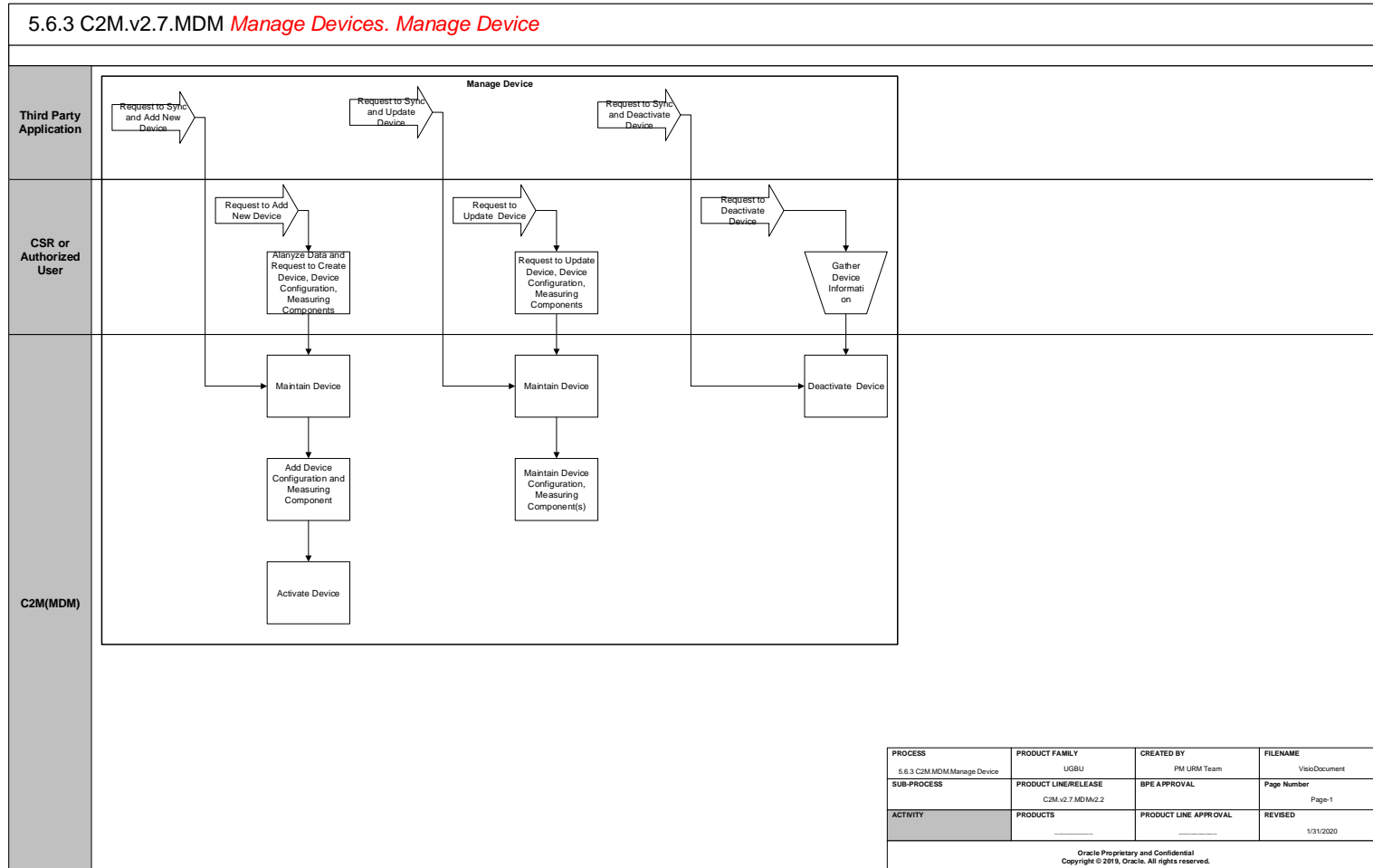

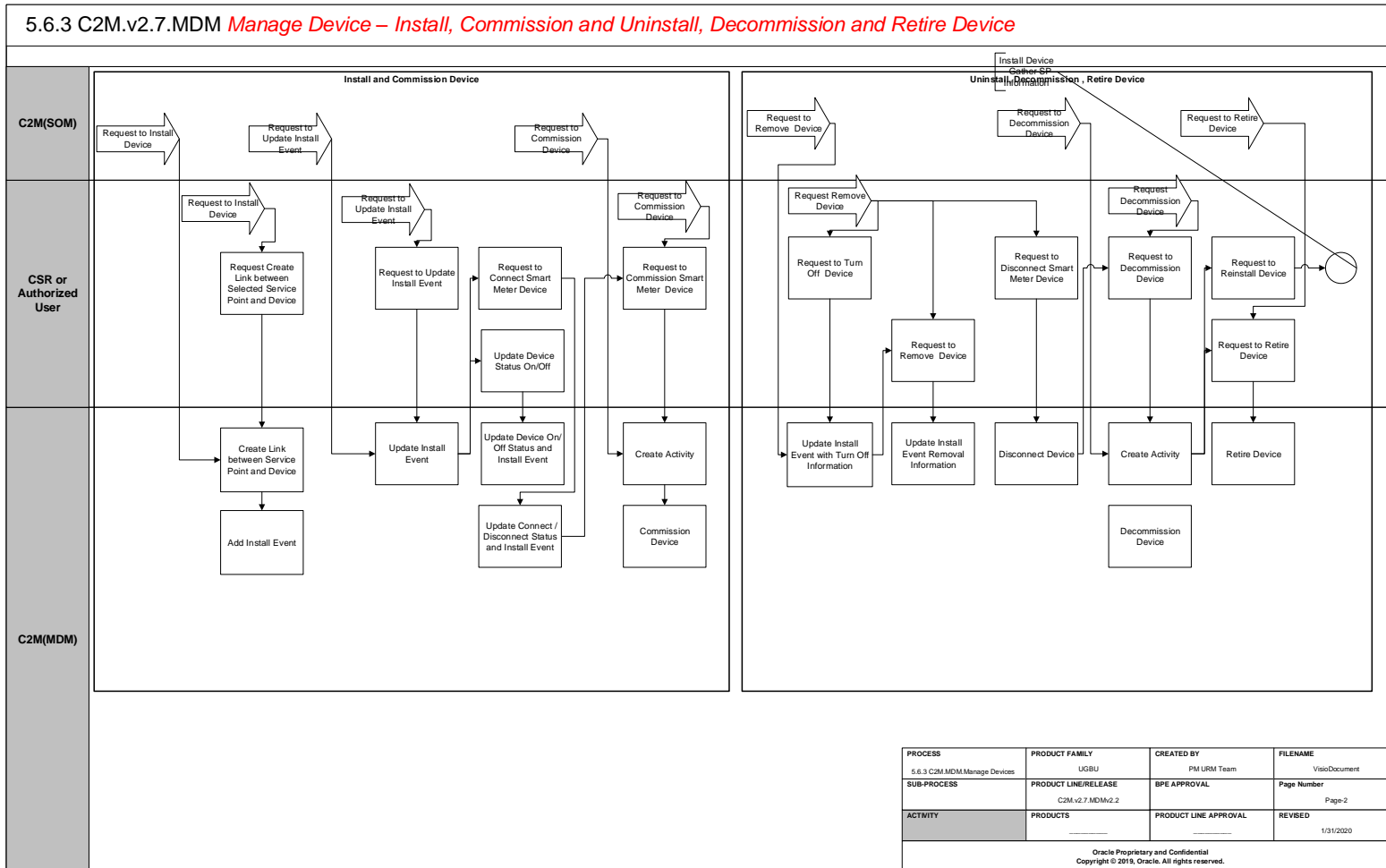
This process describes how business can handle device installation, un-installation, commissioning, decommissioning smart meter devices, and device retirement.
