The below section covers the most used business use cases across the presentation layer and the recommended extensibility patterns. Compliance to these recommendations will play a vital role in the OBEO product upgrades.

1.1.3 General Guidelines

Do's

- Principle to be followed is **Maximum Configuration**, **Minimum build**.
- For use cases which involve hiding or disabling the fields for all roles or role based Security
 Framework must be leveraged since it is all configurations and no build.
- The UI Custom development MUST adhere to the pattern recommendations of using the UI-Extension stated below for the following reasons:
 - Simple Java based development and hence no much appreciable change with regards to migration efforts. Lesser development efforts and faster upgrades.
 - Standards based development.
 - Support for out of the box product toggle available.

Dont's

- Refrain from using the ADF MDS Screen Customization for patterns where UI-Extensions can be leveraged for the following reasons:
 - MDS Customizations involves a lot of artefacts and build efforts are higher Custom Toggling needs to be implemented.
 - Higher Risk from an **Upgrade Perspective** since the customizations stands a chance of getting invalidated if the product base changes.
- Refrain from using Security to hide or disable components which require conditional rendering based on some business logic. Use UI - Extensions instead. Security will not be able to handle such cases.

1.2 Extensibility Patterns - Middleware Layer (Host)

The below table covers the most used business use cases across the middleware layer and the recommended extensibility patterns. Considering the middleware layer to be consumed by multiple channels (OBEO UI, Digital, and so on.), compliance to these recommendations becomes even more critical. Moreover, adherence will expedite the upgrades to higher versions.

1.2.3 General Guidelines

Do's

- The middleware custom requirements MUST adhere to the patterns mentioned below due to the following reasons:
 - No appreciable changes are required when the bank migrates from OBEO Middleware to a fullfledged OBEO implementation, hence faster upgrades.
 - Standardized development hence highly maintainable and easy to troubleshoot.

Dont's

- Do not re-write the entire Application Service if the requirement is limited to pre/post processing.
- DO not extend the APP Layer for Service Extensions and use the APPX layer for the following reasons:
 - Additional support for custom fields available in the Dictionary Array
 - Service Response is available in the APPX layer and hence can be validated or updated. The response is not available in the APP layer for any manipulation.
 - . Approvals can be incorporated and validated in the APPX layer which is not possible in the APP layer.

1.3 Extensibility Patterns - Middleware Layer (SOA)

The below section covers the most used business use cases across the SOA layer. Compliance to these recommendations will play a vital role in the OBEO product upgrades.

1.3.1 Patterns

The patterns are explained in the following table:

1.3.2 General Guidelines

Do's

- Previously the rule component was embodied in every single process resulting in redeployment of long running processes. Now all the rule components have been removed out of long running processes and logically grouped into a new process meant for Rules.
- This will ensure that only this process is re-deployed and hence faster and maintainable.
