# 2.1 Oracle Financial Services Analytical Applications Infrastructure (OFSAAI)

Oracle Financial Services Analytical Applications Infrastructure (OFSAAI) powers the Oracle Financial Services Analytical Applications family of products to perform the processing, categorizing, selection, and manipulation of data and information required to analyze, understand and report on specific performance, risk, compliance, and customer insight issues by providing a strong foundation for the entire family of Oracle Financial Services Analytical Applications across the domains of Risk, Performance, Compliance and Customer Insight.

# 2.2 About Oracle Financial Services Analytical Applications Infrastructure Extension Pack (OFS AAIEP)

The Oracle Financial Services Analytical Applications Infrastructure Extension Pack (OFS AAIEP) offers advanced features and functionalities that can be installed on top of OFSAAI. Before installing the Oracle Financial Services Analytical Applications Infrastructure Extension Pack you must <a href="install">install</a> an OFSAA instance having one or more OFSAA Application Packs.

The Oracle Financial Services Analytical Applications Infrastructure Extension Pack includes the following advanced features and functionalities:

- <u>Distributed Processing Capabilities</u>
  - Supports the deployment model that separates the components that serve the UI or Interactive Application Components from the components that serve to compute requirements of the batch jobs.

 Enables batch processes that must be distributed over multiple nodes by running multiple activation manager (job agent).

#### Analytic Pipeline and Process Models

- Supports interleaving of automated paths or swim-lanes with Human Decisioning tasks.
- Categorization of Pipelines

Categorizes the pipeline types appropriately depending on the nature of tasks that are being orchestrated for the following Pipelines:

- Workflow Pipeline
- Run Pipeline
- Sub-Run Pipeline
- Business Process Pipeline

- Orchestration of Run Pipeline that allows choreography of analytical jobs or Run Pipeline.
- Workflow Pipeline that allows human decisions and automated system task choreography.
- Analytical or Business Process Pipelines that interleave automated paths with human decision tasks. These pipelines can be interleaved with swim-lanes within a Process Model Orchestration.

#### Attribution Analysis

Attribution Analysis is a solution that is derived out of the PMF Application to specially address the requirements to compare Runs by modifying a variable from a list of variables and analyze reports. The Oracle Financial Services Attribution Analysis is a solution that is integrated with the PMF Application to specially address the following requirements for financial institutions:

- Compare Runs by modifying a variable from a list of variables. In other words, compare the Execution Runs in models by varying one factor and studying the impact on other factors that are linked to it.
- Analyze reports based on the comparison.

#### Event-Based Orchestration

The Consumer and Producer Widgets are enabled on the PMF Canvas. This allows users to perform event-based orchestration within PMF.

The Event Framework integrated in PMF is an event-driven messaging framework that uses Apache Kafka (messaging server) to process information asynchronously and in near real-time. Producers that are either external Applications or PMF internal processes, send messages (notify about an event occurrence) to Kafka Topic(s). Consumers, that are internal processes within PMF, read the messages from Kafka Topic(s) and execute other events or activities

configured in the PMF Canvas. The Framework uses the REST transfer protocol to send messages and the JSON data format to construct the messages.

#### Content Management Interoperability Services

The Content Management Interoperability Services (CMIS) is an OASIS standard enabling information sharing between different Content Management Systems. Document Management features can be configured to interface with the CMIS services to perform various operations such as document upload, download, and search. The documents are stored in the CMIS repository.

## 2.3 Installation Scenario

The Oracle Financial Services Analytical Applications Infrastructure Extension Pack can be installed on an OFSAA instance having one or more OFSAA Application Packs. This pack can be installed with any of the 8.1.2.x.x Application Packs.

## 3 Hardware and Software Requirements

The Oracle Financial Services Analytical Applications Infrastructure Extension Pack requires similar hardware and software requirements as Oracle Financial Services Analytical Applications (OFSAA) v8.1.2.0.0 Application Packs.

**NOTE** 

OFS AAIEP supports OEL 8 and Java 11.

## 4 Pre-installation Requirements

The Oracle Financial Services Analytical Applications Infrastructure Extension Pack can be installed on an OFSAA instance having one or more OFSAA Application Packs. This pack can be installed with any of the OFSAA 8.1.x.x.x Application Packs.

**NOTE** 

If the OFS AAIEP license is enabled in earlier versions of OFSAA, skip the installation steps mentioned in this document.

## 4.1 Download OFS AAIEP

To download the Oracle Financial Services Analytical Applications Infrastructure Extension Pack Release 8.1.2.0.0, follow these steps:

- 1. Log in to the Oracle Software Delivery Cloud (OSDC) with a valid Oracle Account.
- 2. Search for Oracle Financial Services Analytical Applications Infrastructure Extension Pack.
- 3. Download the Oracle Financial Services Analytical Applications Infrastructure Extension Pack 8.1.0.0.0 installer and copy (in Binary Mode) to the download directory that exists in the OFSAA Installation Setup.

## **4.2** Extract the Software

You must be logged in to the UNIX Operating System as a non-root user where OFSAA is installed. To extract the software, follow these steps:

1. Download the unzip utility (OS-specific) unzip\_<os>. Z and copy it in Binary Mode to the directory that is included in your PATH variable.

If you already have an unzip utility to extract the contents of the downloaded archive, skip this step. Uncompress the unzip installer file with the command:

```
uncompress unzip <os>.Z
```

**NOTE** 

If an error message "uncompress: not found [No such file or directory]" is displayed, contact your UNIX Administrator.

**2.** Extract the contents of the OFS AAIEP Release 8.1.2.0.0 installer archive file in the download directory with the following command:

```
unzip -a OFS AAIE PACK 8.1.2.0.0 GENERIC.zip
```

3.	Navigate to the download directory and assign execute permission to the Installer Directory with
	the following command:

chmod -R 755 OFS\_AAIE\_PACK

## 5 Install OFS AAIEP

To install the Oracle Financial Services Analytical Applications Infrastructure Extension Pack, follow these steps:

- 1. Log in to the system and navigate to the directory where you have extracted the pack.
- 2. Execute the UNIX user .profile file.
- 3. Navigate to the OFS AAIE PACK directory.
- 4. Execute the ./OFSAAI AAI Extn Pack.sh command in the console to install the pack.
- The installer proceeds with the Pre-installation Checks.
   Check if the pack is applied successfully. Contact My Oracle Support in case of any errors.
- **6.** Restart all the OFSAAI Services. For more information, see the Starting or Stopping Infrastructure Services section in the Oracle Financial Services Analytical Applications Infrastructure Installation & Configuration Guide 8.1.2.0.0.
