1 OFS ALM Release 8.0.0.1.0

OFSALM 8.0.0.1.0 Maintenance Level (ML) includes all the bug fixes and enhancements done since the previous GA (General Availability), that is, 8.0.0.0.0.

1.1 Pre Installation Requirements

You should have OFS ALM Application Pack version 8.0.0.0.0 as the minimum patch set level.

Note:

- For AIX operating system, execute the Slibclean command by root user permission.
- If OFS ALM 8.0.0.1.0 release is being installed on an OFSAA instance where the version of platform (OFS AAI) is already upgraded to a higher release for example 8.0.1.0.0, you need to additionally download patch 21949807 from https://support.oracle.com/ and follow the instructions mentioned in Readme of patch 21949807.



• If you have already installed OFSAA 8.0 Language Pack, you need to additionally download the patch 21221246. Download the patch from https://support.oracle.com/ under the Patches & Updates tab and copy it to your OFSAA server in Binary mode.

1.2 How to Apply This Maintenance Level Release?

Refer to the following instructions to install this maintenance patch.

- Login to https://support.oracle.com/ and search for 21146711 and under the Patches & Updates tab.
- 2. Download the OFS ALM Application Pack 8.0.0.1.0 ML archive file and copy it to your OFSAA server in **Binary** mode.

NOTE: Rename or remove the existing OFSAA Application Pack folder from the OFSAA server prior to extracting the contents from the release archive (.zip).

For example: For this release when extracted from the archive creates a folder with name OFS_ALM_PACK. Rename or remove if a folder with the same name exists in the path where the release archive is copied.

NOTE: There are different archive files for different operating systems such as AIX, Solaris, and RHEL/OEL. The following are the archive files available for this release:

AIX: p21146711 80000 AIX64-5L.zip

Linux x86-64: p21146711 80000 Linux-x86-64.zip

Oracle Solaris on SPARC (64 bit): p21146711_80000_SOLARIS64.zip

- Stop all the OFSAAI services. For more information, see the Start/Stop Infrastructure Services section in Oracle Financial Services Asset Liability Management Application Pack Installation Guide Release 8.0.0.0.0
- 4. Assign WRITE permission to the files/ folders such as commonscripts, EXEWebService, ficapp, ficweb, and ficdb in the \$FIC_HOME folder by executing the command:

```
chmod -R 775 *
```

- 5. If you have Unzip utility, skip to the next step or download the Unzip utility (OS specific) and copy it in **Binary** mode to the directory that is included in your PATH variable, typically **\$HOME** path or directory in which you have copied the 8.0.0.1.0 ML.
 - Uncompress the unzip installer file using the command:

```
uncompress unzip <os>.Z
```



NOTE: If you notice an error message "uncompress: not found [No such file or directory]" when the package is not installed, contact your UNIX administrator.

• Give EXECUTE permission to the utility using the command:

```
chmod 751 unzip_<os>
```

For example, chmod 751 unzip aix

6. Extract the contents of the 8.0.0.1.0 ML archive file using either of the following commands:

```
unzip_<os> -a <name of the file to be unzipped>
OR
unzip -a <name of the file to be unzipped>
```

NOTE: The above "-a" option is mandatory to unzip the archive file.

For example: For AIX operating system

unzip_aix -a p21146711_80000_AIX64-5L.zip

 Update the parameters in params.conf file present in /OFS_ALM_PACK/OFS_ALM/conf directory. The update instructions are present in the file itself.

NOTE: Data model upload is required for ALM 8.0.0.1.0 release, only if you have customized the data model.

8. Give EXECUTE permission to the ML patch installer script. Navigate to the path OFS ALM PACK/bin and execute the command:

```
chmod 755 OFSAAIUpdate.sh
```

9. Execute the following command:

```
./OFSAAIUpdate.sh
```

Verify if the release is applied successfully by checking the log file generated in the installation folder in the path <code>PATCH_EXTRACTED FOLDER>/OFS_ALM_PACK/OFS_ALM/logs/OFS_ALM_patch_installation.log.</code> You can ignore ORA-00001 and ORA-02292 in the log file. In case of any other errors, contact Oracle Support.

- 10. Post successful installation of the ML, perform the following steps:
 - Clear the application cache. Navigate to the following path depending on the configured web application server and delete the files.



Tomcat:

<Tomcat installation folder>/work/Catalina/localhost/<Application name>/org/apache/jsp

Weblogic:

<Weblogic installation location>/domains/<Domain name>/servers/<Server
name>/tmp/_WL_user/<Application name>

Websphere:

<Websphere installation directory>/AppServer/profiles/<Profile name>/temp/<Node name>/server1/<Application name>/<.war file name>

11. Extract and install the patch **21221246** by following instructions mentioned in the Readme.txt.

NOTE: This step is required only if you have already installed OFSAA 8.0 Language Pack and you need to apply the patch **21221246.** For details, refer to Pre Installation Requirements section.

- 12. Delete the existing EAR/WAR file available in the folder \$FIC HOME/ficweb.
- 13. Generate the application EAR/WAR file and redeploy the application onto your configured web application server. For more information on generating and deploying the EAR/ WAR file, refer to the Post Installation Configuration section in Oracle Financial Services Asset Liability Management Application Pack Installation Guide Release 8.0.0.0.0
- 14. After successful installation of the ML, start all the OFSAAI services. For more information, refer to the Start/Stop Infrastructure Services section in Oracle Financial Services Asset Liability Management Application Pack Installation Guide Release 8.0.0.0.0.
