### 1.4 <u>Release Highlights</u>

The following enhancements are made to OBCFPM in 14.4.0.0.0 release.

#### 1.4.1 Facility Management

- Simplified processes for credit proposal evaluation, credit proposal handoff, and credit proposal evaluation restructuring
- Support to capture additional information about the Facility and Liability
- Provision to link / unlink collaterals to / from the existing collateral pool
- Takeover feature to acquire existing facilities from the other banks
- Provision to add multiple pricing components for a single facility



- Support to capture details about the countries at risk in party onboarding process
- Modification of existing facilities already created in Back Office system (ELCM) is restricted based on data segment configuration
- Provision to capture details about the related parties and their exposure as a separate data segment
- Groupwise Exposure data segment is added for capturing exposure details of customers / related parties in other banks
- UX enhancements in Summary screen
- Provision to configure watermark text in comments box
