## 2. Domain & Cluster Configuration

### 2.1 Domain Configuration

#### 2.1.1 Prerequisite

- Database setup for all the modules viz. Plato, SMS, Common Core, OBSCF Services and all Day-0 setups must be completed. **(Required)**
- Machine should have Java JDK 1.8 Update 241 installed.
- Oracle Fusion Middleware Infrastructure 12.2.1.4.0 has to be installed on the machine.

#### 2.1.2 Domain Creation and Configuration

It is recommended to create the domain structure as given below and also to maintain the same nomenclature. For Creating Domain and Configuration, please refer to the “**Create and Cluster Configuration**” from **Annexure** guide.
