1.4 Release Highlights

The rationale for the release of Oracle Banking Trade Finance Process Management version 14.4.0.0.0 is to roll out additional processes in the Trade finance life cycle to support banks' operational requirements, Customer Experience and regulatory requirement.

1.4.1 Enhancements

Following enhancement are made as part of release version 14.4.0.0.0:

1. Import Documentary Collection Booking - New Advices hop introduced to the advices generated to the back office system.
2. Import Documentary Collection Booking - New settlement details screen introduced to display the settlement details simulated from back office.
3. Enquiry - Enquiry of contracts stored in back office and mid office are now enabled in OBTFPM application, which enables to view the details of the contracts.
4. Tracer support is now available in all the import and export processes

- Acknowledgement for Export Documentary Collection Booking and Update.
- Preview Message display for all the new processes along with the existing processes.
- Notification of Rejection of Request
- Limit and Collateral Verification if required
 - Automated Limit Checks and
 - Automated Collateral Checks
- Compliance Checks
 - Automated KYC Status Verification
 - Linkage to AML and Sanction Engine
- Exception Approval if required
 - KYC Exception Screens
 - Limit Exception Screens
 - Amount Block Exception Screens
- Charges Replication from Backend System
 - Replicates and populates the Charges maintained for the Products used from FLEXCUBE UBS
- Customer and other common Core items replication from Backend System
 - Replicates Customer, Branch and other common maintenances from FLEXCUBE UBS
- Draft Confirmation of Import LC Amendment
 - Customer can confirm the LC Amendment before transmission to Advising bank
