# 1 Oracle Insurance Accounting Analyzer Application Pack (Language Pack) 8.1.1.2.4 Release

This document describes the necessary steps to install/upgrade and configure 8.1.1.2.4 (Language Pack) and enable the UI of Oracle Insurance Accounting Analyzer Application Pack in different languages in addition to US-English. The language Packs supported in this release is *Russian*.

## 1.1 Pre Installation Requirements

1. Install the Oracle Insurance Accounting Analyzer Application Pack 8.1.1.2.0 or higher before you proceed to the Language Pack Installation. Log in to [My Oracle Support](#) and search for **33300674** under the **Patches & Updates** Tab. For more information on installing this release, see the [Oracle Insurance Accounting Analyzer Installation Guide](#).
2. Log in to [My Oracle Support](#) and search for the 8.1.1.2.3 patch **33593989** under the **Patches & Updates** Tab. Perform the following steps to install the patch:

- a. Download the Oracle Insurance Accounting Analyzer v8.1.1.2.3 archive file from MOS and copy it to your OFSAA server in **Binary** Mode.
- b. Stop all the OFSAA Services.

- c. If you have the Unzip utility, skip to the next step, or, download the Unzip utility (OS-specific) and copy it in **Binary** Mode to the directory that is included in your PATH variable, typically \$HOME path or directory in which you have copied the language pack archive file.
- d. Extract the contents of the Oracle Insurance Accounting Analyzer Application Pack Language Pack 8.1.1.2.3 archive file using the following command:

```
unzip <name of the file to be unzipped>
```

For example, `unzip 33629590_GENERIC.zip`

- e. Grant 755 permissions to the Installation and Download Directory.
- f. Navigate to `OFS_IIA/bin` directory. Perform the following **Silent Mode** steps:
  - i. Navigate to the path `<directory>/appsLibConfig/conf`.
  - ii. Edit the `params.conf` File.
  - iii. Modify the `UPLOAD_MODEL` parameter to 0.
  - iv. Navigate to the path `<directory>OFS_IIA/bin` Path and Execute the command `./setup.sh SILENT Path`.

3. Install the Oracle Financial Services Analytical Applications Infrastructure Language Pack 8.1.1.0.0. Log in to [My Oracle Support](#) and search for **33071689** under the **Patches & Updates** Tab. For more information on how to install this pack see the [Oracle Financial Services Analytical Applications Infrastructure Language Pack Installation and Configuration Guide](#).

## 1.2 How to Apply this Language Pack Release?

To install the contents of this ML (Language Pack), follow these steps:

1. Log in to [My Oracle Support](#) (MOS) and search for **33629590** under the *Patches & Updates* Tab.
2. Download the Oracle Insurance Accounting Analyzer v8.1.1.2.4 Language Pack Release archive file from MOS and copy it to your OFSAA server in **Binary Mode**.
3. Stop all the OFSAA Services.

4. If you have the Unzip utility, skip to the next step, or, download the Unzip utility (OS-specific) and copy it in **Binary Mode** to the directory that is included in your PATH variable, typically \$HOME path or directory in which you have copied the language pack archive file.
5. Extract the contents of the Oracle Insurance Accounting Analyzer Application Pack Language Pack 8.1.1.2.4 archive file using the following command:

```
unzip <name of the file to be unzipped>
```

For example, `unzip 33629590_GENERIC.zip`

6. Grant 755 permissions to the Installation and Download Directory.
7. Navigate to OFS\_IIA/bin directory. The Language Pack installation is supported in both and **Silent Mode**.
  - i. Navigate to <directory>/appsLibConfig/conf
  - ii. Edit the params.conf
  - iii. Modify the UPLOAD\_MODEL parameter to 0
  - iv. Navigate to <directory>OFS\_IIA/bin path and Execute the command `./setup.sh SILENT`

### NOTE

- Do not use process-interrupting commands such as Ctrl+C or Ctrl+Z, which may terminate the process abruptly.

8. Post successful installation of the Language Pack, perform the configurations as explained in the [Post Installation Configuration](#) Section.
9. Delete the existing EAR/WAR file available in the \$FIC\_HOME/ficweb folder.

10. Generate the **EAR/WAR** file and redeploy the application onto your configured Web Application Server.

11. After the Language Pack has been installed successfully and post-installation configurations are done, **restart** all the OFSAA Services.

## 1.2.1 Report Configuration (OBIEE)

Perform the following steps to configure the reports in OBIEE/OAS for Russian Language:

1. Navigate to **\$FIC\_HOME/IIABI/OBIEE 12.2.1.4.0/Repository** Directory containing the **IFRS17.rpd** File and deploy the RPD. For more information, see the **OBIEE Configuration - Deploy OFS IIA Analytics** section in the [Oracle Insurance Accounting Analyzer Installation Guide](#).
2. Navigate to **OFS\_IIA/bin/IIABI/OBIEE 12.2.1.4.0/Catalog** Directory containing the **IFRS17\_RU.catalog** File and deploy the Catalog.
3. Log in to OBIEE/OAS , navigate to the **Adminstration** Page, select the **Import Caption** option, and then select the Russian language.
4. Import the following XML files from the **OFS\_IIA/bin/IIABI/OBIEE 12.2.1.4.0/Catalog** folder in the below sequence:
  - a. **ifrs17captions\_ru\_RU.xml**
  - b. **long+duration+contractscaptions\_ru\_RU.xml**
  - c. **subledgercaptions\_ru\_RU.xml**
5. Select **Save** and then log out.
6. Log in to OBIEE/OAS, select the Russian language and view the translated strings in the Russian language.
7. Edit the Global Variables.
  - a. In the **Dashboards** drop-down list, click **Disclosure Reports** to open the dashboard.
  - b. Click **Edit** on any of the reports to open the settings window.
  - c. In the **Criteria** tab, in the **Selected Columns** pane, click the **Onerous Classification Code**.
  - d. Click **Settings**  to open the settings submenu.
  - e. Click **Edit** formula to open the **Edit Column Formula** window.
  - f. In the **Variables drop-down list**, select **Global...** to open the **Insert Global Variable** window.
  - g. Select the Global Variable that you want to edit, and then click **Edit Global Variable** .
  - h. Edit a global variable with the following details:

## i. Table 1: Required Values for the Global Variable

Field	Value to be added
Name	denomination
Type	Text
Value	case when '{@denomination}{in thousand}' = 'В тысячах' then 1000 when '{@denomination}{in thousand}' = 'В миллионах' then 1000000 else 1 end

This variable is used to divide all amount values by thousand or million, depending on the selected criteria.

j. Click **OK**, and then click **OK** again to save.
