



Oracle Financial Services Capital Adequacy Pack (OFSCAP) Application Pack Release 8.1.2.7.0 One-off Patch Release #1 (8.1.2.7.1)

Description

Patch ID **37831581** - PATCH RELEASE RCAIII QUALIFICATION ON 812X v8.1.2.7.0 ONE-OFF PATCH RELEASE #1 -8.1.2.7.1.

Pre-installation Requirements

- Ensure that you have installed the Oracle Financial Services Capital Adequacy Pack 8.1.2.7.0
- If AAI version is 8.1.2.5.0 then AAI patch 8.1.2.5.7 should be deployed mandatorily

How to Install this Release

To install the one-off patch, follow these steps:

1. Log in to [My Oracle Support](#), and search for **37831581** under the **Patches & Updates** tab.
2. Download the **37831581_GENERIC.zip** archive file and copy it to your OFSAA server in Binary mode.
3. Extract the contents of the patch archive file using the command:
unzip -a <name of the file to be extracted>
For example: unzip -a 37831581_GENERIC.zip

NOTE The -a option is mandatory to unzip the patch.

If you notice the error message: unzip: not found [No such file or directory] before the package is installed, contact your UNIX administrator.

4. Navigate to the following directory: `./appsLibConfig/conf`
5. Update **params.conf** file with appropriate values for `UPLOAD_MODEL=0`
6. Provide **RWX** permissions to the shell script: `./OFS_BASELA/bin/setup.sh`
7. Stop all the OFSAAI services and web services.
8. Execute the **setup.sh** script.
9. Check the log **OFS_BASELA_installation.log** file in the `./OFS_BASELA/logs` directory to ensure that the patch is applied successfully.
10. Delete the existing EAR/WAR file available in the `$FIC_HOME/ficweb` folder.
11. Generate the application EAR/WAR file and re-deploy the application onto your configured web application server.
12. Restart all the OFSAAI services and web services.

13. Please add the seeded data bundled in the installer at `../OFS_BASELA/bin/scripts/RCAIII/Seeded_Data_RCAIII_8.1.2.7.1` manually in the atomic schema with running skeys of respective tables.

NOTE For solo and consolidated datamodel files deployment in BIP and information related to RCAIII batches, please refer to the Analytics User Guide.
