## 1 Features and Updates

The Oracle Payment Interface 20.3 Release contains the features and changes below.

### Oracle Payment Interface Configuration Tool

The Oracle Payment Interface Configuration tool includes the following enhancements:

 Improved usability by adding the required prefix to the generated IFC8 communication key for easier configuration during the Merchant Setup of the Oracle Payment Interface.

### **Oracle Payment Interface Core**

Oracle Payment Interface 20.3 includes the following core product enhancements:

- Added support for PMS gift card transaction types:
  - Activate/Issue
  - Redeem
  - Void
  - Reload (Top-up)
  - Cashout/Close Card
  - Balance Inquiry
  - Balance Transfer

### NOTE:

This is only available for PMS versions that also support Gift Card Functionality.

- Added support for Virtual Credit Card (VCC) Indicator to confirm a transaction is out of scope for Secure Customer Authentication (SCA) requirements for PSD2.
- Added functionality to support masking the last 4 digits of PAN in addition to the existing PAN masking to support requirements in regions/countries that cannot support the last 4 digits of the PAN.

- Added support for the following Merchant Initiated Transaction (MIT) Indicators:
  - MIT No Show (3904) For No Show Fees
  - MIT Prepayment (I) For payments processed using the Deposit Rules Feature that allows a Pre-Payment prior to arrival using card\token on file
  - MIT Incremental (3900) For any Top Up Authorisation
  - MIT Delayed Charges (3902) for Mini Bar and Late Charges processed after the guest has checked out
- The ability to send through a MOTO flag for any financial transaction processed where the card number is manually entered into OPERA using the OPERA Payment Widget.
- Added option to disable EOD request being sent to Payment Service Provider
