### 2.2 Pre-requisite

In this section, you are going to setup database related configuration for OBCFPM Installation. Before you proceed, ensure pre-installation setup is done. The pre-installation setup includes the configuration of database. After creating the schema for each of the required micro services, DDLs and INCs of each micro-service to be compiled in the respective schemas. The DDLs and INCs ensure the creation of tables and availability of static data required for the execution of services. These are compiled automatically using flyway.

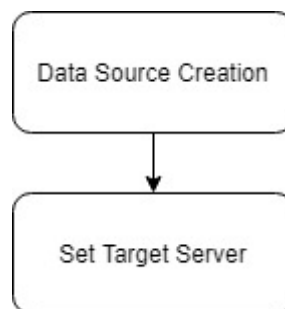

## 4. Data Sources Creation

### 4.1 Pre-requisite

Database setup for OBCFPM has to be performed prior to deployment setup. The data sources for the respective micro-services must be created first before the application deployment. 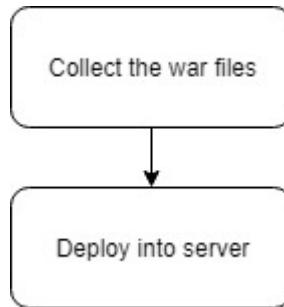

## 5. Deployments

#### 7.1.1 Logging Area:-

OBCFPM Application writes logs in the below area of the server-

<WEBLOGIC\_DOMAIN\_CONFIG\_AREA/servers/OBCFPMAPP/logs/ OBCFPMAPP.out

Let’s assume a domain has been created **obcfpm\_domain** with **managed\_server** name called **OBCFPMAPP** in the following area of the server

/scratch/oracle/middleware/user\_projects/domains/**obcfpm\_domain**”. Logging area for OBCFPM applications would be  
**/scratch/oracle/middleware/user\_projects/domains/obcfpm\_domain/servers/OBCFPMAPP/ogs/ OBCFPMAPP.out.**
