1.5 **Release Enhancements**

1.5.1 <u>Trade – Common Feature</u>

1. MT759 – Tag 23H Changes

- Description for the following function codes are updated as per the latest SWIFT 2020 change request.
 - CLSVCLOS Closing of a service call by Trade Operations
 - CLSVOPEN Opening of a service call by Trade Operations
 - PREDENOT Pre-debit notification
 - REXTMATU Request to extend the maturity date
- > REXTMATU function code is made applicable only for Letter of Credit transactions.

2. MT799 - Tag 59 Population

System enhanced to populate tag 79 with five narrative fields with each tag 79 narrative holding 35*50 from screen 'Trade finance common group message maintenance' and from call form Common group message' of Islamic Letter of Credit/Letter of credit contract input screen and Islamic Bills and Collections/Bills and collection contract input screen.

3. Customer Data Population

On co-deployment, the customer and customer specific details maintained in customer maintenance will be populated to Trade finance customer maintenance using a job in stipulated time interval.

4. ECA Force Block

- OBTF system has been enhanced to resend the ECA request by enabling force block automatically on receiving the following error response from FCUBS system due to insufficient balance of the account.
 - CA-ECA02 Block Amount greater than Available Balance.
 - CA-ECA05 Failed in account balance validation for account \$1 branch \$2.
 - CA-ECA49 Block amount \$1 greater than available balance \$2 for the Overdraft Account
- > On the above error response, OBTF will check for
 - Force posting at the branch level and Force block limit amount maintenance for the Source, Debit Currency and customer combination to initiate a second ECA request with a new external reference number and Force Block as 'F'.
- On EA response from FCUBS, OBTF parses the EA response and checks the tag <TXNSTAT> value. If it is rejected parses error nodes and logs the error, error description and marks the external system status as Error.



1.5.2 Documentary Credit

1. Assignment of Proceeds Walk – in Customer Changes

- > Provision to add multiple Assignees with same walk-in customer id
- > Provision to modify Walk-in Customer name in Assignee Details
- > Assignee name for Bank Customers and Third Party Customers cannot be modified.
- Provision to de-support Other Party Customers as Assignees

2. Amendment of Closed LC's

- System enhanced to support Re-open of Import LCs from LC Amendment Confirmation
- > Closed contract will be made available in LC Amendment confirmation
- > New flag Reopen Request checkbox will be provided
- System will support Reopen of closed contracts only. Reopen of active contracts will not be allowed.
- Amendment and Cancellation of Closed contracts will be restricted. System will provide appropriate error
- Close / Cancel is supported on or after LC expiry date as per existing functionality. System will not validate LC outstanding amount during closure.
- Close / Cancel before expiry date is supported only if LC outstanding amount is zero, else system will provide appropriate error message

3. Tax Component in Export LC Advices

> Export LC Advices enhanced to provide Tax components along with Charge components

4. MT 798 – Changes of LC Messages.

5. MT 798 – Changes of Bills under LC Messages

- System enhanced to support MT 798 Bank-to-Corporate Bills under LC Trade Envelope Messages as per latest SWIFT 2020 standards for below messages
 - Notification of Advice of Discharge
 - Notification of Advice of Refusal
 - Response to Documentary Credit Presentation
 - Advice of Discrepancy
 - Notification of Authorization to Pay, Accept or Negotiate
 - o Notification of Advice of Payment/Acceptance/Negotiation
 - o Notification of Advice of Reimbursement or Payment Index
 - Settlement of Import Documentary Credit
 - Settlement of Export Documentary Credit

6. Document Arrival Notice for Multi tenor Bills

For Multi-tenor bills the Document Arrival Notice (DAN) sent to counterparty (drawee/applicant) is enhanced to include split for each tenor, currency, bill amount, base date, tenor, and maturity date for a bill as a grid.

 - Query to extend or pay Guarantee / Standby Letter of Credit B2C
 - Advice of Guarantee / Standby Letter of Credit Reduction or Release B2C

1.5.4 Zero Downtime Patch Set Installation

Patch set Installation with Zero downtime (ZDT) requires Installer to use Editions in a Database Schema. Installer is enhanced to use Database Schema Editions and apply the DB compilation in patch set edition and then Base edition in a staggered manner to achieve Zero Downtime during the Patch set Installation. Installer is enhanced to have the JDBC connections through Application, Gateway etc. to point to a specific edition (Patch set edition or Base edition) at appropriate stages.
