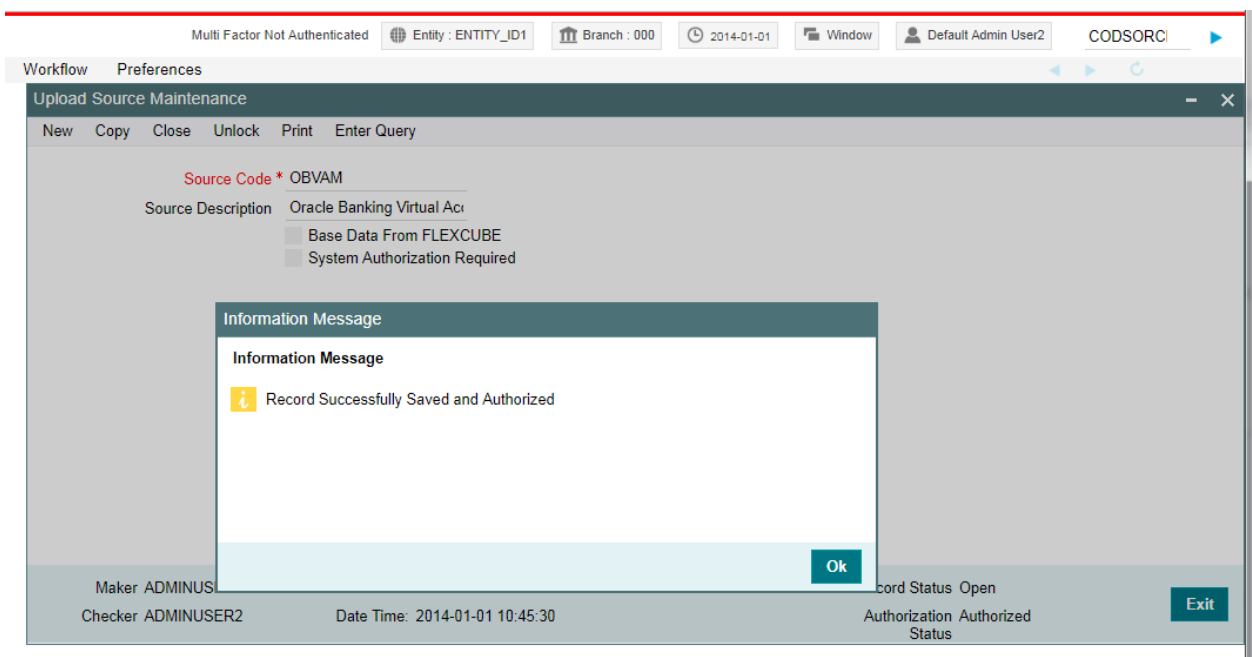
3.1 Introduction
