About Credit 360

Credit 360 in OBCFPM is a smart interface designed to track all the credit related components from single place. The credit related components include facilities, collateral, covenants, terms and conditions, financial profile, etc, that are required to be monitored on a regular basis.



Customer Credit 360


You can view Credit 360 information for all the existing customers to whom the facility is provided by the bank.












12. To view more information about the specific facility category, click on the required category in the pie chart. The data for the selected category appears.

- 16. To view the facility list, click the table icon. The *Facility List* window appears.




17. To view the liability details, mouse hover on the **Liability details** section and click **View**. The *Liability details* window appears.















- 41. To exit the *Pricing* window, click **Close**.






















