3. Quick Snapshot

Quick Snapshot feature is available on the login page of futura bank mobile application. Using this option retail user can view the account summary from mobile application and get important account information in a single view without going on the dashboard.

Quick Snapshot displays the account balance of Current and Savings account and recent transactions on those accounts.

Pre-Requisites

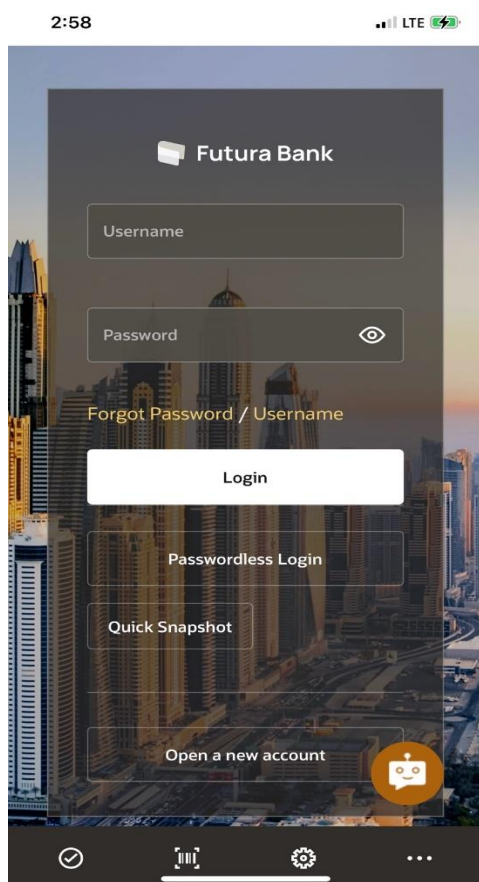
- The User must download futura bank Application and have a valid account with bank with online banking enabled.

To view accounts summary:

Option 1: From the pre-login page, enable the Quick Snapshot to view the snapshot of Current and Savings account.

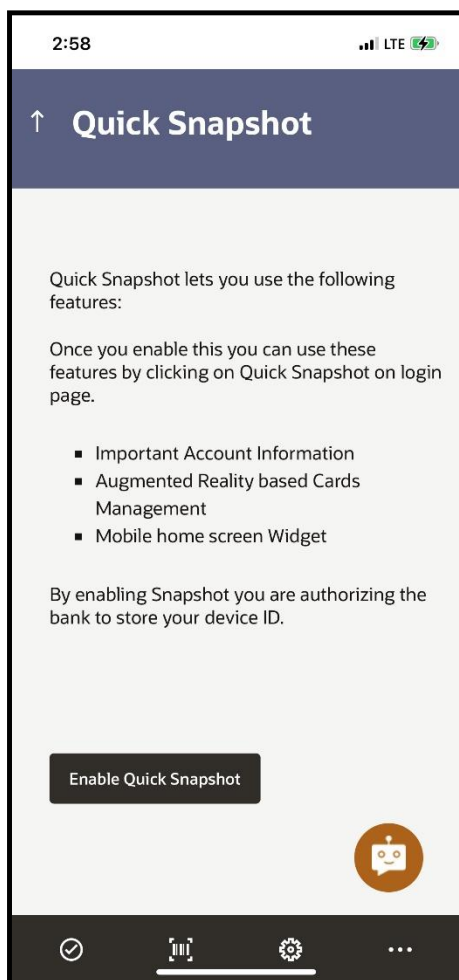
1. Launch the **futura bank** application Page. The **futura bank** login page appears.

2. Click on the **Quick Snapshot**. The **Quick Snapshot** screen appears.

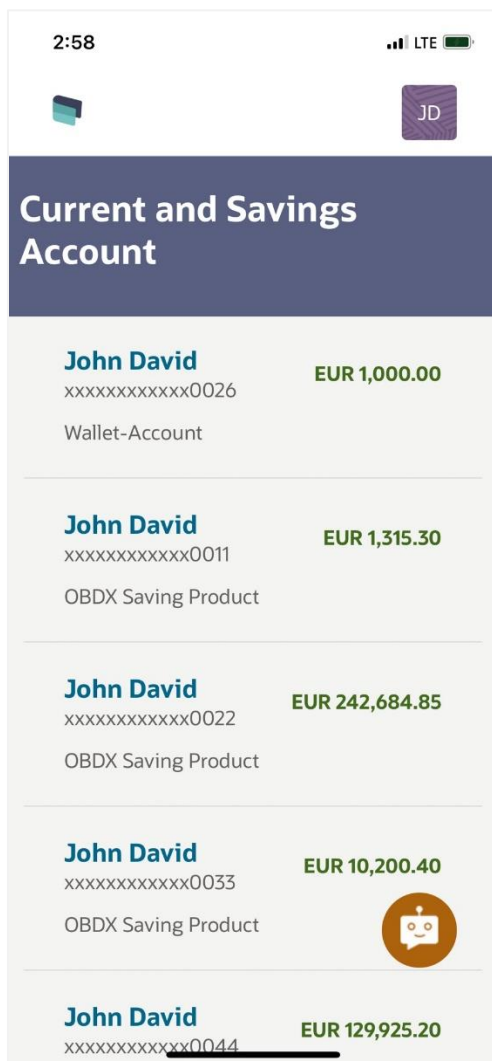
Enable Quick Snapshot Feature



3. Click on the **Enable Quick Snapshot** to enable quick snapshot feature from futura bank application for the first time. The future bank login page appears.
4. Login to Futura Bank app.
5. On click user is redirected to account snapshot screen. Application displays the recent transactions of Current and Savings accounts with account details.


Note: This is one time activity for enabling the quick snapshot. From next time user will directly be taken to account snapshot after clicking on **Quick Snapshot** button.

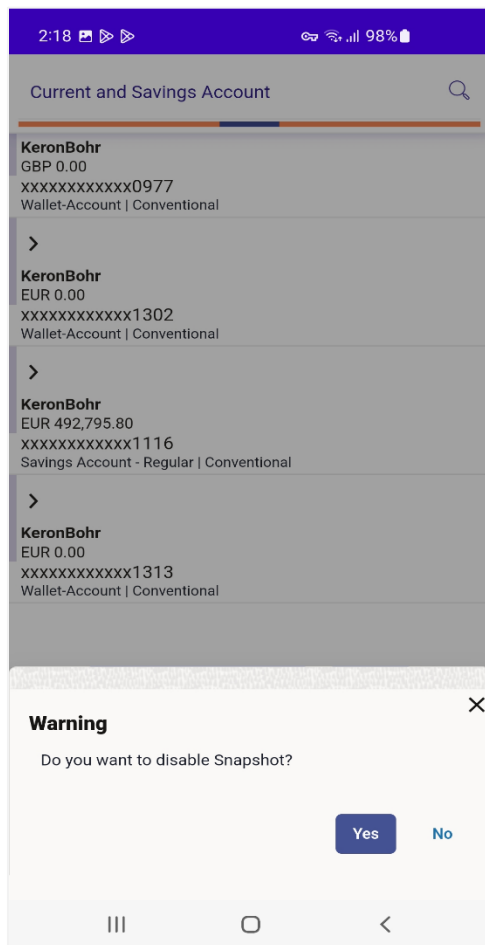

Account Number	Account number in masked format.
Product Name	The name of the CASA product.
Account Type	Type of the account.

Note: Click on the  icon to view the transaction details.

6. Click **Disable Account Snapshot** to disable the quick account snapshot facility for the account. The **Warning** modal window appears to confirm.
OR
Click **Logout** to log out of the application.

Click **No** to cancel the process.

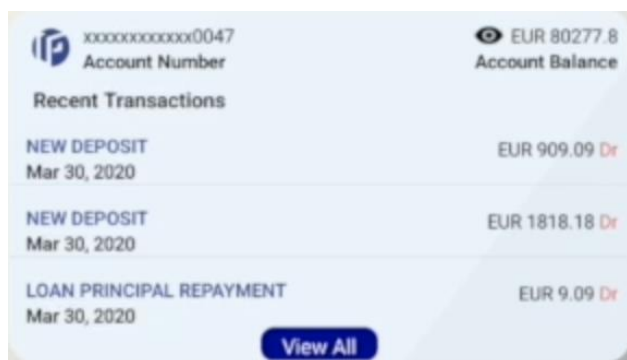
Option 2: From the futura bank home page

The Recent Activity widget on the home page displays the summary of the primary account. The widget displays the account available balance of Current and Savings account and last 3 transactions on those accounts along with the date of transaction.

Note: In case of joint CASA accounts if the primary account number is not setup then shows the summary of the first account from the CASA accounts list.

The **Recent Activity** widget on the **futura bank** home page displays the all the debit and credit entries along with each transaction amount.

Note: In case of Joint CASA account if the primary account number is not setup then shows the summary of the first account from the CASA accounts list;

To set primary account, go to Account Settings > Preferences > Primary Account Number and select an account "Please setup a primary account" to use futura bank's widget.

1. Click on toggle to mask the account balance. App displays the **Account Balance** in masked format.

Note: By default App displays the account balance in unmasked format.

3.1 View the multiple account summary

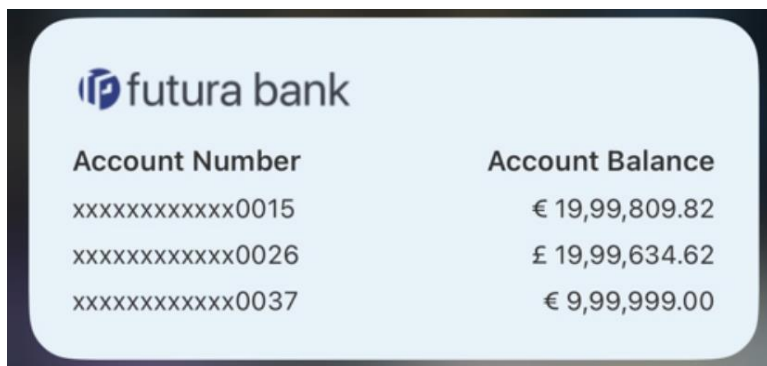
On the home screen, the widget is provided to view their account summary if the user has more than one bank account. The widget on the home page displays the multiple account summary of the registered retail user.

Note:

- 1) The criteria to view multiple CASA account summary is the retail user who should have at least one CASA bank account, has downloaded the mobile app, and activated the screenshot function.
- 2) The widget displays the top three accounts.

1. Click on the widget icon, it redirects to accounts snapshot page.

Note: In case of Joint CASA account if the primary account number is not setup then shows the summary of the first account from the CASA accounts list;

To set primary account, go to Account Settings > Preferences > Primary Account Number and select an account "Please setup a primary account" to use futura bank's widget.

2. Click on toggle to mask and unmask the accounts for ios users of the accounts
OR
Click on an eye icon to mask and unmask the accounts for Andriod users of the accounts.

Note:

- 1) By default App displays the accounts' balances in unmasked format.
- 2) Similar functionality of multiple account summary widget supported for Scan to Pay.

3.2 Augmented Reality based Cards Details

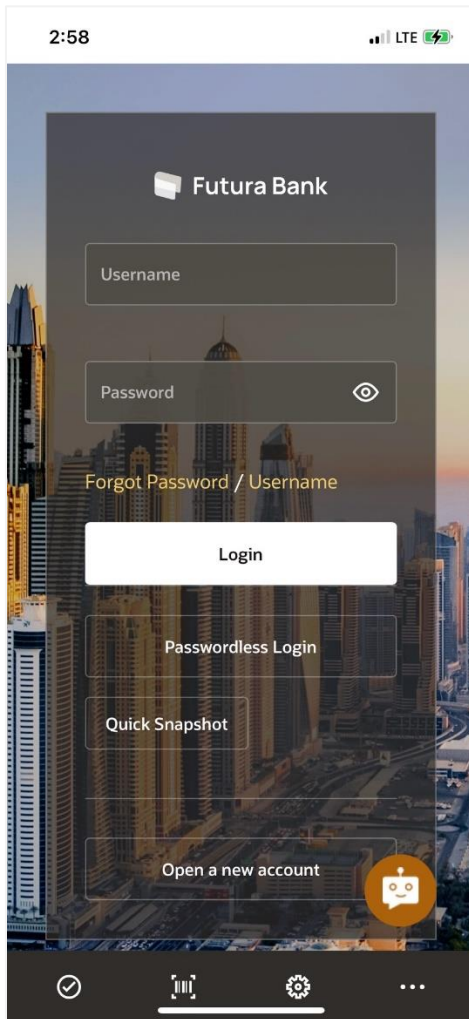
Augmented Reality Cards Details are the physical cards augmented (enhanced) with digital contents (e.g. details about card) embedded into it. This feature provides a visual representation to an end-user of the bank by giving a quick overview of all relevant details about of debit card at one place. It displays the account summary and spends analysis of the debit card. An account summary includes information such as the associated account number, the available balance for the associated account, the last 5 transactions on the account. Whereas spend analysis is information such as expenditure analysis only for the account associated with the scanned debit card.


Note:

- 1) Augmented reality feature is available for any retail user with at least one debit card associated with at least one CASA account, and has downloaded the mobile app and activated the snapshot functionality.
- 2) Any changes done in the spends analysis dashboard by the user, gets reflected here also.
- 3) Fresh data gets fetched every time a card is scanned.

1. Launch the **futura bank** application page. The **futura bank** login page appears.

2. Click on the  icon, and select **Scan your Card** link to access the details of card.

Note:

- 1) The **Quick Snapshot** functionality should be enabled to scan the card.
 - 2) Access should be given to app to use the camera from your device.

3. Scan the card, the system displays the account summary and spends analysis of the respective card.

Field Name	Description
Spend Analysis Donut chart	The spending patterns of the user are in the form of a donut chart. The details displayed in the chart will be based on the category wise expenditure in all savings accounts mapped to the user. The user can also view a period wise and account wise spend analysis. This also displays the total amount expenditure incurred during a period.
Debit Card	Displays the scanned debit card.
Account Snapshot	
Account Number	Account number in masked format.
Balance	The current balance in the account.

Field Name	Description
Description	Short description of the transaction.
Date	Date on which the transaction was performed.
Amount	Transaction amount along with the debit/credit indicator and currency.

Note: To scan another card, click on the < (back) button provided on top.

FAQs

1. What is the benefit of using Quick Snapshot feature?

Quick Snapshot is a quick & convenient way to access your accounts summary, without any need to login to application.

2. Who can use Quick Snapshot feature?

Any futura bank customer who has downloaded mobile application can use this feature

3. Is this feature available for all type of accounts (Current, Savings, Loan, Deposits and Credit Cards)?

No, this feature is only available for Current and Savings accounts.

4. How can the user disable Quick Snapshot?

User can anytime disable this feature by clicking on Disable Quick Snapshot button on the Quick Snapshot screen.

5. Do I need to authenticate myself with my credentials/ alternate login every time I access quick snapshot?

You will need to authenticate only when you are enabling quick snapshot, subsequently clicking on quick snapshot will display the account summary and recent transactions without any authentication.

6. What is Operating system requirements for Augmented Reality (AR) use case?

For iOS minimum support version is iOS 13 and for Android it's Android 6.
