1. Preface

It is designed to help you maintain and process all types of documentary and clean Islamic LCs.

It also assists you in handling the necessary activities in the life cycle of an Islamic LC once it is booked. This includes the generation of messages and advices, the updation of account balances and the collection of various commissions and charges.

You can obtain information specific to a particular field by placing the cursor on the relevant field, and striking <F1> on the keyboard.

This manual is intended for the Customer Service Representatives (CSRs) and the staff responsible for the setting up of new products at your bank.

2. Overview of Islamic Letters of Credit

A Letter of Credit as an instrument of international trade is one of the most secure methods for a seller to be paid. Besides credit risk considerations, LC are the customary business practice for long-distance trade and a particularly important commission earning service for any bank. The Islamic Letters of Credit (Islamic LC) module constitutes a part of Oracle Banking Trade Finance comprehensive trade financing system. Together with the Islamic Bills and Collections module, it automates the entire gamut of trade financing. The Islamic LC module supports the processing of all types of documentary and clean Islamic LC. It can handle all activities during the life-cycle of an Islamic LC. This includes the generation of messages and advice for all the applicable events and the update of account balances. The system also handles the collection of various commissions and charges defined for an Islamic LC.

2.1 Features

In an effort to sharpen the competitiveness of your trade-financing department and to empower your bank to handle a high volume of credit transactions Oracle Banking Trade Finance is designed with the following features:

- The Islamic Letters of Credit module supports the processing of all types of clean and documentary Islamic LCs. These include:
 - Import Islamic LCs
 - Export Islamic LCs
 - Guarantees
 - Shipping Guarantees
 - Clean Islamic LCs
 - · Standby Guarantees
- The Islamic LC module is designed to handle all the events in the life cycle of an Islamic LC. The booking, subsequent amendments and an availment can be processed automatically. The messages and advices applicable for each event are also automatically generated. The messages are communicated done through SWIFT, TELEX, mail, or any other compatible medium.
- The product definition function enables you to create products for specific services you offer. This offers your customer flexibility as well as quick and efficient processing of contracts.
- The product definition covers all the key features of an Islamic LC. For example, details of documents that should accompany it, the free format messages that form part of the correspondence, the advices to be generated for various events, the accounting entries to be passed for an event, the commission and tax handling specifications.
- The details of documents, free format messages, and commodities are defined only once and can be retrieved
 whenever needed. This reduces the effort involved in the capture of Islamic LC details, thus rendering it faster
 and error free. The flexibility built into the system ensures that you can modify these details to suit the requirement of each Islamic LC.



- The copy feature further simplifies, the input processing, for contracts.
- The Central Liability sub-system automatically controls the booking of an Islamic LC against the credit lines assigned to the customer before the bookings are made.
- Oracle Banking Trade Finance supports the concept of 'specialized services branch' concept. If you have trade
 financing expertise at only one branch, say the Head Office (HO) and Islamic LCs for customers of any branch
 is processed only through the HO, Oracle Banking Trade Finance offers absolute ease of operations. The
 Islamic LC can be processed for a customer of any branch, in the same way as you would, for a customer of
 your own branch.
- The module supports automated follow-up for commission and charge payments, confirmation and acknowledgments.
- Graphic User Interface (GUI) facilitates ease of input. Pick-lists have been provided wherever possible. This
 makes the module both efficient and easy to use.
- · The media supported include Mail, Telex and SWIFT
- The National Language Support (NLS) features are available.
- LCs are governed by the Uniform Customs and Practice (UCP) which is published by the International Chambers of Commerce (ICC) Paris, France. You can indicate that the Islamic LCs issued at your bank fall in line with the UCP, which is regarded as a rule book by virtually all banks in the world.

2.2 Operations supported on an Islamic LC

The following are the operations supported on an Islamic LC:

- Open an import Islamic LC or guarantee
- · Open and confirm an import Islamic LC
- Pre-advice an export Islamic LC
- · Advice an export Islamic LC
- · Advice and confirm an export Islamic LC
- · Confirm an export Islamic LC

Thus, your bank can perform one of the following roles:

- The issuing (opening) bank for an import Islamic LC or guarantee
- · The advising bank or for an export Islamic LC
- · The confirming bank for an export Islamic LC

In addition to amendment of the terms of an Islamic LC such as the expiry date, the amount, the latest shipment date, etc., you can amend the operation on an Islamic LC as follows:

· Open to open and confirm of an import Islamic LC



- · Pre-advice to advice of an export Islamic LC
- · Pre-advice to advice and confirm an export Islamic LC
- · Advice to advice and confirm an export Islamic LC

Appropriate messages, advices, and covering letters are generated for these operations. These are listed in an annexure in this manual. The SWIFT messages generated for the different types of Islamic LC are listed in this chapter.

2.3 SWIFT Messages for an Import Islamic LC

The messages that are generated for an Import Islamic LC depends on the operation you perform on the Islamic LC. The following are the SWIFT messages supported for an Import Islamic LC:

2.9 Process Commissions and Charges

In the Islamic LC module, the method of collecting commissions and levying charges is flexible.

Commissions can be collected for the initiation and amendment events of an Islamic LC. The definition of commission rules facilitate the uniform and efficient application of commission across all Islamic LCs processed under a product.

Commissions can be collected in advance or in arrears, periodically or non-periodically. You can choose to accrue commissions at a regular frequency (daily, monthly, quarterly, half-yearly or annually). Similarly, the frequency of liquidation of periodic commission can be varied.

In Oracle Banking Trade Finance various charges such as handling charges, SWIFT charges, etc. can be processed.

The commissions and charges can be collected from any party, and if necessary, debited from a receivable account and liquidated subsequently.

2.10 Variations Supported for an Islamic LC

An Islamic LC being a very flexible payment mechanism can be made available to the customers of your bank in a number of popular variations.

2.11 Red Clause Letter of Credit

You can process a Red Clause Islamic LC wherein you can provide for anticipatory drawings. In such a case, the confirming bank or any other bank is authorized to make advance payments to the beneficiary, before the presentation of the documents.

2.12 Revocable and Irrevocable Islamic LCs

You can process both revocable and irrevocable Islamic LCs. However, irrevocable Islamic LCs are commonly used as they cannot be canceled without the consent of the buyer, the seller and the banks that are parties to the transaction.

A revocable Islamic LC can be canceled without any notice or consent from the parties involved in the Islamic LC.

2.13 Transferable and Non Transferable Islamic LCs

While capturing the details of an Islamic LC, you can indicate whether it is transferable. This information is part of the instrument generated for an Islamic LC.

2.14 Revolving and Non Revolving Islamic LCs

You can open an Islamic LC and choose to make it available again in its original amount after the goods have been shipped, documents presented and credit is settled. Such an Islamic LC is a revolving Islamic LC. Under a revolving Islamic LC the amount is reinstated or renewed without any specific amendments to the Islamic LC. A revolving Islamic LC may be revocable or non-revocable, and can revolve in relation to the following:

Value



Time

This facility can be utilized when a supplier wishes to make repetitive shipments over a period such as a year.

The Islamic LC can have an automatic reinstatement clause, which provides for continuing the renewal of availability. You also have the option to manually reinstate an Islamic LC. The credit may require approval of the opening party before it becomes available again.

2.15 Sight and Usance Islamic LC

Oracle Banking Trade Finance allows the processing of a sight or Usance payment against an Islamic LC.

- In case of a sight Islamic LC, the negotiating bank pays the seller immediately and is later reimbursed by the issuing bank
- In the case of a Usance Islamic LC, the drawee bank accepts the obligation to pay the seller at maturity. An
 Islamic LC with a time draft drawn on the opening party, calling for payment at a future date is called a time or
 Usance Islamic LC.

2.16 Open Ended Islamic LCs

Process an Islamic LC without an expiry date known as an open ended Islamic LC.

2.17 Cash Collateral against an Islamic LC

An Islamic LC can be processed against cash collateral. Oracle Banking Trade Finance provides you with the facility to calculate the cash collateral either as a percentage of the Islamic LC amount or as a fixed amount. Cash collateral advice will be generated for its collection.

When the Islamic LC amount is amended, you also have the option of adjusting the collateral amount accordingly.

2.18 Availment against an Islamic LC

You can process the availment against an Islamic LC either through the Islamic LC module or through the bills module of Oracle Banking Trade Finance. Availment charges can be levied and cash collateral adjusted, during an availment.



3. Islamic Letters of Credit - Maintenance

The Islamic Letters of Credit (Islamic LC) module requires the setting up of certain basic information before it becomes operational. The information that needs to be maintained includes:

- · Document details
- · Clause details
- · Goods details
- · Free Format Text details
- · Insurance Company details
- · Import License Expiry Date for a customer

3.1.1 Maintain Documents and Clauses

This topic describes the systematic instruction to maintain documents and clauses.

CONTEXT:

There are certain standard documents that are required under a documentary Islamic LC. As these documents are standard and common in most countries, their details need not be specified every time you need to use it for an Islamic LC. Instead, you can maintain its details in the 'Bills & Collection Document Code Maintenance' screen and attach it to the Islamic LC you process.

The advantage of maintaining document details is that at the time of creating a product or at the time of entering the details of an Islamic LC, you only need to specify the code assigned to the document. All the details maintained for




the document will be automatically picked up. This helps reduce repetitive work, as you do not need to enter the contents of the document each time you use it.

PREREQUISITE:

Specify **User Id** and **Password**, and login to Homescreen.

- 1. On Homescreen, specify **BCDDOCCD** in the text box, and click next arrow.
 - STEP RESULT: Bills and Collection Document Code Maintenance screen is displayed.

The document details will be automatically picked up and defaulted.
Language Code	Specify the language code using which all the correspondences with the party should be carried out. Click the option list icon to view the list of available language codes.

Document Type	Select the document type from the drop-down list. The available options are Transport, Insurance, Invoice, and Others.
Document Short Description	The documents for an Islamic LC are at times large and hence difficult to identify. Therefore, you can specify a short description or a title that will enable you to identify the document quickly. The short description that you specify is for information purposes only and will not be printed on any customer correspondence.
Document Long Description	Specify the complete description of the document.
Validate Shipping Guarantee	Check this option to indicate that a shipping guarantee should be validated.
Bill of Landing	Check this box to validate the reference number used in the bill against the shipping guarantee Bill of lading reference number.
Clause Details	A clause is a statement that accompanies a document required under an Islamic LC. Instead of specifying the details of a clause every time, you can maintain a list of the standard clauses, which can accompany the documents, required for an Islamic LC, in the Clause Maintenance screen. The advantage of maintaining clause details is that at the time of creating a product or at the time of entering an Islamic LC, you only need to specify the code assigned to the clause. All the details maintained for the clause will be automatically picked up. In this section specify the following details:
Clause Code	Each clause that you maintain is identified by a twelve-character code called a Clause code. You can follow your own convention for devising the code. However, at least one of the characters of the clause code should be a letter of the English alphabet. This code should be unique as it is used to identify the clause. While creating a product or at the time of entering details of an Islamic LC where you need to specify the clauses that should accompany a document, you only need to specify the code assigned to the clause. The clause details will be automatically picked up and defaulted.



Field	Description
Clause Description	After specifying a code for the clause, you can proceed to maintain a detailed description of the clause. The description carries the contents of the clause, which will be printed on the customer correspondence that accompany an Islamic LC. The clause description can contain a maximum of two thousand characters.

3.1.2 Specify Values for the User Defined Fields

Link the User Defined Fields with Branch Parameters Maintenance screen using Function field mapping screen. It is processed by selecting User defined fields, and then Function field mapping. The value for these fields can be specified in the 'Branch Parameters Maintenance' screen.

NOTE: Value for UDF can be made mandatory or non mandatory as maintained in the Field description screen.

After you have entered the details of the document and clause you should save the record. After you have made the mandatory entries and saved the record, your User ID will be displayed in the Input By field at the bottom of the screen. The date and time at which you saved the record will be displayed in the Date/Time field.

A record that you have created should be authorized by a user, bearing a different login Id, before the EOD is run. Once the record is authorized, the ID of the user who authorized the record will be displayed in the Auth By field. The date and time at which the record has been authorized will be displayed in the Date/Time. The status of the record will be displayed in the check box marked Authorized. The field will remain unchecked until the record is authorized.

Click 'Exit' to exit the return to the Application Browser.

3.1.3 Operations on Document Maintenance Record

On an existing Document Maintenance record, you can perform the following operations (if any function under the Application toolbar is disabled, it means that the function is not allowed for the record):

- · Amend the details of a document
- Authorize a Document
- · Copy the details of a document on to a new one
- · Close the Document
- · Reopen the document
- · Print the details of a document
- · Delete the details of a document

Please refer to the manual on Common Procedures for details of these operations.

On an existing Clause Maintenance record, you can perform the following operations (if any function under the Application toolbar is disabled, it means that the function is not allowed for the record):

- · Amend the details of the record
- · Authorize the record
- · Copy the details of a Clause, on to a new record



- · Close the record
- · Reopen the closed record
- · Print the details of a record
- · Delete the record

3.2.1 Maintain Goods

This topic describes the systematic instruction to maintain Goods.

CONTEXT:

An Islamic LC is used for trade payments. It therefore involves merchandise. There are certain standard goods or commodities, the trading of which is done, with Islamic LC cover. Instead of specifying the details of merchandise each time they are traded under an Islamic LC, you can maintain the details of the standard goods in the Commodity Codes Maintenance screen.

The advantage of maintaining goods details is that at the time of entering the details of an Islamic LC, you only need to specify the code assigned to the goods. The description maintained for the goods/commodity code will be automatically picked up. Typically, the statutory body controlling international and domestic trade in a country assigns these codes.

PREREQUISITE:

Specify the **User Id** and **Password**, and login to Homescreen.

1. From Homescreen, specify **BCDCOMCD** in the text box, and click next arrow.

STEP RESULT: Bills and Collections Commodity Maintenance Screen is displayed.

Field	Description
Goods Code	In Oracle Banking Trade Finance goods are identified by a twelve-character code called the Goods Code. You can follow your own convention for devising the code. However, at least one of the characters of the goods code should be a letter of the English alphabet. The code that you assign to a commodity should be unique as it is used to identify the commodity/goods. While processing an Islamic LC where you need to specify the goods transacted, you need to specify the code assigned to the goods. The goods description will automatically be picked up and defaulted.
Language Code	Specify the language code using which all the correspondences with the party should be carried out. Click the option list icon to view the list of available language codes.
Goods Description	After assigning a code to the goods, you can proceed to maintain a detailed description of the goods. The 'Goods Description' can contain a maximum of six thousand five hundred characters. While specifying the details of the goods transacted under an Islamic LC, you can edit the description that is defaulted, to suit the requirements of the Islamic LC you are processing. Specifications such as the quality and quantity of the merchandise can also be entered.
Banned Commodity	As part of maintaining the details of the goods that can be traded under an Islamic LC, you can also specify whether the commodity being defined is banned from import/export. If you are maintaining the details of a banned commodity, you can indicate the same by selecting this option in the screen. At the time of selecting the goods being traded under an Islamic LC, the system will display the commodities in the option-list. In addition, the list will also display whether a particular commodity is banned or not by indicating 'YES' (for a banned product) and 'NO' (for a product that is allowed for trade) against the product.

3. Specify **BCSCOMCD** in the text box, and click next arrow.

STEP RESULT: Bills & Collections Commodity Code Summary screen is displayed.






Figure 3.3: Bills & Collections Commodity Code Summary

3.2.2 Specify Values for UDF

Link the User Defined Fields with 'Branch Parameters Maintenance' screen using Function field mapping screen which can be processed from the Application Browser by selecting User defined fields, and then Function field mapping.

The value for these fields are specified in the 'Branch Parameters Maintenance' screen.

NOTE: Value for UDF can be made mandatory or non mandatory as maintained in the Field description screen.

After making the mandatory entries, save the record.

On saving the record, your User ID is displayed in the Input By field at the bottom of the screen. The date and time at which you saved the record will be displayed in the Date/Time field.

A record that you have created should be authorized by a user bearing a different login Id, before the EOD is run. Once the record is authorized, the Id of the user who authorized the record will be displayed in the Auth By field. The date and time at which the record has been authorized will be displayed in the Date/Time field positioned next



to the Auth By field. The status of the record will be displayed in the check box marked Authorized. The field will remain unchecked until the record is authorized.

Click 'Exit' button to exit the screen. You will return to the Application Browser

3.3.1 Maintain Free Format Text (FFT) Codes

This topic describes the systematic instruction to maintain Free Format Text (FTT) Codes.

CONTEXT:

Free Format Text (FFT) may be a set of instructions or statements that are applicable to the Islamic LCs that you process. There are certain standard statements that should appear in the correspondence and messages, sent to the parties involved in an Islamic LC. Instead of specifying the details of an FFT each time you need to use it, you can maintain them in the FFT Maintenance screen.

The advantage of maintaining FFT details is that at the time of creating a product or while entering the details of an Islamic LC, you only need to specify the code assigned to the FFT. All the details maintained for the FFT code will



be automatically picked up. This reduces your effort, as you do not need to enter the description of an FFT each time you use it.



NOTE: Value for UDF can be made mandatory or non mandatory as maintained in the Field description screen. Click Exit button to exit the screen.

3.3.3 Operations on the FFT Maintenance Record

On an existing FFT Maintenance record, you can perform the following operations (if any function under the Application toolbar is disabled, it means that the function is not allowed for the record):

- · Amend the details of the record
- · Authorize the record
- · Copy the details of an FFT on to a new record
- · Close the record
- · Reopen the closed record
- · Print the details of a record
- · Delete the record

Please refer to the manual on Common Procedures for details of these operations.

3.3.4 Maintain INCO Terms

Associate documents and clauses to INCO Terms as part of a one-time maintenance for your bank. The following are the INCO terms for which you can maintain documents and clauses:

- CIF
- C&F
- C&I
- FOB
- CFR



EX-Works

You can associate any number of valid documents to an INCO term. To each document associated with a term, you can associate any number of clauses.

When creating an Islamic LC product, you can indicate the INCO term that should be associated with it. The documents and clauses associated with the term will automatically default to Islamic LCs processed under the product. When processing an Islamic LC, you can modify the default list of associated documents and clauses.

3.4 Maintain Insurance Company Details

This topic describes the systematic instructions to maintain insurance company details.

CONTEXT:

An Islamic LC, as an instrument of international trade involves the shipment of large merchandise over long distances. To cover the loss or damage of the goods during transition, most merchandise traded under an Islamic LC is covered with an insurance policy.

You can maintain the details of different Insurance Companies in Oracle Banking Trade Finance.

At the time of capturing the details of an Islamic LC contract in the system, you can associate the appropriate Insurance Company Code with the contract. Upon selection of the code, all the details maintained for the selected code will be automatically picked up by the system. Subsequently, on receipt of the insurance policy from the company, the insurance policy number can also be captured in the relevant contract.



Fax Number	Specify the Fax Number of the insurance company.
Customer	Specify the customer identification number of the insurance company. The adjoining option list displays all valid, open and authorized customers maintained in the system. You can select the appropriate one.
Account	Specify the customer account number of the insurance company. The adjoining option list displays all valid, open and authorized customer accounts attached to the chosen customer identification number. You can select the appropriate one. Based on the account specified, the branch in which the account resides is displayed alongside. NOTE: The insurance company will be available for association with Islamic LC contracts only after you authorize the company details.



Field	Description
Customer Id	Specify the customer for whom you are maintaining insurance details. The adjoining option list displays all the valid and open customer identification numbers (CIF) maintained in the system. You can select the appropriate one. The system displays the chosen customer's name in the 'Customer Name' field.



Field	Description
Insurance Company	Specify the company whose insurance policy the customer holds. The adjoining option list displays all the insurance companies maintained in the system through the 'Insurance Company Codes Maintenance' screen. You can select the appropriate one. The system displays the chosen company's name in the 'Company Name' field.
Policy Number	Specify the policy number of the insurance policy that the customer holds.
Currency Code	Specify the currency in which the insurance policy has been taken. The adjoining option list displays all the currency codes maintained in the system. You can select the appropriate one.
Policy Type	Select the type of insurance from the adjoining option list. This list displays all the values maintained for 'Insurance_Type' in the 'Types' screen.
Expiry Date	Specify the date on which the insurance policy expires. If you don't input a date, the system will consider the insurance policy to be open-ended.
Per Bottom Limit	Specify the maximum limit for which an Islamic LC contract linked to the policy can be covered. The amount will be considered in the currency of the insurance amount.
Insurance Amount	Specify the amount for which the customer is insured as per the specified policy.
Utilization Amount	The system displays the insurance amount that is utilized by an Islamic LC contract. Whenever an Islamic LC contract gets saved with some insurance amount linked to it, the system will update this value to extent of amount used. Similarly, if a linked Islamic LC gets closed, cancelled or reversed before the insurance expiry date, the system will re-instate the utilization amount ear-marked for that contract. This is true of Islamic LCs linked to open-ended policies too.



Field	Description
Available Amount	The system displays the available insurance amount that can be linked to an Islamic LC contract. The amount is computed as total insurance amount – utilized insurance amount. Whenever an Islamic LC contract gets saved with some insurance amount linked to it, the system will update this value to extent of amount available. Similarly, if a linked Islamic LC gets closed, cancelled or reversed before the insurance expiry date, the system will re-instate the utilization amount ear-marked for that contract and make it available for further utilization. This is true of Islamic LCs linked to open-ended policies too.

3.5.1 Capture Utilization History Details

You can view the Islamic LC contracts for which the insurance amount has been utilized, in the 'Utilization Details' screen.

Click **Utilization Details** to process the screen.

Here you can view the following details of the Islamic LC contracts:

- Contract Reference Number
- Event
- · Utilization date
- · Expiry date
- Closure Date
- · Contract Status

3.6 Maintain Import License Expiry Date

This topic describes the systematic instructions to maintain Import License Expiry Date.

CONTEXT:

Oracle Banking Trade Finance allows you to maintain the Import License Expiry Date of all the customers of your bank. You can maintain only one License Expiry Date for a customer. On selection of the CIF ID of the customer at the time of processing an Islamic LC contract, the Import License Expiry Date maintained for the selected CIF ID is



also displayed in the Islamic LC Contract screen. The system will not do any validations based on the expiry date. It is used only for information purpose.

The Import License Expiry Date is captured through the License Expiry Date Maintenance screen.



Trade License No.	Specify the trade license number. This must be unique for each customer.
License Expiry Date	After you select the CIF ID, you can specify the Import License Expiry Date for the customer. The expiry date maintained here would be associated with all Islamic LC contracts processed for the customer.

Expired	The system marks the trade license of the customer as expired during EOD if the system date happens to be greater than or equal to trade license expiry date.
Renewal Date	Specify the date on which the trade was renewed.
Charge Account	Specify a valid account to be used to collect the charges for trade license expiry. The adjoining option list displays all open and authorized accounts belonging to the customer. You can select the appropriate one.
Charge Branch	The system displays the Branch Code where the Charge Account is held.
Expiry Due Advice Details	During EOD, advices are generated for customers whose trade license is impending expiry.
Generated Status	The success or failure of message generation through the above process is indicated by the true and false status of the field 'Generated Status'.
Generated Date	The system displays the date on which the message was generated, if any.
Expired Advice Details	During EOD, advices are generated for customers whose trade license has expired.
Generated Status	The success or failure of message generation through the above process is indicated by 'True' or 'False' status of this field.
Generated Date	The success or failure of message generation through the above process is indicated by the true and false status of the field 'Generated Status'.

3.7 Application of Exchange Rate Type based on Transaction Amount

CONTEXT:

Oracle Banking Trade Finance allows you to apply different exchange rates based on the amount involved in the transaction. The cut-off amount slabs are maintained in the local currency of your bank.

If the transaction currency is not the local currency, the system will first convert the transaction amount into the local currency equivalent using the Standard Mid Rate. This is necessary as the cut-off amount slabs are maintained in the local currency. The system will then validate the converted amount against the different amount slabs to determine the appropriate rate type. This is the rate type that will be used for the actual conversion of the transaction currency into the local currency equivalent.

The Document Master Maintenance screen is common for both Islamic Bills & Collections and Islamic LC modules. You can process Bills & Collections Document Code Maintenance' screen by typing **BCDDOCCD** in the field at the top right corner of the Application tool bar and clicking the adjoining arrow button. If you are maintaining details of a



new document, or 3-2 click 'New' icon from the application tool bar. The 'Bills & Collections Document Code Maintenance' screen is displayed without any details.



You can maintain the cut-off amount slabs for: • All Amount Tags: • The maintenance will be applicable to all the amount tags available in the system (Module tags and Non-module tags). • Module Tags: • The amount tags that are specific to a particular module are known as Module Tags. For eg the amount tag PRINCIPAL is specific to the Finances module, BILL_AMOUNT is defined for the Bills module and so on.
Non-Module Tags:	The amount tags that are internally created by the system are referred to as Non-Module tags. The system will automatically create the amount tags for the Profit, Tax, Charge, and Commission components that you define for a product.

Basis Amount	You can maintain the different amount slabs in this field. Specify the lower limit of the amount slab here.
	NOTE: For the first slab, the floor basis amount will always be maintained as zero.
Amount	Specify the upper limit of the slab. The upper limit of the precious amount slab gets defaulted as the Floor Basis Amount. Click on option list to capture each subsequent amount slab.
Currency Rate Type	You can associate a different exchange rate type with each cut-off amount slab that you have maintained. All authorized and active rate types defined in your system are available in the option-list. Select the appropriate rate type for each amount slab.

4. Define Attributes specific to an Islamic Product

In this chapter, we shall discuss the manner in which you can define attributes specific to a Letters of Credit product. You can create a Letter of Credit product in the Islamic Letters of Credit (Islamic LC) Product Definition screen, invoked from the Application Browser.

This topic contains the following sub-topics:

- 1) Create an Islamic LC Product
- 2) Generate Islamic LC Expiry/Closure Advices

4.1 Create an Islamic LC Product

This topic describes the systematic instruction to create an Islamic LC Product.

CONTEXT:

The basic information about the product such as the Product Code and its description is captured through the Islamic LC Product Definition screen. Information related to specific attributes of a product can be defined in subsequent screens that can be invoked from the product definition screen.


PREREQUISITE:

Specify **User Id** and **Password**, and login to Homescreen.

1. On **Home**screen, type **LIDPRMNT** in the text box, and click next arrow.

STEP RESULT: The Islamic LC - Product Definition screen is displayed.





2. On Islamic LC Product Definition screen, specify the fields.

Define the attributes specific to a letters of credit product in the 'Islamic LC Product Definition' screen and the 'Islamic LC Product Preferences' screen. In these screens, you can specify the product type and set the product preferences respectively.

For any product you create in Oracle Trade Finance Banking, you can define generic attributes, such as branch, currency, and customer restrictions, Profit details, tax details, etc., by clicking on the appropriate icon in the horizontal array of icons on this screen. You can define product restrictions for branch, currency, customer category and customer in Product Restrictions (CSDTFPDR) screen. For details on the product, restrictions refer to the Product Restriction Maintenance chapter in the Core Service User Manual. You can define User Defined Fields in the 'Product UDF Mapping' screen (CSDTFUDF). For details on User Defined Fields screen refer Other Maintenances chapter in Core Service User Manual. For letters of credit product, in



addition to these generic attributes, you can specifically define other attributes. These attributes are discussed in detail in this chapter.

Product Type	The product type identifies the basic nature of a product. An LC product that you create in Oracle Banking Trade Finance can be of the following types: • Import LC - This is the basic LC product opened at the request of the importer (applicant) by the issuing bank in favour of an exporter beneficiary. • Export LC - When an import LC has to be conveyed to the beneficiary through an advising bank, for the advising bank this is an export LC. • Guarantee – This is an undertaking by the guarantor (bank) to make payment to the beneficiary of the guarantee in the event of a default by the applicant of the guarantee. Usually, the only document required for payment is a simple invocation letter. Guarantees are normally used in performance contracts • Shipping Guarantee - This again operates on the lines of a guarantee but is used in the scenario where the shipping company releases the goods to an importer in lieu of a bill of lading (transport document) subject to a guarantee being issued in its favour
	 Clean LC - A LC not backed by documents. Usually the only document in a clean LC would be the draft or bill of exchange. This type of LC is used where the goods have already been received and only the payment has to be settled through banking channels. Advice of Guarantee - When a guarantee has been received by a bank and is to be advised further to the beneficiary's bank the product to be created would be an advice of guarantee. Reimbursement Transfer Type - This operates in line with Export type product. This type of product will be used for Child LC Creation in case of Transfer when use transfer product flag is checked at Trade Finance Bank Preference Maintenance The entries that are passed, the messages that are generated and the processing of contracts involving the product, is determined by your input to this field. The field is mandatory.



Field	Description
Slogan	Specify a marketing punch-line to be associated with the product. This slogan will be printed on all the advices that are sent to the customer, for an Islamic LC involving this product.
Product Group	Each product is classified under a specific group. The different groups are defined in the Product Group Definition table.
Start Date and End Date	A product can be set up for use over a specific period, by defining a start and an end date. The Issue Date of an Islamic LC involving a product should be: • The same as or later than the Start Date • The same as or earlier than the End Date The start and end dates of a product come in handy when you are defining a product for a scheme, which is open for a specific period.
Remarks	You can enter information about the product, intended for the internal reference of your bank. The remarks are displayed when the details of the LC are displayed or printed. However, this information will not be printed on any correspondence with the customer. To maintain the allowed and disallowed customer and customer categories, you have to click the button and invoke the 'Customer and Customer Restrictions' screen.
Module	All the modules (like Loans & Deposits, Letters of Credit, Bills & Collections etc.) in Oracle Trade Fince are represented by a code. This code is displayed in the module field. The product code that you assign to a product will identify the product throughout this module.



Resolving	Islamic LC products can be revolving or non-revolving. If you indicate that the product is revolving, you can associate the product with only revolving Islamic LCs. While actually processing revolving you can indicate whether the Islamic LC should revolve in time or in value. Similarly if you indicate that the product is non-revolving, you can associate the product to only non-revolving Islamic LCs. NOTE: All Islamic LCs will be of irrevocable nature.

Field	Description
Tenor (In Days)	You can set the Standard, Minimum and the Maximum limits for tenor based Islamic LCs. The tenor details that you specify for an Islamic LC product is always expressed in days.
Standard	The standard tenor is the tenor that is normally associated with an Islamic LC involving a product. The standard tenor of an Islamic LC is expressed in days and will apply to all Islamic LCs involving the product. If you do not specify any specific tenor while processing an Islamic LC, the standard tenor will by default apply to it. The default standard tenor applied on an Islamic LC can be changed during Islamic LC processing. An expiry date will be calculated based on the tenor, as follows: Expiry Date = Effective Date + Tenor This field is not applicable for Transfer Type Product.



Field	Description
Minimum	The minimum tenor of a product can be fixed. The tenor of the Islamic LCs that involves the product should be greater than or equal to the minimum tenor that you specify. If not, an override will be required before the Islamic LC is stored. This field is not applicable for Transfer Type Product.
Maximum	You can fix the maximum tenor of a product. The tenor of the Islamic LCs that involves the product should be less than or equal to the Maximum tenor specified. If not, an override will be required before the Islamic LC is stored. This field is not applicable for Transfer Type Product.
Cash Collateral Details	In this section specify the following details:
Percentage	For a product, specify the percentage of the Islamic LC amount that should be taken as cash collateral. This percentage will be applied by default and can be changed when the Islamic LC is processed. In addition, the currency in which the collateral is to be collected can be specified in the Islamic LC Contract Collateral screen, while processing an Islamic LC. This field is not applicable for Transfer Type Product.
Limits Tenor Calculation Type	Specify the calculation type for the limits tenor. You can select one of the following options. • Fixed • Rolling
Collateral Transfer Bridge	Specify the GL/account to be used for transfer of collateral between Islamic LC and the Bill upon availment of the Bill against the Islamic LC. The GL/account specified here will be used as the bridge during the transfer accounting. This field is not applicable for Transfer Type Product.

Rekey Requirements	All operations on an Islamic LC (input, modification, reversal, etc.) have to be authorized by a user other than the one who carried out the operation. Authorization is a method of cross checking the inputs made by a user. All operations on an Islamic LC, except placing it on hold, should be authorized before beginning the End of Day operations. You have the option to specify whether certain important details of an Islamic LC need to be rekeyed, at the time of authorization. If you indicate positively, you should also specify the fields that will have to be rekeyed at the time of contract authorization. You can specify any or all of the following as rekey fields: • Amount • Currency • Customer • Value Date • Expiry Date • Total Paid
	When you process an Islamic LC for authorization; - as a cross-checking mechanism to ensure that you are calling the right Islamic LC, you can specify that the values of certain fields should be entered before the other details are displayed. The complete details of the Islamic LC will be displayed only after the values to these fields are entered.
	This is called the 'rekey' option. The fields for which the values have to be given are called the 'rekey' fields. If no rekey fields have been defined, the details of the Islamic LC will be displayed immediately once the authorizer calls the Islamic LC for authorization. The rekey option also serves as a means of ensuring the accuracy of inputs.

INCO Term	Specify the INCO term that must be linked to all contracts under this product. The option list displays all INCO terms available in the system. You can select the appropriate one. This field is optional. This field is not applicable for Transfer Type Product.
Draft Tenor in Days	Specify the fields.
Minimum	Specify the minimum draft tenor for an Islamic LC product. The value you enter must be non-decimal numeric value > = 0 and < Maximum Draft Tenor. This field is not applicable for Transfer Type Product.
Maximum	 Specify the maximum draft tenor for an Islamic LC product. The value you enter must be non-decimal numeric value > 0 and > = Minimum Draft Tenor. NOTE: If the LC Type of an LC product is selected as 'Sight': On save of LC product definition, system will validate that the value defined for minimum and maximum Draft Tenor fields in preferences sub-system is either 0 or null. If the validation fails, system will display a configurable override message. During LC contract creation, on save, system will validate that the value entered for Draft Tenor field in Drafts sub-system is either 0 or null. If the validation fails, system will display a configurable override message. The said validation is also performed on save of LC amendment using LC contract online function NOTE: If the LC Type of an LC product is selected as 'Usance': On save of LC product definition, system will validate that value defined for minimum Draft Tenor is either null or 0 or any positive non-decimal



Field	Description
	 numeric value > 0 but < = maximum draft tenor and the value defined for maximum Draft Tenor is a positive non-decimal numeric value > 0 and >= minimum draft tenor. If the validation fails, system will display an error message. During LC contract creation, on save, system will validate that the values entered for draft tenor field in drafts sub-system is between minimum & maximum draft tenor values defined for the product. If the validation is not successful, system will display a configurable override message. The said validation is also performed on save of LC amendment using LC contract online function. In instances where multiple drafts are captured for a LC contract, system will validate that the 'Draft Tenor' entered for each individual draft is within the minimum and maximum range defined for the product. If minimum and maximum Draft tenor value is not defined for a LC product then on save of a LC contract, system will not perform the validation stated in point (ii) as no range is defined at the product level.

	When only one of the values i.e. either 'Minimum Draft Tenor' or 'Maximum Draft Tenor' is defined for the LC product, then on save of both LC contract creation and amendment, then the value defined i.e. the 'Draft Tenor' of LC contract will be validated against the 'Minimum Draft Tenor' if 'Minimum Draft Tenor' is defined or will be validated against 'Maximum Draft Tenor' if 'Maximum Draft Tenor' is defined. If the validation fails, system will display a configurable override message. The validations described for Draft Tenor field of an LC contract are applicable only if drafts information is captured in the Drafts sub-system. If drafts are not applicable / captured for an LC contract, the said validations are not applicable. The validations stated above are applicable for both Import and Export LC products. This field is not applicable for Transfer Type Product.
Commission	Commission related preferences have been discussed in the Commissions User Manual. This field is not applicable for Transfer Type Product.
Tolerance	Tolerance denotes the variance that has to be built around the Islamic LC amount, to arrive at the Maximum Islamic LC amount.
Positive	Specify the percentage that should be added to the LC amount to arrive at the Maximum Islamic LC amount. When an Islamic LC is issued or advised, the Maximum Islamic LC amount will be the outstanding Islamic LC amount. This will be the maximum amount available for availment. This field is not applicable for Transfer Type Product.



Field	Description
Negative	Specify the percentage that should be subtracted from the Islamic LC amount. The minimum tolerance is captured for information purposes only. NOTE: The tolerance percentage can be changed when an Islamic LC is processed under a product. The positive and negative tolerance amounts will be a part of the Islamic LC instrument and the subsequent amendment instruments. You should use the positive tolerance to indicate the amount that is uncovered, in the Islamic LC amount. Instances could be of the freight or insurance not being paid. This field is not applicable for Transfer Type Product.
Closure Days	In this section specify the following details:
Closure Days	Specify the number of days after which all Islamic LCs processed under the product being defined, will be closed. The number of days specified here and the expiry date of the Islamic LC is used to arrive at the closure date, as follows: Islamic LC Closure Date = Islamic LC Expiry Date + Closure Days By default, the system will display 30 days as the closure days. You are allowed to change this value. At the time of capturing the details of an Islamic LC contract, the system will calculate the closure date, based on the closure days that you have maintained for the product involved in the contract. However, you can change the date to any other date after the expiry date. This field is not applicable for Transfer Type Product.
Exchange Rate	In this section specify the following details:



Field	Description
Default Rate Type	Specify the exchange rates to be picked up and used, when an Islamic LC in a foreign currency, is processed. You can indicate that the standard rate prevailing, as of the issue date of the LC should be used. You can also specify an exchange rate of your choice. The possible values for the rate pickup are: • As per Standard Rate
	As input in the Contract
	If you specify as input in the contract, then the system computes the components of the LC, based on your input in the Exchange rate field, in the 'LC Contract Main 'screen. If you choose 'As per standard rate' the system computes the applicable components, by picking up the exchange rates as of the transaction date, from the Currency table maintained in the Core Services module of Oracle Trade Fince.
Override Limit	If the variance between the rate defaulted and the rate input is a percentage that lies between the Rate Override Limit and the Rate Stop Limit, the Islamic LC can be saved by giving an override.
Stop Limit	If the variance between the rate defaulted and the rate input is a percentage value greater than or equal to the Rate Stop Limit, the Islamic LC cannot be saved.

Period of Presentation	As part of the preferences you define for a product, you can specify the manner in which the Period of Presentation should be calculated for the documents that accompany Islamic LCs processed under the product. The period of presentation can be arrived at in two ways. Firstly, you can specify it directly, in terms of days, in the Number of Days field. Typically, this would be 21 days. 	in the 'Period For Presentation' field in the Islamic LC Contract - Others screen. You can change the default to suit the Islamic LC you are processing.

LIFO/FIFO Rule	Specify the order in which the availment under this contract should be processed. You can choose one of the following options: If multiple amendments are made to the Islamic LC contract amount, then the system applies the FIFO/LIFO rule when utilization is made against the Islamic LC contract. • LIFO – Islamic LC amount will be utilized in 'First In First Out' order when availment is triggered against the multiple amended Islamic LC contract. • FIFO – Islamic LC amount will be utilized in Last In First Out order when availment is triggered against the multiple amended Islamic LC contract. The system will calculate the commission accordingly. The system applies FIFO / LIFO rule when it finds that multiple amendment has been made to an Islamic LC contract against which utilization has been completed.
Finance Details	Specify the finance details here. NOTE: This is allowed only for Shipping Guarantee product. This field is not applicable for Transfer Type Product.
Guarantee Details	Specify the details.
Claim Days	Specify the claim days for the bank guarantee and advice of guarantee. Collateral Funding by Finance Select this to indicate that the guarantee needs to be funded by a finance.
Claim Settlement by Finance	Select this to allow claim settlement by creating a finance in case of insufficient funds in customer account.
	NOTE: This is applicable for Bank Guarantees.

Finance Bridge GL	Specify the bridge GL used for accounting between finance product and shipping/bank guarantee. The adjoining option list displays a list of all GLs. Choose the appropriate one. This field is not applicable for Transfer Type Product.
Financing Product	Specify the finance product used for the creation of finance account. The adjoining option list displays a list of finance products. Choose the appropriate one. This field is not applicable for Transfer Type Product.
Collateral Transfer Bridge	Specify the bridge GL used for collateral transfer from Islamic LC to shipping guarantee and shipping guarantee to Bill. The adjoining option list displays a list of all GLs. Choose the appropriate one. This field is not applicable for Transfer Type Product.
Status	Specify the following status details:
Auto Status	Check this box to set automatic status control for the Islamic LC product. If you do not check this box, the system will not consider the Islamic LC contracts associated with this product for automatic status change. The status of this check box is defaulted to the field 'Auto Status Change' of every Islamic LC contract associated with this product. However, you can modify this at the contract level.
Accrual	Specify the following accrual details.



4.2 Generate Islamic LC Expiry/Closure Advices

This topic describes to generate Islamic LC Expiry/Closure Advices

While creating an Islamic LC product, you can indicate whether a closure/expiry advice should be generated for Islamic LCs involving the product. These advices are generated based on the preferences that you specify for them.

Check against the appropriate option on the screen to indicate your preference. If you indicated that a closure/expiry advice should be generated, you need to indicate:

- · Whether it is to be generated before or after closure/expiry
- The number of days before/after, expiry/closure when the advice should be generated

4.2.1 Opting to Track Limits

You can opt to track limits for all Islamic LCs processed under the product for which you are defining preferences. Choose the 'Limit Tracking Required' option to track limits for the Islamic LCs processed under the product.

Your specification here will default to all Islamic LCs processed under the product. You can modify the defaulted preference when processing an Islamic LC.

4.2.2 Setting Criteria for Status Change

This topic provides systematic instruction to process setting criteria for status change.



Automatic	Here, you can indicate whether the status change has to be carried out automatically.

Forward	Check this option to automatically move forward the status of the Islamic LC. If you do not check this option, the system will not facilitate automatic forward movement of the Islamic LC status. This is applicable only if Islamic LC automatic status processing is enabled.
Reverse	Check this option to automatically move the status in reverse. If you do not check this option, the system will not facilitate automatic reverse movement of Islamic LC status. This is applicable only if Islamic LC automatic status processing is enabled.
Derivation	You can use the following fields to define derivation rules:
Derivation Rule	If you have opted for automatic status change, specify the criteria (rules) based on which the system will perform the status change. An Islamic LC is said to be in a specific status if any one of the five conditions associated with the status holds true. If all the conditions are false, the Islamic LC will automatically move to the next available status for which the condition is true. You can define five conditions for each status. The conjunctions 'AND' and 'OR' can be used to create multiple conditions. Use those buttons appropriately between each condition.
Operators	Select the operator for building a condition for automatic status change. You can use multiple elements, in conjunction with the functions and arithmetic operators. The drop-down list displays the following operators: • + (add) • - (subtract) • * (multiply) • / (divide) Choose the appropriate one.

	Choose the appropriate one.
Upward and Downward Movement	Specify the following details:
Accounting Role	Specify the role to be used for provisioning accounting entries for the Islamic LC contracts in the selected status. The option list displays all accounting roles pertaining to commission components. Choose the appropriate one.
Description	The system displays a brief description of the selected accounting role.
Accounting Head	Specify the account head (GL) to which the provisioning accounting entries should be passed, for the Islamic LC contracts in the selected status. The option list displays real as well as contingent general ledgers. Choose the appropriate one.
Description	The system displays a brief description of the selected accounting head.
	NOTE: In case of prepayment of commission for arrears, if the status of the contingent set of GLs changes, the system does not move the prepaid commission. Accrual continues to take place from the real GLs until the prepaid commission is exhausted. Contingent accrual takes place once the prepaid commission is exhausted.



4.2.3 Specify Applicable Rules of a Guarantee

You need to indicate the rules applicable for the guarantee.

Indicate the rule applicable by selecting the appropriate value from the list of values. The available values are as follows:

- URDG: The guarantee is subjected to the ICC Uniform rules of Demand Guarantees
- URCG: The guarantee is subjected to the ICC Uniform rules of Contract Guarantees
- · OTHR: The guarantee is subjected to another set of rules
- NONE: The guarantee is not subjected to any rules

NOTE: The above values are applicable only for Guarantee type of products.

The default value of Applicable Rule is set to NONE. This is applicable only for Guarantee type of products.

For Import and Export type of products, the following values are applicable:

- UCP LATEST VERSION
- EUCP LATEST VERSION
- UCPURR LATEST VERSION
- EUCPURR LATEST VERSION
- ISP LATEST VERSION
- · OTHR: The guarantee is subjected to another set of rules

NOTE:

- If the guarantee is subjected to rules other than that provided in the list of values, the applicable rule must be indicated as 'OTHR'
- The default value of Applicable Rule is set to UCP LATEST VERSION. This is applicable only for Import/Export
 type of products
- Based on the product type, the list of values will display rules applicable for the product.
- · 'Applicable Rule' and 'Rule Narrative' will be enabled only for import, export and guarantee product types

Rule Narrative

This is enabled only if 'Applicable Rule' is set to 'OTHR'. It is mandatory to specify the rule narrative if the applicable rule is 'OTHR'. You need to describe the Applicable rule here. Oracle Trade Fince will validate the rule narrative for slashes.

NOTE:

- 'Rule Narrative' should not start or end with '/' or should not have two consecutive slashes
- · The above fields will be enabled only for a guarantee



The Applicable Rule and Rule Narrative cannot be amended after authorization

Partial Confirmation Allowed

Check this box to confirm the partial amount. The remaining amount can be confirmed after you receive the approval from the external agent.

NOTE: Partial confirmation is allowed only for Islamic export LC, Islamic Advice of Guarantees and Islamic Advice of Standby Letters of Credit.

Applicable Rule For Reimbursement

Select applicable rule for which you need a reimbursement from the adjoining drop-down list. This list displays the following:

- URR Latest Version-Select if the applicable type is latest version of URR.
- NOTURR–Select if the applicable type is NOTURR.

4.2.4 Generate Advices for the Insurance Company

For generation of advice to an insurance company for the Islamic LC product, you need to associate the message type 'Islamic LC_INSURANCEADV' for the events BISS and AMND respectively. During authorization of these two events, the system will process the messages for all import Islamic LCs.

Refer to the 'Product Definition' User Manual under Modularity for details about events, accounting entries and advices.

All the messages are sent to the insurance company via mail. For this reason, you need to specify the insurance code (Receiver) and the mailing address of the Insurance Company in the Islamic LC Drafts screen.

Refer to the Annexure chapter to view an advice sample generated for the insurance company.

4.2.5 Specify Event for Reissue of Guarantee

You must associate the event REIS for an Islamic LC product for processing of reissue of guarantee. The system will display the REIS event during Events definition in the Product Maintenance.

Refer to Products user manual for detailed explanation of 'The Product Event Accounting Entries and Advices Maintenance screen'.

4.2.6 Generate Advice for Faxing Islamic LC Confirmation to Counterparty

For generation of advice to the counterparty at the time of confirming an Islamic LC, you need to associate the message type 'ILC_INSTR_COPY' and 'ILC_AM_INST_COPY' for the events BISS and AMND respectively. During authorization of these two events, the system will process the messages for confirmed Islamic LCs.

5.1 Introduction

A Letter of Credit contract is an instruction wherein a customer requests the bank to issue, advice or confirm a letter of credit, for a trade transaction. An Islamic Letter of Credit (Islamic LC) substitutes a bank's name and credit for that of the parties involved. The bank thus undertakes to pay the seller/beneficiary even if the remitter fails to pay.

The sequence of the events involved, in processing the Islamic LC is considered as an Islamic LC contract. The specific letters of credit thus processed for the customers of your bank constitutes a contract.

An Islamic LC Contract would, therefore, require information on:

- Who is the buyer or importer?
- · Who is the seller or the exporter?
- · The operation that your branch is performing on the Islamic LC
- · The merchandise traded under the Islamic LC
- Specifications for the transportation of the consignment
- · The documents that should accompany the Islamic LC
- · The amount for which the Islamic LC is drawn
- Details of the parties involved in the Islamic LC
- · The type of Islamic LC you are processing
- The details of the insurance company under which the goods traded are covered

You have defined products to group together or categorize Islamic LC which share broad similarities. Under each Product that you have defined, enter specific Islamic LCs based on your customers' needs. Each of these will consti-



tute a contract. While products provide a general framework and services to classify or categorize Islamic LCs, contracts are customer-specific.

By default, an Islamic LC inherits the attributes of the Product to which it is associated. This means that you will not have to define these general attributes each time you input an Islamic LC involving a product.

5.2 Islamic LC Contract Details

This topic provides the systematic instructions to capture the Islamic LC Contract Details.


PREREQUISITE:

If Registration is for LC issuance and product code is selected BG Issue/SG issue, then the system displays configurable override on product default. NOTE: System will update the status of registration as 'Processed' and contract reference no at registration screen, if acknowledgment reference number is captured at contract screen and (new) contract is created.
Product Code	This is a Mandatory Field Select the product from the list of products created in the Islamic LC. Click 'Populate' for details of this product to get defaulted from the Product screen.
Product Description	Product description given for this product gets defaulted from the Product screen.
Contract Reference Number	The Contract Reference Number identifies a contract uniquely. It is automatically generated by the system for each contract. The Contract Reference Number is a combination of the branch code, the product code, the date on which the contract is booked (in Julian format) and a running serial number for the booking date. The Reference Number consists of a three-digit branch code, a four-character product code, a five-digit Julian Date and a four-digit serial number. The Julian Date has the following format: YYDDD Here, YY stands for the last two digits of the year and DDD for the number of day(s) that has/ have elapsed, in the year.
Product Type	The type of product gets displayed here from the product screen, specifying if the product is of type import/export or revolving or non-revolving.
User Reference	In addition, a contract is also identified by a unique User Reference Number. By default, the Contract Reference Number generated by the system is taken as the User Reference Number. But you have the option to change the User Ref Number. Oracle Banking Trade Finance also provides you the facility to generate the user reference number in a specific format. NOTE: You can specify a format for the generation of the User Reference Number in the 'Sequence Generation' screen available in the Application Browser. Refer to the Core Services User Manual for details on maintaining a sequence format.



Description	
Select the fund id from the adjoining option list populated from FCUBS application. The fund information is fetched based on the below criteria. • Funds with OBTF Application date in between Fund Start and end dates. • Funds which belong to the global OBTF Branch.	
The system automatically generates the Source Reference number. You can change it i required. This message identification number is used to identify an incoming message coming from an external system. This is defined as the ICN number. On upload of an incoming message into Oracle Banking Trade Finance, this number, given by the external system, is stored in Oracle Banking Trade Finance and passed on to the contract generated as a result of the incoming message. If the incoming message results in an outgoing message, the ICN number is linked to the outgoing message also. This number will help you in creating a relationship between the incoming message, the resultant contract in Oracle Banking Trade Finance, and the outgoing message, if any. If an Incoming message results in an outgoing contract (outgoing message), Oracle Banking Trade Finance will store the source reference number (ICN Number) at the following levels. Incoming Message Level Contract Level (Resulted due to the Incoming message) Outgoing message (As a result of the above contract) You can capture the same source reference number for LC advising and reimbursement contracts if LC Issuance (MT700) and LC Reimbursement Authority (MT740) are received from the same issuing bank. NOTE: The system will not allow to capture, the same source reference number for more than one advising or reimbursing contracts.	
Select the fund id from the adjoining option list. The system defaults the value of Default Mudarabah Fund as fund id.	
The operations that you can perform on an Islamic LC are determined by the type of Islamic LC being processed. The operation that you specify will determine the accounting entries that are passed and the messages that is generated. You can select operation code from the list of valid operation code value based on Product Type. The type of operation that you can perform on an Islamic LC has been diagrammatically represented in the Figure 5.2: Operation you can perform on an LC.	

NOTE: If you are calling a contract that has already been created, click on Summary view. You can capture the Islamic LC Contract Summary screen details by typing LISTRONL in the field at the top right corner of the Application tool bar and clicking the adjoining arrow button or you can open an existing contract by double clicking the contract.

Specify Details of an Islamic LC

Through the screens that follow in this section, you can process all types of Islamic LCs (import, export, invoice, clean, guarantees, shipping guarantees).

You can choose to enter the details of a contract using the following methods:

- Copying the details from an existing contract and changing only the details that are different for the Islamic LC you are entering
- Using your keyboard or the option lists that are available at the various fields to enter the details of the Islamic LC afresh

To facilitate quick input, you only need to input the product code. Based on the product code, many of the fields is defaulted. Overwrite on these defaults to suit your requirement. You can add details that are specific to the Islamic LC like the Islamic LC amount, details of the buyer and the seller, etc.


Upload Islamic LCs/Guarantees

Oracle Banking Trade Finance allows you to a facility to automatically upload Islamic LCs and Guarantees.

The MT 700 and MT 701 messages that you receive is uploaded into Oracle Banking Trade Finance as Islamic LC contracts. Depending on whether confirmation is required, the uploaded Islamic LCs is of type 'advice' or 'advice and 'confirm'.

Similarly, you can upload MT 760 messages as Guarantee contracts and copy the details of the incoming guarantee from field 77c (and amend these details, if required). You only need to furnish minimal details such as the Currency, the Amount, the Parties, etc. Upload processing will also upload the document reference of Shipping Guarantee Contracts.

5.3.1 Description of the Islamic LC Contract Details Screen

The Islamic LC Contract Details screen consists of a header and footer that contains fields specific to the contract being entered. Besides these, you will also notice six tabs and a horizontal array of icons along the lines of which you can enter details of the contract. Contract details are grouped into the various screens according to the similarities they share.

The Islamic LC Contract Screen contains six tabs along the lines of which you can enter details of the contract.

The six tabs are:

Table 5.2: Tab Details

Field	Description
Main	Click this tab to enter the essential terms of the Islamic LC. This screen along with its fields has been detailed under the head Entering Main Contract Details.
Preference	Click this tab to set the preferences
Parties	In the screen that corresponds to this tab, you can enter the details of all parties involved in the Islamic LC. This screen along with its fields has been detailed under the head Entering Party Details.
Parties Limit	Click this tab to capture parties limit details
Shipment	In the screen that corresponds to this tab you can enter details of the documents required under an Islamic LC and the clauses that should accompany the documents. Besides, you can also specify a description of the merchandise traded under the Islamic LC and shipping instructions for the transportation of the merchandise.
Goods	Click this tab to capture the goods details
Documents	Click this tab to capture the document details
Tracers	Click on this tab to enter details of the tracers that should be generated for an Islamic LC.
Advices	In the screen corresponding to this tab you can view, suppress and prioritize the advices that are to be generated for a contract. This screen along with its fields has been detailed under the head Specifying Advises for an Islamic LC.

On the Contract Detailed screen are also displayed a horizontal toolbar. The options on this toolbar enable you to process a number of functions vital to the processing of an Islamic LC contract. These options have been briefly described below.

Collateral	In the screen that corresponds to this icon, you can specify details of the cash that you collect as collateral form a customer for the Islamic LC that you process. The details of this screen are discussed under the head Specifying Collateral details for an Islamic LC.	
Events	Select this option to view the details of the events and accounting entries that a contract involves.	
Linkage Details	In this screen, you can link an Islamic LC to a deposit or account, and indicate the funds that you would like to block.	
Fields	Click Fields , to view the user-defined fields linked to the product.	
MIS	Click MIS, to define MIS details for the Islamic LC.	
Transfer Details	If the LC is transferred to a new party then a transaction is populated here. You can only view the details. IB Linkages choose this option to specify IB linkages	
Split Settlement	Specify split settlement details	
Finance Preference	Click Finance Preference to view the 'Finance Preference Screen'. You can enter the details of the finance.	
Brokerage	Use this option to capture brokerage details for the Islamic LC contract and set your preferences for sharing the brokerage amount among multiple brokers.

Enter valid inputs into all the mandatory fields or you will not be able to save the contract. After making the mandatory entries for the Islamic LC, save the contract by either clicking Save in the tool bar.

A contract that you have entered should be authorized by a user bearing a different Login ID, before the EOD is run

NOTE: You have the option to amend all the unauthorized entries made for an Islamic LC. However, after authorization, certain fields cannot be amended.

Click Exit to go back to the Application Browser.

Hold Support during Islamic LC Issuance [LIDTRONL]

Click HOLD to support a New operation during Islamic LC Issuance from LIDTRONL.

The system is enhanced to support Hold during LC amendment.

- User can unlock contracts put on HOLD, modify details if required and Save. In the existing functionality of amendment, Save would continue 'Deletion of Hold' and 'Hold of Hold' support.
- 'Similar to Hold of New operation', the system will perform only mandatory validations.
- · Validations applicable during amendment, is processed.

However, authorization is not supported for Contracts put on Hold.

5.3.2 Specify the Main Details of an Islamic LC

This topic provides the systematic instruction to specify the main details of an Islamic LC.

CONTEXT:

While defining a product, you defined a broad outline that is applied on Islamic LCs. However, while processing an Islamic LC involving a product, you need to enter information specific to the Islamic LC.

This information is captured through the Islamic LC Contract Details Main screen.



Figure 5.4: Islamic LC Contract Input - Preferences



Oracle Banking Trade Finance allows you to amend Islamic LC contracts. Such amendments may have direct impact on the parties limits defined in the contracts. This section examines the some amendments that is made to an Islamic LC contract and their impact on the parties' limits.

Increase in Islamic LC Amount

If there is an increase in the Islamic LC amount, based on the amount tag, the system updates the parties' limits as follows:

5.3.5 Specify the Media Details for a Party

The advices for a party is sent to the default media maintained in the Customer Addresses table. If you want to send the advices through another medium, you should indicate it in the Parties screen. The address should be also indicated. The advices is sent through the new medium, only if you indicate so in the Advices screen of contract processing. If not, the advice will continue to be sent to the default address defined for the party.

You can use this feature to send a one-off advice, through a different medium. For example, for a particular customer, you normally send all advices through mail and hence haven't defined SWIFT or TELEX advices. For an Islamic LC involving a customer, you want to send the advices through SWIFT. In such a case, you can specify the medium as SWIFT and specify the address only for the Islamic LC you are processing.

5.3.6 Specify Credit Administration Details

The details on credit lines that feature on this screen have been covered in the chapter titled Specifying Central Liability tracking details.

5.3.7 Specify Shipping for an Islamic LC

This topic provides the systematic instruction to specify shipping for an Islamic LC.

CONTEXT:

An Islamic LC, which is an instrument of trade finance, involves details of merchandise.

Hence, you will need to specify the following details for the Islamic LC:

- · Details of the merchandise
- · Details of the mode of transportation







5.3.8 Specify Advices for an Islamic LC

CONTEXT:

An important part of processing an Islamic LC is the generation of various advices applicable for a contract.

The advices that is generated for the events that occur during the lifecycle of an Islamic LC are defined for the product, to which the Islamic LC is linked. For example, you may have specified the following advices for a product:

- Issue of an import Islamic LC: pre-advice by SWIFT and Islamic LC instrument by mail to the advising bank, the authorization to reimburse to the reimbursing bank
- · Advice of an export Islamic LC: the acknowledgment advice to the advising bank



Issue of a guarantee: the guarantee instrument to the beneficiary

The details of the advices for an event are displayed in the Advices screen. The party type to whom a specific advice should be sent is picked up automatically based on the type of Islamic LC being processed and the parties involved.

The advices screen is displayed. The advices defined for the event you are processing is displayed. You can choose to suppress any of them. The address of the party to whom the advice is addressed to is picked up by default, based on the media and address maintenance for the party.

These is changed if required. For a payment message by SWIFT, you also have the option to change the priority of the message



Suppress	By default, all the advices that have been defined for a product is generated for the Islamic LCs involving it. If any of the advices are not applicable to the Islamic LC you are processing, you can suppress its generation by Checking against the suppress field.



Field	Description
Priority	For a payment message by SWIFT, you also have the option to change the priority of the message. By default, the priority of all advices is marked as Normal. The priority of a payment message is changed to one of the following Normal Medium High
Medium	The medium by which an advice is transmitted and the corresponding address is picked up based on the media and address maintenance for a customer. You can, however, change either of these while processing the Islamic LC. Typically, if changed, both of them is changed. After selecting the advices to be generated for the Islamic LC, click on 'Ok' to save it. Click on 'Delete' to reject the inputs you have made. In either case, you is taken to the Contract Main screen.

5.3.9 Specify the Free Format Instructions that should accompany an Advice

Free Format Text instructions (FFTs) are a set of instructions or statements that are applicable to the Islamic LC that you process. It is used to enter additional details related to the Islamic LC you are processing. In the Islamic LC Contract - Advices screen you can specify the FFTs that should accompany an advice, generated for an Islamic LC. When you select an advice code on this screen, the advice code together and the party type, to which it is to be sent,



is displayed in the FFT section. This indicates that the FFTs that you specify will appear on the advice, which is displayed and is sent to the party type that is displayed.

All the FFTs defined for the advice, at the product level will also be displayed. You have the option to add to or delete from the list of FFTs defaulted for an advice. To add an FFT to the list, click on add in the screen and then on the option list.

Select an FFT code from the option list that is displayed. After selecting the code that identifies the FFT you wish to attach to the advice, its description is automatically picked up and displayed. The FFT description is changed to suit the requirements of the Islamic LC you are processing.

To delete an FFT from the list, highlight the code that identifies the FFT and click on the delete in the screen. The free format codes for the following purposes have the fixed codes:

SND2RECMTxxx	Sender to receiver information (Field 72 of SWIFT).	
INSTRUCTION	Instructions to the Paying/Accepting/Negotiating bank (Field 78 of SWIFT).	

Sender to Receiver Info Tag

FFT codes "SND2RECMTxxx" is used to pick up the sender to receiver information in various swift messages. In the FFT code "MTxxx" will stand for the SWIFT message type in which the FFT code is picked up. This facilitates defining a separate FFT code for each of the SWIFT message.

This is applicable for the following swift messages: MT700, 707, 705, 710, 720, 730, 740, 747, 760, 767, 768, 400, 410, 412, 420,422, 430, 734, 732, 742, 756, 750, 752,754

The various FFT codes for SND2RECMTxxx are maintained in the Free Format Code maintenance screen. During contract processing, based on the event being processed system defaults the advices maintained for the particular event. For messages of SWIFT type, you can select the corresponding SND2RECMTxxx FFT code from the list of values In the SWIFT message generated, the tag 72 is populated with the text associated with the FFT code SND2RECMTxxx attached for the advice at the contract level. System will not validate the FFT code SND2RECMTxxx being attached with the advice. This has to be operationally controlled.

During advice generation, if the FFT code SND2RECMTxxx corresponding to the advice is not attached or if a different SND2RECMTxxx is attached, system will not populate the tag 72 in the advice generated.

5.4 Cancel an Islamic LC

CONTEXT:

You may have to cancel an Islamic LC that has been opened, before its Expiry Date. An example for a cancellation is when the trade deal for which the Islamic LC is opened falls through. A canceled Islamic LC will not be available for any availment. However, you can cancel an Islamic LC that has been availed partially. In Oracle Banking Trade Finance, the following are the prerequisites for cancellation:

· The Islamic LC has not yet reached its expiry date



· The cancellation event - CANC, has been defined

The accounting entries for this event are generally the reversal of the accounting entries passed for liability and collateral, when the Islamic LC was opened. In addition, a charge is levied for canceling the Islamic LC.

A cancellation advice informing, the advising bank or beneficiary, about the cancellation is generated.

- 1. To cancel an Islamic LC, from the Contract Detailed View, do the following:
 - a. Select Close from the Application toolbar
 - b. Click 'Reopen' icon in the Toolbar

You is prompted to confirm the cancellation.

5.5 Close, Reopen, and Black list an Islamic LC

This topic contains the following subtopics:

- 1) Closing an Islamic LC
- 2) Reopen an Islamic LC
- 3) Black Listing Islamic LCs

5.5.1 Closing an Islamic LC

Normally, an Islamic LC that is opened is negotiated within its expiry date. If the negotiation does not happen even after the expiry date, you can close the Islamic LC. By closing an Islamic LC, you is reversing the liability entries passed for the Islamic LC. This ensures that the credit limit that was taken by the Islamic LC is released and is available for future utilization.

In Oracle Banking Trade Finance, you can close an Islamic LC under the following circumstances:

- · The event CLOS is defined for the Islamic LC
- · The Islamic LC is beyond its Expiry Date

The accounting entries defined for this event is generally the reversal of the outstanding liability. No availment is made against an Islamic LC that is closed. You should reopen a closed Islamic LC if you have to make an availment against it. This would be required in a situation when the Islamic LC comes in for negotiation after it has been closed. The reopening of the Islamic LC will put back the outstanding liability and availability for the Islamic LC.

5.5.1.1 Close an Islamic LC automatically

In the Islamic LC Contract Main screen, you can specify the following dates related to the closure of an Islamic LC:

· Whether auto closure is allowed



· The date on which the Islamic LC should be automatically closed

To recall, the date of automatic closure is based on the 'Closure Days' maintained for the product involved in the Islamic LC. However, you can change the closure date, to any date, after the expiry date of the Islamic LC.

An Islamic LC that is defined for automatic closure is closed during the End of Day processes on the closure date.

5.5.1.2 Close an Islamic LC manually

An Islamic LC that is not defined for automatic closure is closed any time after its Expiry Date.

By clicking 'Reopen' icon in the Toolbar, when the details of the Islamic LC IS displayed in the Detailed View screen.

Oracle Banking Trade Finance displays a message prompting you to confirm the closure. The closure of an Islamic LC should be authorized by a user, bearing a different User ID, before the End of Day operations begin.

5.5.2 Reopen an Islamic LC

To avail against a closed Islamic LC, you have to reopen it. This occurs when the Islamic LC comes in for negotiation after it has been closed. The reopening of the Islamic LC will put back the outstanding liability and availability for the Islamic LC.

To reopen a closed Islamic LC, you should have defined the event ROPN for the product under which the Islamic LC is processed. For this event, you should have ideally defined the same entries for the Islamic LC outstanding amount and the liability, as you would for the opening (issue or advice) of an Islamic LC. You can levy a charge for reopening an Islamic LC.

5.5.2.1 Procedure to reopen an Islamic LC

Clicking 'Reopen' icon in the tool bar when the details of the Islamic LC are being displayed in the Detailed View screen. Oracle Banking Trade Finance will prompt you to confirm the reopening of the Islamic LC. You need to click save icon to reopen the LC.

5.5.3 Black Listing Islamic LCs

This topic provides the systematic instructions to Black Listing Islamic LCs.

CONTEXT:

You can black list Islamic LCs and collection bills based on a set of criteria that you can define. You can define criteria for black listing Islamic LCs and bills in the Black Listed Transaction Input screen processed from the Application Browser.

Prerequisite:

Specify the **User ID** and **Password**, and login to Homepage.

On the Homepage, type LCDBKLST in the text box, and click the next arrow.

STEP RESULT: The Black Listed Transaction Input is displayed.

5.6.1 Reverse an Islamic LC

You can reverse any particular version of the Islamic LC Contract or entire Islamic LC. This can achieved through reversal operation. The Reversal of an Islamic LC should be authorized by a user, bearing a different User ID, before the End of Day Operation begins.

This is applicable for Islamic Guarantees and Standby Letters of Credit.

5.6.2 Procedure for Reversing an Islamic LC

This topic provides the systematic instructions to reverse an Islamic LC.

PREREQUISITE:


Specify the User ID and Password, and login to Homepage.

From the Homepage, navigate to Islamic LC details in the Detailed View screen

1. On the Islamic LC details in the Detailed View screen, click Reverse.

STEP RESULT: Select Event screen is displayed.

The Reversal options are:



- Contract Reversal
- Event Reversal
- 3. Confirm the reversal when prompted.

5.6.3 Contract Reversal

On selecting the 'Contract reversal', system will reverse the Islamic LC contract. A Reversed Islamic LC will not be available for any further operations. 'REVR' event is triggered which updates the contract status as 'Reversed'. This will reverse the liability entries passed for the Islamic LC to ensure that the credit limit that was taken by the Islamic LC is released and is available for future utilization. In addition to this, Charges, Commission, Limits Utilization and Accounting entries will also be reversed on contract reversal.

5.6.4 Event Reversal

In case of 'Event Reversal', system will reverse the last version creating event along with the non-version creating events (if any) in between the current version and previous version. This reinstates the contract to the version corresponding to the version of the immediate previous event of the reversed event.

'REVE' event is triggered and reverse the associated events, but the contract status is available as 'Active'. However, you cannot reverse the last event reversal even though it is a version creating event.

This will also reverse the liability entries passed for those particular reversed LC events to ensure that the credit limit that was taken by the Islamic LC is released and is available for future utilization.

Reversal of the event will have impact on the below details

- · Accounting entries- Negative entries is posted for the reversed LC events
- Commission
- Charges
- Limit utilization

You cannot reverse more than one event at the same time or reverse a canceled or closed Islamic LC contract.

When there is only one version available for the contract and if you select 'Event Reversal', the system displays an error message and in this case you need to select 'Contract Reversal'.







Figure 6.2: Islamic LC Contract Input



Besides the Islamic LC amount, the other components of an Islamic LC include the commissions that you collect and the charges that you levy on the parties involved in an Islamic LC.

While defining Accounting Roles for a product you must specify the internal accounts that should be picked up when commissions are collected and when charges are levied.

For an Islamic LC having the operation code 'Reimbursement', you will not be able to save commission related details. While saving the contract, the system will display an error message if you enter details in the **ICCF** screen.

While creating or amending an authorized contract, you can modify the percentage of commission to be charged. Enter the rate and click Re-compute button to recalculate the commission percentage to be charged.

NOTE: The details of the commissions that can be collected and the procedure of making them applicable to the Islamic LC you are processing has been detailed in the chapter Processing Commissions in the Modularity User Manual.





Islamic LCs that are issued or confirmed is often processed with cash collateral. In cases like a in a Guarantee, you may even take a 100% cash collateral. This is when an applicant is not a customer of your bank and the credit worthiness of the applicant is not known. Details of such cash collateral can be maintained in the Islamic LC Contract - Collateral Details screen.

The cash collateral percentage is defined for the product under which an Islamic LC is processed. This percentage is picked up by default for the Islamic LC being processed.




Figure 6.9: Trade Finance Events






Figure 6.16: External Customer Composite MIS








Figure 6.23: Document Upload

















6.2.2 Create Contract

Through the screens that follow in this section, you can process all types of Islamic LCs (import, export, invoice, clean, shipping guarantees). You can choose to enter the details of a contract using the following methods:

- Copying the details from an existing contract and changing only the details that are different for the Islamic
 LC you are entering
- Using your keyboard or the option lists that are available at the various fields to enter the details of the LC afresh

To facilitate quick input, you only need to input the product code. Based on the product code, many of the fields will be defaulted. Overwrite on these defaults to suit your requirement. You can add details that are specific to the Islamic LC like the Islamic LC amount, details of the buyer and the seller, etc.



6.3 Authorize a Contract

This topic provides the systematic instruction to authorize a contract.


CONTEXT: Every Islamic LC transactions that you enter manually must be verified and authorized. Only a user who has appropriate rights can perform the verification and authorization functions. Such a user is called an authorizer.

Specify the User ID and Password, and login to Homepage.

You cannot authorize a contract in the following cases:

- the contract has multilevel of authorization pending, the same will be done using the **Multilevel Authorization Detailed** screen
- the level of authorization is greater than or equal to 'N'
- the 'Nth' or the final level of the users authorisation limit is less than the difference between amount financed and sum of the limits of all the users involved in authorizing a transaction, this case holds good when the 'Cumulative' field is checked in the Product Transaction Limits Maintenance screen



- the transaction amount is greater than the authorizer's authorisation limit if the Cumulative field is unchecked in the Product Transaction Limits Maintenance screen.

On receipt of the bills or on notification from the negotiating bank, you can record an availment under an LC. The availment on an LC can be made only up to the Maximum LC amount, specified in the Contract Main screen.

Once an availment is recorded, the current availability under the LC will be reduced and the outstanding liability updated automatically. It will be reduced by the availment amount. When an availment is recorded and there is cash collateral outstanding against the LC, invoke the cash collateral screen and specify the amount of cash collateral to be released.












Figure 7.10: Advice Details







7.2.2 Islamic LC Liability Reversal

When an Islamic LC is availed using a Bill (or using the Availment function from the Browser), the Availment Amount and the Liability Percentage specified for the underlying Islamic LC contract, will be used in computing the default Liability Amount. The default value that is displayed can be changed.

NOTE: During availment, the Positive Tolerance Percentage specified for the Islamic LC is not taken into account to compute the default value of the Liability Amount.



7.2.4 Reversal of an Availment

When an Islamic BC contract under an Islamic LC contract is reversed, the system will automatically reverse the corresponding availment on the Islamic LC contract. When a Reversal of availment (RAVL) event is triggered on the Islamic LC contract, Islamic LC outstanding amount and the Islamic LC Liability amount is updated.

You can manually reverse the availment made under Islamic LC. All availment made on the Islamic LC will be displayed. You can select an availment for reversal in the availment screen. The system will not allow the manual reversal of availments, triggered by Islamic BC contract from the availment screen.

To reverse the details of an Islamic LC, click on 'Reverse' icon in the tool bar. On reversing an availment on an Islamic LC, the system passes reversal entries for the availment.

When a bill booked under an Islamic LC is partially or fully liquidated and the Islamic BC is reversed, the system will reverse the corresponding availment automatically and update the Islamic LC outstanding and liability amounts.

When an Islamic BC contract booked under an Islamic LC revolving by time and non cumulative is reversed after the reinstatement of the Islamic LC, the system will not reverse the availment. Similarly for Islamic LCs revolving by value, the system will not reverse availment if the BC contract is reversed after reinstatement of the Islamic LC.

Reversal of Islamic LC Liability

When an Islamic LC is availed using a Bill (or using the Availment function from the browser), the Availment Amount and the Liability Percentage specified for the underlying Islamic LC contract will be used in computing the default Liability Amount. This default value can be changed.

NOTE: During availment, the Positive Tolerance Percentage specified for the Islamic LC is not taken into account to compute the default value of the Liability Amount.

8. Amend Details of an Islamic LC

8.1 Introduction

An amendment to an Islamic Letter of Credit (Islamic LC) signifies any change made to the terms of an Islamic LC after it has been authorized. An amendment is made at anytime after an Islamic LC has been authorized and before its expiry date.

The following are some examples when you would amend the details of an Islamic LC:

- · You, as the issuing bank, have received an application from your customer to change the terms of the Islamic LC
- · You as the advising bank have received instructions from the issuing bank to amend an Islamic LC as advised.

8.2 Procedure to Amend an Islamic LC

While in the detailed view of the Islamic LC, you can amend the details of the contract depending on whether:

- · The Islamic LC has been authorized
- The Islamic LC has not been authorized even once after it was input

Depending on the authorization status of an Islamic LC contract, you can amend its details as follows:

When you have captured the details of a contract and it is not yet authorized, its attributes, financial as well as non-financial, is changed, even if the details have been saved. If accounting entries are involved in the change, the old entries are deleted and new ones passed.

Once a contract has been authorized, additional entries are passed, depending on the nature of amendment.

For each amendment, a new version of the Islamic LC are generated. Different versions of the Islamic LC will also be generated by events like reinstatement and reopening. In the 'Contract Detailed View screen, you can view the different versions by clicking on back for the previous version and forward on the screen for the next one. When a customer requests for changes in the terms of the contract, the details of the Islamic LC are amended accordingly and an amendment instrument is generated. The amendment of the following details of an Islamic LC, result in the generation of an amendment instrument:

- · An amendment in the Islamic LC amount
- · An amendment in the expiry date
- · A change in the latest shipment date



· Any change to the free format instructions for the Islamic LC

If there are changes in the terms of the Islamic LC other than IN the amount, the expiry date or latest shipment date, indicate the same in the form of a free format instruction, for the amendment instrument.

In the case of an amendment, you have the option to reissue the Guarantee. If you choose to do so, the REIS (Reissue of Guarantee) event are triggered.

The system checks for any previous amendment. In case no amendment has been performed, the system displays the message as "Do you want to Reissue the Guarantee?"

Click on OK to reissue the Guarantee or click on Cancel to process the amendment of Guarantee.

The system checks if the REIS event is maintained for the product. If the event is maintained, the system does not allow any further change in the Islamic LC contract details apart from FFT fields, which is modified/added but you cannot delete the existing data.

The system creates a new version for the Reissue event and the event inherits all the contract information defined for the authorized BISS event. The version also inherits the information from the subsystem excluding Charges and Commission. No commission is associated with the Reissue event and charges are maintained for the REIS event, which is processed along with the reissue event.

When the Reissue event is authorized, the advices maintained in the REIS event are processed.

8.2.1 Indicate a Change of Value for a Field

When the Islamic LC amount is being changed, the new amount of the Islamic LC should be indicated after the amendment.

For example, the original Islamic LC amount was USD 100,000 and you want to make it USD 150,000. In the Islamic LC amount field, during amendment, enter the amount as USD 150,000. The system will calculate the increase in amount and pass the appropriate entries.

The Islamic LC amendment instrument will have both the old and new values.

The original Islamic LC amount was USD 100,000 and you want to change it to USD 75,000. In the Islamic LC amount field, during amendment, enter the amount as USD 75,000. The system will calculate the decrease in amount and pass the appropriate entries. The Islamic LC amendment instrument will have both the old and new values. When you are changing the expiry date or the latest shipment date, you should enter the new date in their respective fields.

8.2.2 Commission and Charges for the Amendment

While amending the details of an Islamic LC, you can specify the commissions and charges that you want to levy for processing the amendment. These are effective from the date of amendment. It will not affect the booking commission in any way.

Amendment commission is computed based on the Claim Expiry Date for bank guarantee and advice of guarantee.

Refer to the chapter Commission calculation for details on how commission is calculated, for an amendment.

8.2.3 Amendment of an Unauthorized Islamic LC

The amendment of an unauthorized Islamic LC is considered as a modification. When an Islamic LC that you have entered is not yet authorized, you can change all its details except the details in the header (contract reference number, the product and type of operation). To change any detail on an Islamic LC that has been stored and not authorized, delete the Islamic LC and input a new one.

After amending the details of the unauthorized Islamic LC, save the contract with the new information. On saving the amendment, all the accounting entries that were passed during the input of the contract and the earlier



accounting entries specified for the Islamic LC, are deleted. A fresh set of accounting entries are passed for the amended Islamic LC contract.

As the advices to be generated for an Islamic LC, are generated only at the time of authorization, no action needs to be taken regarding messages.

NOTE: The system will not allow you to amend the following fields in the 'Islamic LC Contract' screen:

- Their Reference Number for Party Types ABK, BEN, COB and ISB (in the 'Parties' tab)
- Issue Date (in the 'Main' tab)
- Expiry Date (in the 'Main' tab)
- Islamic LC Amount (in the 'Main' tab)
- Positive and Negative Tolerance (in the 'Main' tab)
- · Additional Amount Covered message (in the 'Others' tab)
- Shipment From (in the 'Ship/Docs' tab)
- Shipment To (in the 'Ship/Docs' tab)
- Port of Loading (in the 'Ship/Docs' tab)
- Port of Discharge (in the 'Ship/Docs' tab)
- · Latest date of shipment (in the 'Ship/Docs' tab)
- Shipment period (in the 'Ship/Docs' tab)
- Sender to receiver information (in the 'Parties' tab)

However, you can amend the above fields in the 'Amendment Confirmation' screen. This screen is explained in the following section.

8.3 Islamic LC Amendment Details

8.3.1 Confirm the Islamic LC Amendment

This topic provides the systematic instructions to Confirm the Islamic LC Amendment.

CONTEXT:

The option to amend these fields is also available in the **Islamic LC Amendment Confirmation Input** screen. However, the amendments will become effective only upon receiving the confirmation from the beneficiary.

PREREQUISITE:

Specify the **User ID** and **Password**, and login to Homepage.

1. On the Homepage, type **LIDAMEND** in the text box, and click the next arrow.




Figure 8.1: Islamic LC Amendment Confirmation Input

The system displays an error message in the following cases:

- If beneficiary confirmation is pending for an amendment and LC amount is modified for that amendment and if the user is initiating a fresh amendment with a change in tolerance value.
- If beneficiary confirmation is pending for an amendment and Expiry Date is modified for that amendment and if the user is initiating a fresh amendment with a change in Latest Shipment Date or Shipment Period.
- If beneficiary confirmation is pending for an amendment and Latest Shipment Date is modified for that amendment and if the user is initiating a fresh amendment with a change in Expiry date.
- If beneficiary confirmation is pending for an amendment and Latest Shipment Date is modified for that amendment and if the user is initiating a fresh amendment with a change in Shipment Period.

Upon selection of the contract, the following details are displayed in editable mode:

- Currency The contract currency
- Version Number
- · Contract Amount The amount that is availed under the Islamic LC
- Issue Date The date on which the Islamic LC is issued. You cannot specify a future date here.

- Expiry Date The date on which the Islamic LC is scheduled to expire. On confirmation of guarantee amendment, revised Expiry Date is propagated to 'LIDTRONL'. System derives Claim Expiry date based on the new Expiry Date.
- Closure Date This the date Islamic LC is scheduled to be closed. You can modify this particular value.
- Additional Amounts Covered This indicates the value to be carried in field 39C of the SWIFT messages MT700 and MT740
- Increase Decrease of Islamic LC Amount A display field which indicates the amount of Islamic LC increased or decreased.
- Latest Shipment Date The last date by which the shipment of the goods has to take place. This date should not be earlier than the Issue Date of the Islamic LC or later than the expiry date
- **Shipment Period** The extension of the shipping period. You can enter the Shipment Period only if you have not specified the Latest Shipment Date
- Port of Loading The port from where the goods transacted under the Islamic LC are loaded.
- Port of Discharge The destination port to which the goods transacted under Islamic LC should be sent
- From Place The place from where goods are to be dispatched or transported
- To Place The final destination to which goods are to be transported/delivered

- Positive Tolerance% The percentage that is to be added to the Islamic LC amount to arrive at the Maximum Islamic LC amount
- Negative Tolerance% The percentage that should be subtracted from the Islamic LC amount.

- Confirmation Instructions Select the confirmation option to indicate that the Islamic LC can have an

- Requested Confirmation Party Specify the confirmation party type (Advising Bank, Advice Through Bank or Confirming Bank).
- Party details in the 'Parties' tab of the screen You can amend 'Their Reference Number' and the 'Dated' fields values only.
- Free Format Text details in the 'FFT' tab of the screen
- Beneficiary Account Specify the account details of beneficiary. This field is read only.
- Sanction Check Status The system displays the sanction check process
- Last Sanction Check Date The system displays the last sanction check date.

For more information on processing sanction check refer 'Processing Sanction Check' section in LC user manual.

Make the necessary amendments. Save the changes. To save, click save icon in the toolbar of the screen. On Save system validates if there are any unsettled claims and provides appropriate override.

The system will update the following details in the audit trail of the screen:

- Input By Your login id
- Date Stamp The date and time at which you saved the contract
- Amendment Status The status will always be 'Unconfirmed'
- Auth Status The status will always be 'Unauthorized'










Figure 8.8: Fields













8.3.2 Authorize Amendment Details

While saving the amendment details, the amended amount is validated against the product transaction limit and the user input limit maintained in the system. If the amount exceeds the allowed input limit or the product transaction input limit, an appropriate override/error message is displayed.

The system will convert the contract amount using the standard mid rate to the transaction limit currency and check against the transaction limit amount maintained for the product if the contract currency is different from the transaction limit currency.

You have to get a contract authorized by your supervisor. Follow the steps given below to authorize:

- · Click authorize icon in the toolbar of the screen. The following screen are displayed:
- Click 'OK' to proceed. The system will seek a confirmation for generating the messages. Click 'OK' to proceed.
- Click 'Cancel' to return to the 'Amendment Confirmation' screen. The system will display a message to confirm successful authorization of the record. The audit trail of the screen will now display the following details:
 - Checker ID Login id of the authorizer
 - · Checker Dt Stamp The date and time at which you authorized the contract
 - Auth Status The status will updated to 'Authorized'



8.3.3 Confirm Amended Details

Once authorized, you will not be allowed to modify these details. The system will provide option for confirming or rejecting the amendment details. To confirm the details, do the following:

- Click confirm icon in the toolbar of the screen. The system will display the following override message to proceed:
- Do you want to confirm the record? OK to proceed.
- Click 'OK' in the message window to proceed. The system will display the following message to confirm the confirmation:
- · The Record is successfully confirmed.
- Click 'OK' in the message window and this takes you the Islamic LC contract online screen. The charges are waived using this screen. Note that the 'Amnd Status' is updated to 'Confirmed' and the 'Auth Status' is updated to 'Unauthorized' (in the audit trail of the screen).

8.3.4 Amend details using the Contract screen

You can unlock the Islamic LC contract screen after clicking 'OK' in the message window above. The Islamic LC contract online screen is used for modifying details after confirmation of the amendment action. The system creates an amendment on the Islamic LC once the proposed amendment is confirmed. When this amendment is created the confirmation and amendment events are both left in an unauthorized state. This allows unlocking of the Islamic LC contract to make the necessary amendments.


Once the confirmation is saved on the amendment screen, the Islamic LC contract online screen is launched with the data modified, and this is unlocked and modified, or closed as chosen by the user. These changes are directly



made by launching the Islamic LC contract screen. However the amendment can only be deleted by using the amendment screen as described above.

The amendment cannot be deleted using the Islamic LC contract screen, and can only be deleted using the amendment screen as part of the confirmation. This is done by deleting the confirmation using the amendment screen Hence the process is carried out as follows:

- The amendment is confirmed using the Islamic LC Credit Amendment confirmation screen. It is completed by clicking C and saving the confirmation.
- The Islamic LC contract screen is launched once the confirmation is saved. This screen contains the details of the amendments done in the confirmation input screen.
- This screen is unlocked and the details are made available for modification. Subsystem details like charges and commission is modified or waived as required.
- During an auto authorization of Amendment Confirmation, the amendment created by this confirmation is also authorized

8.3.4.1 Authorize Confirmation

Your supervisor now needs authorize the confirmation to view the changes made. The steps to authorize are given below:

- After logging in, invoke the 'Amendment Confirmation' screen and navigate to the record that needs to be authorized.
- Click authorize icon in the toolbar of the screen. The system will create a new version of the contract and display the details of the contract in the 'Islamic LC Contract' screen, as shown below.
- After confirming the changes, click save icon in the toolbar of the screen to save the details.

NOTE: You can delete the amendment if the 'Amnd Status' of the contract is 'Confirmed' but unauthorized.

No accounting entries are passed nor will any charges be levied during the registration of an LC. An LC is registered based on the first set of documents (original or duplicate) received. On registration, an acknowledgment reference number is allocated to the LC. At the time of processing an LC that has already been registered, you need to specify the acknowledgment reference number. All the details entered at the time of registration will automatically be picked up and defaulted to the main contract screen.







10.1 Introduction

In Oracle Banking Trade Finance, you can make transfers from an Islamic LC (Islamic LC). While transferring funds from an Islamic LC, you need to note the following conditions:

- The transferred Islamic LC will always be of the same type as the old Islamic LC and is created under the same product.
- The charges applicable to the transfer should be associated with the event TRNF defined for the product.
- · You can only transfer an amount that is less than or equal to the amount available under the original Islamic LC.
- An Import Islamic LC is transferred only if the Applicant and Beneficiary are customers of your bank.

10.2 Transfer Islamic LC

This topic provides the systematic instructions to Transfer Islamic LC.


PREREQUISITE:

Specify the User ID and Password, and login to Homepage.

1. On the Homepage, type **LIDTRANF** in the text box, and click the next arrow.

To create child contract in Transfer Type product, Use Transfer Product has to be checked at Trade Finance Bank Preference Maintenance screen and Transfer Type product has to be maintained.

Creation of transfer contract is supported from LIDTRONL screen with product type as Transfer and Transferred LC flag checked if Use transfer product flag is checked at bank level.

Error will be displayed when transferred flag is unchecked for Transfer product type contract creation.

If use transfer product flag is not checked at the bank level, contracts under Transfer product type will not be allowed to be created.

Transferred Contract with new product code will have product type as Transfer in LIDTRONL and LIDAMEND screens.

New product Type 'T' will be available in LISTRONL summary screen for Query

Transfer product Flag at LISPRMNT summary screen, will list product codes based on the Transfer product type.








Figure 10.4: Islamic Letters of Credit Transfer Input - Parties Limits







Figure 10.9: Message Preview











10.2.1 Note on Transfers from Import and Export Islamic LCs

How Transfers from Import LCs are Processed

While transferring an import LC, the original LC is modified to include the additional details of the transferred LC. For instance, the new beneficiary and new advising are added to the existing list of parties.

In Oracle Banking Trade Finance, the transfer made from an LC is taken as a new event 'TRNF'. Availment made by the new beneficiary against the transferred LC is tracked against the original LC.

How Transfers from Export LCs are Processed

In the case of an Export LC, a new LC is opened for each transfer that you make from the original LC. The transfer amount is taken as the new LC amount.

On authorizing the transfer,

- An availment to the tune of the transferred amount is made against the original LC i.e. the outstanding amount
 of the Original LC is reduced by the transfer amount
- · A new LC is created based on the transfer details that you specified

The transferred LC is separated from the original LC. Availment made from the new LC will not affect the outstanding of the Original LC.

10.2.1.1 Process of Transfers from Import Islamic LCs

While transferring an import Islamic LC, the original Islamic LC is modified to include the additional details of the transferred Islamic LC. For instance, the new beneficiary and new advising are added to the existing list of parties.

In Oracle Banking Trade Finance, the transfer made from an Islamic LC is taken as a new event 'TRNF'. Availment made by the new beneficiary against the transferred Islamic LC is tracked against the original Islamic LC.

10.2.1.2 Process of Transfers from Export Islamic LCs

In the case of an Export Islamic LC, a new Islamic LC is opened for each transfer that you make from the original Islamic LC. The transfer amount is taken as the new Islamic LC amount.

On authorizing the transfer,

- An availment to the tune of the transferred amount is made against the original Islamic LC i.e. the outstanding amount of the Original Islamic LC is reduced by the transfer amount and
- A new Islamic LC is created based on the transfer details that you specified.

The transferred Islamic LC is separated from the original Islamic LC. Availment made from the new Islamic LC will not affect the outstanding of the Original Islamic LC.

11.1 Introduction

A Standby Letter of Credit (SBLC) and Bank Guarantee (BG) is a payment guarantee generally issued by the issuing bank on behalf of an applicant securing payment to the beneficiary, If the buyer fails to fulfill a contractual commitment the issuing bank will release payment to the seller.




Figure 11.1: Islamic Guarantees and Standby Letters of Credit Contract



Max Amount	Maximum contract amount will be defaulted. This is the sum of contract amount and (%(tolerant) of contract amount).




Figure 11.3: Islamic Guarantees and Standby Letters of Credit Contract Input - Preferences









Figure 11.12: Trade Finance User Defined Events Triggering










Figure 11.2: Islamic Guarantees and Standby Letters of Credit Amendment






Figure 11.5: Islamic Guarantees and Standby Letters of Credit Amendment - Parties






Figure 11.2: Islamic Guarantee Claim Lodging



















Figure 11.12: Islamic Guarantee Claim Settlement










Figure 11.18: Islamic Guarantees Transfer Input Summary

12. Liquidate Receivable Components

This chapter contains the following topics:

- 1) Introduction
- 2) Maintain Online Receivable/Payable Details

12.1 Introduction

Whenever you have to collect a component (typically for a commission or charge, or under certain circumstances the availment amount or the collateral amount), you debit it from the customer's account. On some occasions, you may have to debit it from an internal receivable GL, is debited from the customer account at a later date.

The debiting of the receivable account happens at the event for which the commission or charge has to be collected (issue of an Islamic LC, amendment of an Islamic LC, availment against an Islamic LC, etc.). When the customer account is debited at a later date, you have to perform, what is termed as receivable liquidation.

There are two related functions associated with liquidation:

- A batch process that reverses the liquidated receivable components, for a contract that is reversed during the day (the LQ EOTI function).
- A batch process that generates the charge and commission claim advice to the party on behalf of whom a charge or commission was debited, from a receivable account during the day (the LQ EOD function).

12.2 Maintain Online Receivable/Payable Details

This topic provides systematic instruction to maintain Online Receivable/Payable Details.

CONTEXT:

You can pass manual entries into LQ Module to maintain additional entries into the AR/AP LQ Module in the Receivable/Payable Online screen.

PREREQUISITE:


Specify the User ID and Password, and login to Homepage.

1. On the Homepage, type **LQDTRONL** in the text box, and click the next arrow.

STEP RESULT: Receivable or Payable Online screen is displayed.

NOTE: For further details on generic attributes that you can define for liquidation of an LC contract, please refer the 'Liquidation' User Manual under Modularity.

12.2.1 Liquidate the Receivable Components of an Islamic LC

Once you enter the reference number of the Islamic LC in the Receivable Liquidation screen, the system automatically assigns a unique liquidation reference number to the component you are liquidating. Besides this, the following details of the Islamic LC are picked up and displayed:

- The counterparty (customer) code
- The Value Date of the Islamic LC
- · The account to which the liquidated amount should be credited
- · The currency of the receivable account
- The branch to which the account belongs
- The total outstanding amount for the component as of the value date (the date on which the payment is made)
- Details of the tracers that were generated thus far for the outstanding component
- The Status of the Islamic LC

You can specify the following details for the Liquidation:

- The account that is debited for the liquidation amount.
- The branch to which the account belongs
- The currency of the account
- If the component currency and the currency of the account to be debited for the liquidated amount is different, you can indicate the exchange rate to be used in the conversion. By default, the exchange rate specified for



the product under which the processed Islamic LC is displayed. You can change this, and the changed rate should be within the variance limit specified for the product.

The outstanding components of an Islamic LC are displayed for each event. To liquidate an outstanding component, choose to Liquidate by clicking Processing on the application toolbar.

After the liquidation of an outstanding component, if there are other outstanding components for the event, the system will inform you of them and prompt you to liquidate them as well.

12.2.2 Manual Liquidation of Receivable Components for the Islamic LC

This topic provides systematic instruction about Manual Liquidation of Receivable Components for the Islamic LC.

CONTEXT:

Manual liquidation of transferable charge and/or commission components to an Islamic LC is performed, through the Islamic LC Deferred Liquidation screen.

PREREQUISITE:


Specify the **User ID** and **Password**, and login to Homepage.

1. On the Homepage, type **LIDEPMNT** in the text box, and click the next arrow.

STEP RESULT: Islamic LC Deferred Payment is displayed.

- 2. On the Islamic LC Deferred Payment screen, click New.
- 3. On the Islamic LC Deferred Payment New screen, specify the details as required.
- 4. Click **Save** to save the details OR **Cancel** to close the screen.

The outstanding commission and charge components is liquidated using this manual liquidation screen. During manual liquidation, you can opt to waive the receivable charge / commission amounts. No backdated value dates are allowed during manual liquidation of these components.

For information n fields, refer to: Table 12.1: Islamic LC Deferred Payment.

12.2.2.1 Specify Payment Breakup Details

The system displays the total amount due for the commission and charge components till date during payment as the payment breakup, inclusive of the details of each component.

Upon complete liquidation of the component, the system updates the status of the component from Receivable to Liquidated. The amount liquidated is also updated in the receivable component details.

The accounting entries maintained in 'MLIQ' event are passed for the amount paid.

12.2.2.2 Waiver of Components during Manual Liquidation of Islamic LC Charges

During manual liquidation of charges, the system allows a waiver of certain components. When the waiver option is selected, the system defaults the amount paid as the amount due and does not allow modification of the same for the component.

Upon waiver, the system marks the component in the Islamic LC as liquidated, internally.

Waivers are processed in the system as a new event initiated along with the MLIQ event.

12.2.3 Specify Details of the Advices for the Liquidation

This topic provides the details to Specify Details of the Advices for the Liquidation.

The advices that are generated for the events that occur during the life cycle of an Islamic LC are defined for the product involved in the Islamic LC. In this screen, you can specify the advices that should be generated to the parties concerned, indicating that you have liquidated a receivable component of the Islamic LC.

The details of two advices are shown in this screen:

- · Charge Claim Advice
- · Debit Advice

The Charge Claim Advice is generated at EOD; on the day the receivable account is debited. This is the event for which a charge is attached or a commission liquidation event (Event Code CLIQ). Its details whether it was suppressed during the event, the medium through which it was transmitted, and the date on which it was generated is displayed. This is for information purposes only.

The Debit Advice is generated when the receivable components of the Islamic LC are liquidated. You can suppress the generation of the advice or change the media and priority when you are processing the liquidation.

Suppress

By default, all the advices defined for the product involved in the Islamic LC is generated. If you do not want to generate specific advice, you can suppress its generation by indicating so.

Priority

Priority applies to the advices that need to be sent, through media like SWIFT or TELEX. By default, the priority of all advices is marked as normal. Advices are prioritized to one of the following options:

- Normal
- Medium
- High



Medium

It is mandatory also to specify the medium through which advice is transmitted. The advice is transmitted through Telex, Mail, SWIFT or any other media that you have defined in your branch. You can select the appropriate medium code from the option list.

In addition, the details for the Charge Commission Tracer are also displayed. This tracer is generated after the event has taken place until the component is liquidated. These details are for information only. The default from the product under which an Islamic LC is processed.

12.2.3.1 Account Entries Passed During Account Receivable Liquidation

The system passes the following accounting entries during account receivable liquidation when:

13. Credit Limit Tracking for an Islamic LC

This chapter contains the following topics:

- 1) Introduction
- 2) Track Credit Limit

13.1 Introduction

When you issue an import Islamic Letter of Credit (Islamic LC) or advise and confirm an export Islamic LC, you would track your liability against the party on behalf of whom you are undertaking a liability. For an import Islamic LC, you would track the exposure against the applicant while for an export Islamic LC that you confirm; you would do so for the issuing bank.

13.2 Track Credit Limit

In Oracle Banking Trade Finance, credit limit tracking is done using credit lines allotted to a customer.

The credit line allotted to the party against whom you want to track your liability is indicated while you capture the details of an Islamic LC. In the case of an amendment, from the advice of an export Islamic LC to advice and confirm, you can indicate the credit line during the amendment also.

You can specify Central Liability details for an Islamic LC, in the 'Islamic LC Contract Party details' screen. To display this screen, you have to click on the 'Parties' tab from the Contract screen.

The amount that is tracked is the Islamic LC Liability Amount. It is arrived at as follows:

Liability Amount = Maximum Islamic LC Amount + Liability% of the Islamic LC amount

In the case of an Islamic LC revolving in time, the liability amount is calculated, taking into account all the scheduled reinstatements.

This topic contains the following subtopics:

- 1) Specify whether Limit Tracking is Required
- 2) Indicate the Customer against whom the Islamic LC Liability Amount is Tracked
- 3) Specify the Limit Track Tenor
- 4) Indicate the Credit Line for Liability Amount

13.2.1 Specify whether Limit Tracking is Required

Every credit-seeking customer of your bank is assigned a credit limit under a Credit Line.

Check against the credit limit tracking option, to indicate that the Islamic LC liability amount is tracked against the credit limit assigned to the customer. Leave it unchecked to indicate you do not wish to track the Islamic LC liability amount against the credit limit assigned to any of the parties involved in the Islamic LC.

13.2.2 Indicate the Customer against whom the Islamic LC Liability Amount is Tracked

This topic provides the details of

- 1) Party Type
- 2) CIF ID of the Party



Party Type

You would have already captured the details about the different parties involved in the Islamic LC. For each party type (APP, ABK, ISB, etc.), you would have specified the details of the party. While specifying credit limit tracking details, you have just to indicate the party type against whom you want to track the credit limit. The party details are picked up by default.

CIF ID of the Party

When you specify a party type against whose credit limits you wish to track the Islamic LC amount the CIF ID assigned to the party is automatically picked up and displayed.

13.2.3 Specify the Limit Track Tenor

While maintaining the preferences for the contract, you can specify whether you want to track the limits based on Islamic LC tenor or the Max Draft tenor (Usance period). For this, you need to indicate your preference by selecting the appropriate checkbox.

NOTE: The credit lines are displayed depending upon the preferences specified at the time of creating the line. E.g. Products allowed, branch allowed etc.

For all the contracts, change your preference for limits tracking before or after authorization. However, every time you change the tenor type, you need to select a credit line again. Subsequently, tracking is done for the new tenor and credit line.

13.2.4 Indicate the Credit Line for Liability Amount

You have to specify the credit line of the party against which the Islamic LC liability amount is tracked.

If more than one credit line is defined for the party, only those credit lines whose restrictions are in line with that of the Islamic LC is displayed. The restrictions could be one of the following:

- Tenor
- Product
- Branch
- Currency

Also, the expiry date of the line should be before the Issue Date of the Islamic LC.

NOTE: When you enter an Islamic LC for a customer and choose a line, the cash collateral percentage defined for the customer and line will default. If you have not defined the cash collateral percentage for a customer and a line, the cash collateral percent defined for the product will default to the Islamic LC Contract. You can change this default value to suit the Islamic LC you are processing.



14. Automatic Processes

This chapter contains the following topics:

14.1 Introduction

The following processes relating to Islamic Letters of Credit (Islamic LC) is made automatic:

- · Automatic closure
- · Automatic calculation of periodic commission
- · Automatic liquidation of periodic commission
- · Automatic reinstatement of the Islamic LC amount
- · Automatic accrual of commissions
- · Generation of tracers

The events that are to take place automatically are triggered off during the Batch Process. The batch process is an automatic function, run as a mandatory Beginning of Day (BOD) and End of Day (EOD) process. During EOD, the batch process should be run after End of Transaction Input (EOTI) has been marked for the day, but before End of Financial Input (EOFI) has been marked for the day. The tracer generation function should be run after end-of-financial-input (EOFI) has been marked for the day.

NOTE: You should maintain the Islamic LC EOD function as a mandatory batch process, once as a BOD and the next as a Pre-EOC program. It is maintained in the EOC mandatory program stable of the Core Services-module. The tracer generation function should also be defined as a mandatory EOD function.

Revenue that has to be shared with the Co Banks for Islamic Counter /Counter Counter Guarantee contracts, will be processed as part of LCEOD batch.

14.2 Maintain Branch Parameters

This topic provides the systematic instructions to Maintain Branch Parameters.

CONTEXT:

The set of rules that govern the Islamic LCs processed through the Islamic LC module, in a particular branch of your bank, is defined in the Branch Parameters screen.

PREREQUISITE:


Specify the **User ID** and **Password**, and login to Homepage.

1. On the Homepage, type **LCDBRPRM** in the text box, and click the next arrow.

STEP RESULT: Letters of Credit Branch Parameters Maintenance screen is displayed.

14.3 Batch Process

This topic provides the systematic instructions to display the Batch Process.

CONTEXT:

Batches are run automatically. In the mandatory programs, all batches whichever are required are maintained in sequence and that is triggered automatically as based on the maintenance in the Mandatory Batch Program Maintenance screen.



It is done after the availment that makes the current availability to zero is made. When Islamic LCs are automatically reinstated, the necessary accounting entries and advices specified for the event code REIN (reinstatement), is passed automatically. As a part of the BOD process, this function reinstates all the revolving Islamic LCs (specified with automatic reinstatement), which needs to be reinstated. This is determined by two factors: • Whether the Islamic LC revolves in time and the next revolving date is less than or equal to the current date or

	Islamic LC, is reduced to zero by the availments that were made.



14.3.1 Generating Tracers

For an Islamic LC, the following types of tracers are generated:

- The acknowledgment tracer (sent to the advising bank when an import Islamic LC is issued and an acknowledgment is sought)
- The charge-commission tracer (sent to the party who has to bear the commission or charges for an Islamic LC that has been processed, pending the payment of the charge or commission)
- The confirmation tracer (sent to the confirming bank, seeking a letter of confirmation).
- Guarantee claim Tracers (Sent to the party mapped in the tracers till the Claim is in Lodged status)

These tracers are generated at a frequency, specified for the Islamic LC. On the day they have to be generated, the EOD processing: Tracer generation function will generate them. This function should be run after the End of Financial Input (EOFI) has been marked for the day.

14.3.2 Intra Day Accruals

The Intra Day Accruals is a batch process that computes accruals for different kinds of investments made by funds. This batch includes processing of fixed asset depreciation. The intra-day accruals / depreciation are performed only for those products for which accruals /depreciation cycle is due for the day. In case of inter-fund subscriptions, the system does not calculate the profit for the investing fund. This is an intra day process that is applicable only to fund branches.Intra Day Accruals work in line with the normal end of day accruals. Intra day accrual will process in the same manner as an End of Day (EOD) batch. In LC module, it is processed based on the branch level accrual parameters.
