Oracle Banking Credit Facilities Process Management (OBCFPM) 14.1.0.0.0 was released in July 2018 to enable banks in offering collateral and credit facilities process management services to their corporate customers. In OBCFPM 14.7.0.0.0 release, the product is further enhanced with additional functionality.

1.4 Release Highlights

- The following enhancements are released as part of OBCFPM 14.7.0.0.0 version.

1.4.1 Single Customer Multiple Liabilities

- A new section has been added in the Liability section where users can link customers created as part of this application or link the banks common core customers to the liability being created.
- Further, users can now go to restriction section of the facility and add the customers linked to the liability as allowed/disallowed customers for this facility.
- As part of hand off, liability and its linked customer will get handed off to ELCM.

1.4.2 Customer Summary Changes

1.4.2.1 Other Customer Linked to Liability

- An option has been added to see the other customers linked to the liability

1.4.2.2 Customer Linked to Other Liabilities

- An option has been added to see the other liabilities to which this customer is added

1.4.3 Collateral Changes

1.4.3.1 Liability Selection

- Considering now a customer can be linked to multiple liabilities the user can select the liability under which he wants to initiate the collateral perfection process.
- A field has been provided to select the liability.
- This field will only appear if the customer is linked to multiple liabilities.
