2.1 Execution Order of Installation Manual

- Security Management System Service Installation Guide
- Common Core Services Installation Guide
- Oracle Banking Supply Chain Finance Services Installation Guide
- Oracle Banking Supply Chain Finance User Interface Installation Guide

2.3 Prerequisite

The OSDC package consists of the five zip files. Before proceeding with the installation, unzip the files into the same common folder.

- OBSCF {release number}_Part1.zip
- OBSCF {release number} Part2.zip
- OBSCF {release number} Part3.zip
- OBSCF {release number} Part4.zip
- OBSCF_{release number}_Part5.zip

Note: For the release number, refer to the OSDC file available as a part of the release.

- Oracle WebLogic Server Enterprise Edition
- LDAP Server
- Apache Kafka



- Apache Zookeeper
